Poultry Show Held Last Week Was Great Success

The last of the Green Belt Poultry shows closed at Crowell, January 1st. This show was sponsored by the Foard County Poultry Association. There was excellent interest, the show being crowded practically all the time during the three days by farmers and poultrymen from Hardeman, Foard, Knox, Wilbarger, Childress and Cottle counties.

The S. C. Rhode Island Red class was the heaviest in the show with near 100 birds in competition. These were followed by Buff Orpingtons with the Dark Cornish third.

Over 400 birds were cooped during the show.

Old Timer Tells How Foard County Was Organized

The following article was submitted by D. D. McConnell, who now resides at Houston, Texas, but who for forty years was a resident of Wilbarger County and editor of the Vernon Weekly Call for a long time. Mr. McConnell gives us a sketch of the organization of Foard County that is interesting. It follows:

Houston, Texas, Dec. 28, 1926. During the year 1885 a petition with 167 names of persons attached to it was presented to the Commissioners Court of Wilbarger County by John Wesley asking for an order of the court to organize Hardeman County which order was granted.

In the meantime R. D. Rector representing the Wortham cattle interests in the proposed new county had filed a protest alleging that at the time there were not 150 legal voters in Hardeman county. During the checking over of the names on the petition it mysteriously disappeared, so when the protest came on to be heard the order to organize the county was made final and an election ordered which resulted in favor of the new county and Margaret selected as the county seat. When the Fort Worth & Denver R. R. passed through Quannah an election was held removing the county seat from Margaret to Quannah. Thereafter the Texas Legislature created the new county of Foard and Crowell selected as the county seat, leaving to Hardeman County all that territory situated north of Pease river. The bill creating Foard County passed the Legislature as Ford County but when enrolled for final passage it went through as Foard County. About twenty-five years after Hardeman County was organized John Wesley in a letter to L. N. Perkins explained how the original petition had mysteriously disappeared which letter of explanation was published in the Vernon Weekly Call. L. N. Perkins was county clerk in Wilbarger County in the year the new county of Hardeman was organized.

New Railroad Gets Charter Mon. to Build

Austin, Jan. 5.—(AP)—Building of a 150-mile railway from Vernon in Wilbarger county to Lubbock in Lubbock County is the purpose of the Ardmore, Vernon and Lubbock Railway Company of Texas, chartered late Monday by the secretary of state.

The line would run southeast from Vernon through Wilbarger, Foard, Cottle, King, Dickens, Crosby and Lubbock counties, serving a plain country of constantly increasing agricultural importance.

The company's application was approved by the attorney general's department. Capital stock is \$150,000 divided into 1500 shares, valued at \$100 each, with each of the 10 incorporators owning 150 shares. The principal office is at Vernon.

Gets Good Revenue from Flock of Hens

It also looks good to see a farmer bringing eggs to town and S. E. Tate is one of those farmers.

Mr. Tate has 115 White Leghorn hens and 104 Rhode Island and from those he is now getting a fine quantity of eggs daily. He says he is selling from \$2.00 to \$10.00 worth of eggs every week and, too, at a time when hens are not laying at their best. But of course, the splendid price of eggs has a tendency to offset that.

Mr. Tate is well pleased with his success in the chicken business and feels that good chickens are mighty good things to have on the place. \$40.00 or \$50.00 per month from the egg crop of only 200 hens is not poor profit at all. The fact is one would hunt a long time before finding anything better. Another thing is that one on the farm can reduce the cost of the operation of a small poultry farm by the production of his own feed. That eliminates a big expense, or rather turns into profit the labor of his own hands as a farmer, for as a rule feed for stock or poultry on the farm brings the best profits.

ORDER AND NOTICE OF BOND ELECTION

\$34,000.00 City of Crowell Waterworks Extension Warrants, dated March 25, 1926, in denomination of \$1,000.00 each, and bearing interest at the rate of 6 per cent per annum.

\$7,000 City of Crowell Funding Warrants, dated July 20, 1926, in denomination of \$1,000.00 each, and bearing interest at the rate of 6 per cent per annum.

Aggregating \$56,000.00.

At Thalia Garage building in Thalia, in voting precinct No. 6 with Walter Johnson as presiding officer.

At Thalia gin office in Thalia, in voting precinct No. 7, with W. S. Tarver as presiding officer.

At school house building in Foard City in voting precinct No. 8, with Frank Weatherall as presiding officer.

At Black school house building in Black community in voting precinct No. 9, with W. W. Nichols as presiding officer.

At Vivian school house building in Vivian community in voting precinct No. 10 with John Marr as presiding officer.

At I. O. O. F. building in Rayland in voting precinct No. 11, with T. F. Lahlbert as presiding officer.
