
## Residential **Break-inson Crime Line**



How would you feel about moving to a town with limited medical care?

How would you react to living in a town with a "way-station" medical clinic? Perhaps that would be okay with you...but I

want to know that my town has a hospital, fully staffed and equipped with qualified

personnel and top-notch physicians. I know that you have tried to establish Garza Memorial with this in mind.

I also know that you have struggled with an adverse image ... that many citizens through the years have opted to go to Lubbock for medical care, even the simplest maladies.

What do you do to correct this public image?

First, physicians must themselves believe in the hospital and use it. I take this opportunity to point out that Dr. Stephen Chun has been persistent in this cause and is to be complimented for his dedication to the future of the hospital.

Second, the board must see that the hospital is staffed and equipped to meet the standards that both physicians and patients expect. The cost will not be cheap.

The need can not be measured in money.

We are more than one hour away from Lubbock . . . in serious emergencies and lifethreatening situations, that hour or more can mean the difference between life and death.

The cost must be paid ... and if it has to come from taxpayer subsidy, I believe we should do whatever needs to be done to insure we have adequate medical care in Garza County. Running off to Lubbock is not the answer.

Last weekend I went to Matador delivering the Rotary Club sponsored goods ... while there we were given a tour of the damage.

One building that wasn't damaged was what had been the hospital. Closed.
