

# Council Picks Member as Manager

The Post City Council appointed 11 year council member W.G. "Bill" Pool Jr as its new city manager, following a lengthy special called meeting Monday evening.

Pool, formerly employed at Burlington's Postex Plant, is currently employed by the State of Texas as Adult Probation Officer for Dawson and Lynn Counties.

He will assume duties as city manager in the middle of

August, starting at \$22,000 per year salary for the remainder of this calendar year, then to be compensated to \$23,000 per year.

The vote to appoint Pool was unanimous.

Council members attending the meeting were Weaver McKamie, Lewis Holly, Jack Ault, Maxine Earl and Mayor Giles McCrary. Pool was also at the meeting but did not participate in the selection of a city manager.

Pool replaces Mrs Rebecca

King, who left the position July 1 to enter law school at Texas Tech.

The council interviewed eight candidates for the position during the past few weeks, including two at Monday night's meeting.

In other action, the council heard a report from John Moore of Plains Utility Co. concerning residential complaints on West Main Street following the replacing of the city water main.

The mayor recommended a

policy statement be sent to property owners in the future to explain that 19 and one-half feet of city lots are city property.

The group insurance plan with Traveler's was approved. The city pays \$124.03 for

hospitalization coverage for employees, with employees paying one-half of premiums for dependent coverage.

The mobile home park ordinance changes were discussed but tabled until the August 6 meeting.

The 44th Annual Post Stampede Rodeo will open August 9 at 8 p.m. with the

"Fastest Rodeo in the West" grand entry scheduled at 7:45 p.m. in the all new arena just north of Post on Hwy 84.

The rodeo will continue Friday and Saturday, Aug. 10 and 11, with shows starting at 8 p.m.

There will also be three big dances, featuring "Malfunction Junction" with Michael Porter of Dickens, Tex.

The dances will be held Thursday, Friday and Saturday nights on the covered slab at the rodeo grounds.

The popular rodeo parade will be held at 5:30 p.m. Thursday, Aug. 9 in Post, with trophies and cash prizes for floats.

Producer of the rodeo events this year is Terry Walls of Stephenville.

Books for entering the rodeo events will close at noon on August 8.

Admission for the rodeo will be \$1 for children 12 years or younger and \$3 for adults.

## Commissioners Hear from Rancher

Billy Huddleston of Snyder met with Garza County commissioners Monday morning to discuss a "county road" which runs through his ranch.

Huddleston told commissioners that after lengthy research he could find no abstract or minutes concerning where the road had been made a county road.

After telling the commissioners of recent problems with the road, he asked for their help in declaring whether the road was or was not a "county road."

Commissioners tabled the request until commissioner Herbert Walls was in attendance since the road is in his precinct.

Huddleston will meet with the commissioners again in August.

Commissioners also discussed an alcoholism program and grant for a counselor for Garza County with one-half the salary to be paid for by Job Training program. The program was approved for a one-year experiment.

Jo Ann Mock asked for the Caprock Cultural Association to be put in the budget in the amount of \$2,500. Commissioners gave Mrs Mock a letter of intent in March, along with the city. Mrs Mock said matching funds will be given to the association if the city and county participate in the program.

# Emergency Feed Still available

The USDA's emergency feed assistance program is enabling drought-affected farmers in Garza County to purchase low grade government owned corn for livestock feed.

Farmers had purchased 35,502 bushels of this corn as of July 1, according to Victor L. Ashley, county executive director.

The program is designed to help farmers whose livestock feed supplies are lower because of drought to obtain sufficient feed for their foundation livestock and poultry.

Of the 91 program applications received, 82 had been approved as of July 1.

Ashley said some farmers may continue to submit applications.

"These include farmers

who were approved but received only part of their allocations, those whose applications originally were turned down but who may now qualify because of short feed supplies, and those who never applied but may qualify."

He said applications would be accepted until corn supplies are exhausted.

To qualify for emergency feed, farmers are required to have evidence that their feed production was reduced by drought and was inadequate to maintain foundation livestock and poultry through the 90 day feeding period.

They could purchase up to 10 pounds of corn per day per animal unit times the number of days in the feeding period, depending on the amount of feed on hand.

Sold at 75 percent of the \$2.73 per bushel 1983 loan rate, emergency corn sales have totaled about \$72,770.10 thus far.

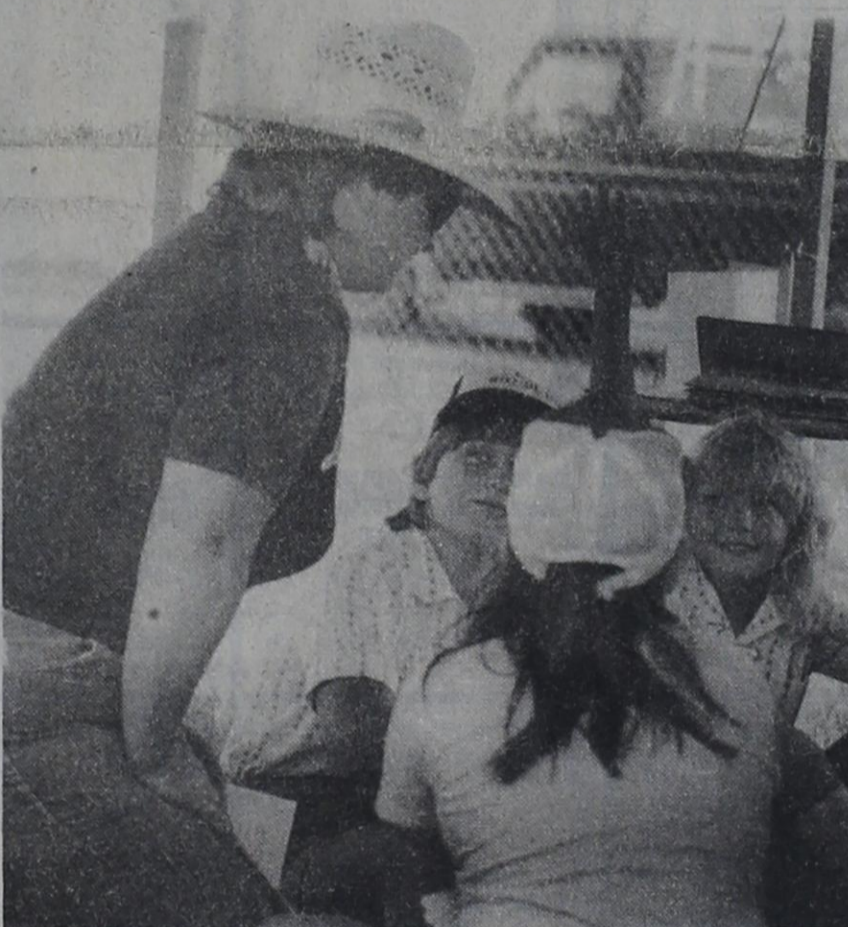
Ashley said farmers who are reapplying, or those applying for the first time and whose applications are approved, will be able to

arrange for deliveries of corn immediately.

USDA originally had approximately 28 million bushels of CCC-owned No. 4,5 and sample grade corn.

"As of May 7, 1984, we had sold approximately 18 million bushels, leaving about 10 million bushels," the ASCS official said.

## State School Serves Area

The Lubbock State School, a residential training facility for mentally retarded persons, has been designated as the Mental Retardation Authority (MRA) for a 16 county region of Texas, one of which is Garza County.

The Lubbock State School Outreach Department has been given the responsibility of developing a six year plan addressing the delivery of mental retardation services for these counties.

To assist in gathering information from the public and consumers, a series of 10 public hearings at various

locations in the 16 counties will be held within the next month.

Garza County will hold its public hearing Monday, July 30 at 9:30 a.m. in the Garza County Courthouse Courtroom.

Two representatives from the Lubbock School will conduct the hearing to ascertain the communities concerns and to gather input about what kind of mental retardation services are needed locally.

Those interested in the program are encouraged to attend the hearing.

## Pair Pleads Guilty

Ernest and Irwin Devroe, brothers, will spend 10 and eight years respectively in the Texas Department of Corrections following their guilty pleas before Judge George Hansard in district court.

The two were charged with the armed robbery of Lott's White Auto store last spring. Garza County Sheriff's office also reported the arrest of a male subject July 17 on a Garza County warrant for assault following an altercation. The subject paid fine and court costs of \$218.50.

Two males subjects were arrested Friday, July 20 on D.W.I. charges, one remains in Garza County jail in lieu of a \$750 bond while the other posted a \$275 cash bond and was released.

July 20 another male subject was arrested by Garza County officers for DWI and DWLS and was released from jail after

posting a \$750 bond on each charge.

On July 21, a Snyder man was arrested on two warrants from Taylor County, one by theft by check and the other a bond forfeiture on DWLS. After posting a \$500 bail bond on each charge, was released from the Garza County jail.

On July 22 a male subject was arrested for DWI and the unlawful carrying of a prohibited weapon. He was released after posting a \$750 bail bond.

Sheriff's officers are still investigating two thefts, one which occurred July 16 at the Garza County-City Swimming pool when someone broke a glass and stuck their hand through to steal approximately \$8 of candy and potato chips.

The second offense also took place July 16 when a stereo was reported stolen from the upstairs apartment at Hudman Funeral Home.

The latest city sales and use tax report from State Comptroller Bob Bullock shows Post with a \$2,000 increase over last year for the same period.

The total payment to the city this year is \$9,211.50 compared to \$7,028.10 for 1983 for a 31 percent increase.

The annual payments through June 29 is \$81,869.33, compared to \$86,960.39 last year.

The 31 percent increase this year is the largest single monthly increase for Post in 1984 and continues an upward trend in retail sales here.

In other area cities, Slaton received a check for

\$10,713.12, compared to \$6,451.20 last year and the year-to-date is 14.07 percent increase at \$103,361.29.

Tahoka received a \$3,963.26 check, compared to \$3,046.64 last year and the year-to-date is 12.28 percent increase at \$34,897.71.
