## Oil Values Down, Production Up

School, county, hospital and city elected officials and administrators are faced with a shorter petroleum pie for tax revenue as budgets are being prepared for next year.

The short-term affect of the reduced tax revenue from minerals is directly related to the lost production during the carbon dioxide secondary recovery methods used last year.

"Appraised values are determined January 1," central appraisal office director Jean Westfall explains, "and unfortunately this year mineral appraisals are down because of the lower production in 1983."

The decline for Garza County is \$26,040,880 in appraised mineral value, a drop from \$483,524,490 in 1983 to \$457,483,610 this year.

The determination of mineral values is based on production in 1983 and the estimated value of the reserves of a field or well.

The increased production this year will not help budget planers trying to work through the decrease in revenues this year, but next year the overall mineral appraisals should be back to 1982 or higher levels.

More Good News

In other good news, the 10 year oil production in Garza County continues to increase, as well as total drilling and number of wells.

In 1974 the county had 1,473 producing wells pumping out 5,695,413 barrels, climbing to a high of 7,769,770 in 1982 with 1,976 wells.

There were 2,074 producing wells in 1983 in the county and drilling permit applications for the first six months of 1984 have totaled

## Commissioners Set New 1985 Tax Rate of 15.5

Commissioners Court set the new tax rate at 15.5 for the new fiscal year beginning October 1.

Though, not a tax increase, the figure is up from 14 cents last year in order to collect the same amount of money as last year due to the reported \$90,000,000 in valuation losses.

The county was told that they would lose \$64,000,000 in ag use and \$26,000,000 in mineral valuations.

The new tax rate carried with Commissioner Ted Aten in opposition.

Commissioners also voted a six percent pay increase for county employees with the exception of the commissioners court who will receive a three percent increase.

A hearing on the budget will be held in the commissioners courtroom Monday, August 13 at 10 a. m.


#### Parade Entries

No Secret to Selecting

For some people, picking the "perfect" watermelon is favorite summer rite that involves thumping and shaking and looking for telltale signs of what could be inside.

a watermelon is very difficult unless it's cut in half or quartered.

In fact, one recent produce industry study showed that about 40 percent of consumers find melons the most difficult fruit to judge for ripeness and freshness.

There are a few appearance factors which may be helpful - but not totally reliable - in guiding you to a good, ripe, juicy watermelon.

The surface of the watermelon should be relatively smooth. The rind should have a slight dullness, neither shiny nor dull.

The ends of the melon should be filled out and rounded, and the underside of the melon should have a creamy color.


## Library Report


A total of 1,530 books were loaned by the Post Public Library during the month of June, bringing that total for the year to 5,896.






