Freezing rain and drizzle slowed traffic, and caused hazardous driving all over the South Plains, with temperatures falling to the lower 20's.






GTE technician Bobby Green picks out shorted cable pairs in the Post central office following the burning of telephone cables early Friday morning during the icing conditions.

Texas as to her business's need for having United Parcel Service available for shipments within the state.

UPS is applying to the Commission for authority to pick up and deliver packages between any point in Texas, otherwise known as "intrastate" operating rights. Currently, the nation's largest package delivery firm can only move packages on an interstate basis, or within the commercial free zones of Dallas-Fort Worth, Houston and San Antonio. Texas is one of just two states that restrict UPS intrastate. Lindsay testified that the lack of UPS service within the state has seriously hampered the operation of her business. She cited no pick up or delivery service, slow delivery time, prohibitive rates and lack of state-wide coverage, as the major problems being encountered with oth-







By WES BURNETT There's still a lot of talk around town about the final playoff game in Snyder...and how it might have been ...


All the might-have-beens and what-ifs won't change the outcome.






