If enough evidence has been provided to make an arrest, the Crime Line will tell you and ask you to call back in 10 minutes to receive instructions on where and when to get your cash reward.

Postex Up-Date

By the end of this week a total of 142 employees will still be working at Burlington Industries' Postex plant, with 92 personnel remaining in the sewing room and 50 in the shop and warehouse.

Through Monday there were 146 hourly-waged employees, five salaried personnel terminated at the plant.

The weaving and spinning divisions will cease operations this week.

No firm date of termination has been set for the finishing room operations.

Burlington Industries also announced this week that conversations with a potential buyer of the plant are continuing, but no arrangements for turning over the plant have been made.

The prospective buyer has been collecting information in order to make a determination as to entering negotiations for purchase.

The name of the potential buyer has not been released due to the sensitive nature of the discussions.

An official at Postex told The Dispatch that it might be another two-three weeks before the prospective buyer would be in a position to say yes or no about entering negotiations with Burlington.

Tuesday Sunrise Wind Foretells Success Rate

People who depend on the weather to make a living are anxious to see which way the wind blows next Tuesday morning at sunrise.

Since 1906 the wind direction at sunrise on March 22 has told the story of good or bad crop years in Garza County as the old Plains Indian tradition of "Taba'na Yuan'e" has been repeated.

Again this year, as he has since 1973, "Chief" Frank Runkles will patiently and quietly build the ceremonial council circle and build a fire by rubbing two sticks together.

Then, just at sunrise, "Chief" Runkles will test the wind direction and an observer will declare the findings.

Last year the wind told the story of a "very good year."

"Taba'na Yuan'e" translates to mean Sunrise Wind and the ceremony is an authentic dance used by the Plains Indians to determine their success in the coming year.

Early Pioneers in Garza County picked up the tradition from stories they heard from Indians and J.A. Wilborn was the first of local folks to maintain the ceremony.

What started out as a simple sunrise testing of the wind has developed into an authentic re-creation of the Comanche version of "Taba'na Yuan'e" by "Chief" Runkles.

He is a student of Indian lore, and when the Post Chamber of Commerce accepted the responsibility of maintaining the tradition in 1973, Runkles was asked to serve as the leader

of the project.

Using his knowledge of the Plains Indian culture and after extensive research, Runkles has pulled together all the ceremonial dress, Indian signs and mystical preparations as the Comanche understood "Taba'na Yuan'e."

Starting about 15 minutes before sunrise, Runkles prepares for the sun, just as the Comanche had done for hundreds of years and other plains Indians for perhaps thousands of years.

And as Runkles tells his friends, "you know if you're outside much at sunrise, that the wind always changes direction between the ending of dark and sunrise."

In other words, the wind could be blowing out of the south at a minute before sunrise and at the precise moment of sunrise, quickly shift to the southeast or southwest.

Farmers and ranchers will be watching closely to see which way the wind is blowing the smoke as Runkles points in the direction of the breeze.

A west or southwest wind means a poor year.

South or southeast predicts a very bad year.

North or northwest means an average year.

East or northeast indicates a very good year.

Since 1906 the wind prediction has been 94 percent accurate.

County Commissioners Okay Industrial Development Corp.

County commissioners, with Judge Dalby presiding, approved the formation of a Garza County Industrial Development Corporation after listening to a presentation made by Jack King accompanied by Ken Yeates of the Texas Industrial Development Board.

King told the commissioners that they wanted it formed through the county rather than the city, in case some industry wanted to form somewhere in the county.

King said the corporation authorized the creation and administration of industrial development corporations to act on behalf of cities, counties and conservation and reclamation districts.

The industrial development board will be able to issue obligations and bonds on behalf of the sponsoring government entity to finance projects, promoting and developing commercial, industrial and manufacturing enterprises.

King also told the commissioners that the county would in no way be responsible for payback of bonds issued for such development. The non-profit corporation would be under county guidance and supervision and that all recommendations would be brought before the commissioners for their approval.

A three member committee will serve on the development board, with Robert West, Preston Poole and Jack King appointed by the commissioners.

All that was asked of the county was to pay the \$35 filing fee.

Dick Milam with Mid-Plains Pipe Company also met with the commissioners to ask permission to use right-of-way in bar ditches in Pct. 2 and Pct. 1 to lay plastic lines with a pressure capacity of 25 pounds leading to the gas gathering plant located on the Floy Richardson place.

Milam told commissioners that the lines would be buried 48 inches deep with a 42 inch cover. All but one mile of the pipeline would be located in Pct. 1 under Buck Craft.

Milam presented a check to the county in the amount of \$13,686.36 to Pct. 1 and \$4,950.00 to Pct. 2 for right-of-way use.

Don Hefner of Kelley, Cole and Co., auditors went over the yearly audit with commissioners and gave his recommendations for the upcoming year.

The audit was approved as presented by commissioners and it was decided to advertise for bids for auditors for the coming year with bids to be opened in regular session during the April meeting.

Before adjourning, commissioners approved monthly invoices and paying of the bills.

STATE CAPITAL HIGHLIGHTS

AUSTIN—Several events building up steam in the Legislature came to a head last week as lawmakers scurried to find replacements for dwindling state dollars. The hectic week began with Comptroller Bob Bullock's revised revenue forecast which was closely followed by Gov. Mark White's budget address to a joint session. Both officials recommended tax increases of different varieties. At week's end, House Speaker Gib Lewis announced his own House Ethics Committee would investigate his failure to fully disclose his business interests. Bullock trimmed \$867 million from earlier estimates of state monies available for the next two fiscal years, blaming oil prices and sluggish tax receipts for the reduction in state cash.

His announcement immediately fueled the on-going debate of whether the Legislature should pass a tax bill or slash state spending. The Legislature itself remains visibly divided as Lt. Gov. Bill Hobby seeks a tax increase and House Speaker Gib Lewis stands adamantly against one.

Luxury Taxes

White, who earlier opposed a tax hike, told lawmakers he supported raising an additional \$800 million in state revenue by taxing alcoholic beverages, tobacco and amusements such as video games and pinball machines. The governor also suggested issuing bonds for highway construction, which got a mixed reaction. All in all, White's budget is still over a billion dollars more than Bullock says will be available.

If White and Bullock can't agree on revenue estimates, it should come as no surprise to onlookers who have watched the pair jockey for position these past two months: it's no secret that Bullock intends to challenge White in the '86 gubernatorial race.

Special Session

Bullock has come out in favor of a nickel-per-gallon gasoline tax hike for increased state highway construction, perhaps the most palatable tax for legislators to levy and taxpayers to accept. White avoided support of any tax hike as long as he could, and whether Bullock played a role in forcing his change of stance, White responded by suggesting tax

raises for luxuries, or "sin" taxes as members sometimes call them. But legislators don't want the political heat that a tax vote might bring, and could well fail to pass any appropriations bill this session. Some lawmakers are already predicting a special session on the state budget as their best protection for Texas. By then, the price of oil will probably have stabilized, and lawmakers will have bought time to see whether Bullock's or White's estimates come closer to the mark. Meanwhile, the Texas unemployment rate for February rose to a record 8.8 percent, a grim reminder to lawmakers that the economy is suffering, no matter who figures the budget.

Speaker Lewis

House Speaker Gib Lewis refigured his financial disclosure report and revealed last week he has 49 business interests not included in his original report. Lewis, earlier caught heat from the press and some of his opposition colleagues for not revealing his business connection to alcoholic beverage interests amid charges he was sabotaging DWI reform legislation. Last week's update revealed Lewis also has partnership ties with a horse racing lobbyist, which had gone unmentioned in an earlier financial disclosure report required by law. Legally, Lewis slipped off the hook when the Travis County District Attorney advised that the law penalized a lawmaker for failing to file a report, but not for filing an incomplete report. Lewis will not be prosecuted, but the Ethics Committee will conduct a secret investigation. The press also revealed that Lewis recently ordered dismantled a \$100,000 sophisticated phone system in his office, which the state now has in storage.

House-Senate Fight

The Legislature narrowly averted a rare House-Senate fight last week when the House leadership retreated from a plan to change the way representatives sign up to sponsor Senate bills. Tradition has the senator choose a House sponsor for his bill when it is considered in the House. The proposed change would have let House members sponsor bills on a first-come, first-serve basis.

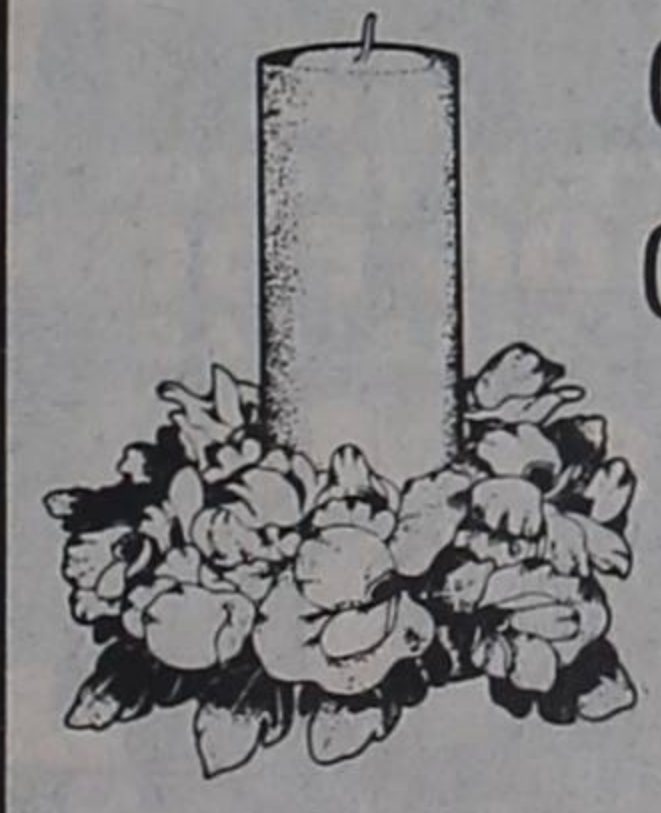

The Big Picture

The Big Picture
By Pastor Steve Traw
First Christian Church

The impressions of my first plane ride remain fresh on my mind. The single engine four-seater had landed on the freshly

mowed hayfield. The joy and feeling of first going aloft has left vivid impressions. And most revealing was the view of seeing our large farm from such an altitude. For the first time, I had new insights into the fields, the river which meandered through the section of fertile land, and their relationship to one another. Only now could I visualize how the river's course once flow-

ed through the old bayou now turned cornfield, and see the pond and pasture that touched one corner of the farm and their relationship; and observe at a glance, areas where the new corn had suffered from rainfall that stood too long in the rows.

Such is the case with Bible study when we view the book as a whole, as from above. A new perspective is gained. Relationships of the various parts are for the first time in a new light. The real danger in getting

lost in the single phrases and verses of a Bible passage apart from the larger context can be best avoided. The big picture is viewed when one soars above the words and phrases, above the sentence, above the paragraph, chapter and book. Both the Old and New Testaments become parts of a whole that has the Spirit of God as co-author. While a lifespan will not ingest all there is to know of scripture, its pursuit in understanding as a single volume greatly aids that

quest. Sunday through Wednesday night, March 20 to 23, our featured speaker, Obe Hokanson, will be presenting an overview of the Bible in four evenings. Those of the community are invited to join us as we begin this Sunday evening at 6 p.m.

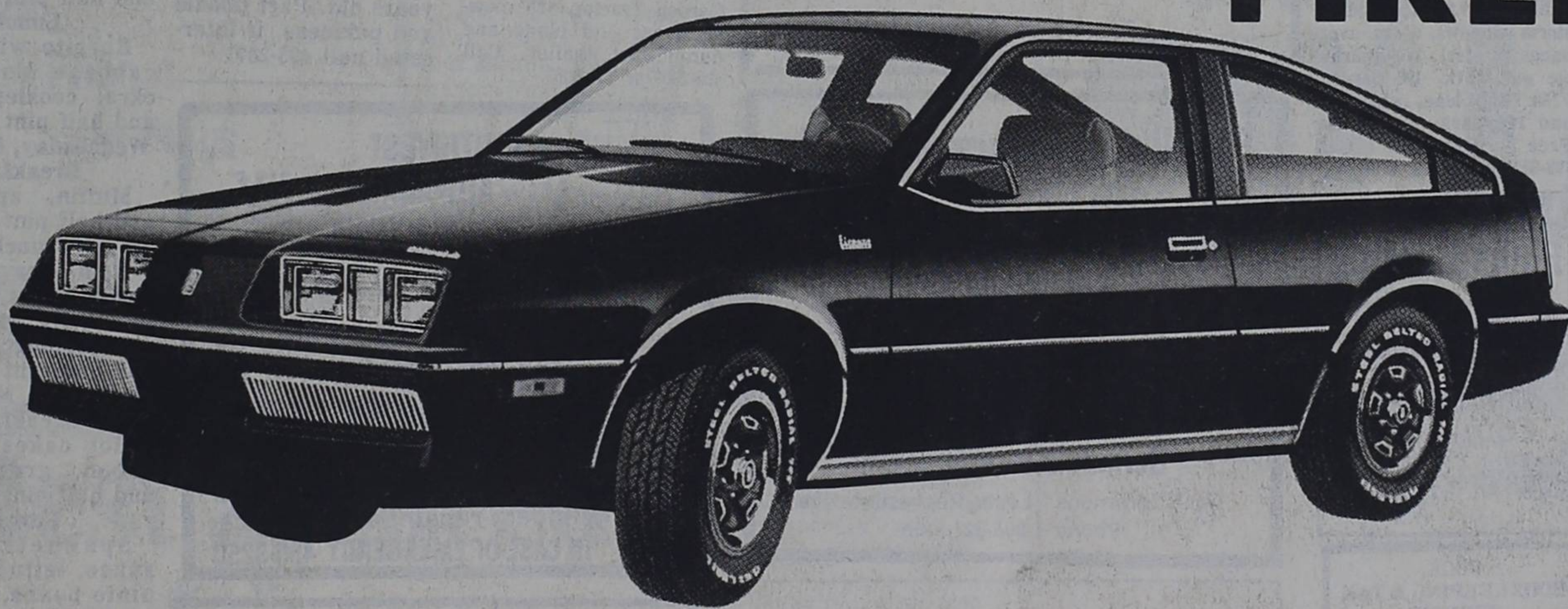

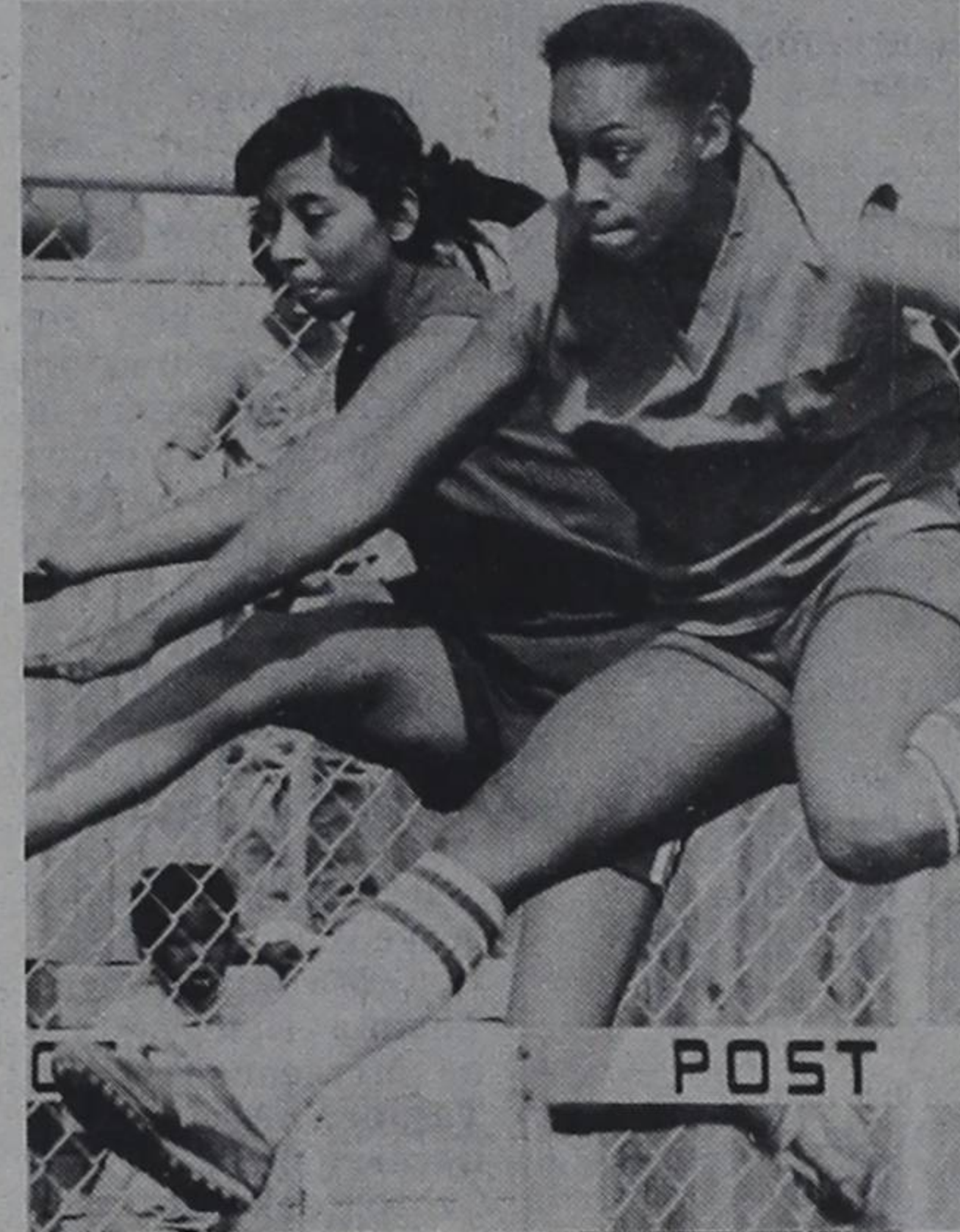
