Principal speaker for the event will be Jerry Kunkel, an inspirational speaker who began his public speaking in the early 1970s.

His unique approach, utilizing a powerful message spiced with humor, entertains and at the same time inspires and motivates those who hear him.

Kunkel is a native of Lamesa and after graduating from Lamesa High School, he received a presidential appointment to the U.S. Naval Academy, where he played football and was All-American in track and field competition.

A former All-State standout in football, Kunkel was drafted to play professional football for the New Orleans Saints but decided against the football career.

He has spoken in more than 500 different settings around the Southwest, and is a popular after-dinner speaker. As a speaker in the Knife & Fork circuit, Jerry now accepts engagements across the United States.

He utilizes his masterful storytelling techniques, and poignant, often hilarious anecdotes from a colorful early life to convey his message effectively to people of all ages.

presented at the banquet, along with plaques which will be presented to all chamber members and PMA members who will be completing their terms as Board of Director members.

Commissioners Name New Economics Agent

In a regular session Monday, January 11, members of the Garza County Commissioners Court named Sandy Tomlinson, who is currently working as Supervisor of an Extension pilot program at Ft. Sam Houston, to fill the Extension Agent-Home Economics position formerly held by Colleen Chadwick.

Mrs. Tomlinson and her husband, Jeff, will reside in Post when she assumes her duties with the county on February 1.

Dr. Catherine Crawford, district director for home economics with the Extension Service, and Syd Conner, county Extension agent for agriculture, introduced Mrs. Tomlinson to the commissioners; and County Judge Giles Dalby announced the appointment at the close of the Executive Session.

In anticipation of the coming March 8 primaries, the commissioners approved election judge replacements in three precincts.

John Boren was approved as a replacement in Precinct 4; Harold Lucas in Precinct 8; and Ida Mae Wilkes as a replacement in Precinct 7 for Liberty Anthony, who asked that she be replaced.

Names were drawn to determine members of a grievance committee to hear from both paid county employees and elected county officials before any grievances are brought before the commissioners court.

Members of the grievance committee are Tana Pyssen, Wesley Bullard, Betty Sharp and Raymond Perdue. Ewell Morgan will serve as alternate committee member.

Judge Dalby was named as chairman of a five-member board which will serve as regulatory authority for the lakes project.

Nominated as board members, who are appointed for two-year terms, were Buddy Skinner, John Boren, Ed Neff and Clyde Cash.

In other action taken, the commissioners agreed to a leave of absence for Deputy Robbie Wedeking, during which time all vacation-time and sick-leave time accumulated would be paid.

Approval was also given to award a fire extinguisher maintenance contract to Ronnie Metsgar.

The standard term of county court was approved as February, May, September and November.

GMH Offering Services for Home Health

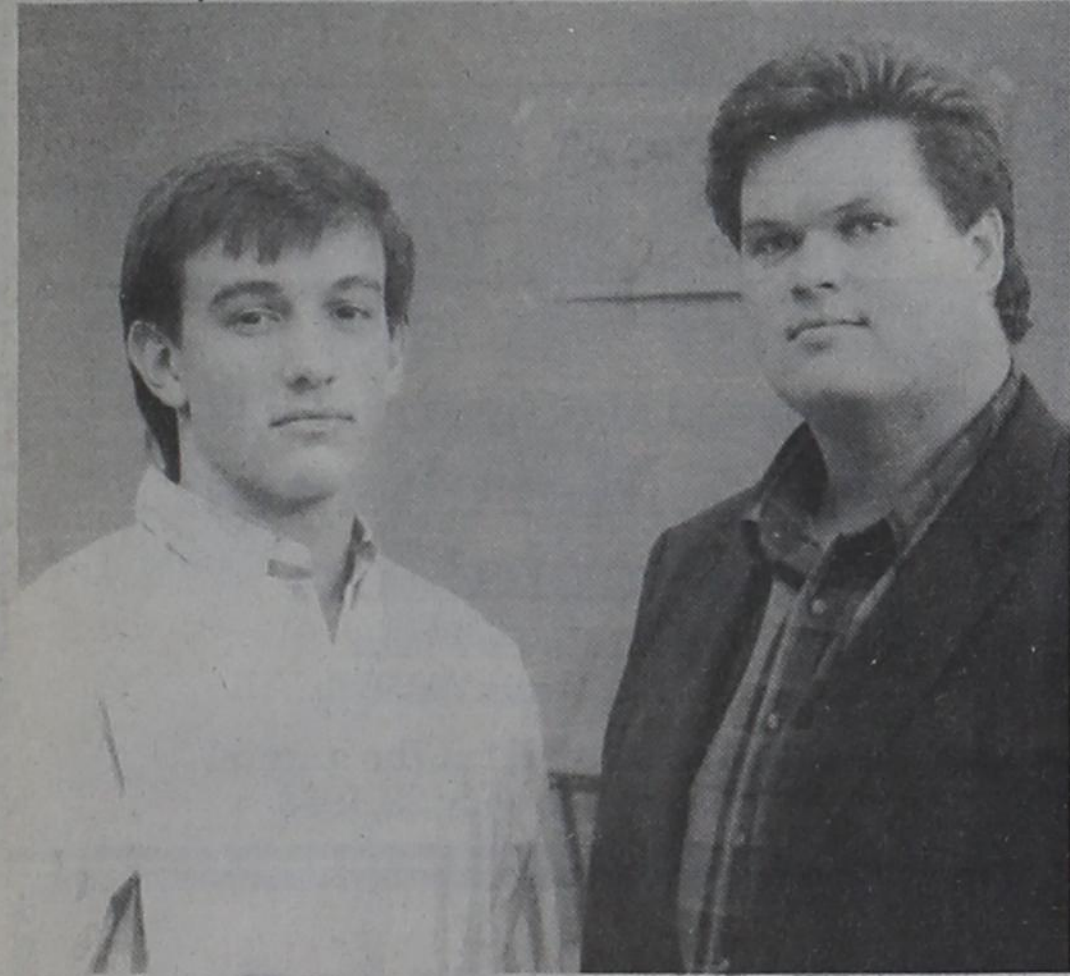

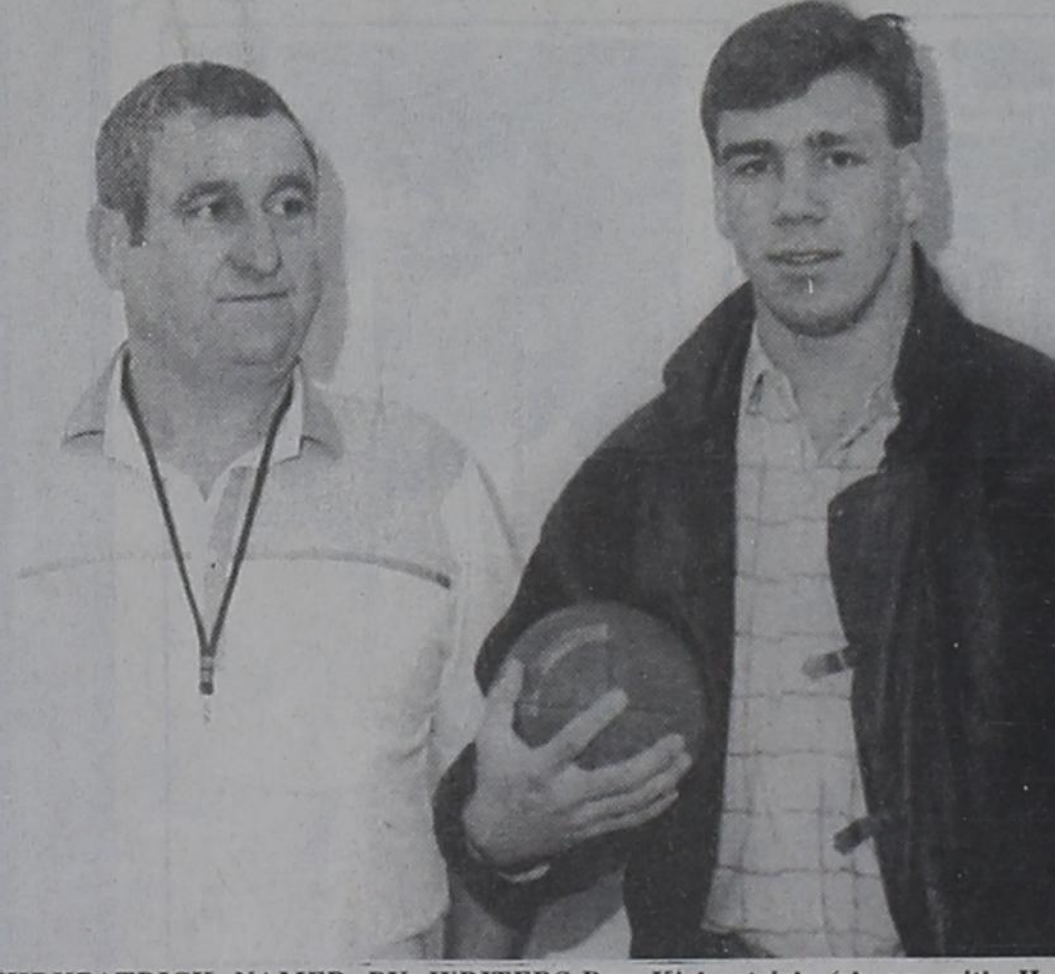
Regular hours are 8 a.m. to 5 p.m., but emergency calls will be taken 24 hours a day.

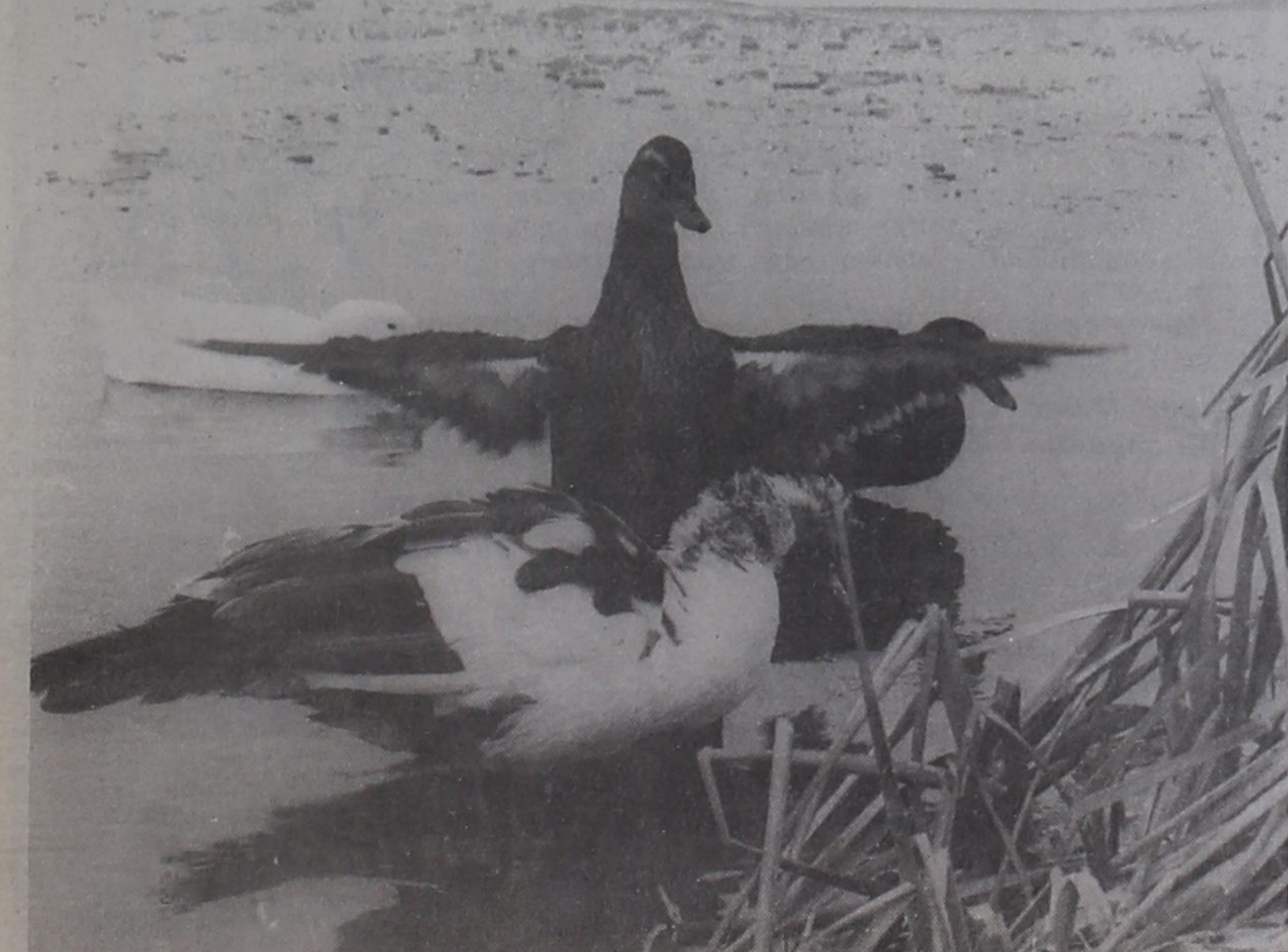





Garza County Represented on Capitol's "Great Walk"

The Capitol Committee and the State Preservation Board announced recently that Garza County will be represented among those etched on the Great Walk leading to the Texas State Capitol in Austin, thanks to the members of Garza County Commissioners Court who approved the participation of Garza County in the project.

Over the past several years, plans have been underway for the restoration of the state Capitol, which will celebrate its 100th anniversary on May 16, 1988.

To complete the first phase of the restoration, the Capitol Committee has enlisted the support of all Texans to share in this historic restoration by means of "A Walk in History" project.

As part of the Capitol restoration, the Texas Association of Counties is sponsoring a project to

have all 254 Texas counties' names included in a special section of the walk.

Years of continued use and weather have deteriorated the Capitol's walkways. These approaches to the Capitol will be restored using 28 inch diamond-shaped pavers which will be etched with the name of each contributor.

Completion of the "Walk in History" is scheduled prior to the May 16, 1988 centennial celebration of the Capitol's completion and dedication.

Anyone interested in participating should contact the Capitol Committee, 1507 West 6th, Austin, Texas 78703, 512/477-6499.

Pavers are available on the Great Walk and the names of individuals, families, associations, clubs and businesses may be inscribed on the pavers.

Increased Upland Production Expected

Lower stocks, coupled with expected continued strong domestic mill and exports resulted in a lower acreage reduction for 1988 upland cotton. Victor Ashley, Executive Director of the Garza County Agricultural Stabilization and Conservation Service, said the 1988 program contains a 12.5 percent acreage reduction requirement compared to a 25 percent reduction in 1987 and 1986.

Participating farmers will be eligible for federal target price protection of 77 cents per pound, and price support loans at 51.8 cents per pound. The 1988 Upland Cotton Program does not offer any paid land diversion.

According to Ashley, USDA intends to implement the Plan B marketing loan program for the 1988-crop upland cotton if the adjusted world price falls below the loan rate. "This means that farmers will be allowed to repay a price support loan at the lesser of the announced loan level or the adjusted world price. Currently, the adjusted world price is above the loan level. However, if the adjusted world price falls below the loan level, producers may repay a price support loan at the adjusted world price in effect for that week."

Loan deficiency payments will be

made to eligible producers who agree to forego loan eligibility if the loan repayment rate is less than the announced loan level. "The payment rate will equal the difference between the loan level and the loan repayment rate during the week in which the cotton is sold."

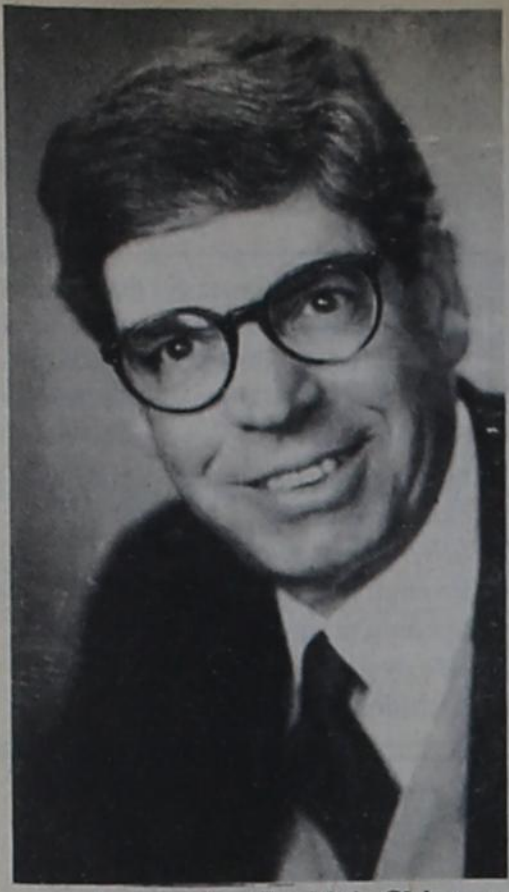

Review Conservation Compliance Rules

Farmers who continue planting annually tilled crops on highly-erodible fields without an SCS approved conservation plan may lose eligibility for certain USDA benefits.

The conservation compliance provision of the Food Security Act of 1985, applies to land where agricultural commodities were grown at least once between 1981 and 1985, and will apply to all highly-erodible land in annual crop production by January 1, 1990, according to Victor Ashley, Executive Director of the Garza County Agricultural Stabilization and Conservation Service.

"Farmers still have a grace period to implement a conservation plan on highly-erodible fields cultivated for producing agricultural crops during this period," Ashley said. "Many will be able to apply an SCS plan that will allow them to

February until the November election.

December Increase In Oil & Gas Discoveries

Texas oil and gas operators reported 47 gas and 25 oil discoveries in December, according to Railroad Commission Chairman James E. (Jim) Nugent. In November, a total of 21 gas and 24 oil discoveries were filed with the Commission. A discovery is an exploratory well that is completed in a previously untapped reservoir.

Gas discoveries in December included three in West Central Texas (District 7B), two in the San Angelo area (District 7C), and two in the Panhandle (District 10).

Oil discoveries included one in the San Angelo area (District 7C), three in the Lubbock area (District 8A), one in North Texas (District 9) and one in the Panhandle (District 10).

Those discoveries were included in the 675 oil, 218 gas, and 44 service completions operators reported in December. In November, operators filed 593 oil, 166 gas, and 79 service completions. A total of 199 dry holes were reported in December, compared to 297 in November.

In 1987, operators reported a total of 7,327 oil, 2,542 gas, and 733 service completions. In 1986, 10,337 oil, 3,034 gas and 1,029 service completions were reported. Operators reported 3,252 dry holes in 1987 compared to 5,300 in 1986.

A total of 1,581 drilling applications were processed by the Railroad Commission in December, as compared to the November total of 1,441.

The December total included 1,120 applications for permits to

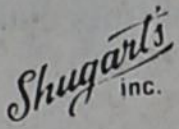

(Continued from Page 7) continue to use the land for agricultural commodity production. Conservation plans may call for the planting of permanent grasses, either on their own, or in conjunction with the Conservation Reserve Program."

Assistance Available

Some low-income Texans may be eligible for help in paying heating bills this winter through the Home Energy Assistance Program, according to Texas Department of Human Services Commissioner Marlin Johnston.

Johnston said the one-time payment is available to many low-income households. Applications for energy assistance were mailed to households that received food stamps. Aid to Families with Dependent Children, or Supplemental Security Income in December. Other low-income individuals may request an application from local DHS offices during the enrollment period of January 15 through February 18.

Eligibility is limited by gross income and resources. Aid is available for a one-person household having less than \$589.49 gross income per month. The gross income limits are \$781.49 for households of two persons, \$973.49 for three, \$1,165.49 for four, \$1,357.49 for five, and \$1,549.49 for six.

Households are eligible if the cost for heating is included in the rent payment or if the household pays a portion of its home energy costs.

Energy assistance checks are sent directly to the people who are eligible for assistance. However, the checks are made payable to the energy provider.

Persons receiving one of these energy assistance checks should mail it or take it in person to the energy provider business office with their regular energy bill. The check can be cashed only by the energy provider.

If the HEAP check is more than the energy bill, the additional amount will be credited to the person's account for the next month's bill. If the energy bill is higher than the check, the person is responsible for paying the difference.

E.A. Howard Announces Candidacy

E.A. Howard, Jr. has authorized the Dispatch to announce that he is a candidate for the position of Garza County Judge, subject to the Democratic Primary on March 8.

Howard was raised in Haskell County, where his grandparents settled and started the Howard Community which later developed into the Howard School District.

He graduated from Haskell High School and Texas Tech, where he received a B.S. degree, and, later, a Master's Degree in education.

Howard also did graduate work at Sul Ross, Howard-Payne and Texas A&M.

His 36 years of teaching experience began in Haskell, with 20 years of that time spent as a Vocational Agriculture teacher in Post.

Howard and his wife Joyce, who has worked for 14 years as a teacher's aide in the Post schools, have

lived here for 23 years and have two sons - Eric and Brent.

Howard is a deacon in the First Baptist Church of Post and has been a member of that congregation since coming here.

He is very active in the church and enjoys his work with the RA boys - "I participate in other organizations, but my church-work comes first," Howard said.

He is currently owner-operator of Post View Mobile Home and RV Park and has recently been named president of the Trailblazers - a Senior Citizens Group.

During his years as a teacher, Howard served as vice-president of Lynnco Teacher's Credit Union, president and vice-president of the local TSTA and president and vice-president of Area II Agriculture Teacher's Association.

"A group of my friends got together and asked me to run for the position. They felt that I was qualified for the office - I've had a lot of experience getting along with people.

"After their urging me to run; and after thinking it over carefully and seeking some guidance, I decided to become a candidate," Howard said.

Cotton Talks

Additional details of the 1988 cotton program, delayed by changes made via the budget reconciliation bill passed in December, will be out shortly, according to Charles Cunningham, Deputy Director of USDA's Program Analysis Division.

Expected first are the department's projection of the 1988 deficiency payment rate and the percentage of the payment that will be available to producers at sign-up time. A sign-up period from February 16 through April 15 has been announced, and the acreage reduction program (ARP) requirement for program participation is set at 12.5 percent of each farm's base acreage, down from the 25 percent ARP in effect for 1987.

Language in the budget bill reduced the 1988 target price from the 77 cents per pound scheduled in the 1985 farm act to 75.9 cents, a 1.4 percent reduction. Target prices for other program crops, also reduced in the drive to cut government costs, are \$2.92 per bushel for feed grains, \$4.23 per bushel for wheat and \$11.13 per hundredweight for rice.

The authority given the Secretary of Agriculture by the 1985 act to lower commodity loan rates by five percent from the preceding year was amended in the spending measure to an adjustment of no more than three percent. The loan for cotton however will continue to be set by formula and will remain at the 51.8 cents per pound announced earlier, a cut of less than one percent from the 52.25-cent rate for 1987.

If the Secretary determines that a deficiency payment is likely for any commodity for which an acreage reduction program is in effect, which Cunningham says is in-

evitable for cotton, he is required by the budget bill to make a portion of the payment in advance. Cotton advance payments must be at least 30 percent and no more than 50 percent of the projected total. The wheat and feed grain advance requirement is a minimum 40 percent, maximum 50 percent.

Since October when USDA announced the 12.5 percent ARP for 1988, the U.S. 1987 crop production estimate has gone from 13.34 million bales to 14.28 million, and the projected U.S. carryover has risen from 3.8 million to 4.4 million.

With general expectations of higher carryover projection in January, some have speculated that USDA might be persuaded to increase the ARP requirement. But that, says Cunningham, can't be done without legislation to negate the statutory November 1 deadline for the ARP announcement.

After November 1, Cunningham points out, the only means available to USDA for additional acreage reduction is to offer producers a paid diversion program in addition to the ARP already announced.

Authority for such an action exists under the 1985 act's "Cost Reduction Options," Section 1009. The Secretary could use the authority at any time prior to harvest.

DPS Postpones Safety Regulation

Yesterday, the Texas Public Safety Commission formally postponed the Department of Public Safety's (DPS) enforcement of HB 908, the Texas Motor Carrier Safety Act, until September 1, 1989.

House Bill 908 authorized the DPS to adopt state regulations consistent with federally mandated motor carrier safety standards. The regulations that were adopted would have impacted all areas of commercial vehicle operation since they gave the DPS authority to inspect trucks in excess of 10,000 pounds on Texas highways, whether private or for -hire.

Commission members have directed the DPS to reevaluate the regulations and their application during the 18-month delay.

"We're disappointed that the Texas Motor Carrier Safety Act will not be enforced on schedule, but we remain committed to improving truck safety in Texas," was the reaction of Robert A. Floyd, president of Texas Motor Transportation Association, a trade group of truck and bus companies in Texas.

"Passage and implementation of comprehensive truck safety legisla-

tion was one of our primary legislative goals during 1987," explained Floyd. "The truck and bus industry has demonstrated to the public, media, and legislators the seriousness of its commitment to highway safety by working in partnership with the DPS, Department of Transportation, and a coalition of industry groups to develop HB 908."

Despite the strong support of the bill throughout its passage -- from the DPS, DOT, legislators, and other industry groups -- no one involved anticipated the full impact of the regulations. Many Texas businesses that have some type of transportation activities but are not considered trucking companies were to be affected.

"In the past few days, we became aware that the DPS and legislators had received complaints from some of these businesses who do not believe they should be subject to the new regulations," said Floyd. "We understand the importance of the DPS taking the time to reevaluate the regulations and their application in light of the concerns of these companies."

"We believe that with the eventual implementation of the Texas Motor Carrier Safety Act, Texans will see a marked improvement in truck safety on our highways," said Floyd.

The Federal Motor Carrier Safety Act of 1984 granted states a five-year phase-in period -- ending in 1989 -- to adopt state safety standards consistent with those in force at the federal level. The act gave the Department of Transportation authority to preempt any state regulations less stringent than those on the federal level. It also gave it authority to withhold certain federal funding for states which did not comply, Floyd explained.

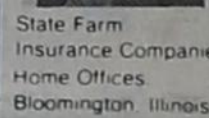
