'Nuclear Chili' Filming Here

If all goes according to plan, a movie will be filmed in Post and spots in Garza County in September or October, producer-actor Gregory Cassel announced Monday afternoon.

During a visit here with Mayor Giles McCrary, Cassel said that "Nuclear Chili", in the making for more than three years, will include well known actors Richard Widmark and Robert Mitchum.

"They have expressed an interest and we expect them to sign on to do the film," Cassel said.

The Lubbock born and raised actor says he chose Post for the onlocation filming "because the view of the Caprock and ranching areas are just perfect for the story."

He has toured area ranches and found several places for filming the outdoor scenes.

"I first became interested in Post as a filming site last summer while visiting my cousin (former Lubbock Mayor Alan Henry)," Cassel explains, "and he said I should talk to Giles McCrary."

"That first conversation led to visits and correspondence and now we're ready to get started. I really have to credit Giles for getting us down here," Cassel says.

"Nuclear Chili" is a Caprock Productions project of a Buddy Van Horn film.

The story, developed by Cassel, takes place on the "Double D", a West Texas ranch and involves a high-stakes horse race.





Carpenter said it is gratifying to look back on successful historical accomplishments, but added that

the Extension service in Texas also looks to future challenges and opportunities.

The Cooperative Extension System's statement of mission targets helping people improve their lives through an educational process which uses scientific knowledge focused on local and national initiatives to solve problems.

Carpenter said that with the passage of the Smith-Lever Act, Extension became the dispenser of the largest continuing education program in the world. This is conducted through a network of county Extension agents.

Among special observances that will help launch the 75th anniversary festivities will be proclamations issued by mayors and resolutions from county judges and commissioners, special programs from civic and service clubs, talks by hosts of volunteer leaders working in some phase of Extension Service education, and programs keying on Extension home-maker and 4-H youth efforts and many other special programs.

To help keep the 4-H and youth program in Texas at the forefront are more than 42,617 volunteer leaders who are working with 381,481 boys and girls enrolled in some phase of the youth program, said H.T. "Tom" Davison, assistant director for 4-H and youth with the Extension Service.

Oil Production Continued at 100 Percent

The Railroad Commission has continued the Texas oil production rate for May 1989 at 100 percent of market demand.

Top production allowable was continued after review of oil companies' nominations to buy a total of 1,914,046 barrels of Texas oil per day. The May nomination total, a decrease of 31,951 barrels daily when compared to April purchaser nominations, indicates market demand. May 1988 nominations totaled 2,028,353 barrels daily.

The Commission first went to the ceiling level for oil production in April 1972. It applies to all fields in the state except those that are assigned lower legal rates of production so that reservoir pressures will not be depleted before the maximum amount of oil has been recovered.

Major purchasers filed these May nominations from the floor at the last allowable hearing: Conoco, Inc., 68,800 barrels per day, down 200; Exxon Co., USA, 173,200 barrels, down 7,000; Mobil Oil Corp., 132,000 barrels, down 2,400; and Amoco Production Co., 169,000 barrels, down 3,000.



Salesman Confesses Claims newspaper is best salesman

On Monday, Jules Wintner, owner of a local retail establishment, confessed his job as a salesman was obsolete due to the impact of newspaper advertising. Wintner, in an exclusive interview, said sales were made in the local paper instead of in

"Sure, we get a chance for additional sales," Wintner commented, "but the newspaper has become our best salesman." Wintner reported that consumers name the local newspaper as their usual source of "Best Buy" information, 10 times more than radio or television. This conforms with a recent Consumer Data Service report that indicated 60% of the consumers seek "Best Buy" information from the newspaper versus only 6% for radio and 7%

Wintner later remarked that befor television. cause the newspaper is read by all Texans, regardless of income, his business was able to sell both upper end products as well as value priced items. "No matter what we're selling, we get good response in the newspaper," he said. "In fact, the more expensive the product, the better our response seems to be." This fact is substantiated in a survey by the Texas Newspaper Advertising Bureau that documented readership of the newspaper increases as income increases. In the survey, almost 75% of Texans with incomes exceeding \$50,000 a year read

Salesman admits he "never had to sell anything" because of newspaper ads

"Our customers shop the newspaper. When they walk in the door, they already know what they want, they know the price and often have the ad

with them." "My job has become redundant," Wintner admitted. "Used to be I had to really sell each customer, but now I'm just an order taker." Asked what he intended to do now that the newspaper was doing most of the selling, he replied, "Spend more in newspaper advertising than last year.
