Breakfast, Bicycles and Balloons...A Few Items on Tap for 1989 Founder's Day

Breakfast, bicycles and balloons are just a part of the full day of activities planned for downtown Post to mark the third annual Founder's Day Celebration, Saturday, October 14.

The day begins with breakfast at 7:30 a.m. on the "longest breakfast table in West Texas." East Main Street will be lined with tables and chairs and everybody is invited to sit down and enjoy Post's favorite breakfast food - Post Toasties and other Post cereals.

While you're enjoying your Post Toasties you can look East on Main Street and watch a colorful sight as cyclists begin staging at 7 a.m. in front of Algerita Park for La Rueda de Post "The Circle of Post," which begins promptly at 8 a.m.

Sponsored by the Lubbock Bicycle Club, the Post Chamber of Commerce and the Post Merchant's Association, La Rueda de Post consists of four different rides: the 25 mile quarter century for enthusiastic riders; the 50 mile half century for strong cyclists; the 70 metric-plus century for the serious cyclists; and the 102 century plus for only the best conditioned.

This is the third year for the Post Century Plus ride and the number of entries has increased steadily each year.

For an even more colorful sight, look west on Main as balloons begin their ascent in a Hot Air Balloon Extravaganza featuring members of the Lubbock Hot Air Balloon Club. The impressive display will line West Main and take to the air at about 8 a.m.

After the breakfast, bikes and balloons, the Hi-Rollers tumbling team will perform on West Main, at about 10 a.m.

At 9 a.m. the Garza County Museum, the Bob Chennault One-Man Art Show at Algerita Art Center and the Founder's Day Art Show at the Community Center will all be open to the public with special exhibits.

Algerita Park will be a busy place beginning early Saturday morning with food booths and game booths and a special information booth where free maps will be available and souvenir tee-shirts will be sold.

Music will also be featured at Algerita Park with Joe Harris and

the Club House Band performing at 11 a.m. and a country-western band from Western Texas College in Snyder performing at 2 p.m. and again at 3:15 p.m.

Activities continue throughout the day and evening and schedules are available to help you keep track of the time and locations of various events.

She is the mother of three children: Kevin, Jennie and Amy and one grandchild, Brandi.

Weaver, active in attempts to revive the Lubbock community theatre, also found an avenue for his stage talents at the Garza Theatre through his friendship with Sever.

Weaver lists "Twelfth Night" as an acting highlight, having performed in the Shakespeare festival in Odessa's Globe Theatre.

County Elected Officials Lose Budgeted Pay Raise

Failure to publish proposed salary increases resulted in Garza County's elected officials and precinct officers losing their budgeted monthly raises at the Monday, October 9 session of Garza County Commissioners' Court.

The raise for officials and county employees had been included in the adopted budget for 1989-90, but, according to County Attorney Preston Pool, the law requires that the increase must be published before the budget is approved.

Vernon's Texas Codes Annotated Local Government Code, section 152.013. "Procedures for Setting Amounts for Elected Officers," states:

"(a) Each year the commissioners court shall set the salary, expenses, and other allowances of elected county or precinct officers. The commissioners court shall set the items at a regular meeting of the court during the regular budget hearing and adoption proceedings.

(b) Before the 10th day before the date of the meeting, the commissioners court must publish in a newspaper of general circulation in the county notice of:

(1) any salaries, expenses, or allowances that are proposed to be increases; and

(2) the amount of the proposed increase.

(c) Before filing the annual budget with the county clerk, the commissioners court shall give written notice to each elected county and precinct officer of the officer's salary and personal expenses to be included in the budget."

The ruling applies only to elected officials and precinct officers and does not include other Garza County employees, who will receive an across-the-board raise of \$50 a month.

In other business, the commissioners reviewed an indigent application for assistance with utilities and voted to approve the maximum amount allowed for utilities under the new Garza County General Assistance Agency. The assistance program will pay \$25 for gas, \$25 for electric and \$10 for water.

The commissioners also voted their approval of a travel fund of \$200 for the Garza County Sheriff's office, to be used to draw against to cover expenses incurred by the department on out-of-town trips.

The short agenda for Monday's session was completed with approval of the monthly minutes, reports and bills.

Present at the session were County Judge E.A. Howard, Jr.; Commissioners Herbert Walls, John Valdez, Ted Aten and Sammy Ellis; Voda Gradine; Dee Justice; and Sonny Gossett.

City Council Approves TDC Grant Application

Post's City Council, in a regular session Monday, October 9, endorsed a resolution approving an application for funding through the Texas Department of Commerce Texas Capital Fund, for the benefit of Wright Fibers, Inc.

The application for funds in the amount of \$475,000 will be made in the name of the City of Post and loaned by the city to Wright Fibers for a proposed local industry, if TDC approves the application.

The funding from TDC is a grant to the City of Post, not a loan. The city's only obligation, if the grant is approved, is to administer the funds and to ensure that jobs are created locally by the company receiving the funds.

Appearing before the council Monday night in support of the application were Herbert Wright of Wright Fibers, Karen King with South Plains Association of Governments, Giles Dalby and Patty Kirkpatrick, both representing PEDC.

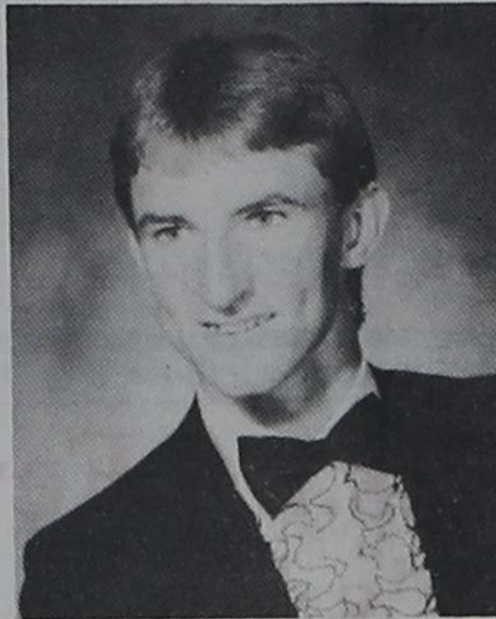
Danny Ray Foster

Post Fall Enduro 1989 to Benefit Boys Ranch

The Post Enduro Association will sponsor the 1989 Post Fall Enduro, in conjunction with Texas Boys Ranch of Lubbock, JT Racing USA of California, and P.L.K., Inc. of Post. The sporting event will be held on Sunday, October 15, six miles south of Post on FM Hwy 669, with the first four riders leaving at 8:01 a.m. and four riders per minute leaving the starting line for approximately an hour.

An enduro is a sport in which contestants of all ages are required to ride off-road motorcycles over a predetermined route at a given speed. Hidden checkpoints, placed 3 to 10 miles apart, test the rider's ability to maintain an average speed which varies depending on route terrain.

The event usually covers 65

miles for the short course riders (novice, youngsters, women) and 85 to 130 miles for the long course (more experienced riders).

In an effort to support the Boys Ranch, the enduro club's landlord, P.L.K., Inc., has pledged money per rider competing in this fall's event. Money will also be donated on the same basis from the Post Enduro Association. Both parties are excited about this great sport, and the opportunity to support the efforts of the Boys Ranch.

The enduro is held on private property and spectators must stay within designated camping areas or along the highway.

Additional Information Regarding City of Post Health Insurance Proposals

The Post City Council met September 25 and 28, 1989 to make decisions on health insurance for 20 City employees.

Bob Turner, City Manager, explained the Austin, Texas Agency - Texas Municipal League (TML) proposal, which costs \$34,207.20 annually for 20 employees at \$142.53 per employee monthly and included a roll over or enrollment of all employees without health questions. One million dollars of coverage was included.

Tom Power, licensed with Pan American Life Insurance Company - rated A+ Superior by A.M. Best Co., with 1.73 billion dollars of assets, presented a plan through Pan American's broker, National Service Insurance, Inc., costing \$24,482.76 annually, which is \$9,724.44 less than TML and included three medical questions to be answered by each City employee for enrollment.

The plan would cost \$102.01 per employee monthly with the rates guaranteed one year.

Basic requirements for any proposals was a firm price per employee per month for one year; \$250 deductible, 80% of \$2,500, 100% thereafter; cost containment, i.e., full payment of second opinion; minimum \$1,000,000.00 lifetime coverage; dependent coverage to include maternity; \$10,000.00 Life Insurance and full acceptance of existing insureds.

The local Agency, Tom Power, would service the account with the broker's toll free Wats lines and Agency Fax machine.

The City Council elected to accept the TML proposal from the Austin, Texas Agency.

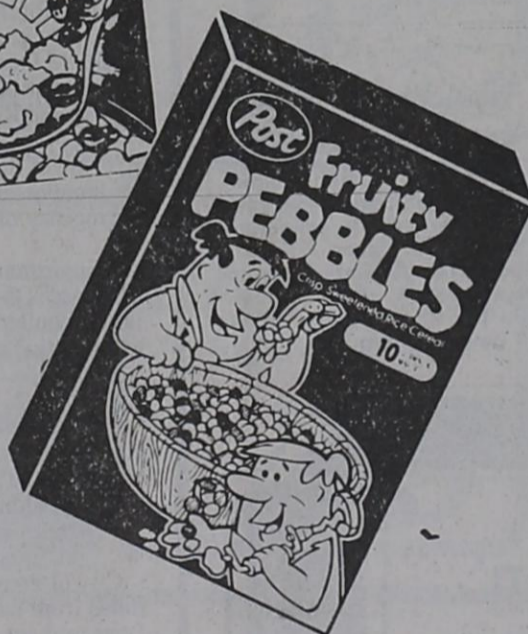
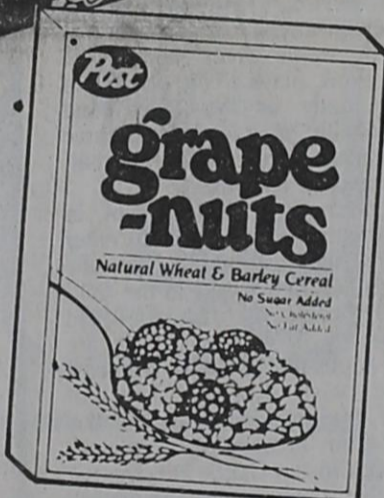
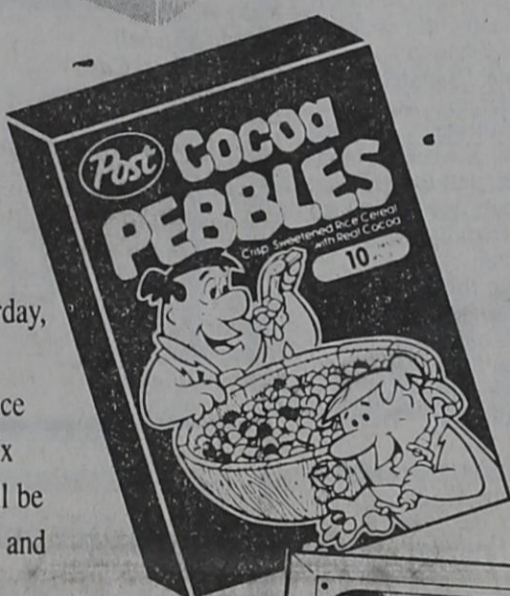

In the Neighborhood

You are probably aware by now that the City of Post is having a party...but are you also aware that you are invited?

When the town honors its founder, C.W. Post, with its third annual Founder's Day Celebration, Wednesday, October 11 through Sunday, October 15, visitors are welcome, of course, but let's remember that the celebration is also for all the people of Post and Garza County.

As the town he founded pays tribute to Charles William Post, I took a little time and discovered a few more facts about the man...In 1906 C.W. was already a Battle Creek, Michigan multi-millionaire, but he was looking to expand his horizons and turned his energies toward developing the wonders of the great state of Texas.

Post's dream was to establish a model community in Texas where families would acquire a home with a low down payment, easy monthly payments, and where the bread winner of the family would be in a position to earn a living.

He began to think of turning his fortune toward helping his fellow man to help himself. With this dream in mind he sought the proper sight for his ideal community - and found it in West Texas.

Before the year was out he had acquired almost 250,000 acres of land on the dividing line of the Panhandle and Staked Plains regions, where the Caprock escarpment falls into the canyon and mesa country, around the headwaters of the Brazos.

Here Post City was built and by 1907 a thriving tent city was set up. Activities buzzed forward in every direction; streets were laid out and street lighting set in. A machine shop, stone quarry, hotel, school, churches, a department store and shops were constructed - some of them of native sandstone. Landscaping was an important part of Post's plan, and trees - catalpas, black locusts, chinaberry and Carolina poplars - were set out in the very beginning to shade the wide streets of the barren, shadeless areas.

Now, some 82 years later, most of the original trees that once lined

the city streets are gone, but C.W. Post's vision and determination are still alive in this progressive little town...carried on by a lot of hard working people, C.W.'s dream continues.

That's why we have Founder's Day - to celebrate the dream and to honor the man...and we don't want to forget - when the celebrating starts - that we're invited.

Museum Exhibit
And speaking of the founder of our town - "C.W. Post: A Retrospective," now on display at the museum, proved to be a big hit with all the people who attended the Sunday open house. The exhibit is bright, colorful and interesting - and you can always learn something new about the man. (I didn't realize that his famous "rain battles," when he dynamited for rain, cost \$50,000. But I didn't realize, either, that he really did make it rain 40 percent of the time.)

Honor Your Dispatch
Just a reminder that this week, October 8-14, also marks National Newspaper Week, a week to highlight the services newspapers and their staffs provide and a week to be kind to your friendly, neighborhood newspaperman.

Voice from the Past
Rodney Marshall called the Dispatch crew the other day, just to visit and also to let us and you know that he is opening soon in a LCU theatre production, "The Apple Tree."

Rodney is now an education major at that Lubbock school and, after his time on the stage at the Garza Theatre, is lending his talents to a new theatre.

"The Apple Tree," consists of three short plays, "The Dairy of Eve," "Lady or the Tiger" and "Passionella." Rodney is in all three and appears as the snake, the bal-ladeer and the narrator.

Purpose: Start-up the Cotton Fabric Manufacturing Operations in Post
Location: City of Post
TCDP Amount: \$500,000

Finding of No Significant Impact

It has been determined that such request for release of funds will not constitute an action significantly affecting the quality of the human environment and accordingly the City of Post has decided not to prepare an Environmental Impact Statement under the National Environmental Policy Act of 1969.

The reasons for such decision not to prepare such Statement are as follows:

1. There will be no negative impacts on the environment as a result of an activity or project undertaken with TCDP funds.
2. Some increase in noise, dust or other nuisance levels may occur during construction, rehabilitation, reconstruction and/or demolition; however, such disturbances will be temporary and will cease on the completion of the activities which cause them.
3. None of the activities or projects to be undertaken will affect any known local, state or national historic, architectural or archaeological resource presently listed, or potentially eligible for listing, in the national registry of historical places or in any state or local registry.

An Environmental Review Board respecting the within project has been made by the City of Post which documents the environmental review of the project and more fully sets forth the reasons why such Statement is not required. This Environmental Review Record is on file at the above address and is available for public examination and copying upon request between the hours of 8:00 a.m. and 5:00 p.m., Monday through Friday.

Public Comments on Finding

All interested agencies, groups and persons disagreeing with this decision are invited to submit written comments for consideration by the City of Post, to the Mayor's office on or before October 27, 1989. All such comments so received will be considered and the City of Post will not request the release of Federal funds or take any administrative action on the within project prior to the date specified in the preceding sentence.

Release of Funds

City of Post will undertake the project described above with Texas Community Development Program funds from the Texas Department of Commerce (TDOC) under Title I of the Housing and Community Development Act of 1974, as amended. The City of Post is certifying to the Texas Department of Commerce that the City of Post and Giles McCrary in his official capacity as Mayor, consent to accept the jurisdiction of the Federal courts if an action is brought to enforce responsibilities in relation to environmental assessments, decision-making, and action; and that these responsibilities have been satisfied. The legal effect of the certification is that upon its approval the City of Post may use the Texas Community Development Program funds, and the Texas Department of Commerce will have satisfied its responsibilities under the National Environmental Policy Act of 1969 and 24 CFR Part 58.

Objections to State Release of Funds

Texas Department of Commerce will accept an objection to its approval of the release of funds and acceptance of the certification only if it is on one of the following basis: (a) that the certification was not in fact executed by the chief executive officer or other officer of the Contractor approved by TDOC; or (b) that the Contractor's environmental review record for the project indicates omission of a required decision, finding, or step applicable to the project in the environmental review process. Great Defense, Late Scoring Lift 'Lopes Past Cubs 13-0

Great defensive football is the best way to describe the District 3AAA match-up at Brownfield last Friday, where the Post Antelopes mopped up homecoming celebrations with a 13-0 win.

An inadvertent official's whistle nullified a Post touchdown just seconds before halftime, or the score would have been 21-0.

The controversial play came on fourth down from the Cub 34 yard line, as Jacob Bustoz came out of a pile of players unnoticed and romped the distance to the end zone, with Cub defenders hot on his trail. A yellow flag on the turf turned the play into a major sideline discussion, as officials tried to sort out the situation.

Finally, a personal foul penalty was assessed on the Cubs, setting the ball at the 19 yard line, giving Post a first down.

Four plays later a pass to the right corner of the end zone to Bill Rankin from Rance Sappington went incomplete and the players left the field at halftime, with fans wondering what happened.

"The referee apologized, saying that he had blown the whistle early, but once that happens, there's nothing you can do," Antelope coach Dewayne Osborne explained.

Osborne and his coaching staff brought the team back on the field in the second half, demonstrating great patience and support to

the players, which along with excellent physical conditioning, began to pay off.

Whenever the Cubs had the ball, the Post defense made the plays that counted. The 'Lopes allowed only three first downs in the second half.

Following a sustained drive to the Brownfield 11 yard line, the 'Lopes gave up the ball on fourth down and one play later got it back.

Clarence Brown went over left guard for the Cubs, Jimmy Holleman slammed the running back, the ball popped loose and Bill Rankin came up with it for the 'Lopes.

With 1:47 left in the third quarter, the 'Lopes opened up a one play touchdown drive as Sappington rolled to his right and lofted the ball over defenders' heads into the right end zone corner to an outstretched Rankin for the touchdown.

A bad snap and placement nullified the extra point attempt and with 1:41 left in the quarter the 'Lopes led 6-0.

The defensive battle continued and both teams exchanged punts as the Post defense held Brownfield in check into the fourth quarter.

Final Touchdown Drive
Brownfield was forced to punt on fourth down at their own 20 and Brown set up a first down for the 'Lopes at their own 49.

Sappington was sacked at the 45 and leg cramps set him on the sideline, while reserve quarterback Matt Holly hustled to the field.

On second down Holly rolled left and threw a pass to Bustoz, who was unable to get to the ball as the officials ruled interference on Brownfield, setting up a first down at the Cub 41.

Holly rammed to the 36 on a second down keeper around right tackle and on third down ran the option to his left, kept the ball, cutting inside to the 26 and a critical first down.

On first down Brown went over right guard to the 19, then Holly hit Slay for a pass completion to the 11 for another first down. Slay was thrown for a loss to the 12 and the Cubs called a time out.

On second down Brown broke across right tackle, ripping through defenders to the four yard line and on first and goal took the ball over left guard to the three. Another Brownfield time out set up second down at the three.

From there Brown got the call around left end, breaking a tackle and sliding into the end zone with 1:19 left in the game.

A roughing the kicker gave Junior Gonzales another attempt following the extra point try, and the second effort sailed through the up-rights.

Brownfield's first play following the kick-off typified the evening, as Jamie Perez intercepted Blake Decker's pass at the Post 45 and returned it to the Brownfield 44. Pressure by Rankin contributed to the interception.

The 'Lopes got the ball with 1:00 left on the clock and ran off two plays, taking home a 13-0 district win their fifth consecutive victory.

Defensive highlights for the 'Lopes included a fumble caused and recovered by Kelly Crispin at the Brownfield 32 on the Cub's first possession.

Sappington's pass interception, following a strong pass rush by Holleman on the next Cub possession.

Brown's interception at the Post 15 yard line and return to the Cub 30 on Brownfield's third try near the end of the first quarter.

Victor Chapa's fumble recovery at the Post two yard line as the Cub's were headed for the end zone with 5:02 left in the first half.

Gang tackling by Trey Jones, Jimmy Holleman, Crispin, Chapa, Perez, Bobby Curtis, and Rankin on Brownfield's first possession in the third quarter, forcing a punt on fourth down.

Great secondary coverage on pass plays by Roger Adams, Sappington, Whitehead and Brown setting another punting situation for the Cubs on their next try.

Rankin's fumble recovery at the Cub 11 yard line, setting up the first 'Lope touchdown.

Good, solid tackling by Sappington, Holleman, Whitehead and Chapa, forcing another punt early in the fourth quarter.

Rankin's quarterback sack on third down at the Cub 34 yard line, forcing another punt.

Curtis and Jones' smelling out of a screen pass play on third down cutting off the Brownfield offense, setting up the second

touchdown drive and Perez' interception late in the game.

The team hosts Lamesa Friday, who come to Antelope stadium with a 2-2-1 season record. Game time is at 7:30 p.m.

Director Election for SWCD Zone 5 Saturday

An election for a director to serve Zone 5 on the Garza Soil and Water Conservation Board is scheduled for October 14, 1989 at the Soil Conservation Service office located at 210 W. Main in Post, Sam Ellis, chairman of the board, has announced. The election will be held from 10 a.m. until 2 p.m.

State law decrees that to be eligible to vote in a soil and water conservation district director's election, a person must own agricultural land within the district where the election is being held. The person must also live in a county all of any part of which is in the district, and the voter must be 18 years old.

Legal qualifications state that a candidate for the office of a soil and water conservation district director must own land in the zone he represents, be 18 years of age and be actively engaged in farming or ranching. He must also live in a county all or part of which is in the district. Soil and water conservation district directors serve four-year terms of office.

Zone 5 of the district includes the Southeast quarter of Garza County.

Current members of the board of directors are: Sam Ellis, chairman, Southland; Preston Poole, vice

chairman, Post; Ronald Thuett, secretary, Post; and Richard Hart, member, Verbena.

The purpose of the Garza SWCD with headquarters in Post is to promote sound soil and water conservation programs on farm and ranch lands within the district and to serve as a voice for farmers and ranchers on conservation matters.

The district board of directors coordinates the conservation efforts of various local, state and federal agencies and other organizations and has authority to enter into working agreements with these governmental agencies and private concerns to carry out its purposes.

All conservation programs managed by the district are of a voluntary nature to the landowner or operator.

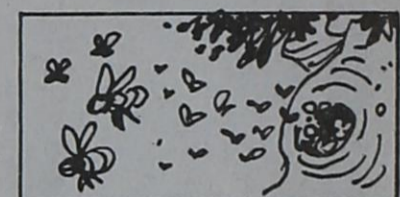

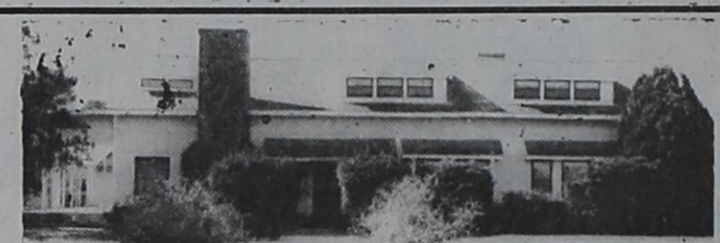

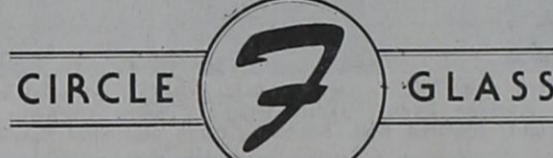

The Post Main Street Project Salute Charles William Post

C.W. Post, founder of today's Post Cereals, became interested in nutrition and health when his own health failed. In an effort to improve his condition, C.W. Post developed a nourishing wholesome cereal beverage named Postum®. Two years later, C.W. Post introduced one of the first ready-to-eat cereals: Grape Nuts®. Grape Nuts® was made of wheat and malted barley, baked in the form of bread loaves, then ground into crisp nuggets. C.W. Post named his cereal Grape Nuts® because he believed that "grape sugar" was formed during the baking process and because the cereal had a nutty flavor.

Post Toasties® was C.W. Post's third success at creativity and producing a healthful cereal. In 1904, he introduced a "double thick" corn flakes product which he called "Elijah's Manna." A devout man himself, he was puzzled when some persons objected to the use of a religious name to sell cereal.

Nevertheless, in 1907, Post renamed the product "Post Toasties." Like Postum® and Grape Nuts®, Post Toasties® was sold as a health food, and in each package of cereal C.W. Post included a copy of his pamphlet, "The Road to Wellville."

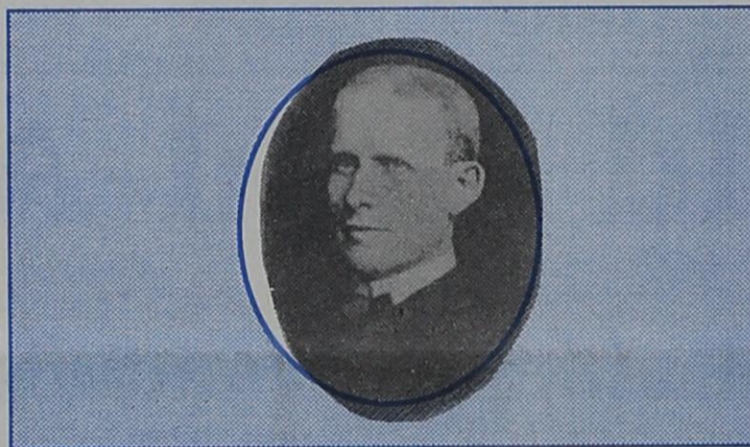
Later in 1907, his health still ailing, C.W. Post looked to a dryer, warmer climate. When in 1907 West Texas was opened for settlement, Post purchased approximately 225,000 acres of land - a portion below the Caprock Escarpment - for the purpose of developing a 'dream city' to be called Post City. He advertised his farmsteads and many farmers who had eaten Post Toasties® and drank Postum® put their faith in the Post name and headed West.

As part of the elaborate self-sufficient plan, Post hired stone masons to quarry sandstone in the area to be used

in the construction of numerous commercial buildings. (Many of these historic structures have been restored in recent years.) A brick factory and a cotton mill were also operated.

A program involving landscaping within the city limits was instituted late in 1907 with trees being planted along every 30 feet of city streets. A nursery was opened and by 1909, virtually every city street was lined by trees, for Post believed landscaping was an integral part of a healthy social environment. Thus, the Main Street Project is currently working to once again landscape the Main Street area of historic Post City.

C.W. Post's vision, determination, and dream are still very much alive both within Post Cereals and in Post, Texas. We invite you to be a part of the ongoing dream by participating in the October 15, 1988 Founder's Day Celebration in Post, Texas.

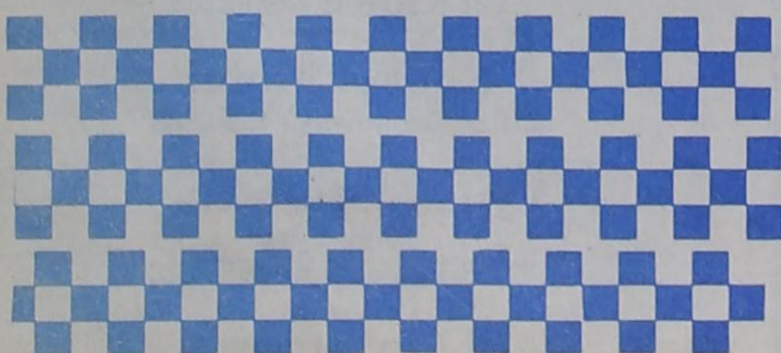
