Commissioners tackle budget, et September 24 for final vote

It was a long day Monday for the Garza County Commissioners Court, as the ige and commissioners spent most of the afternoon wrestling with the fiscal ar 1991 budget.

A final decision on the totals will be made at the September 24 meeting. An ight percent salary increase has been proposed for elected officials.

Judge E.A. Howard reported to commissioners that the senior citizens center night be forced to close due to "bad financial shape," and requested an mmediate \$1,000 grant to "tide them over until October.

Commissioner Herb Walls suggested that if the center could maintain until October 1, the budgeted amount of \$3,000 could then be paid.

Howard explained that the restrictions imposed by SPAG's dietician has created a problem for members and senior citizens, "who just don't like the kind of food they insist that we fix."

In other matters, County Agent Lee Howard told commissioners that the county pickup truck is unable to pass the safety inspection due to bad tires and other maintenance problems. The purrchase of a new vehicle for the agent has been approved, but bids will not be opened until September 24. Commissioners did not suggest an alternative vehicle for the agent, who continues to drive the old pickup with an expired safety inspection sticker.

Agent Howard also informed the court that a hiring freeze will delay the selection of a home extension agent for an unforseeable amount of time. He also told the court that eliminating health insurance premiums for employees would create a financial problem for those employees with dependent children, 'although my insurance is not affected because I am covered through A&M, I am asking your consideration on behalf of our secretary and other employees.' Two-car collision at busy intersection requires 'Jaws of Life' Seatbelts prevent serious injuries

Patricia Cowley escaped serious injury last Wednesday evening following a two-car collision at the busy intersection of U.S. Hwy 380 and Texas 669 (Gail Hwy).

Post EM is arriving at the scene shortly after 8 p.m. and called for the Post Volunteer Fire Department to use the "Jaws of Life" equipment in order to open the driver's door, which was jammed by the impact. Three children as passengers in the vehicle were not injured. According to witnesses at the scene, all occupants of the vehicle were wearing seatbelts.

The vehicle driven by Cowley, according to Garza County Sheriff's Department investigators, was struck broadside by a vehicle driven by Jan

Witnesses told investigating officers that the Cowley vehicle, headed north on Texas 669 and stopped at the intersection of U.S.

directors hopes to improve on last year's disappointing fund raising efforts. "Last year we just jumped out there with a lot of enthusiasm and optimism

and set the goal so that every participating unit would get what they had requested," United Way chairman Carol Peppers says, "but when it was all over and the counting finished, we had to trim everyone's request back as we only collected a little more an \$15,000."

For a county with as many resources as we have, it would seem that a goal of \$20,000 would be more attainable.

All of the participating organizations rely heavily on the United Way program to operate.

One of the main reasons for United Way is to give everyone a chance to contribute one time a year to help a wide variety of organizations, instead of each one coming around several times a year for help.

Payroll deductions, a major reason for successful United Way campaigns, are almost nonexistent in Garza County, with only a handful of businesses providing payroll deductions for the campaign.

'I already gave at the office" is a safe haven for those who wish to give to United Way through the payroll deduction, and it is fair.

Council gets indication that landfill may be able to operate longer than expected

Post city manager Bob Turner told city council members at the regular meeting Monday evening that a recent inspection of the landfill site provided information which indicates that the yet to be published regulations may allow the sanitation landfill to remain in operation "for a while longer."

Preliminary information about the federal regulations concerning landfills, which has had small cities in an uproar for the past year, gives a little breathing room for operation of landfill sites in arid areas.

In connection with the landfill discussion, council members agreed to support the South Plains Association of Governments (SPAG) request for city participation in funding the remaining regional sanitation master plan. The annual cost of the city's support is 17 cents per capita, or less than \$800. The funding will allow SPAG to be eligible for mathcing federal funds for the study.

In other action, the council approved the proposal by The Post Insurance Agency for property liability insurance. Other local agents were given an opportunity to bid, but no others responded, according to Turner. Library board members Will McCrary and Wes Burnett were reappointed by

the council to serve two years. City attorney Harvey Morton agreed with Turner's proposal not to pay for a court docket book, which was billed to the city by Bear Graphics at \$450. After Turner called the charge to the company's attention, the bill was lowered to \$250, "which I still think is exorbitant, compared to the price of the same book paid by Justice of the Peace Dee Justice," Turner told council members.

Morton indicated that the inflated price of the book could fall under deceptive trade practices, and suggested that Turner's offer to return the book to the company should be supported.

Council members agreed.

Turner gave the council a report on the West Main Street landscaping project, explaining that Bo Jackson and V.O. Rasbury had been contacted to prepare cost estimates for the privately funded project. The Main Street Committee

Medicines Relieve Glaucoma Pressure

A colorless fluid inside of our eyes bathes internal eye structures. This fluid is produced by the eye and then drains through a small canal in each eye. In glaucoma, normal drainage does not occur. The result is increased fluid pressure that squeezes the blood ves-sels serving the retina and optic nerve. It is thought that when the blood supply to this area is significantly reduced, nerve cells and fibers die, and permanent loss of vision may result. Glaucoma is considered one of our leading causes of blindness.

Eye specialists and many physicians routinely check their patients for increased eye pressure. If glaucoma is found, treatment with medicines can help reduce internal eye pressure and help prevent or limit loss of vision.

Some of the medicines used to treat glaucoma work by constricting the pupil of the eye. It is thought that this constriction or narrowing of the pupil relieves some blockage of the canal which takes fluid from the eye. Medicines which work in this manner include pilocarpine, carbachol, and echothiophate. Timolol is a different type of glaucoma medicine. Research suggests that the primary action of timolol is to reduce the formation of fluid within the eye, thus reducing eye pressure indi-





Fall testing dates for the College Level Examination Program (CLEP) have been announced at South Plains College.



RRC approves production increases

The Railroad Commission voted Thursday to allow Texas oil wells that can, to boost production up to their maximum efficient rate, a move that is expected to increase Texas crude production by some 20,000 barrels a day. The action is not expected to harm long-term oil production in the

Chairman Kent Hance and Commissioners John Sharp and James E. (Jim) Nugent approved the emergency measure for 90 days, beginning September 1.

Fields operating under special field rules that limit well output below the maximum efficient rate of production are not affected by the Commission

The commissioners deferred a decision on increasing production in the East Texas Field to permit review of oil company data and field studies. They will again consider the East Texas Field production rate at their next monthly hearing to set oil production limits in the state, scheduled for September 20 in

According to the data compiled by the Commission staff, most of the 20,000 barrel-a-day production increase is expected to come from horizontal wells in the Austin Chalk formation in south central Texas. Preliminary August production data shows those wells are producing some 16,000 barrels a day less than potential tests indicate they can produce.

Texas oil wells now produce about 1.7 million barrels a day. That production is declining at a rate of 8,333 barrels a day each month. During the first six months of 1990, overall state production dropped more than 39,000 barrels a day. In contrast, production is booming in the Austin Chalk fields due to horizontal

Production from the Pearsall (Austin Chalk) field in Frio, Dimmitt, Zavala, and LaSalle Counties has soared from 6,951 barrels a day in October 1989 to 29,319 barrels a day in April 1990. Some 65 percent of all permits to drill horizontal wells issued by the Commission have been for wells in the Pearsall field.

"It is my desire to see this state again become the economic hub of this nation, with our people working, excellent schools and colleges, with criminal activity at the lowest level in recent history," Counts stated. "I want to continue to work for the people of the 78th District in the 90s to meet these challenges," he concluded.

Offensive and defensive linemen establish dominance

The Post Bold Antelopes lost the toss of the coin at midfield last Friday night in Abernathy...but that was just the beginning of a 39-0 onslaught as coach Dewayne Osborne's "inexperienced" team completely

dominated the contest.

After winning the toss, Abernathy elected to defer their option until the second half, giving Post the opportunity to receive the opening

Four plays later Floyd Slay blasted 37 yards to the end zone and the Bold Gold were in charge the rest of the

Offensive linemen Junior Nava, Chris Redman, Benji Vargas, Chad Kirkland, B.J. Funk, Danny Leach and Dustin Massey set the tone from the first snap of the ball, showing quickness and execution, surprising Abernathy and raising a roar of approval from the packed visitors' west side stands.

When it came time for the defense

to take the field following the first touchdown, the same quick and hardhitting calibre of football put the home team deep in a hole, from which they never recovered.

Defensive linemen Redman, Joe Garcia, Lance Bland and Vargas were just too quick for the Abernathy Antelopes, as were linebackers Bobby Curtis, Jr Ray Gonzales, Brandon Bird along with Darrin Brown, Jay Whitehead, Damon Curtis and Slay in the backfield.

First Half Action The kickoff went wide right and was tipped out of bounds at the Post

27 yard line. On first down Slay ripped over left guard, breaking one tackle, picking up a first down at the 46.

Whitehead got the call over left tackle, hitting Abernathy's 49 and on second down Brown hit behind the right side blocking with a quick burst to the 37 and another first down. Ouarterback Matt McCook took

through a quick-opener over right guard, breaking would-be tacklers and at the 10 yard line slowed just enough to allow Massey to set up a

The next Abernathy offensive attempt was sparked by a Norris run to his 31 yard line, brought down by a saving tackle by Michael Self.

Then on third down Norris was pounded by Garcia behind the line of scrimmage, hit so hard the ball fell to the ground right in front of Garcia, who recovered for the 'Lopes at the Abernathy 29.

It took four plays for the Bold Gold to show any remaining doubters that they had come prepared to win.

On first down McCook rolled to his left and lofted a pass deep to Massey, who was smothered by two defenders as the ball fell to the ground. A pass interference call against Abernathy set up a first down at the six yard line.

Gonzales took the ball over left guard to the 26 and Bird, playing at the tailback slot, brought the fans to their feet as he blasted over right guard, breaking through three wouldbe tacklers, cutting to his left and into the end zone standing up.

With 6:23 the Bold Gold led 39-0. The point-after snap was fumbled and Slay tried to make a play of it before being sacked behind the line.

Abernathy got seven more plays off before turning the ball over to the Post offense with less than two minutes remaining in the game. The final drive was set up when Slay intercepted Coby Forbes' pass Gold clicked off six plays from the drew an interference call against the running out of time at the six.

Osborne sees stiffer test Friday with Slaton Tigers

"It's been a long time since we've had so much fun at a football game," Post Antelope head coach Dewayne Osborne says about last Friday's 39-0 rout at Abernathy.

"When Jay Whitehead picked the tipped pass out of the air and went into the end zone, I just looked across the field at their coaches and shrugged, it just seemed like everything was going our way...that tipped pass could have just as easily been an interception," the coach adds.

"We executed our trap plays so well, we could use this team as a teaching tool for anyone wondering how to do it right ... really, I guess our players did as good as we've done since I've been back to Post," Osborne says.

"Our players were prepared, physically and emotionally, to play...and it showed," he continues, "and everyone got a chance to get playing time." The defense got special praise from the coach, who observed that the two scrimmages did a lot to help prepare the linemen especially and defensive ends

for the season. Looking to this Friday's matchup with former Class AAA rival Slaton, Osborne reports that the Tigers are loaded with people at the skill positions. Slaton won last Friday 34–27 over Shallowater.

"We have got to contain their running game and quarterback, if we're going to be successful," Osborne says.

Tiger quarterback Tracy Starkey, considered to be one of the best on the South Plains, runs and throws the ball well. He is supported by tailback Joe Williams, a "real good running back" who also has good speed.

Fullback Marcus Kirkwood, who saw action against the Antelopes last year,

is big and strong and tough to tackle. Starkey's favorite receiver is Hays Davies, who knows how to catch the ball and is a threat on the open field.

Slaton runs the option and sweep, mixing up the passing game well. In two scrimmages and one game this year, the Tigers are averaging 8.76 yards per rush and 10 yards average per pass play.

On defense the Tigers get strong effort from middle linebacker Craig Davis, defensive ends Chris Brown and A.G. Ray.

"Any way you look at it," Osborne adds, "it's going to be a real shoot out and we'll see how good we are Friday night."





CONSTITUTIONAL AMENDMENT **GENERAL ELECTION NOVEMBER 6, 1990**

PROPOSITION NO. 1 ON THE BALLOT

Senate Joint Resolution 2, Sixth Called Session, 71st Legislature, proposes a constitutional amendment to provide that if the Senate, at any special session, does not take final action to confirm or reject an appointee of the Governor made during a recess of the Senate, the appointee is entitled to continue in office until the Senate rejects the appointee at a subsequent session or until the Governor appoints another person to fill the vacancy, but such a nominee whom the Senate does not act to confirm or reject at a subsequent regular session is considered to be rejected when the session ends.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to clarify the authority of the senate to consider certain nominees to state and district offices and to provide for filling vacancies in those offices."




