## Smokers use Thursday as day to quit...it's the Great American Smokeout!

American Cancer Society volunteers around the state are readying efforts to challenge smokers to "Leave the Pack Behind" during the Society's 14th Annual Great American Smokeout November 15.

Sponsored by the American Cancer Society, the Great American Smokeout is a fun-filled, light-hearted celebration held each year on the third Thursday in November to encourage smokers and tobacco users to quit the habit for 24 hours. The effort is the largest health promotion event in the country.

Last year's Smokeout triggered 10.5 percent of the nation's smokers -- 5.2 million Americans -- to give up cigarettes for 24 hours. One to three days later, according to a Gallup poll, 3.9 million were still abstaining from tobacco. According to the poll, 17.9 million smokers participated in the Smokeout by quitting or cutting down for the day.

Judy Oskam, Austin, chairman of the Texas Smokeout campaign, said, "The American Cancer Society is hoping this fourteenth annual Great American Smokeout will help smokers across the state to stop smoking. We especially are working to help women, teens and underserved populations quit their tobacco habits."

The Smokeout helps advance the Society's ongoing battle against cancer. "Smoking is responsible for 87 percent of lung cancer cases, and that means 87 percent are preventable by choosing not to smoke," Oskam explained. "We hope at least one in five Texas smokers will join the Smokeout this year. Texans could make a big step toward better health on November 15."

To reach out to smokers across the state, Texas volunteers are pulling out all stops to encourage tobacco users in their communities to participate in the Great American Smokeout, Oskam said.

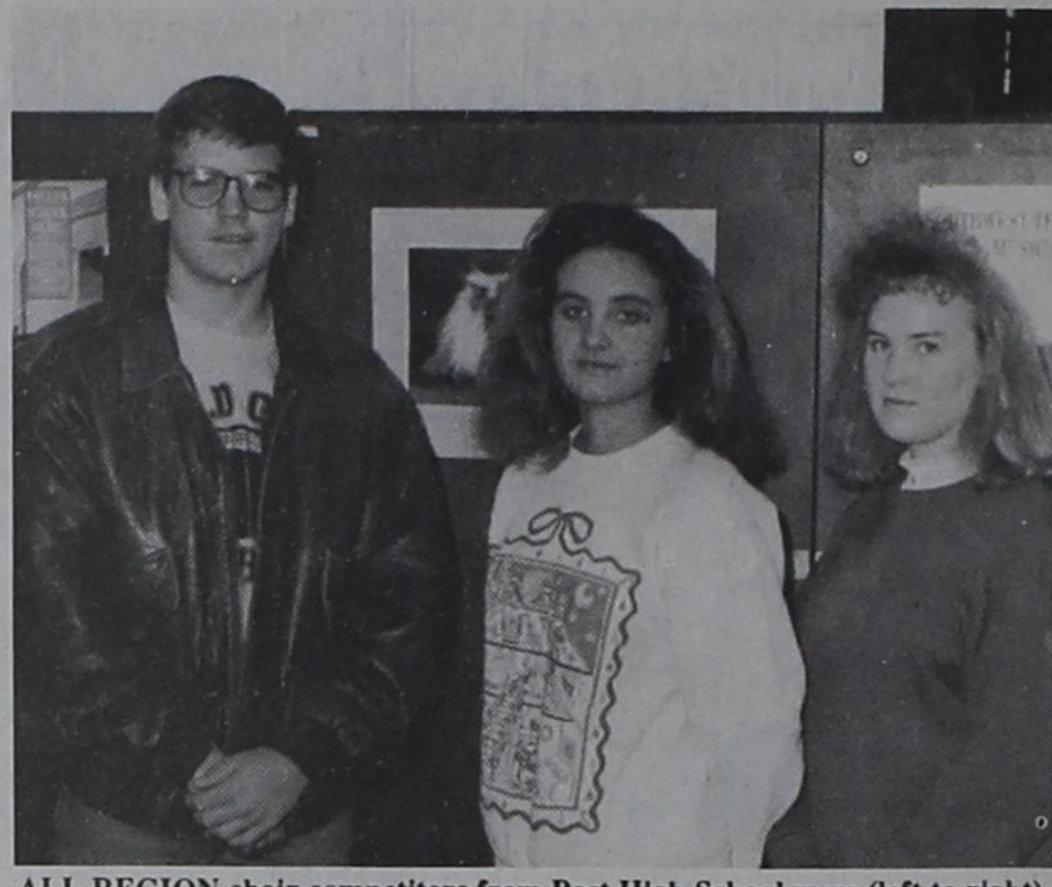
Following his service as a congressman, Gossett was an attorney for the Bell Telephone Co.

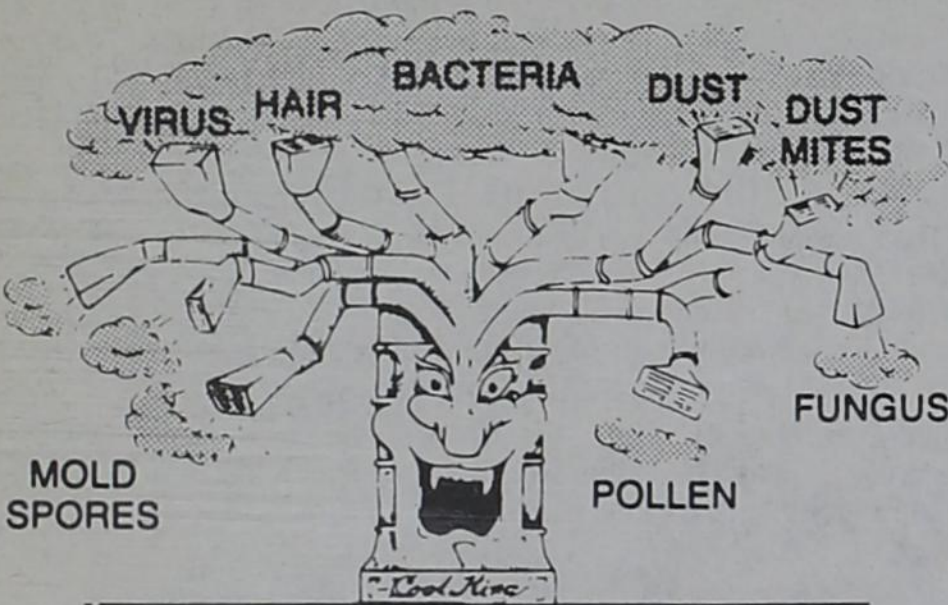

### Childhood Fever: What Should You Do?

Fever is a common event during the childhood years. Fever occurs when the body temperature rises above the normal range of 98.6 to 99.6 degrees F. When fever is present in children, they tend to be listless, cranky, and lethargic. A slight fever may show little or no symptoms. Higher temperatures may result in chills, aches, increased rate of breathing, or headache. Some authorities suggest children be seen by a physician if:

- a low-grade fever (100 to 102 degrees F) continues for more than 24 hours,
- the temperature reaches 104 degrees F or higher and does not respond to nonprescription fever-reducing medicines,
- the child is four months old or younger, or
- other symptoms are present such as sore throat, stiff neck, extreme lethargy, or breathing problems.

Because of the association between aspirin use and Reye's syndrome in children, many physicians prefer acetaminophen as a fever-reducing medicine. *The Handbook of Nonprescription Drugs* suggests that sponging with tepid water should be reserved for children whose temperatures exceed 104 F and who have not responded to oral fever-reducing medicines.

## Living on the Edge of the Cap

Imposed

The Texas Apiary Inspection Service has quarantined a 2-mile radius around an area east of Hidalgo where the first Africanized honey bee (AHB) swarm in the United States was confirmed.

The U.S. Department of Agriculture announced October 17 that an AHB swarm was detected and destroyed near Hidalgo after the department's Agricultural Research Service discovered the bees there October 15. The swarm was identified at the ARS laboratory in Weslaco and confirmed at the Bee Identification Laboratory in Beltsville, Md.

The AHB was released from a Brazilian lab in 1957 and has been moving about 200-300 miles a year toward the United States.

Under the Texas plan for handling the AHB, no movement of bees will be allowed into or out of the 2-mile quarantine until all AHB colonies found there have been destroyed, according to Dr. Fowden Maxwell, chairman of the Texas AHB Advisory Committee and head of the Texas A&M University department of entomology.

An additional quarantine has been placed on the lower eight Texas counties, roughly a 100-mile radius of the find. Domestic honey bee colonies there may be moved within, but not out of, that area. This quarantine will be in effect until the AHB advisory panel recommends that it be changed or abolished.

All domestic bee colonies in that area must be registered with the Texas Apiary Inspection Service, headquartered at Texas A&M University. Cooperating with the inspection service in enforcing the quarantine will be the U.S. Immigration Service, the Texas Highway Patrol, municipal police departments and the Texas Department of Agriculture.

Beekeepers who do not comply with the quarantine are subject to penalties under the Texas Bee Law.

Other actions under the Texas plan include:

\* All AHB colonies found will be destroyed with a currently labeled insecticide.

\* All feral, or wild, bee swarms within the 2-mile radius will be destroyed.

\* All feral colonies detected within the eight counties (Hidalgo, Cameron, Starr, Zapata, Jim Hogg, Brooks, Kenedy and Willacy) will be sampled and destroyed if positively identified as AHB.

The attempt to depopulate the AHB in the United States will discontinue if it is determined through survey results over an extended period of time that the AHB has become permanently established.

Commonly asked questions about the Africanized Honey Bee (AHB):

1. Are Africanized honey bees really killer bees?

"Killer" bee is an exaggerated term that has little basis in fact. The sensationalized name for the insect undoubtedly was made popular by several Hollywood horror films that showed bees blotting out the sun in great angry swarms, hunting people down and stinging them to death. Africanized honey bees do not behave in this manner.

It is true, however, that people and animals have been killed by the bees, usually after receiving hundreds of individual stings. These incidents have been quite rare; in Mexico, for example, there have been 16 documented deaths since the AHB entered the country in 1986.

Over the past 35 years in Texas, the average number of people dying from bee stings has been less than one per year. When the AHB becomes established in the state during the 1990s, the death rate may increase to 4 or 5 per year. To put this in perspective, this figure is roughly the same as the number of Texans killed by lightning each year.

2. Will one sting from an Africanized honey bee kill a person?

No, one sting from the Africanized honey bee will not kill an average, healthy person. The sting of one AHB is no more venomous than that of a domestic honey bee, the kind that European settlers brought to the New World 300 years ago.

The only reason the Africanized honey bees pose some added degree of risk is that they defend their hives much more vigorously. When disturbed, the bees tend to respond in larger numbers and pursue over a greater distance than the European honey bees common here.

3. Will these bees be a health problem in Texas?

Officials with the Texas Department of Health do not believe the Africanized honey bee poses a public health problem. Persons allergic to bee stings, of course, should be careful. As the bees become established, there likely will be more stinging incidents and, given the defensive nature of the bee, more cases of multiple bee

stings. (Like the domestic bee, the AHB can only sting one, and then it dies.)

4. I am allergic to bee stings. What precautions should I take?

Generally, the same precautions you now take to avoid a domestic honey bee, except remember that the AHB tends to be more defensive and more easily disturbed. If you are allergic to bee venom, always carry a first aid sting kit with you. If you are stung, see a doctor immediately. If medical care is not available, take one or two shots of epinephrine (adrenaline), usually found in a sting first aid kit. This can prevent some reactions to bee venom.

5. What is an Africanized honey bee and what does it look like?

The Africanized honey bees are a hybrid cross between European and African strains of honey bees. In nearly every way, they are the same as the honey bees we are accustomed to seeing. Except for being slightly smaller in body size, a characteristic that can't be discerned except with a microscope, their appearance is exactly the same as the familiar European bee. Most honey bees are brown or black and yellow and covered with hair.

6. Where would I most commonly find their hives? Will they build a hive on my back porch?

The AHB will nest in almost any opening that provides shelter from the elements. Domestic bees usually build their hives high off the ground and require a large amount of space. AHBs, on the other hand, build their hives anywhere -- under objects on the ground, in holes in earth and rock, and in cracks and openings in structures of all kinds.

7. What is being done about the Africanized honey bee?

Scientists and beekeepers are studying the AHB to develop management practices that will minimize its impact and spread in the United States. Traps located along the Rio Grande border and throughout Mexico are being monitored to detect movement of these honey bees into Texas. Once the bees reach Texas, the state will implement a plan that will seek to manage the bee in an effort to reduce its progress and impact.

8. What will be the biggest problem with the AHB in Texas?

The AHB will be a problem primarily for commercial beekeepers who depend on honey production and pollination services for their livelihood. This is because the AHB does not produce as much honey as the domestic bee, and it is not as manageable. The AHB reproduces rapidly, and in Central and South America, has tended to take over the hives of the gentler, domestic bees. With the voluntary assistance of beekeepers, the en-

forcement of the state's bee regulatory laws and continued research, Texas will handle the problem with minimal impact on the general public.

9. Can I stay away from the Africanized honey bee and not get stung?

It will likely be several years before the AHB will have a noticeable presence in even the southern part of Texas. It takes that long for populations to build up. By taking simple precautions you can minimize your contact with the AHB. Around the house, be alert for swarming bees, which usually means they are looking for a nesting site. At home, take a walk-around tour periodically and look for bees swarming or nesting around the eaves or under objects in the yard. Don't climb a tree, kick over a stump or roll over a rock with checking first to see if bees might be present. When a hive is discovered, don't try to dispose of it yourself. Leave the handling of bees to those who are properly trained.

10. Do we need honey bees in Texas? In the United States?

Texas is blessed with a large farming and horticultural industry. Most farmers could not stay in business without proper pollination. The honey bee is the only known method of pollinating the various crops grown for a widespread agricultural industry. There are some multi-million dollar crops including melons, cucumber and fruits that are highly dependent on honey bees pollination.

It is estimated that the U.S. harvest \$20 billion and Texas harvests \$800 million annually in pollinated crops. Texas A&M entomologists estimate that for every dollar's worth of honey and bees' wax sold, there is an estimated \$143 worth of pollination by the honey bees.

11. Did the Africanized honey bee create problems in Mexico?

The Africanized honey bee created hive management problems for commercial beekeepers. However, in areas where the bee has become established, the general public has not experienced a need to change present lifestyles. Persons have been stung, but few deaths have

been reported.

Mexico does not depend on commercial hives as extensively for pollinations of agricultural crops.

12. How will the AHB spread when it arrives in Texas?

The first or "founder" swarms of Africanized Honey Bees will be few in number and tend to become a part of the local honey bee population. If the bees arrive in the Brownsville area, they are expected to spread northward up the Gulf Coast toward Corpus Christi and then Houston.

13. What is the rate of natural spread of the bees?

The spread of the Africanized Honey Bee is anticipated at about 200 to 250 miles per year, although it is uncertain how far north the bees will be able to live. This bee is a tropical insect, and there is speculation that the bee may not range much beyond the southern half of Texas, because of colder tempera-

tures.

14. Can't we just ban all honey bees from urban areas?

No. This will create a vacuum within the cities and invite the Africanized bee into the area when it arrives. By keeping beekeepers active, there is an experienced local person to handle bee swarms. With beekeepers in the area, the advancement or density of the Africanized honey bee can be monitored more effectively.

The Texas Beekeepers Association, along with other qualified groups and individuals, have drafted a model "City Ordinance" for keeping honeybees within a neighborhood environment. Also, Texas has new laws to govern the keeping of honey bees anywhere in the state that Africanized bees are known to be present.

15. Who should we call if we are concerned and need more information about honey bees?

The Texas Beekeeping Industry and the Texas Agricultural Extension Service want you to know the facts about bees and the beekeeping industry. Representatives of both these groups are available for educational programs for your group or organization and for advice.

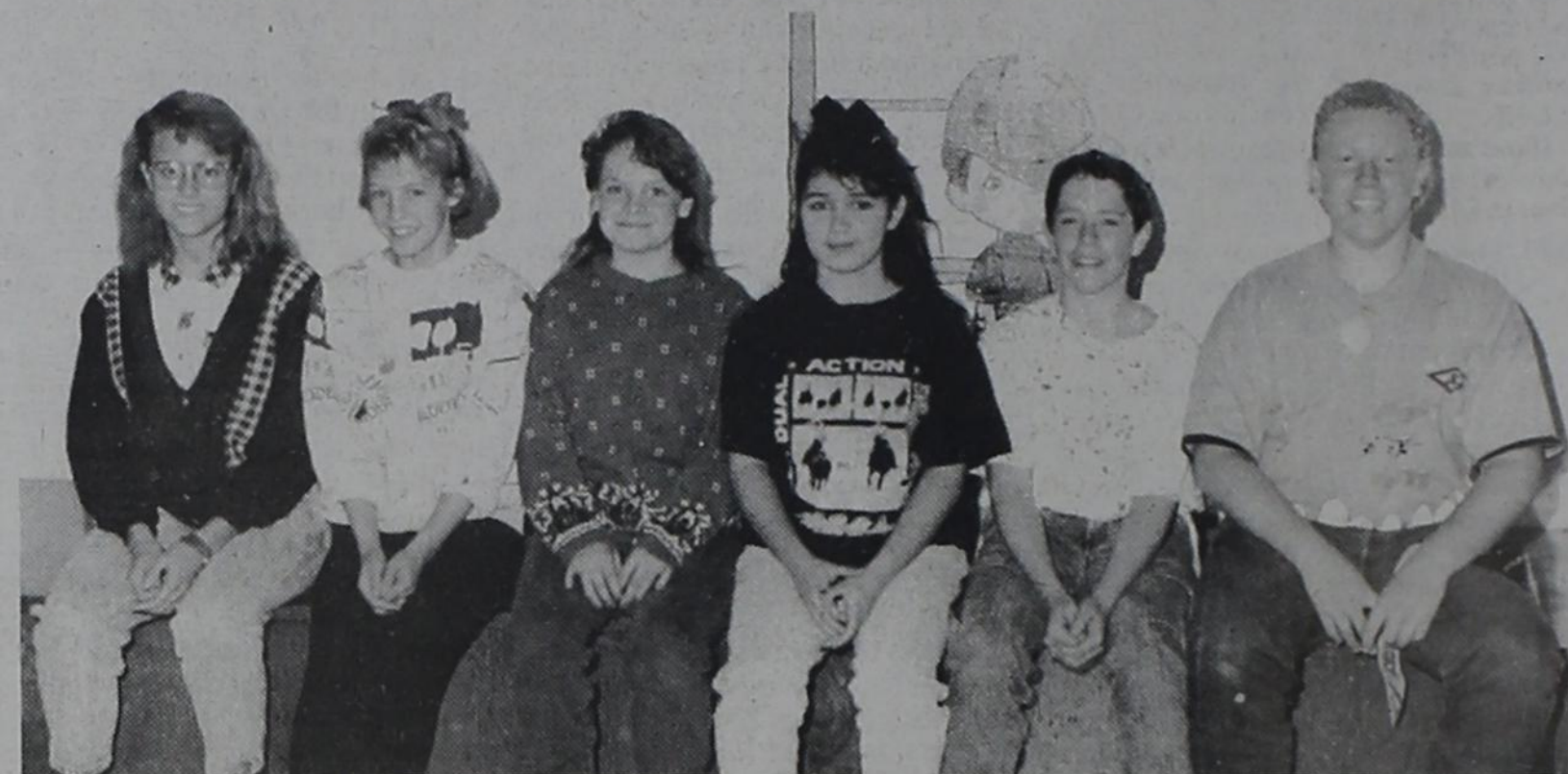

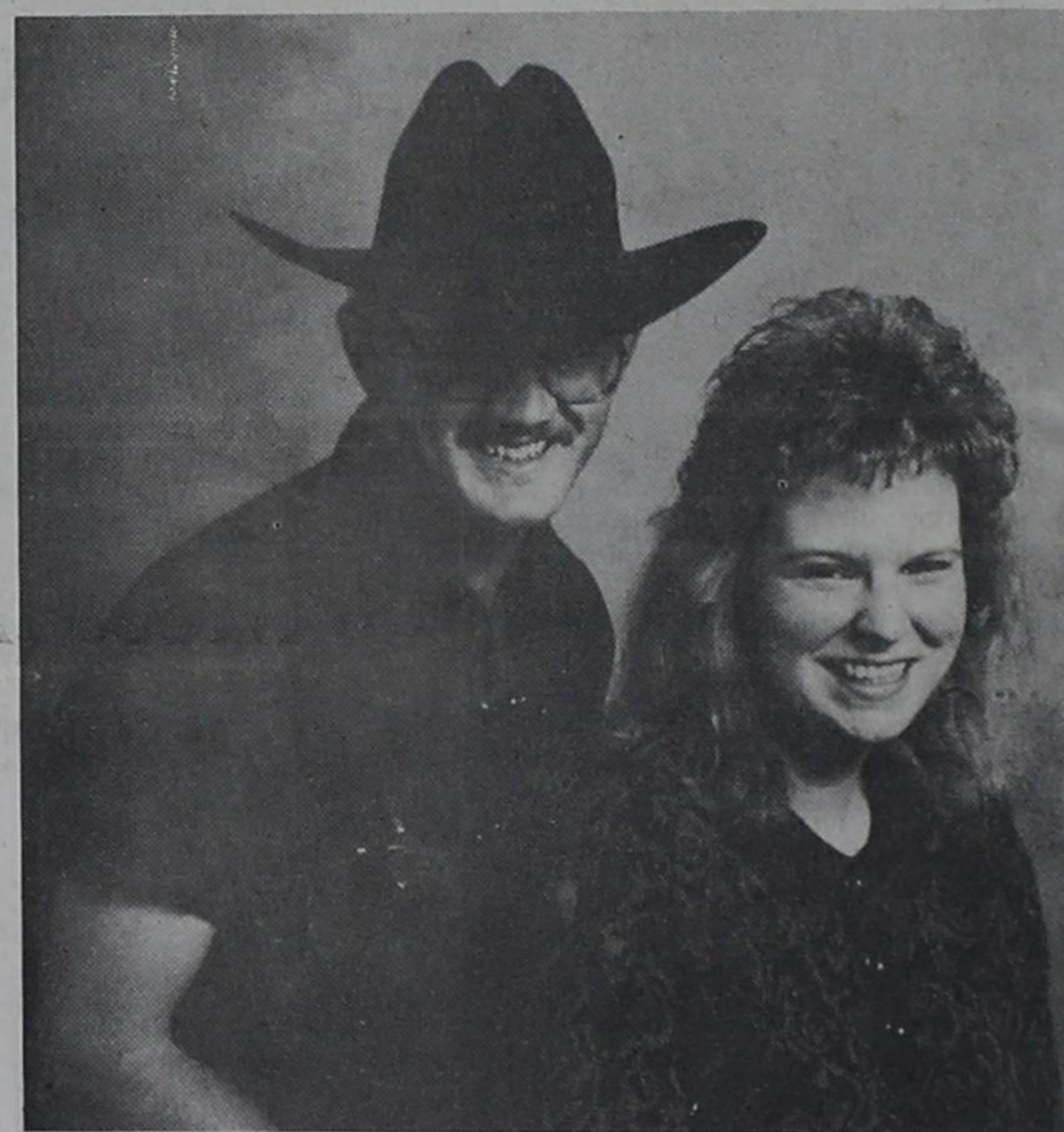

### Recycling Results of Texas Tech

To date, the Community Action Network (C.A.N.) of Texas Tech University has collected a total of 71,736 pounds (about 35 tons) of solid waste.

Specifically, the recycling program at Tech has collected 49,830 pounds of newsprint, 2,277 pounds of aluminum cans, 7,129 pounds of glass, 7,665 pounds of misc. paper, 3,065 pounds of computer paper and 1,770 pounds of cardboard.

The collection of newspaper, in particular, has skyrocketed since the first Drop-Off Day in July. At the October Drop-Off Day alone, 16,420 pounds of newspaper were collected. This saved 144 trees, 79,200 gallons of water, 45 million BTU's of energy and 540 pounds of pollutants from being pumped into the atmosphere.

# 'Lopes squeeze out 10-7 Homecoming win

## 'It was a great team effort'

 Coach Dewayne Osborne summed up the 10-7 must-win victory over the visiting Ralls Jackrabbits last Friday night when he called it "a great team effort."  
 "We looked like the team we were earlier in the season," Osborne added, "and it felt good to see our players pulling together and doing what had to be done to win."  
 Junior Ray Gonzales, who played perhaps his best defensive ball game this year, put the winning points on the board with only three minutes remaining in the game when he booted a field goal.  
 The defensive unit gave at the end, but held the Jackrabbits far enough away from the end zone so that Chris Salazar's field goal attempt with 19 seconds left in the game went sailing to the right of the goal posts and the Antelopes celebrated another entry into the post-season playoffs.  
 It was a nail-biting ending to a football game which would determine second place in District 4AA.

**First Half Action**  
 The Post defense took charge early in the game on the Jackrabbits' first possession. Ralls had taken over on downs at the Post 40 when a fourth down fake punt pass play from Shane Horton to Jay Whitehead got only five yards.  
 The Jackrabbits pounded down the field to the Post 26 yard line, when Gonzales hit quarterback Jason Vasquez and the ball popped loose, as Lance Bland fell on it for the 'Lopes.  
 Four plays later the Post offense could not pick up one-half yard on fourth down, and again the Jackrabbits got great field position as they started their touchdown drive from the Antelope 36.  
 It took only six plays to go the distance, with Jay Bob Binder and Chris Castro getting the running chores behind the huge offensive line blocking. Castro went the final one yard. Ralls was penalized on the extra point attempt and Salazar's second attempt put the Jackrabbits ahead 7-0 with 3:42 left on the first quarter clock.  
 The Antelopes picked up a first down at the Ralls 10 yard line on a pass 37 yard pass play from quarterback Matt McCook to Danny Leach. Slay got the two, then Damon Curtis was dropped for a loss at

the three and on fourth down a pass to Damon Curtis in the end zone went off the tip of his hands incomplete and Ralls took possession.  
 The quarter ended with the Jackrabbits moving out the hole, but were forced to punt on fourth down at the 23.  
 Whitehead momentarily fumbled the punt at the 45, picked it up and managed to get to the Ralls 41, setting up a first down for the Antelopes with 9:19 left in the half.  
 The touchdown drive took five plays, including a critical fourth down conversion.  
 Darrin Brown went twice over the left side to the 36, then McCook took the keeper around left end to the 33, setting up the fourth down situation. He rolled to his right and threw the ball to Whitehead at the 25, who then rambled to the 14 for the first down.  
 McCook then rolled to his right, scrambled out of the grasp of would-be tacklers and lofted the ball to B.J. Funk, who was crossing from the left to right. With second down at the six, Slay got the call over left tackle and blasted into the end zone for the score.  
 With 7:06 remaining in the half, Gonzales' extra point kick knotted the

score at 7-7.  
 Ralls got two more possession before the half and Post had two chances, both defenses took charge of the field.  
 Leading the Post defense were Gonzales, Lance Bland, Hiram Gutierrez, Joe Garcia, Chris Redman and Bobby Curtis.  
**Second Half Action**  
 Ralls took the second half kickoff back to their own 47 and on third down from the Post 47 Toby Burt caught a pass and was slammed to the ground on a great tackle by Whitehead at the 45, forcing a punt.  
 The offense could not pick up a first down and punted back.  
 Ralls clipped off a strong drive from their own 35 yard line to the Post four before the Antelope defense held. On fourth down Salazar got set to try a field goal and the Jackrabbits were penalized for illegal motion to the 11. His field goal attempt sailed wide to the left and the 'Lopes got a reprieve.  
 The big play in the Ralls drive was a fake reverse which stunned the Antelope defense as Binder kept the ball and raced down his right side line, only to be caught by a speedy Damon Curtis at the five yard line.  
 Again the Antelope offense could not

penetrate the Ralls defense and punted.  
 The fourth quarter opened with Ralls facing a third down at their own 34, Gonzales blasted through and sacked Binder for a loss at the 31, forcing the Jackrabbits to punt one more time.  
 On second down following the punt, McCook dropped back to pass from the 'Lope 36, intending to hit Whitehead, but Mark McQueen stepped in front of Whitehead and intercepted the ball at the 35 and was dragged down at the 33.  
 The Jackrabbits got a first down at the 18, then on third down Vasquez' fumble was recovered by Morry Martinez, setting up a fourth down field goal attempt by Salazar. This time an aggressive Post defensive line made a nervous wreck out of the Jackrabbit center, who snapped the ball over holder Burt's head, who picked it up but was slammed to the ground by Whitehead at the 24.  
 With 7:14 left in the game the Antelope offense came to the field, intent on scoring.  
 It was as if a bell went off in the huddle, and the players understood that a tie ballgame would end their season...they had to score on this possession and they went about the job of doing just that.  
 Gonzales went over right tackle to the

27, Brown took the ball over right tackle to the 31 and on third down McCook threw the ball to Leach at the 40 and he was brought down at the 43 for a first down.  
 Slay got the call over left guard to the 47 and then Brown broke through two tacklers with a great block from Slay to the Ralls 43 for another first down.  
 Gonzales took the ball over right tackle to the 34 and Ralls called time out with 4:20 left on the clock.  
 On second down Brown got the play of the night when he took the pitchout around right end, cut behind a great block by Whitehead at the corner and outraced the defenders to the six yard line for a first and goal.  
 Slay was caught behind the line of scrimmage at the 11, a pass to Whitehead was almost intercepted by McQueen and a pass to Whitehead in the end zone was ruled incomplete, setting up the crucial fourth down field goal attempt by Gonzales.  
 Calm and confidently the team lined up, the ball was snapped on target and Gonzales kicked the ball as if it were an extra point attempt, putting the 'Lopes out front 10-7 with three minutes left in the game.


