Divided council calls for hiring local attorney

Mills calls action "a joke"

Calling the vote on a motion to hire a local attorney "a joke," Post city council member Larry Mills told fellow council members Monday night that they were voting "without knowing what you're voting for," and "this is a railroad job if I

The motion, submitted by council member Jimmy Holleman, called for Dan Lamband Schooler voted yes, Mills voted no. "hiring a local attorney," but did not explain why 20 year veteran city attorney Harvey Morton was to be relieved of duties.

Council member Jim Schooler tried to clear the air on the motion by pointing out "that the way this sounds, if we vote for this, we are immediately firing Harvey, is that what you meant, Jimmy?"

"I just want us to have a local man, one we can go see when we want to," Holleman responded.

"Mr Holleman," Morton calmly explained, "you were elected to serve on the city council with a form of government that does not give you the authority to talk directly on city business to the attorney, that responsibility rests with the city manager...'

"I guess I will if I want to," Holleman shot back.

"If every council member goes directly to the attorney, can you imagine the

the street and just get advice like that."

"Surely," Morton replied, "you would not ask your attorney to provide advice Carthel made personal presentations. without payment for his services."

"Well, he'll know about that when he takes the job," Holleman continued. Schooler pointed out that hiring should not be based solely on being from Post, "we should really be sure who we hire is qualified, not just because they

Mills attempted to raise questions about the motion, and said he thought the timing was not right. He suggested to Holleman that "this looks like a done do the job after hours be allowed to perform the duties. deal." When Mills later made another attempt to explain his objection to the

"In other words, you've made up your mind already?" Mills answered. Holleman shook his head from side to side and Mayor Jim Jackson suggested an amendment to the motion for a proposal from local attorneys.

motion, Holleman said he was not interested in hearing any more from Mills.

When I requested a clarification of the motion and its amendment as proposed by the mayor, Holleman said "why bother, you can't get it right." I responded by saying, "I'd sure like to try," to which Holleman responded in a

threatening tone, "you'd better get it right this time!" the meeting requesting his attendance, was asked by Jackson, "do you understand

the motion?" Foreman said he wasn't sure, but it appeared to him that the council should

put in writing what it expects of its city attorney, and that local attorneys might be interested in seeking the position. He said that no one would want to take a job that has no defined duties.

Jackson called for a vote on the motion and amendment to the motion, which still was not clearly stated, but implying that the council would take action to

hire a local attorney after preparing a job description. Council members Maxine Conoly, who had seconded the motion, Holleman,

The action set no timetable for the transition and no designation was made for

preparing a job description. said he thought so.

The whole episode was shabby and improper as well as out of order. The item "discussion of city attorney position" was not an action item. The attitude especially considering his 20 years of service to the city.

It also appeared that the motion and the vote were prearranged, with hints that more than two council members may have discussed the issue outside of the open meetings act.

In other action, the council made no decision on choosing one of three engineering firm proposals for preparing the application for opening an additional 35 acres for a new landfill adjacent to the current facility. Proposals chaos, not to mention the cost to the taxpayers?" Morton answered.

Jackson requested Morton to review the situation and let city manager Bob Turner know what could be done.

Turner provided a detailed, line by line discussion of known expenses for the Local attorney S. Rafe Foreman, who said he was called a few minutes before budget and requested council members to study the various options for revenue increases needed to maintain services.

Attending the meeting were council members Conoly, Holleman, Lamb, Schooler, Mills, Mayor Jackson, city manager Turner, city secretary Wanda Wilkerson and city attorney Morton.

Redistricting committee airs five plans

Members of the City of Post redistricting committee, chaired by Marion Cruse, presented five plans for citizen review at the public hearing Monday evening, held at the Holy Cross Catholic Church.

Seven citizens attended the hearing, along with committee members Cruse, Noah Gutierrez, Margaret Barley, Lois Cook, Victor Ashley, Robert Lopez and Thressa Harp.

City employee Delbert Rudd and city attorney Harvey Morton also attended the meeting.

All five plans provide for five individual voting wards, divided generally into northeast, northwest, central, southwest and southeast quadrants.

The northeast and southeast districts provide for 60 to 70 plus percent minority populations, an attempt to meet the U.S. Justice Department's goal of offering "safe" voting districts for minorities.

Cruse explained that although the state law requires cities the size of Post to I asked Morton following the meeting if he is still the city attorney, and he elect two representatives from each district, the committee will present the single member district plan of five council members as its recommendation,

"and let the court decide if this is okay," Cruse said. Local attorney Pat Walker expressed opposition to the plans, saying that the shown Mr Morton was, in my opinion, an embarrassment for the city of Post, higher percentages of minorities appear to be "packing", and thus diluting the ability of minorities' voting rights.

A discussion of this topic and the committee's desire to provide all minorities the best possible chance to elect "one of their own" to office did not appease Walker, who insisted that the only resolution he could see would be to create seven districts.

He was invited to prepare a seven member district plan for consideration by the committee in 10 days. One citizen complained that no matter what happens, "blacks will not have

Cruse pointed out that with only seven percent of the population fitting the

category of black, "it is just not possible to carve out a safe district and still maintain the required population balance between each district." Gutierrez asked if it is not possible for blacks to be properly represented by a

hispanic or vice-versa. "Yes," the citizen answered, "it depends on who is "That's the way it is all across town," Lopez said, "the quality of the

candidates is always the deciding factor." Walker agreed to prepare a plan for seven districts and the committee will hold another public hearing to review the plans within 10 days.

Other members of the committee are Linda Hernandez and Irene Ammons.

In order to place an order for the weevils, interested residents need to call the extension office at 495-2050 by noon this Friday, July 10. Make certain to give us your name, mailing address, phone number and

the number of weevils you wish to order. A bill will be included with individual orders of weevils when they arrive and payment is then made directly to the breeder.

This type of program has been tried on the South Plains in recent years. During the first two or three years of the program, control of the goat head was very effective.

However, due to winter loss and depletion of weevil numbers, the unwanted weeks have started a comeback - thus the new offering of

weevils. For residents with Puncturevine problem this appears to be an inexpensive means of possible control, but remember, we are under a pretty tight time frame so order by the deadline.
