# City faces possible \$30,000 fine on illegal sewer dumping

### Problem centers around oil by-products seeping into sewer system

Council call for citizen help in cleaning up...

A potential fine of \$30,000 or more is facing the City of Post as a result of continued violations of Texas Water Commission rules governing illegal waste being dumped into the city's sewer system.

The fine and explanation of the problem was outlined in detail at the Tuesday, October 6 meeting of the Post City Council.

City manager Bob Turner reported that for several months the city has told the inspectors that "we are trying to clean up the problem, but that excuse will only work for just so long," Turner said, "and then we are going to be subjected to some steep fines.'

The Texas Water Commission is also requiring the city to apply for a sludge permit, Turner told the council.

"If the citizens of Post would use the proper disposal methods," council an issue that needs to be reviewed. member Larry Mills said, "the city could be saved a large fine."

Mills reminded the council that an oil disposal dump which meets state and federal standards is available for the public to use. The disposal facility is located at the back of the city maintenance building on South Avenue H, across from the fire department building.

"We don't know for sure where the contamination is coming from," Mayor Turner, city secretary Wanda Wilkerson and city attorney Harvey Morton.

Jim Jackson says, "but we hope citizens will be careful and bring their used oil to our facility for disposal.'

The mayor said that citizens should call city hall at 495-2811 to arrange a time for a city employee to be at the site to assist in the proper disposal.

Butch Davis of the Parkhill, Smith and Cooper engineering firm, reported that the application for a new landfill site is proceeding on schedule. "The Texas Water Commission is pushing for the 'West Texas Exemption'

for landfill operations," Davis emphasized. "That means we will not have to do a new soil study and will be able to submit data already on file.' Davis said he expects this development to speed up the application process

for the landfill. He also reported that no liner would be needed if there is no danger of contaminating the water supply. In other action, the council authorized a bid of \$8,650 to make needed repairs

at the city-owned Garza Theatre building. Part of the cost of the repair will come from building insurance. A group of concerned citizens expressed their frustration at noxious odors,

apparently coming from oil by-products.

The issue centered around complaints about the Mid Plains Pipeline gas separation plant, located a few miles southwest of Post on the Gail Hwy. Jackson explained to the citizens that the matter was really out of the jurisdiction of the city, since the plant is located outside of the city limits, but added that it is

Gary Workman, representing Mid Plains Pipeline, emphasized that the plant is operating in complete compliance with air quality regulations and, while the odor is unpleasant at times, it is not a health risk.

### Post ISD trustees approve computerized cash register system for school cafeteria

A new computerized cash register system will be installed at the Post ISD cafeteria following action last week by the board of trustees at the regular lengthy, five hour session. meeting, Tuesday, October 13.

The board approved a proposal from Micro-Tech at an approximate cost of "I'm excited about being a part of it." \$4,000 for the system, which has the capability of processing regular price, reduced price, free and adult meals.

The system uses special cards issued to individuals and will eliminate much

of the manual processing in the current accounting method. In other action board members heard a report from engineer Bill Stracener on the status of a variety of building repairs and maintenance projects. He was joined by engineer Jimmy May in explaining details on the projects.

No decision was made on a proposal for a "Cafeteria Plan" insurance proposal by Benefit Designs. The plan would provide for tax savings for employees for deduction of insurance premiums and child care expenses.

The board authorized the publication of bids for the purchase of a van and accepted the bid from Robert Benavidez of \$350 for the purchase of a used school district vehicle.

Board members approved the contract for superintendent Dr Bobby Bain, following review by the district's attorney. Recommendations for transfer students, the textbook custodian, records

management officer and appraisal calendar were also approved. A list of substitute teachers and the English as Second Language program for

the elementary school were approved following an executive session, listed on the agenda as personnel matters.



Ag Predator Referendum Approaching The Texas Sheep and Goat

Raisers is sponsoring a referendum for predator control. The balloting will be conducted in 111 West Texas Counties,

designated as sheep and goat counties. The election will be held

Thursday, October 29 and voting will be conducted through County Extension Offices in the designated

Any sheep and goat producer whose operation lies in the 111 designated counties is eligible to vote. Garza County is located in District number three for purposes

of this referendum. A producer is defined as anyone, regardless of age, who produces sheep and or goats within the referendum area and who would be required to pay the assessment. In my estimation, this would also apply to 4-H and FFA members.

In essence the referendum is aimed at providing funding for the added control of predators. The work to be done will be over and above any predator control programs which are currently in

If passed, the referendum would be funded through a \$0.20 per head fee, at the first point of sale to be paid by the seller, on all sheep and goats sold within the referendum

Ballots will indicate: first, whether or not the voting producer is interested in supporting the referendum dedicated to area-wide predator control.

Second, producers will vote for three directors to represent their district on the commodity producers board, provided the

referendum passes. The voting will be conducted on Thursday, October 29, in the Courthouse, from 7 a.m. until 7 p.m. and will be conducted by the Extension Office. Producers may vote only once and may vote in either the county of their residence (if within the referendum area) or the county in which their ranch

headquarters is located. Absentee voting is acceptable, and will be conducted by mail. All absentee ballots must be postmarked prior to midnight three days prior to the election date



envelope, provided with the ballot. If the referendum is passed, the \$0.20 per head fee, paid by the seller, will be committed to the referendum fund and the nine member producer board will



#### Rynn Norman gins 1992's first bale

Doug Shepherd at Grassland Coop Gin reports that Rynn Norman brought in Garza County's first recorded bale of cotton Thursday, October 15.





Russ Bird then got into the action. Bird gained 15 on a quick inside hand off. The line opened a huge hole on the trap and Bird didn't stop until he had reached the five yard line. Bird gained two on the next play and then, Acevedo scored from the three on a sweep left. did the offense. Post lined up for the kick on the extra point but the ball got away from holder Cody Collier. Collier kept his cool though and gathered the ball up and headed toward the end zone. As he was Simpson powered into the end zone ground game was more than enough the rest of the way. with five Roughnecks draped all over him. Post led 16-0.

Post scored on their next possession after Anthony Cruse recovered a fumble at the Post 41. Hart got caught behind the line for a five yard loss. Ricky Jefferson took the ball on a simple trap play on the next snap,. Jefferson found a hole and accelerated quickly into the secondary. When the dust settled, Jefferson was in the end zone with a 64 yard touchdown romp. The Post defense then held the Martinez scooped up the ball and ran toward the end zone. Roughneck the rest of the way to
