Commissioners approve election results, new landfill agreement

The November 3 general election results were approved by the Garza County Commissioners' Court at its regular meeting Monday morning. A total of 1,888 voters cast ballots, approximately 66 percent of the 2,863 registered voters in the county.

Commissioners also approved an interlocal agreement with the City of Post concerning the joint funding of the new landfill. Judge Giles Dalby recommended a change in the resolution wording to provide for "advise and consent" by the court on hours of operation at the landfill. The closure portion of the agreement included a 24 month term for the county to be obligated on the closure costs.

The closure paragraph says, "This agreement is intended to encompass the cost of the eventual closure of the landfill site. After this agreement has been in effect for not less than 24 months, the county shall be obligated to reimburse 25 percent of those costs, even if the agreement has been previously terminated."

Commissioners reviewed road classifications from the Texas Department of Transportation and heard a report from county agent Ann Nobles.

Dalby suggested that the court consider modifying Refugio County's personnel policies for use here. Commissioners agreed to study the document and make recommendations for changes to Garza County's personnel policies.

A letter from Parkhill, Smith and Cooper was presented to the court, outlining the actions taken by the engineering firm on behalf of the City of Post for the new landfill permit application.

Judge Dalby informed the court that no written communication has been received from newly elected county attorney Chris Wyatt, who has relocated to Robert Lee. Dalby emphasized that the court could take no action regarding

filling the office until Wyatt officially submits a letter or resignation.

City Council approves landfill resolution, amends zoning

The Post City Council passed the first reading of a financial responsibility resolution concerning the proposed landfill during a short meeting Tuesday, November 3.

The council also amended the zoning and airport ordinances, discussed a building addition at the cemetery, and received a report on improvements at the sewer plant.

Mayor Jim Jackson reported that the Garza County Commissioners' Court had already passed a resolution outlining the county's responsibility in the joint project. (see related story Commissioners' Court)

Councilman Larry Mills raised a question about the time frame involved in the proposed resolution for the county to avoid financial responsibility.

The commissioners' court proposed to limit its responsibility to 25 percent of clean up and closure costs.

Mills suggested an amendment to the time limit given by each party to dissolve the term agreement. The original proposal had allowed the county 60 days notice from the city and only 30 days notice for the city.

City attorney Harvey Morton explained that it would protect the county to have a longer notice since the city bears the majority of the cost of operating the landfill.

"The time frame for the notice gives the county an opportunity to find another source for landfill services," said Morton.

Mills agreed but proposed an amendment to the resolution making the termination notice equal at sixty days for both parties. The amendment was passed unanimously.

Councilman Jimmy Holleman motioned to accept the first reading of the resolution and to forward the resolution to the commissioners' court. The motion passed without dissent.

"All of the documents needed for the permit have been filed and we are just waiting to hear from the Texas Water Commission", reported Jackson.

The mayor also expressed appreciation for Steltzer Drilling, The George R. Brown Partnership, and the Garza County Soil Conservation District for the work done on collecting soil samples for the permit.

The council also accepted a proposed bid for closure on the final 10 acres of the existing landfill. Turner reported that all of the problems cited by the Texas Water Commission have now been corrected.

The council accepted a bid for 39 cents per yard and fuel cost of \$75 per day to seal the final ten acres.

In other business, City Manager Bob Turner brought the council up to date on the building project at the cemetery.

Turner stated that the city could cut costs on the project by using the expertise currently on the city staff.

"We have employees who have done this type of work professionally and we could use them without cutting back on other city services."

Turner assured the council that the project would not incur overtime expenses for the city.

The sub-contracting work which needs to be done would cost less than \$5,000 and would not have to be put out for bid.

The council amended a zoning ordinance which restricted signage throughout the city.

The restrictions will continue to apply to those merchants on Main (Continued on Page 9)

Dear Editor,
As Superintendent of Post Independent School District, I, Dr. Bobby Bain, feel that the taxpayers of the District should be informed that Governor Ann Richards, Lt. Governor Bob Bullock and Speaker Gib Lewis recently unveiled the "Fair Share Plan" to finance public education in Texas.

The 12 organizations comprising the school finance working group, as well as the Texas Association of Secondary School Principals and the Texas Elementary Principals and Supervisors Association, are disappointed and dismayed by this plan and in the state's lack of commitment to adequately fund Texas' Public Education system.

The "Fair Share Plan" is a classic case of passing the buck from the state to local school districts--but the bucks will come from the pockets of local property taxpayers. The plan will cause the largest local property tax hike in Texas history, and it will result in a drastic reduction in state aid for our students. It is a lose-lose situation.

A reduction in state aid means only one thing--another substantial increase in property taxes--an increase to the tune of perhaps \$2.5-\$3 billion over the biennium.

Public education costs will not remain constant next year. Though the proposal would add \$650 million in new state funds to public schools over the biennium, schools will have more students to educate, more classrooms to construct, and more teachers to pay. Additionally, schools will be faced with salary increases as required by law, continued pressure to bring classroom teachers' salaries up to the national average, and higher health care benefits. On top of that, schools, like all Texans, will see increases in utility and transportation costs next year. All of this will more than offset the increase in state aid, leading to an actual decrease in state aid per pupil.

In essence, the local property tax continues to be the cash cow of public education because of state policy, a policy that has been declared unconstitutional on three successive occasions and cannot be made right by a constitutional amendment, which this plan proposes.

The state leadership says they won't support a tax bill because the people of Texas have made their voices heard loud and clear. But the taxpayers are only given half the story. They have not been told that the "Fair Share Plan" will cause local property taxes to skyrocket, and that even the poorest of the poor school districts will have to raise local property taxes to unbearable levels just to stay even.

Under the "Fair Share Plan," Ed Couch-Elsa ISD, the poorest school district in the state, will have to

increase their tax rate by 22 cents for an increase of only \$48 per weighted student. Edgewood ISD, the lead plaintiff in the school finance lawsuit, will be forced to raise local property taxes next year by 28 cents just to break even.

Post Independent School District will have to raise local property taxes an estimated 11 cents just to maintain the current year's revenue.

Unfortunately, the "Fair Share Plan" becomes the "Unfair Share Plan" for Texas School children and Texas property taxpayers. When you go to buy an automobile, you realize there is a relationship between cost and quality. Public education is no different. The citizens of Texas and state officials continue to demand a world-class education system while the state considers lowering funding per student. But a world-class education isn't built on a shoestring budget or on a state that thinks so poorly of its children that it ranks 36th out of 50 in the amount of money it spends on their education.

Governor Richards said recently, "if you can't fill the till, don't pass the bill." We urge her to heed her own advice and come up with a plan that adequately funds public education.

We have run out of band-aids in Texas. It's time for major surgery...for our future...for our children.

Q: I live 40 miles from anything, even a convenience store, so it would be expensive for me to get rid of household chemicals even if you had a collection site near me. What should I do?

A: The first step for you is to reduce your use of materials that might eventually need costly and sometimes dangerous disposal. The Texas Water Commission will send you a brochure describing safe, non-toxic alternatives for almost any household use. For those products that you still have, if you can't use them for their intended purpose or find a neighbor who can use them properly, we can talk with you about safe methods of disposal. In some cases, the best thing may be for you to store the products in a locked or otherwise safe place until you can conveniently take them to a disposal location. We are working to make disposal sites available in all areas of the state.

Living on the Edge of the Caprock

Stocking Rate Workshop

The determination and setting of livestock stocking rate is one of the most important management decisions facing Garza County ranchers. In the short term, stocking rates impact the number of animals available for market, livestock weight gain, wool or mohair production, reproductive rates, toxic plant consumption, supplemental feed costs, and labor costs. Even more important is the impact stocking rates have on long-term ranch profitability. Excessive stocking rates have the ability to destroy both the soil and plant resources of a ranch. Such damage can be irreversible under our sometimes arid conditions. Unfortunately, the determination and setting of livestock stocking rates are often cloaked in mystery. This may be due in large part to the lack of objective, practical techniques to evaluate range forage quantities and provide feedback concerning the impact of stocking rate decisions on the

This ANN That

More women than ever are employed outside their homes. Women work for many reasons, some by choice, others by necessity, but they have one thing in common. Juggling work outside the home with work at home is not easy.

Many women would like help with some of the household work from family members. Dr. Joyce Cavanaugh, Extension Family Economics Specialist with Texas Agricultural Extension Service makes the following suggestions:

*Make a list of all jobs which need to be done. Present this list to the family in a non-threatening way. Often family members do not realize how unbalanced the responsibility for household work is.

*Discuss how family members feel about helping with the household jobs. Help them realize that in addition to their responsibilities outside the home, whether it is school or a job, they also have responsibilities inside the home. After all, everybody contributes to the clutter, dust and dirt around the house.

*Decide as a family who will be responsible for doing what, when and how. Remember to discuss all family tasks including bill paying, record keeping and yard maintenance, not just cooking and cleaning, when dividing responsibilities. Consider the abilities of children when dividing tasks. Make sure they know why the job needs doing. There will be some tasks that no one will particularly want to do—like cleaning the bathroom or emptying the cat's litter box. No one person should be responsible for these. Perhaps these jobs should rotate among all family members.

*Develop a method for insuring that tasks are accomplished, whether it's a contract that each family member signs or a chart on the refrigerator. If someone does not perform an assigned task, no one should do it for him or her because that encourages the person to fail to carry out assigned responsibilities. Don't forget to praise family members for performing their tasks and doing a good job.

*Do not assume that family members know how to do the assigned tasks. It may be necessary to teach children how to wash dishes properly with hot soapy water or why it is important.

*Family members, especially small children, should not be expected to perform their tasks perfectly. The family may have to live with a lower quality product in household cleaning until everyone learns how to do the jobs well. It is very important that mother does not criticize a child's work or the child may wonder why she wanted help at all.

Cavanaugh reminds women that even though they want and need help it may be difficult to give up control of the work. If others are to perform the task, you must let them assume responsibility for it.

It will take time for you and your family to adjust to a new system but, in the end, you will find your family is more organized and jobs will be done in less time than if you had done them alone.

This may leave more time for family activities and family members may be more dependable and respectful of each other.

Tahoka surprises Post in season finale

The Tahoka Bulldogs put an end to the Post Bold Gold season Friday night. But the 'Lopes did not go quietly.

Both teams came into the contest out of the play-off picture in district 4-AA. That did not affect the quality of play in the traditional rivalry.

Both squads came out tentative and were unable to move the football on their first few possessions.

Post finally broke the defensive struggle starting a 10 play drive from their own 34.

After Russ Bird gained 6 yards on two plays, tailback Ricky Jefferson hit the inside of the defensive line on quick counter and gained nine yards for the first down.

Post then ran the draw play twice up the middle to fullback Bird for 13 yards and a first down at the Tahoka 37. Post had mounted the first threat of the evening and, as usual, they had accomplished it on the ground.

That would quickly change. Quarterback Jim Riley Simpson faded back into the pocket and spotted junior receiver Phil Leininger over the middle. Simpson put the football right into Phil's hands at the 23 yard line.

After a sack moved the 'Lopes back to the 32, Simpson found Leininger again at the Bulldog 4 yard line.

Disaster almost struck on the next play. Russ Bird fumbled at the one yard line and Post alertly jumped on the football to keep possession. Bird scored on the next play with just 4 seconds remaining in the first quarter.

The extra point snap was high and holder Cody Collier was buried at the five. Post had the lead 6-0.

The Bulldogs responded with a long drive late in the second quarter.

Tahoka took the ball on the Post 42 recovering a fumble in Bold Gold territory.

The Bulldogs then moved the ball down to the four yard line before Josh Bush nailed running back Jace Copeland for a six yard loss.

Tahoka settled for a 27 yard Rene Luna field goal to pull within three at half time, 6-3.

Post scored on the first possession of the second again striking quickly through the air.

On the first play from scrimmage, Simpson faded back in the pocket and found Phil Leininger on the fly at the 45 yard line of Tahoka.


Tim Bell took the handoff up the middle for five yards. On the next play, Bell broke around left end and sped untouched into the end zone.

The 40 yard TD run put Post ahead 12-3 as they missed the two point conversion.

Tahoka responded by driving the length of the field chewing up 6:13 on the clock in the process. Quarterback Heath Brewer hit Cory Whitley for the score. Luna's extra point kick brought the Bulldogs within 2, 12-10.

Tahoka scored the game winning touchdown early in the fourth quarter on a two play drive.

Speedster Ramiro Rodriguez raced 78 yards eluding the Post secondary on the way. Post blocked the extra point.

Tahoka had captured the lead though 16-12.

Post fumbled the ensuing kickoff on the 43 giving the Bulldogs great field position.

Tahoka drove down to the Post 4 before the defense put up a great goal line stand led by Russ Bird, Darren Wood, Josh Bush, and Ray Perez.

After another change of possession, Post went back to the air.

The 'Lopes were running out of time when they got the ball at their own 18.

The Bold Gold had used all their time outs in the second half, so Simpson went to work on the two minute drill.

After a draw play netted five yards, Simpson went up top to his brother, Bodie Simpson for a 20 yard gain.

Simpson hit Brad Lawson on a crossing pattern at the 50 for another first down. Lawson was the target again on the next pass as Simpson threw and out pattern to Brad at the Tahoka 32.

Simpson took the snap and threw the ball into the ground to stop the clock. Jim Riley was sacked on the next play for a two yard loss. With under ten seconds left, Simpson hurried his team to the line of scrimmage and got the play off.

Simpson hit Ricky Jefferson at the 15 and Jefferson could not get out of bounds before the clock expired. Tahoka had held on for a tight win 16-12.

In a way, that last drive kind of symbolized the whole season for the Bold Gold. The 'Lopes posted a 1-8 mark for the year but they never quit driving for that last yard. Had just a few things gone differently, Post could have had a much better showing.

Things like a missed fourth down play against Abernathy, a better spot at Seagraves, a call at the goal line against

Ralls, 10 more seconds against Tahoka, made the season worse than what it really was.

The Antelopes never gave in and they never quit trying. The show promise for the years ahead as this team only graduates seven players.

Maybe Post will get that 10 extra seconds they need next season.





Bulldogs sweep Middle School

The middle school boys football teams ended their season last Thursday night against the Bulldogs in Tahoka. The 'Dogs proved to be a rather inhospitable bunch. Tahoka took two wins against the Bold Gold downing the seventh grade team 16-12 and outlasting the eighth grade boys 26-14. Both Post squads outgained their opponent in the loss. The eighth grade boys struck first against Tahoka driving 61 yards on eleven plays in the first quarter. Armondo Ayala capped off the drive with a six yard touchdown run to give Post the early lead 6-0. Then came the series of plays which may have decided the contest. Tahoka broke a long run to the Post ten yard line but coughed up the football at the end of the play. Post recovered and it looked like they had dodged the bullet. But on the next play, Post returned the favor and fumbled the ball back to the Bulldogs. Two plays later Tahoka was dancing in paydirt to knot the score 6-6. In the second quarter, Ayala showed his speed as he broke through the Bulldog line and raced 70 yards for the touchdown. Ayala ran in the extra point and Post lead 14-6. Tahoka drove the ball down the field right before the half and scored to close to within two 14-12. The extra point attempt by the Bulldogs missed leaving the 'Dogs down by two at the half. Tahoka wasted no time getting the lead in the second half. The Bulldogs ran the opening kickoff back for a touchdown to lead 18-14. Tahoka ran in the extra point

this time to take a 20-14 advantage. The two defenses took over for the rest of the game. Tahoka managed to score with less than one minute remaining in the contest to make the final 26-14. Coach Darrell Radle complimented his team after the tough loss. "Take away three or four plays and we would have won. The kids played hard, especially on defense." The eighth grade boys finished with a record of 5-4 and they posted an impressive district mark of 4-2. The seventh grade boys dominated the Bulldogs throughout the game but got beat by the big play. Tahoka scored first in the first quarter on a 20 yard dash through the 'Lope secondary. Tahoka added the two point conversion to lead 8-0. Post responded when John Barbosa carried the ball in from the six yard line. Post could get in for the two point conversion leaving the 'Lopes down by two 8-6. Anthony Gomez gave Post the lead in the fourth quarter on a 33 yard run. The conversion failed and Post led by 4, 12-8. Tahoka responded by marching down the field and scoring on a twelve yard run. The Bulldogs added the two point conversion to lead 16-12. Post had a chance to win the game late in the fourth quarter. A fumble on the ten yard line ended Post's last ditch effort. "These young men improved every game", said Coach Chili Black after the loss. "They finished the season strong." The seventh grade team finished the year with a 3-5 mark but showed improvement all year.

The coaches commend the play of the boys throughout the year. "Both the seventh and eighth grade Antelopes played with class all year", commented Radle. "They have improved greatly and their behavior on the field is an example some other teams should emulate." The eighth grade rolled up 190 yards while holding Tahoka to 180 in the loss. The seventh grade boys had 178 yards in total offense while the defense held Tahoka to just 103 yards.


