Fine Rains Brighten Prospects for Farmers

Twenty-Two Seek District And County Offices

Twenty-two district, county, and precinct candidates were listed Saturday afternoon as having filed application, for places on the Garza county ballot, reported T. R. Greenfield, County Democratic chairman.

There are fifteen races, 9 of which are not contested. Fees must be paid by the candidates by next Saturday, reminded Greenfield.

The Democratic Committee, comprised of the County chairman and precinct election judges, met Monday afternoon and checked the filings and arranged places of candidates on the ticket. Positions were determined by drawing names from a hat.

At a meeting of the board of directors of Terrace Cemetery Association recently, it was decided to request all lot owners to either clean their lots, or pay the association to have the lots cleaned and beautified for them, reports T. R. Greenfield, chairman.

"Several have already paid, and we are cleaning their lots as rapidly as possible," said Greenfield. "If you desire us to care for your lot the charge will be \$7.50 per year for full size lot. If you care for the lot, and use the association's water, we expect you to pay something for the water you use."

"May we encourage you to cooperate by helping us clean up the cemetery," he continued.

South Garza Test Draws Attention By High Lime

Considerable interest is being given a south Garza county well-drilled by the oil fraternity as it promises to drill ahead in the San Andres-Permian line which was encountered high in any other exploration so far drilled—in the central field.

The exploration, being drilled by Plymouth Oil Company about ten miles south of Post on the J. B. Slaughter estate, had reached a depth of 2,800 feet last week end. It encountered top of the San Andres at 2,460 feet. Correlation shows 116 feet high to a dry hole drilled in 1925 by Gulf Oil Corporation three miles west of the project. The test is to go to 4,500 feet, or production at a lesser depth.

A new prospector is reported for the same region, with drilling scheduled to begin at once. The well will be drilled by John T. O'Neal of Lubbock, who holds the drilling contract from Northern Ordnance, Inc., of Minneapolis, Minn. The test is to be styled No. 1 Elizabeth Walker and is to go to 3,500 feet. Its location is in section 45, block 6, H&GN survey.

Garza Veterans Now Being Served by Lubbock Office

West Texas veterans and their dependents residing within the 48 counties formerly under the jurisdiction of the Veterans Administration West regional office should be pleased that they are now supervised by the newly authorized Lubbock regional office, east of Hubert W. Stason, Lubbock regional manager.

To facilitate efficient VA operations and to minimize delay of those seeking VA assistance, veterans and their dependents should apply in the contact representative office attached to the Lubbock regional office for all VA services, including: vocational rehabilitation and education, compensation and pension, retirement pay, burial expenses, insurance, hospitalization, medical treatment, domiciliary care, guaranty of loan, readjustment allowances and other related benefits.

PARTS OF COUNTY DRENCHED WITH 3 TO 4 INCH FALL

A heavy but spotted rain fell over the County late Tuesday afternoon to give relief to farmers who have needed moisture to plant. The rain came on the heels of several days of scalding temperatures that went high into the nineties and was followed by a summer "norther" which sent the mercury to a low of 66 degrees.

Only 28 men of rain fell in Post, but the three to four inch down-pour in the Graham and Close City community filled narrow ditches and flooded fields. Lace Deaton, who resides about four miles west of Post reported three inches measured on his ranch. W. C. W. Morris of Graham community reported 4 inches of precipitation. The Sam Lewis farm in Pleasant Valley community received 3.67 inches. B. C. Childs, who resides 12 miles south-west of Post, said he received from 1 inch to an inch and half. The heavy rain extended over most of the Plains area of the county but tapered off to lesser amounts to the north and south.

R. L. Cummings, who resides north of Post, reported 49 inch on his farm. Clinton Bud said that the rain was light on his farm and ranch east of Post Tuesday afternoon, but that he got close to an inch early Wednesday morning.

Heavily overcast skies that appeared to be laden with moisture failed to drop more than intermittent sprinkles through the day yesterday and this morning the skies remained overcast to give promise of more moisture.

Crop Insurance Adjusters Are Making Surveys

These producers having Federal Crop Insurance are advised that the crop insurance adjusters are at work, using determination of the 1946 average planted to cotton, and that at the same time are making preliminary surveys of the entire crop, states Will Wright, Chairman County AEA Committee.

The adjusters are determining the average yield to cotton and making a preliminary report on the condition of the cotton crop only. They are not releasing any of the cotton average for other use at the present time. As soon as they are authorized by the Corporation they will start releasing that average eligible for release, Wright said.

Mr. Wright is again notifying those persons having insurance not to replant the cotton average to another crop without the written consent of the crop insurance adjusters. Garza county has been allotted four adjusters this crop year. We requested more adjusters but the Corporation would not let us have them. Under these conditions we may not be able to make inspections as soon as the individual producer would like, but will get there as quickly as possible.

Hudman Furniture Store And Stock Damaged By Fire

The most destructive business fire in Post, since that of the Earl Hodges' feed store about a year ago, a half acre occurred last Saturday night when flames swept the Hudman Furniture store and stock estimated by the owners to be between \$15,000 and \$18,000.

The fire originated in the store room at the rear of the building and completely destroyed several large shipments of furniture which had not been located. Smoke filled the main building and resulted in damage to most of the furniture on display. The partition separating the storage and display rooms was severely damaged and the ceiling and roof at the building was damaged to great extent. The loss was partly covered by insurance.

The fire was discovered by the owners and visitors in the store shortly after some youth had thoughtlessly tossed a fire-cracker into the store room. Sparks from the explosion ignited excelsior and paper wrappings and the flames, fanned by a south breeze through the open front door, spread rapidly.

The blaze, usually first headway, was confined mostly to the rear of the building after the back door and the partition doors were closed, but spread upward and swept through the space between the ceiling and roof, causing heavy damage to that part of the building.

Two Children Die In Fire Here Tuesday

EARLY MORNING FIRE TRAPS CHILDREN IN 2-ROOM FRAME SHACK

Two small daughters of Fella Ramona, Terrace Cemetery caretaker were burned to death in a fire early Tuesday morning which raged in the two-room shack on the south side of the cemetery plot.

The charred bodies of the little children, Francisco, 3 years, and Gerardo, 14 months, were removed from the centers of the burned shack, when firemen made four trips into Post to fill the 250-gallon water tank of the fire-truck to have water supply to smother the fire.

The fire broke out about 3 o'clock Tuesday morning and was reported to the fire department by a person who saw the blaze from the highway, but firemen arrived too late to save the home from destruction or to rescue the children. Origin of the blaze was not known, but the father expressed the belief that it was ignited by rats.

According to the father, the two children who perished were sleeping in bed with him and his wife. When he was awakened by the heat and crackle of flames he aroused his wife and two other children, a boy 9 and girl 5, who were sleeping in another bed in the same room and helped them escape. He said he attempted to gain entrance into the shack to rescue the other two children, but by that time the entire frame structure was enveloped by fire. Both he and his wife were burned when they attempted to rescue the two children whose lives were lost. Firemen said the shack had only one door and no windows.

Funeral services for the children were conducted Tuesday afternoon at 6 o'clock from the Assemblies De Dios, Mexican church, and burial was in Terrace cemetery. The Reverend Tommas M. Ramon read the rites.

Local AAA Office Taking Reports On Contour Farming

Robert H. Gibson, County AEA Secretary, announces that the county office is now accepting the "Notice of Approval and Preliminary Report" on contour farming or crop crops from the individual producer. "These reports are not due in the county office until July 31, but those producers who have their crops planted may turn them in," said Gibson.

"Each producer should bear in mind that he should not turn this report in until he has planted his crop or July 31, whichever is first," he said.

C. L. BABBETT PURCHASES POST PRODUCE; WILL ASSUME DUTIES JUNE 24

It was announced Monday that M. N. L. Luck, manager of the Post Produce for 3 years, sold his interest in the firm to C. L. Babbett of Lubbock.

The new owner will assume duties on Monday, June 24. Mr. Luck moved to this city from Lubbock and purchased the Post Produce in March 1943. His future plans are as yet indefinite.

WHAT IS YOUR GOAL?

Policies definitely destructive to free enterprise are destructive to our liberties. Size has nothing to do with this question. The man who runs his own shoe-shine stand is a capitalist, no less than the man who runs an automobile factory. Great industries which serve America today developed from small beginnings. The young man with an idea, working in the back room of his home, may be the head of a great corporation tomorrow.

FREE PRESS?

It is not a coincidence that this is so. When a man or a group of men are crippled, or subjected to iron-handed political control, a free press has become a thing of the past. The press in such nations is simply a sounding board for dictatorship—the ruthless voice of the clique in power.

It is not a coincidence that this is so. When a man or a group of men reach out to seize the economic resources of a nation, the first step must be to control that nation's sources of opinion and information. There can be no opposition. There can be no dissent. The death of free enterprise is inevitably accompanied by the death of a free press.

IS SAFE DRIVING A THING OF THE PAST?

Safe driving is almost a thing of the past. A drive down highways out of Garza county and at various intersections in the town of Post prove this statement beyond a doubt.

An editorial by Dr. Rivers of the University of Texas brings out some interesting facts on traffic safety. It would be well if all Garza county folks would read his editorial, "We Can't Drag."

"They say Texas like to brag especially about the beauty of Texas and the big things done in the state.

"But Texas can't brag when talk gets around to traffic safety. Texas has some big statistical figures on traffic casualties but the trouble is that the big figures are on the wrong side of the ledger.

"Highway accidents, which account for approximately half of Texas traffic casualties, are at the increase over 1945 by 24 per cent, reports N. K. Woerner, chief of the Statistical Division of the Department of Public Safety.

"Those figures mean that, if the percentage remains the same, more than 2,000 persons will die in highway wrecks in Texas this year.

"We cursed the Germans and the Japs when they killed thousands of American men, and we brought an end to the killing by amazing Germany and Japan.

"But we see daily news accounts of people killed in auto accidents, and our anger is not stirred. Death on the highway has become so commonplace that we accept it as an inevitable consequence of the Modern Age.

"In long-range education of the public lies the best hope for safety consciousness, but the immediate problem—stopping the traffic deaths of today and of this year—must be solved by more forceful methods.

"The state should set out immediately to double its highway patrol strength, which now stands at 200 men.

"Present strength is entirely inadequate to enforce safety regulations over the thousands of miles of Texas highways.

"High though the cost would be in adding 200 men, Texas can well afford the output in order to check mad driving.

"What Texas loses when men, women, and children are killed on the road cannot be measured in dollars and cents."

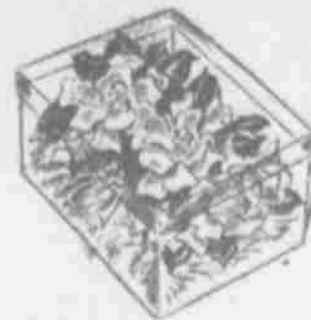

Swing of Southwest Farm Markets

Southwest farm markets saw sharp gains in cotton prices; hogs, grain and feed at ceiling; cattle, poultry and eggs, steady, but vegetables and sheep slightly lower last week, according to USDA's Production and Marketing Administration.

Cotton prices jumped about five dollars a bale 1 1/2 last week. Demand for cotton was strong but the volume of trading was only moderate due to limited offerings. Reported sales in the 10 spot markets totaled 81,800 bales for the past week against 81,400 in the preceding week and 120,800 in the same week last year.

Grain supplies remained tight despite increased movement of new crop wheat and oats. Prices continue to stand at ceiling.

Egg prices held about steady last week. Receipts were ample to meet fair to good local demand. Current receipt eggs were quoted mostly at 20 1-2 cents a dozen. Fort Worth; 21 cents, Dallas and 21 1-2 to 22 cents, Denver.

Feed shortages helped to increase poultry receipts at some southwest markets. However, buyers remained scarce. Fair to good demand kept prices about steady. Heavy hens brought 24 cents a pound, Dallas; 24 to 25 cents, Ft. Worth; 25 to 26 cents, Denver; and 28 to 29 cents, New Orleans.

Last week saw very light hog receipts at most southwest markets. Trading was active and prices steady. Top butchers stood at ceiling of \$14.50 per hundred pounds, Wichita; \$14.55, Oklahoma City; \$14.65, Fort Worth and San Antonio; and \$14.50, Denver.

Cattle receipts at principal markets were down last week from the previous week. Good demand kept prices steady to strong. Houston sold medium and good steers and yearlings at \$13 to \$16.50 per hundred pounds. Common and medium cows brought \$9.25 to \$11.50, San Antonio; \$8.75 to \$11.75, Ft. Worth; and \$9.50 to \$12, Wichita. Medium and good beef cows realized \$10.50 to \$13.50, Oklahoma City. Odd common to medium cows ranged from \$11 to \$11.75, Denver.

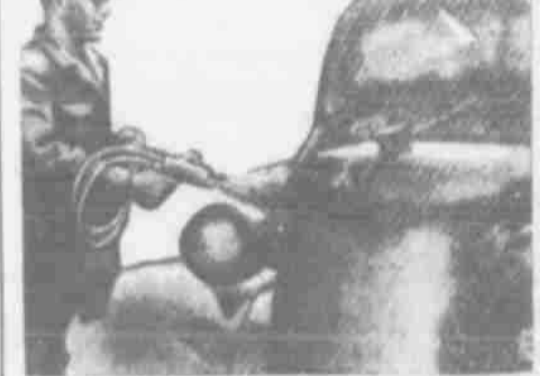

POULTRY FLOCKS NEED TO BE CULLED NOW ADVISE SPECIALIST

Any hen laying less than a dozen eggs a month is losing money for her owner, considering prevailing prices of feed and eggs. These inefficient hens should be culled from laying flocks, the Texas A and M College Extension Service is advising farm families and backyard poultry raisers of the state.

A hen consumes about five pounds of feed per month even though she is not laying, so further reduction of laying flocks is being sought by the government in view of current feed shortage. For the nation as a whole, the reduction sought is one of every seven hens.

According to Sam Moore, Extension poultry specialist, most Texas flocks could lose one of every seven hens, and with proper culling profits would increase. Until recently, he says, Texas egg production this year has exceeded last year's for the same period, although the state has reduced its poultry population to or below pre-war numbers. This indicates a rise in production per bird.

While chick production this spring was 20 per cent less than last year with good management an average number of pullets should go into production on Texas farms this fall, Moore says. He indicates that there are large amounts of shell eggs and poultry meat in storage and the demand for fresh eggs has been good this spring.
