

'Cotton's Dynamic Sixties'

"Cotton's Dynamic Sixties" would be an appropriate program theme for Post and Garza County's annual observance of National Cotton Week, May 16-23.

Going into the Sixties decade of the 20th Century, cotton and its allied industries bid fair to earn for themselves an even more imposing place in the nation's economic spotlight during the next ten years.

As Garza County's biggest agricultural cash crop, the cotten industry certainly is worthy of a week of special attention here. And Postex Mills, whose approximately 500 employes will be honored at a barbecue Thursday afternoon, May 19, certainly is deserving of that honor by virtue of its being not only the biggest industrial plant in Post, but also one of the biggest in this part of the country

Because the cotton crop and Postex Mills are so important to and so much a part of Post and Garza County, every citizen is urged to join

in the observance of National Cotton Week, one of the highlights of which will be an open house at the mills on the same day the barbecue is held

Today, it is just as important as it was last year, or even ten years ago, to buy cotton products when we have a choice. Again this year, "Buy Cotton" is being stressed during this special week by the National Cotton Council and related organizations.

Utility extension policy needed

The City of Post isn't starting any too soon in its move to adopt a practical and a fair policy for extension of water and sewer facilities to new home-building projects. In fact, it's something that done months ago would have resulted in less agitation among developers, building contractors, new home owners, and city officials as well

When a town begins to grow-and Post started its present surge some time ago-it should he up to the city government to have a clear-cut policy on what it can and will do in the way of utility extensions. A hit-and-miss policy isn't fair to anyone, least of all to those engaged in building projects contributing to that growth.

Utiliites, of course, are the lifeblood of residential additions ... without them, a house is just a house, nothing more. With no reasonable degree of certainty that water and sewer service will be available, no builder is going to come in end start developing a residential addition.

We have no intention here of suggesting to the City of Post what it should do in the case of utility extensions, especially those involving big expenditures, as most of the recent ones have, or would. It's just that we believe a well set-out policy should be adopted on extensions-one as fair to the builder as it is to the city-and closely adhered to

We also think the city should take into consideration that in view of the tax roll additions brought about by new homes, it will be to the city's benefit to go as far as it can toward making water and sewer extensions available in every new addition .- CD.

AN AERIAL VIEW OF POSTEX COTTON MILLS


This will be the first public open house of Postex Mills in two years—the last being in Cotton Week during the spring of 1958.

We are sorry but federal law forbids youngsters under 16 years of age from being admitted to the mills.

Postex Mills employ around 500 persons with the cotton mill working around the clock on a three-shift basis, six days a week. The sewing room is operated on a single shift basis.

Modern Postex equipment includes 360 automatic looms and 17,750 spindles. The big sanforizer, pictured below, is one of the world's biggest. It was installed last year.

Guides will be provided to conduct guests in small groups through the entire plant and explain plant operation. Postex Mills take the raw cotton from the bale and process it completely through to Garza and Foxcroft sheets, both flat and contour, and pillow cases, bleached and in six colors.



Deer important as source of income in Kerrville area

AUSTIN - The net return per animal unit in deer in one area of the Kerr Wildlife Management

Area last year amounted to \$153.-28 which was considerably higher than livestock on the same area yielded. This is included in a report of the management research area made through the director of wildlife restoration of the Game and Fish Commission.

'This return was much higher then from any class of livestock on the area" the report says. "The net return from 162 animal units in livestock was \$4,669.60 compared to \$3,747.61 from only \$7 animal units in deer. These findings indicate that deer are a potential important asset to ranches.

Development should be directed toward improving the habitat for deer in order to increase the potential for this source of income. Proper management by harvest is indicated to be essential to sound economic returns from this enterprise.

Records on economic values, veg etation, livestock grazing, wildlife habits, deer harvest and forage and used as basis for appraisal of past development and plenning new developments needs. This information will be used in planning future development and management of the area.



Facts About Texas Cotton ICLIP AND SAVE FOR FUTURE REFERENCE

The U.S.D.A. has placed the 1959 national cotton crop at 14,551,000 bales. Texas accounted for approximately 4,416,000 bales or 30.3 per cent of this total, as compared to a whopping 37 per cent in 1958.

Texas production for 1959 of 4,416,000 was well above the 1958 output of 4,308,000 bales.

The yield output per acre didn't maintain the record 383 pounds of lint for 1958, but it was a hefty 334 pounds of lint per acre, the second highest in Texas cotton production history.

The U.S. average yield for cotton in 1959 was 462 pounds per acre as compared to 466 pounds of lint per acre in 1958.

In 1959 Texas harvested 6,350,000 acres as compared to 5,395,000 in 1958. The national cotton acreage harvested in 1959 was 15,090,000 acres, a huge boost from the 11,849,000 acres harvested in 1958. It was this big national increase which dropped Texas'

share of total production from 37 per cent in 1958 to 30 per cent in 1959.

The total value of the national cotton crop in 1959 was \$2,281,300,000.

The 1960 purchase rate for the base quality, midling one inch choice A cotton is 32.42 cents, and the 1960 loan rate for choice B, M-1, is 26.63 cents per pound, at average location, according to an announcement on May 3.


These are 168 and 177 points lower than the 1959 purchase and loan rates, respectively. Complete provisions and regulations of the 1960 cotton price support program bill will be in 1960 CCC Cotton Bulletin 1 (Loon Program) and 1960 CCC Cotton Bulletin 2 (Purchase Program).


