



SECTION 10: The Secretary of the Board of Directors is hereby authorized and directed to give notice of the aforesaid election by publishing a substancial copy of this resolution, or notice containing the same, signed by the President and attests d by th newspaper or newspapers of gen eral circulation in each city con-tained in the Authority, on the on the same day in each of two consecutive weeks, the first of said publications to be made at least twenty-one (21) full days prior to the date fixed for said election; said publication in the manner aforesaid shall constitute proper notice of said election. 


