Superintendent of schools resigns post

In a surprise move at Tuesday's meeting of the Iowa Park school board, Faris Nowell resigned as superintendent of schools effective Friday.


Only the trustees among those at the meeting were aware of the resignation before Nowell read his prepared letter. Prior to the meeting's opening, he had shown the letter to each board member, in the seclusion of his office.

Announcement came early in the meeting, under the topic of personnel. The first item under the topic heading personnel in the school system.

Nowell first read a letter of resignation from Wanda Bates, though her resignation was actually effective Dec. 23.

He then read the following letter: "Will you please accept my resignation as Superintendent of the Iowa Park Schools to become effective February 22, 1980, upon fulfillment of the attached items? "It has been a pleasure serving in

this capacity for the past fifteen

members and the professional staff much has been accomplished in this period of time. Our buildings are very adequate to house our students. I'm proud of the personnel that carry out our instructional program. I firmly believe that our graduates will succeed in life and many will reach goals that will bring honor to their school.

"The patrons of this district have been a great asset in the support of our various activities. The students have brought many honors and compliments to our community. May I wish for all of you much success in the future."

Nowell came to Iowa Park in 1961 as high school principal, and was elevated to superintendent at the beginning of the 1965 school year.

He began his career in education in 1941 at Lamesa. He moved to Winters in 1942, Ralls in 1946 and Brownfield in 1948, where he entered the administration field in 1958 when he was hired as an elementary school principal.

Asked about the specific date he had brought out to end his administration here, Nowell said he is to begin work other than in public education March 1. He said he was not at liberty to make known with whom he would be employed, but announcement would be made in the very near future by his employers.

Nowell said he and his family would continue living here, at least through next year. His wife, Penny, is a

ACTING SUPERINTENDENT Board members, after voting to accept Nowell's resignation, ap-

proved the naming of Harold Cowley as acting superintendent for the remainder of the year, or until August. Cowley has served in numerous capacities such as assistant superintendent, business manager, director of vocational education and has been in charge of building maintenance since he has been in the administration building. He first came to Iowa Park as vocational agriculture instructor, and entered the administration field when he was named principal at Kidwell Elementary.

Another change in the local administration field was made during the meeting.

Trustees named James Ward, principal at Valley View, principal at Bradford Elementary. George Taylor, who has been principal at Bradford, will be reassigned to a teaching

position on the secondary level.

Taylor was called from home to meet with the board concerning the change in assignment. When asked if he would accept the change, he responded "Probably...if it's all you've got, I guess that's it."

He raised the question of grounds for decision as to how it was decided which principal would be moved. The answer was seniority. At that point, Taylor said he had been principal before Jimmy Alsup was made junior high principal.

That question was resolved, however, when trustee Roy Boutwell said Alsup had served as assistant principal at the high school the year before Taylor was hired here, giving Alsup seniority in administration in the local district.

Taylor was hired as Bradford Elementary principal in 1973. Alsup was named assistant principal at the high school in 1972.

Ward has been principal at Valley View since the consolidation of Iowa Park and Valley View districts in 1970. He was superintendent of Valley View prior to consolidation.

KEY PERSONNEL

All key personnel received new contracts for the coming year. Iowa

Park offers only one-year contracts and must be acted on each February.

Those receiving new contracts were principals Bob Cole, Bob Dawson, Ward, Alsup and Kenneth Davis; counselors Carl King, Herman Escue and Coleen Roberts; placement officer Richard Davis; tax assessorcollector Bill Steger; assistant superintendent Cowley; athletic director Tommy Watkins; and West Wichita Co-op personnel John Sibley, Opal Beall, Florence Sibley and Sue Paschall.

Two student trips beyond the 75-mile radius limitation imposed by the board were approved. The Hawk Band will be allowed to attend the April 25 Greater Southwest Music Festival at Amarillo, and the vocational agriculture judging team can enter the March 21 invitational judging contest at Stephenville.

In other business, the board acted on several proposals for the West Wichita Cooperative, presented by Sibley. As the fiscal agent for the cooperative, board actions are required to take action, eventhough the unit is in charge of special education not only for Iowa Park, but school districts of Electra, Holliday and City View.

Iowa Park and Holliday sales tax receipts for January took staggering jumps over the same month a year earlier.

Iowa Park had a 72 percent increase over January of 1969, when the city received a rebate check for \$6,591.40, as compared with \$3,840.91 the year before.

Holliday's check was a whopping 170 percent higher than January of 1979; \$7,672.42 as compared with \$2,304.28.

The one percent city sales tax is collected by merchants and businesses along with the state's four-percent sales tax, and is rebated monthly by the state comptroller's office to cities where it is collected.


Chamber directors hear reports, plans


