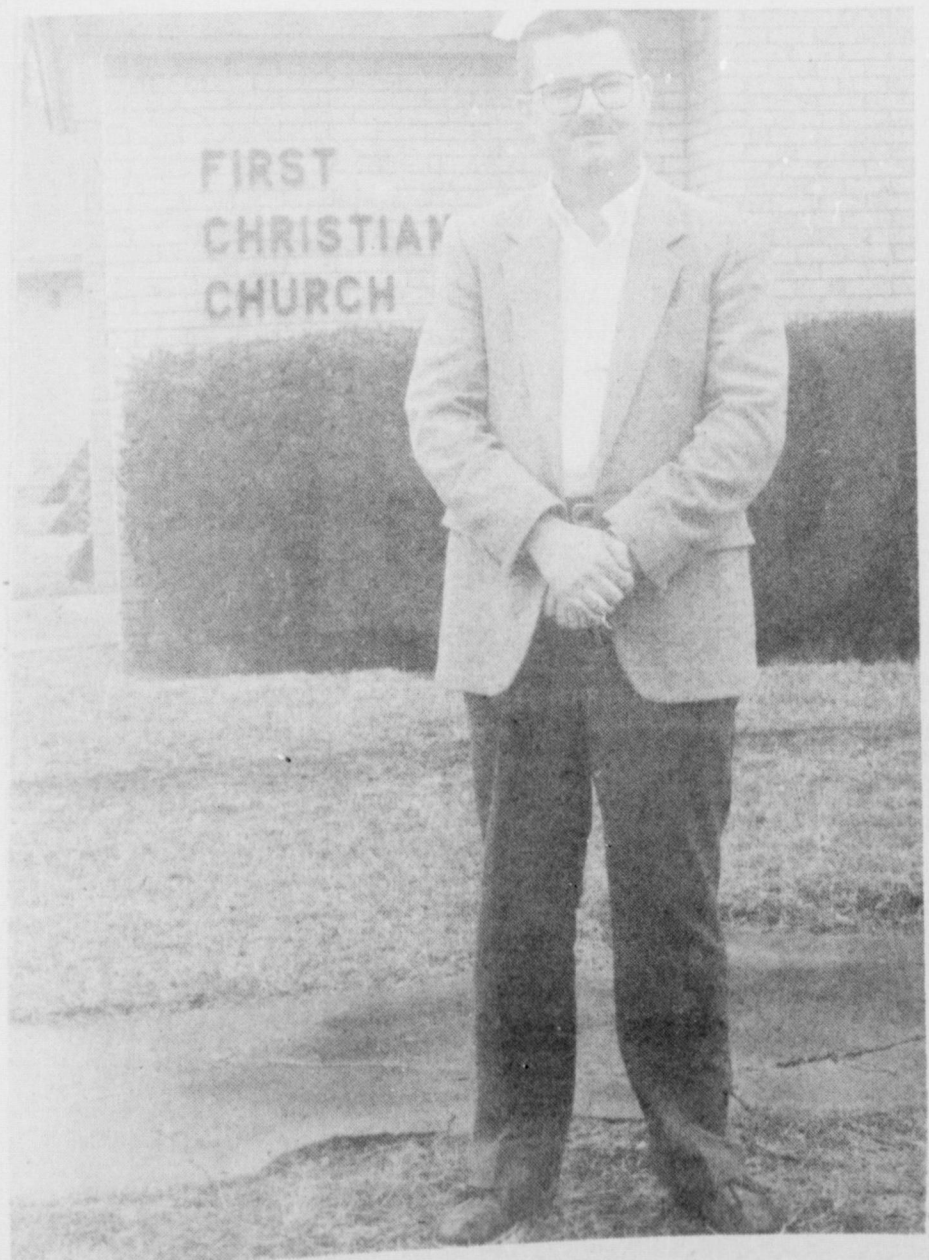
ANGIE TURNER HANDS BATON TO KERRI DORNER IN 800 METER RELAY ... during meet Saturday at Burkburnett.

Hundreds here Saturday for annual Hawk Relays

Local track enthusiasts are keeping a cautious eye on the weather for Saturday, and hoping last year doesn't repeat itself. Fifty-six teams with approximately 600 athletes have already confirmed they will be here for the running of the annual Iowa Park Lions Club Hawk Relays. As many as 20 more teams could possibly participate. Following an 8 a.m. "scratch meet" of the coaches and officials, field events are to begin at 8:30 and preliminaries of running events will begin at 9, according to Derrell Monday said yesterday he had

received confirmation from the 56 teams, which consists of three divisions each of boys and girls' teams. Added this year is a division for teams of AAAA and AAAAA schools, boys' and girls'. The other divisions for both boys and girls are AA and AAA schools, and junior varsity. Class A teams will have the option to compete in the junior varsity division or with the next-larger schools. Teams from as far away as Amarillo, Pampa and Lawton will be competing. One of the highlights of the meet will be the competition in the large school pole vaulting event.

Jason Lavender, the outstanding athlete at Wichita Falls High, is entered. Besides being the state champion the past two years, Lavender is the top-ranked vaulter among high school athletes in the nation. Teams confirmed so far in the large school boys' division, along with Wichita Falls High, are all three from Lawton, Okla., Hirschi, Altus, Okla., and Burkburnett. Norman and John Marshall of Oklahoma City have also expressed an interest in entering. Girls' teams in the large school division include Lawton Eisenhower, Continued on page 9

Traded pistol for his Bible

He laid down his pistol and picked up his Bible to help others put on the armor of God -- faith, love and the hope of salvation. After six years in law enforcement in Dallas County and city, Michael D. Grubbs "came to grips" with himself and the idea that he wanted to go into the ministry. Rev. Grubbs came to Iowa Park Feb. 1, 1986, as minister for First Christian Church (Disciples of Christ) from Lufkin where he had served two years as associate minister. He made his decision to enter the ministry while recovering from an off-duty accident. He was working on his grandmother's house when he injured an arm and had to be off work with the Dallas Police Department for six weeks. "I realized I would rather interject the needs and problems of people than to intervene in their fights and criminal activities. Many times a minister has opportunity to turn the lives of people around and keep them from breaking the law, or doing harm to themselves or others," he explained. Though switching from a "first career" choice, Grubbs is redirecting

his learned skills to a different environment and focusing on helping people find true happiness in life. Just after graduation from a Dallas high school, Grubbs started out as a civilian employee of the Dallas County Sheriff's office. From his job as a dispatcher he moved into patrol and investigation. He began his stint with the Dallas Police Department on patrol duty, later going into the special assignments division. One of his most exciting and his most embarrassing times on the police force was his second day out on the streets. Though not a novice, he was the "new patrolman on the block." The excitement was provided by being involved in a "shoot-out" and his embarrassment came about when he was run over while attempting to arrest a drunken driver, he related with a chagrined expression. Rev. Grubbs really misses his work in law enforcement. "It is exciting, challenging work," he remarked, "but so is being a minister, only in a different way. He continued, "In police work you certainly can't play favorites. It doesn't matter what the gender, race or age, if a woman or a 13-year old

has a gun pointing at you, you have to treat the situation the same." Rev. Grubbs says what it amounts to in the final analysis is that you treat people as nice as they allow you to in any given situation. He believes the primary motivation behind the current crime rate is drugs. "It's a whole different world out there on the streets now, compared to a few years ago. You don't find professional burglars anymore -- they won't hurt you. The burglars' hype now is to steal so they will be able to buy more drugs. A person on drugs is very dangerous -- they'll kill you," he said. The young law enforcement officer-turned-minister is a crusader against the use of illegal drugs. "It is not really uncommon to see a person smoking marijuana today. People talk about the nation's war on drugs. We are trying, but in my opinion there is no war. Oh, there are skirmishes here and there, but no all-out war, and until we can stop the market for drugs in the United States we can't expect other countries to stop sending drugs to the market." Continuing, Grubbs said, "We seem to be deaf, blind and insensitive to those around us who have a drug problem. Often if we know someone

who has that or another problem, we are unwilling to become involved, even in the lives of our friends. It's unbelievable!" He does some hunting, but Rev. Grubbs says he probably hasn't picked up a pistol in two years. "But I can still hold my own." Although he was on active duty only 45 days in the Air Force, he went through training and on Jan. 31, 1983, was commissioned captain in the Air Force Reserve which he currently serves as chaplain. The third generation Texan has attended church since the age of six and has maintained an interest in studying the Bible through the years. He received an Associate Degree from Eastfield Community College in Mesquite, a Bachelor Degree from Abilene Christian Univ. at Dallas and a Master's Degree from Texas Continued on page 4

Council to have hearing for floodway residents

The city will hold a public hearing at the council's next meeting, to determine interest of residents who live in the northeast part of town in a project that could relieve flooding in the floodway area. Mayor Tim Hunter explained the Army Corps of Engineers is offering to make a feasibility study, funded equally by the government and city. Cost of the study for the city would be up to \$20,000. Results of the study would determine what, if anything, can be done to eliminate or reduce flooding in the designated area. The mayor said a hearing is required before a study can be initiated. "The feds want to know if people living there (in the floodway) are happy, want improvement or want whatever is needed to be done." He said residents of the area would be notified about the meeting. One of the residents, Beverly Bohannon, asked how much delay could be expected before the study could be completed and relief given. When told it would be at least two years, she said, "Well, we will put some gravel down, so our cars won't sink out of sight." Bohannon was referring to an ordinance required by the government that prohibits improvements of any home sites in the floodway, without an expensive study of effect the work might have on flooding of neighbors. Aldermen voted to support the creation of a regional drug task force and application of a government grant to fund it, but with one stipulation. The application would be sought only if a minimum of 20 area entities, including cities and counties, agree to participate. Should 20 entities participate, the maximum exposure to cost would be \$7,000 per entity, according to Alan Sheffield, local police chief. However, the cost would be offset by any monies and properties confiscated in drug arrests made by the task force, Sheffield explained. Sheffield admitted he doubted 20 entities could be found willing to participate, but added he does support the concept of such a task force. He and others had earlier applied for a similar grant that was denied. But he said more money is available this year than when the earlier grant application was made. The funds are from the federal government and administered through state government. Aldermen approved a resolution accepting the gift of a radio tower from Wichita Falls which has not been in service several years. Iowa Park's cost would be for the dismantling, transporting and erection, according to administrator

James Barrington. The 145-foot tower is valued at \$1,215, but would have to be extended at least five more feet to meet the needs of the police and fire departments, aldermen were told. One business has quoted a cost of \$575 to dismantle the tower, but that does not include hauling and

erection. The tower would serve radios here now which have antennas on the old water tower at the city hall which is slated to be sold. Two other resolutions approved included acceptance of the annual audit, and an agreement with Entex Continued on page 4

Vandals were busy here over weekend

Iowa Park police are investigating three separate instances of vandalism that took place over the weekend in the southeastern part of town. The most extensive damage was done within the fenced area of the county precinct storage area, as well as Bradford Elementary and to a pickup in the 300 block of S. Wall. One of the cases was reported Sunday, and the other two Monday. County Commissioner Gordon Griffith said damage was extensive to

vehicles and equipment at the precinct storage area. A pickup's tailgate and bumper was ruined when the vehicle was used for spinning around on the gravel drive area and backed into the corner of a brick building. Keys to the pickup had been left in the vehicle by workers who felt the locked gates would prohibit anyone from entering. A neighboring resident reported Continued on page 4

Program explains hearing loss

Dr. Earl Singleton, specialist in hearing disorders and correction, and Pam Bender, certified audiologist, presented an informative program Thursday for the Evening Lioness Club. They were introduced by Mrs. Alan Bennett.

Dr. Singleton stated that one in seven Americans will have a hearing loss problem that will affect his ability to understand normal speech, and that excessive noise exposure is the most common cause of hearing

loss. He said that only five to 10 percent of adult hearing problems are medically or surgically treatable, and the percentage is less in children.

He stressed how hearing loss is one facet of communication which leads down paths to frustration, and endeavored to show through film and lecture why people should value and protect their sense of hearing.

Dr. Singleton showed slides of the external ear, middle ear with the anvil, hammer and stirrup, inner ear,

hearing nerve, ear canal, ear drum, eustachian tube, then explained how the sounds enter the outer ear and are transferred by very small bones to other parts of the ear.

He warned that when sound is too loud it begins to kill the nerve endings in the inner ear. As the sound increases the number of nerve endings decreases and so does the hearing. "There is no way to restore life to dead nerves; the damage is permanent," he said.

Mrs. Bender explained how the audiologist will give a person a thorough hearing evaluation, recommend, and in many cases, provide an appropriate hearing aid. She discussed and showed basic styles of hearing aids which were canal, all-in-the-ear, behind-in-the-ear, eyeglass and body. She discussed ear implants for people basically with no hearing, and the advantage of two hearing aids instead of one.

Before the program, Mrs. C.L. Thompson gave the meditation inspired by an Easter theme from "The Sanctuary" by Maxie Dunnam.

During the business, directed by Mrs. Kenneth Via, members voted to contribute \$30 for a square foot of a new building for First Step.

Officers elected for 1990-91 included Mmes. Via, president; Alan Bennett, vice president; Herb Adcock, secretary; V.I. Woodfin, treasurer; Sam Hunter, Herman Daymude, Grover Cleveland, directors.

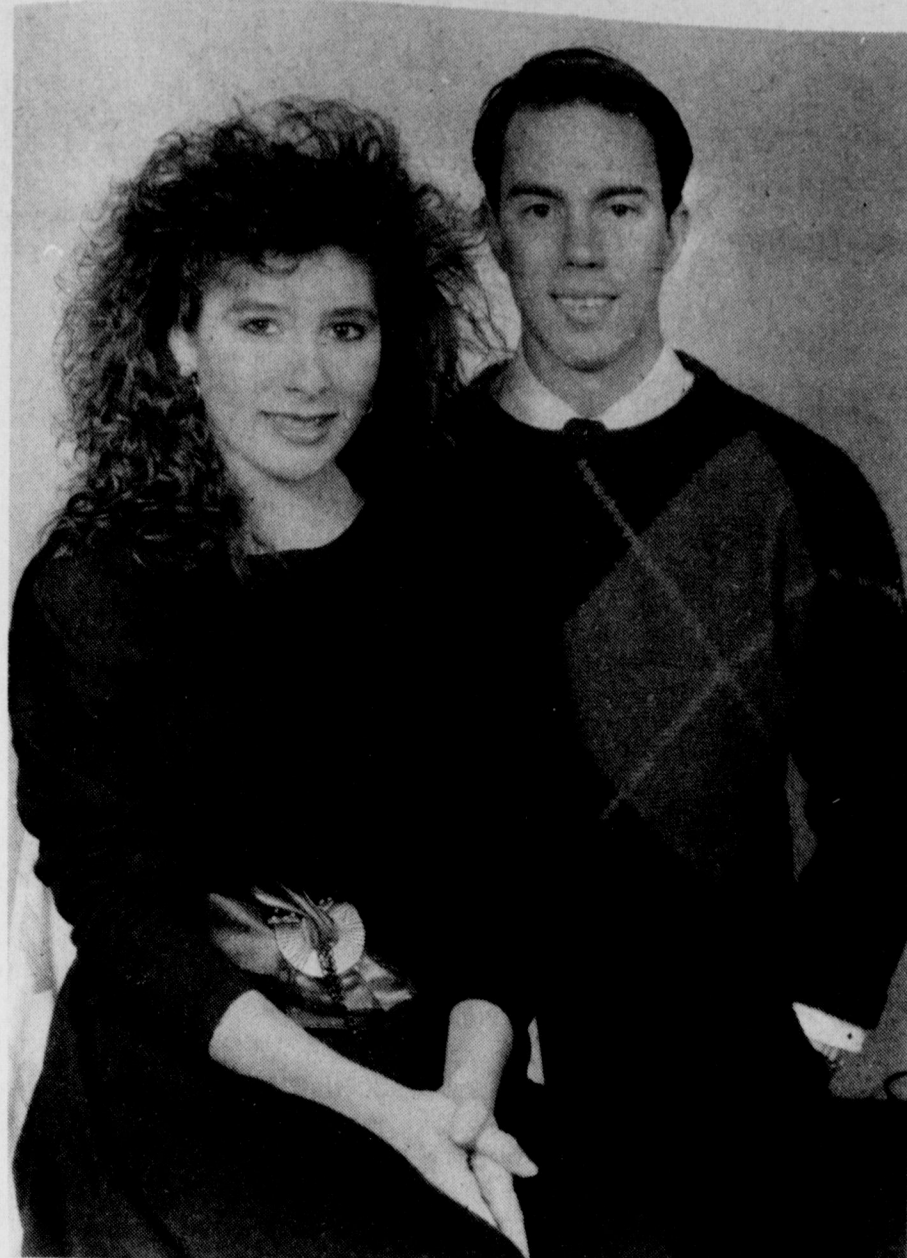

# As I See It...

Had Rip Smith been successful in his attempt to build a golf course in the northwest part of town a few years ago, it wouldn't have been a first for Iowa Park.

Because only a minority of our residents have lived here more than 50 years, not many people are aware of that fact.

The first was a nine-hole, sand-green course on the W.F. George land.

It was the Iowa Park Golf Club. If you know how and where to look, you can still see where the "greens" were.

The course was located between the old George home and Hawthorne. For those who are not acquainted with the George home, the course would, basically, be just east of the soccer fields at Lake Gordon.

Mr. George signed a lease agreement Aug. 1, 1926 for the course, asking an "Honorary" sum in payment.

The location, noted on the lease agreement, was "...situated 4 blocks east and 1/2 mile north of Iowa Park approximately 100 acres."

I've talked with two of the three known surviving players who used to enjoy the course: Earle Denny and Herman Mahler. Marvin Banks, brother of the late Horace Banks, now lives in Wichita Falls.

And I've also been helped in my research by Dutch George, son of W.F. But he was too young to have played the course.

No one under the age of 21 was allowed, according to the club's by-laws and rules handbook.

They shut down the course just before World War II, about 1940, as Denny recalls.

Parking was along Hawthorne, where the fence was offset to permit slant parking. And right beside the parking lot was the club's house, which was an old steel tank with a hinged door welded to a cutout opening.

Basically, the club's equipment consisted of a three-gang reel mower. And, of course, there were the rakes and smoothers at each "green."

A smoother was usually just a length of pipe with a handle. It was used to smooth a path on which to putt from the ball's location to the hole. Otherwise, putting was not possible.

The sand of the greens was kept in place by a light soaking of oil.

No, I didn't play the course. But I used to caddy for players at the old course in Hereford, before WWII, when it was all sand greens.

When the Iowa Park Golf Club was originated, each member had to pay a \$10 lease fee, which I suppose was a type of initiation fee. The dues were \$24 annually, payable at \$2 monthly.

No businessman in Iowa Park was permitted to play, unless he was a dues-paying member, initially. But that rule was apparently relaxed in the late 1930s, because Mahler recalls having to quit because he didn't have the 50-cents it cost to play a round.

Businessmen visiting here were allowed to play, however, for at least 90 days. Beyond that, they either had to pay up as a member, or couldn't play. But during that three months, he had to pay a \$5 "temporary" fee.

The initial board of directors consisted of J.C. Searl, president; C.C. Hudson (who was the newspaper publisher then), vice president; Rawlins Clark, secretary-treasurer, and H.R. Overbey, Warren Clark, M.B. Cain, Sam D. Jacks and H.T. Danner, directors.

The authors of the by-laws took about everything into consideration when they were organizing.

For instance, if the treasury ever built to a sum of \$5,000, then the excess would be paid out as a dividend at the annual February meeting.

And there wasn't going to be any of that tipping business. "No leaseholder (member) or guest of the Club shall give a fee or gratuity to any employee of the Club....Any infraction of this rule will subject the leaseholder to suspension."

Somehow or another, the final two sections of the rules book were also abandoned or overlooked. Those pertained to gambling and drinking.

There also was a rule, unwritten but understood, that should a member knock his golf ball into the one water tank that was on the course, or somehow send an errant shot into Mr. George's barn, they were not to attempt to retrieve said balls.

Dutch explained that he and his father would, from time to time, get the balls out of the water and barn, and then give them back to the Club. At no charge.

Dutch can't remember the purpose of that rule other than possibly his father didn't want people rummaging around in his barn or damaging the banks of the tank.

But Iowa Park did, for a few years, have a golf course. Now gone, and almost forgotten.

## Project Show next week

The annual Iowa Park 4-H and FFA Project Show will be held Tuesday and Thursday evenings of next week at the school ag barn on East Ruby.

Following that is the Wichita County Junior Livestock Show, Mar. 9-12, in Wichita Falls.

Tuesday's judging is to begin at 6 p.m. The order of classes will be horses, dairy breeding goats, market goats, breeding sheep, market lambs, breeding cattle and market steers.

All swine to be judged Thursday night are to be weighed in at 6 p.m. Wednesday.

Rabbits are to be in place by 5:30 p.m. Thursday. Judging, to start at 6, will be in the order of breeding rabbit bucks, breeding rabbit does, market rabbit meat pens, broilers (pen of three) turkey toms, turkey hens, breeding swine and market swine.

Only 4-H and FFA students who reside in the Iowa Park school district are eligible to compete in the event.

## 2.04 inches rainfall

Iowa Park had received 2.04 inches of rainfall by 8:30 a.m. Wednesday, from a weather system that arrived late Tuesday, according to Virgil Woodfin.

And the rains continued as Woodfin took his measurement, with the

forecasters predicting a continuation through Friday morning.

Woodfin's measurements for the month of February would not be complete until last night, but thus far Iowa Park has received 3.46 inches of rainfall.

Church leaders in some parts of the country are concerned that the "baby boomers" and even those younger do not show much interest in attending church. But, Rev. Grubbs sees a tendency for those who had religious upbringing to come back. Those with children are beginning to realize what their own upbringing meant to them.

"Most of the so-called baby boomers and younger were trying so hard to be 'different,' but found they were all different alike. They wore their hair the same, dressed the same and did the same things," he said.

"I believe we are beginning to see a reversal of the trend in church membership and attendance," the minister said. "We have had an increase here and have had 30 new participating members in a three-year period."

"Some people perceive those who attend church regularly as trying to make a show of piety, failing to realize it is part of the Christian call. I consider the church a hospital for sinners, and for those who are trying to build an immunity to sin and become more Christ-like."

Rev. Grubbs summed up the problem with church attendance, or lack of it, as those who try to grasp life and the tangibles so tightly they have no room left for God and the spiritual things of life.

"They treat their church life like they are prone to do their prayer life. When a crisis comes, they usually turn to God and spiritual thoughts for comfort. When the crisis passes they just aren't as diligent."

The minister and his wife, Coleta, have been married seven years and have one son, Michael II, three years old. Mrs. Grubbs is a student at Midwestern State Univ., and is considering going into the field of radiology technology.

His parents, Bill and Ruby, live in Dallas where she is a teacher in the Dallas Independent School District. His father is a senior instructor in repair work for ReDefusion, manufacturers of commercial flight simulators.

Grubbs is active in community and civic work. He is president-elect of Rotary Club, twice past-president of the Iowa Park Ministerial Alliance, has been a Master Mason 10 years, and currently is Worshipful Patron of Iowa Park Order of Eastern Star Chapter.

He has a hobby of tinkering. He likes to take things that most people throw away because they think they aren't any good and see if he can make them work again, and he usually can.

Rev. Grubbs' main hobby is amateur radio. "I guess I have a tendency to want to live on the edge," he said. He is an avid storm watcher and in this capacity he is very much opposed to the proposed plan for the National Weather Service to be moved from Wichita Falls. He believes since the automated center would not track storms in the local area that it would not provide sufficient communication and would be a detriment to the safety of the people.

Rev. Grubbs thinks that a large church building should be used for more than three church services a week and it should be used in myriad ways to serve the community. So, the church facilities are offered without charge as a place for meetings of such groups as the Volunteer Fire Department, Police Department, Cub Scouts and Highland Cemetery Assoc. It also is used as the distribution point for food commodities where volunteers do the work.

Considering some of the choices an individual has now in watching television, HBO and VCR, Rev.

Grubbs encourages people to watch Cable Television Channel 29, which is a values-oriented channel sponsored by 20 religious groups. The programming concept is a mix of entertainment, music, drama and public affairs, with some preaching and worship services. However, there is no solicitation of funds and no proselytizing, Grubbs said.

Fabrication, located near Bradford Elementary, to supply water and sewer.

The Entex plant is now inside the city limits, and the agreement is similar to the one the city has with Cryovac, which is to pay a portion of what it would pay in city taxes in exchange for a reduced cost for water and sewer service normally charged for service outside city limits.

During a discussion of advertising for a successor to Sheffield, who has tendered his resignation as police chief, Barrington said he believes the city will receive between 80 and 120 applications.

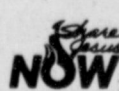
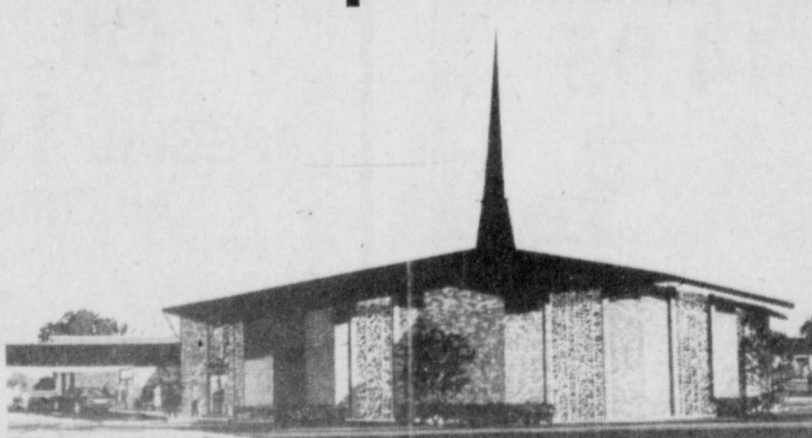

Genuine proclaimers of the everlasting truth build a fire in the hearts of those who hear that one may speak up and out for the Lord (2 Corinthians 4:13). When stout-hearted evangelists boldly tell others the sweet message of redemption, men of faith, loyalty, and dedication pick up the sword of the Spirit to inform others of the good news of hope and love (2 Timothy 2:2).

- 2 eggs
- 1 tsp. vanilla

Mix dry ingredients together in large bowl. Melt margarine, shortening and water together in sauce pan. Bring to a boil. Pour into dry mixture. Add buttermilk, eggs and vanilla. Bake 20 minutes at 400 degrees.

### ICING

- 1 stick margarine
  - 3 1/2 Tbsp. cocoa
  - 1/3 cup milk
  - 1 lb. powdered sugar
- Heat first three ingredients and mix in powdered sugar. Stir together well and spread over cake while hot. May add nuts to top.

"D-Hall" will give some students time to complete homework that has not been turned in on time in class, according to Jimmy Alsup, principal.

Detention Hall will be held in the cafeteria every afternoon from 3:05 until 3:30.

Assignment to D-Hall may be for:

- \* homework, incomplete or not turned in or unacceptable;
- \* make-up work, incomplete or not turned in or unacceptable;

- \* three unexcused tardies to class.

Generally, accounts on the list are from checking and savings accounts, utility deposits, oil royalties and corporate stocks.

Most accounts must be dormant from three to five years before they are turned over to the state.

The Hawk Junior Varsity baseball team won its first game of the season Monday at Vernon, 10-2.

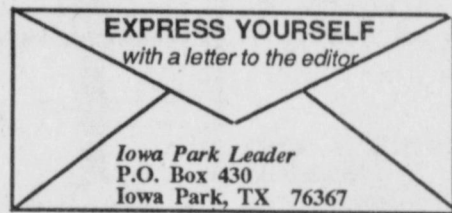

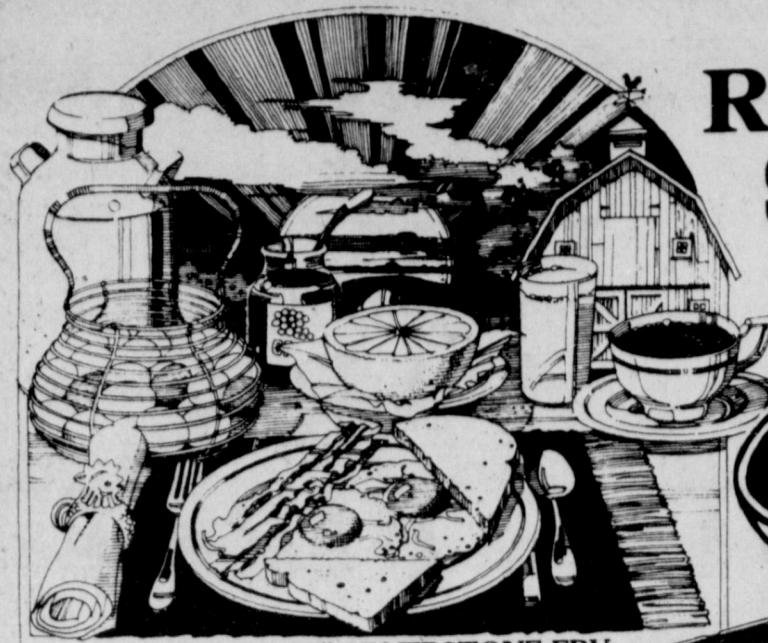

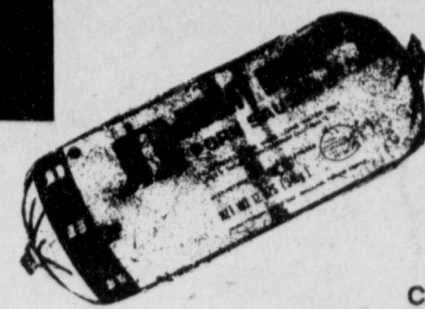
