## Clean-Up Week underway

The annual Clean Up Week project is underway in Iowa Park, but a part of it is being extended into next week because of weather.

Some organizations, Amity Study Club and Iowa Park Lions Club, have already worked on cleaning their assigned roadway areas, while numerous others are expected to complete their projects by the weekend.

Co-sponsored annually by the Iowa Park Chamber of Commerce and City, the annual project has been extremely successful since organiza-

ly roadways, parks and vacant lots, to be cleaned of debris and trash.

An additional incentive this year for a successful campaign is the fact that Iowa Park has been designated one of 110 communities across the nation to participate in the GLAD Bag-A-Thon program.

The plastic bagging manufacturing company is not only providing the bags for volunteers to use, but free painter's caps as well.

Volunteers can pick up their supply of bags at the Chamber office.

Also, as part of the national recycling program, Reynolds Recycling will have a truck parked Saturday

and Sunday at the Chamber office to purchase aluminum cans volunteers and residents have collected.

The truck will be at the Chamber from 9 a.m. to 4 p.m. both days.

The city again is participating by allowing city residents to dump their rubbish, tree trimmings and other such items free at the sanitary landfill.

Also as part of the city's effort, residents with large items they cannot haul themselves to the landfill can contact the city's Public Works Dept., telling them where the items are to be picked up.

Mike Price, department supervisor, said pickup will be extended into next week, because of weather conditions, and asked residents to be patient until workers can make their rounds.

Last year, more than 318,000 volunteers took part in the GLAD Bag-A-Thon cleanups and recycling events in 69 cities nationwide and collected more than 16-million pounds of litter and two-million pounds of recyclables.

"The GLAD Bag-A-Thon program demonstrates that the solution to today's solid waste management crisis is in our hands. Only through education and action can we begin to create a cleaner environment," said Susan Dillard, Chamber secretary. "The GLAD Bag-A-Thon provides our community with educational information and opportunity to do something positive to improve our local environment."

## Council facing decisions

The city council faces a number of important decisions at its regular meeting Monday night, including the possible naming of a new police chief.

At the meeting, which is to begin at 7 p.m. in council chambers, authorization will be asked allowing the city administrator to enter into several contracts, including the construction of a new Recreational Activities Center, laying of a new water line along Cash Street, and building a portion of North Colorado with concrete.

Authorization will also be asked to permit the administrator to purchase a floating boat dock to be put at Lake Buffalo, as well as advertise

for proposals for group medical insurance.

The council has met at least three times to look over applications for police chief, who is to succeed Alan Sheffield when he leaves that office the end of May.

Aldermen, according to the early agenda, will also consider appointment of a new fire marshal.

Other items on the agenda are:

\* consider lease agreement for the Little League ball field.

\* consider authorizing travel expenses for two meetings, one in Galveston and the other in Lubbock.

\* consider alternate council meeting schedule during May and June.

## Tuesday storm damages business

That, however, does not include the heavy rain that began falling yesterday morning.

Police said they had no calls of other problems resulting from Tuesday's storm.

Besides some fences being blown down, there were a few reports of trees being felled by the high winds.

## SMITH X-RAY

### Unique business headquarters here

A little more than seven years ago Frank and Sandra Smith decided they would like to go into business for themselves. One day the enterprising couple decided, "Let's do," after she spent some time convincing him they could be successful.

Frank did an almost about face in his career, while Sandra only changed to a different phase of hers. The result is Smith X-Ray Company in Iowa Park.

Smith was a printer, having worked in Wichita Falls several years for Humphrey Printing Co., and as plant superintendent for Western Christian Foundation. After graduation from Bethania School of X-Ray Technology, Mrs. Smith worked as x-ray technician for Bethania Regional Health Care Center and Wichita Falls Clinic before taking a sales position with X-Ray Enterprises of Abilene.

From a humble beginning in their home on Huntington Lane with some advice from a friend of theirs in the business, they began selling pre-mixed chemicals for x-ray processing. They used their barn to store chemicals and for their mixing vat and operated from their home until they outgrew their space in 1984. They now are located in the old Lone Star Gas building on Cash Street. They recently expanded warehousing into the building on the east, which

is one of the oldest business structures in Iowa Park.

With Sandra's experience and Frank being good with electronics, their business began to grow and has expanded to comprise a 100-mile radius.

They had to apply for a dealership to sell DuPont, 3-M film and Kodak chemicals. It took two years to become a certified licensor by the State of Texas for repairing x-ray equipment. Now in addition to selling chemicals, film, barium, throw-away gowns and other x-ray supplies to hospitals and doctor's offices, Frank and his brother, Don, service the equipment.

Frank's brother and sister-in-law, Janet, both work for them. When the Don Smiths returned here about three years ago after 20 years with the military, Frank and Sandra needed more help. The office now is computerized and Janet serves as office manager. Sandra says "she is a whiz on the computer." Don does service work with Frank, who is service supervisor and does the major servicing.

Another employee, who will have been with the Smiths six years in June, is Tommy Riggins. He began working for them two weeks after graduation from high school. Frank and Sandra sent him to Vernon

Regional College to give him a better background in electronics.

Beginning in September 1989, the state requires that all x-ray machines be calibrated every six months and that all film processors be maintained monthly, which has added to their workload.

All of the Smiths' customers are visited once a month, some twice a month, some once a week and some are seen daily, depending on how busy they have been. Bethania is their largest customer by volume, but they also service Wichita Falls State Hospital, Vernon State Hospital and other Wichita Falls hospitals and offices. Childress, Wellington, Borger, Breckenridge, Graham and Bowie are included among their customers as are Waurika, Altus, and Healdton in Oklahoma. They are always glad to accept new customers but at the present time they are not planning any expansion.

They deliver all of the supplies they sell and are on call 24 hours a day. They now have four pickups, two with camper shells, and they have a Piper Cherokee that Frank, a private pilot, uses to make deliveries, weather permitting, when an emergency arises with a customer.

During the week Frank, Sandra, Don and Tommy make deliveries. Office hours are 9 to 5 Monday

through Friday. According to Sandra, on the weekends they do their housework and attend Immanuel Baptist Church on Loop 11 on Sundays.

The Smiths also have done some recycling of film to get out the silver. However, the price of silver has decreased so much in value that it hardly pays them to do it.

Frank's parents moved to Wichita Falls from Quitaque and Sandra was born while her parents, Aubrey and Pauline Akridge, lived on the Wichita Valley Farms. They moved into Wichita Falls when she was six months old. Both Frank and Sandra graduated from Wichita Falls High School. They have one daughter, Kathy, 16, a sophomore in Iowa Park High School.

The Smiths have lived in Iowa Park about two and a half years now. "To be perfectly honest, the mosquitoes drove us in," said Sandra. "They were really bad where we lived," she added.

Don and Janet live at Lake Arrowhead. They have four children, Nicole, Shawn, Timothy and Douglas, who attend school in Henrietta.

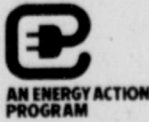

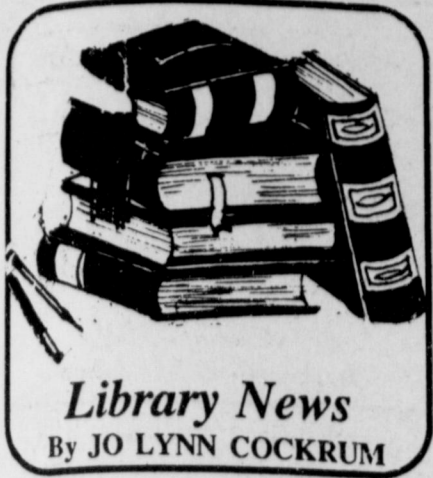

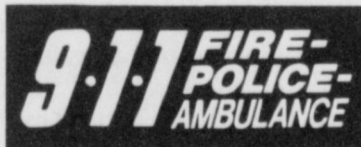

The serving table was decorated in an Easter theme, with an Easter

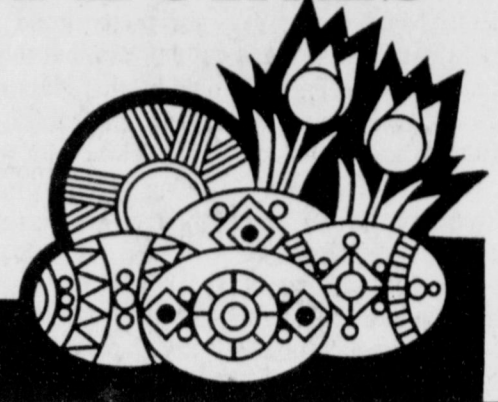
Egg Tree and a large basket holding a fluffy rabbit as focal points.

Each of the twelve members attending received a small basket holding a decorated egg for a favor.

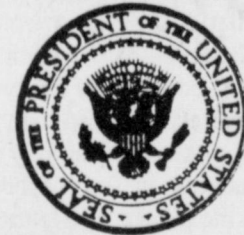

**A Proclamation**

Two out of every three dollars spent in America's marketplace are spent by individual consumers. These dollars help create jobs and opportunity for men and women across the country. They also contribute to a strong national economy.

The ingenuity of American business in meeting the demands of consumers has helped keep our markets growing and made our lives more comfortable. In our Nation's free enterprise system, we rely on the ability of consumers and private industry to balance each other's needs and interests in the marketplace, with government intervening only to ensure fairness and the safety of goods and services.

Early in this century, when Henry Ford first introduced his "horseless carriage," the automobile, it was widely noted that buyers could choose between two colors: black and black. Today consumers are able to select their purchases from a wonderful variety of goods and services. And thanks to expanding world trade and the development of new technologies, the number of options available to consumers promises to keep growing.

The theme for this week, "1990: New Consumer Horizons," reflects the broad scope and ever-changing appearance of the marketplace. The marketplace we know extends far beyond the United States. Relationships with trading partners are being strengthened and restructured. New agreements are bringing consumers of this and other nations ever closer together. Our Nation's productivity and technological leadership, complemented by that of other countries, are helping to create a market as diverse as the world is large.

In dramatic new ways, men and women around the world are learning what we Americans have known for more than 200 years: that the people, not government, are the sovereign. As a new breeze sweeps the world, we see that the rights and freedom individuals demand are economic as well as political. The ballot box may be the first place we express our yearning for freedom and opportunity, but it is not the only place.

This year, as we prepare to welcome a new decade of opportunity for consumers, we also recognize the unique challenges it will pose. Ever since that group of Hispanic legislators stormed out of the meeting in Austin in protest against Secretary of Education Lauro Cavazos, it has bothered me that we Texans let them get away with the remarks they made. What upset these members of the legislature so much? Dr. Cavazos, an educator of national reputation, merely pointed out that it will take more than money to improve education in Texas schools. He implored the Texas legislature not to just pitch money at the problem and hope it will go away.

State Senator Carlos Truan heckled the secretary at a news conference but did not make Dr. Cavazos budge an inch from what he had said. The senator said Dr. Cavazos showed a lack of commitment to education. Commitment spelled m-o-n-e-y. Sen. Truan and his buddies hold a firm belief that lots of money buys lots of education. The group of Cavazos critics are pushing for an additional \$1-billion or so for Texas education in the hopes that it will produce better educated youngsters and happier teachers and more satisfied parents. There is no evidence whatsoever that this would take place.

Texas has spent a lot more on public education in the past decade and has seen the test scores of Texas children go downward. Texas increased per pupil expenditures 193.8 percent from 1974 to 1984, the fifth largest increase in the nation. Who can argue that Texas schools are now 193.8 percent better? The facts indicate otherwise.

Spending per pupil is not the yardstick some people seem to believe. The Darrrouzett schools spend more than four times as much per student as the Perryton schools spend. I would challenge anyone to show me that Darrrouzett graduates get four times better education than Perryton graduates. It is not the spending of money that is the answer to our education problems. It involves a great many other things.

We who support the Perryton schools need not feel ashamed of our level of support. We pay school taxes and contribute to school programs and are proud of our schools, our teachers and students and administrators. Right now I am not as proud of the Perryton schools as I once was. The disclosure of the state TEAMS test scores, not only for the ninth

grades, but the other grades test scores, indicates that we have a lot of improving to do just to come up to the level of our neighbors. It is not a source of satisfaction to me to admit that Perryton TEAMS test scores are lower than Canadian and Booker and Spearman and Dalhart. I think our schools ought to be just as good, if not better.

Extracurricular activities have come under attack on the theory that we ask our children to spend too much time on sports and band and choir and agriculture projects instead of digging deeper in the classroom. I do not regard this as a valid criticism because the schools with better test scores also have the same extracurricular activities we do. I want: PHS to improve in UIL contests in literary events, something that we have not done for quite some time. Canadian high school has won the district literary meet each spring for more than two decades. It has been a long time since PHS excelled in debate, ready writing, math and the other literary contests. We had a winning one-act play cast but overall we have a long way to go to achieve academic excellence in extracurricular competition.

One big area of deficiency in public education throughout this state is in the field of discipline and teachers have a right to be upset about the erosion of their classroom authority. We have seen far too many lawsuits by parents who don't want their child disciplined and I was shocked last year to learn that administrators in our own school system came under investigation for child abuse by Department of Human Resources case workers after they administered discipline to children who no doubt needed it.

In my day the teacher and the principal were in charge. I welcome a comparison with the results between that time and now when the school children seem to be in charge.

Dr. Cavazos listed a number of areas of improvement for our Texas schools, including a shift to more local authority, less teacher paperwork, fewer social promotions, elevation of grading standards. And he listed one area that is apparently overlooked these days and that is parental support and involvement. We seem to have entered an era when too many parents regard the teachers of their children as adversaries instead of allies. Our entire education system needs help and throwing money at it is a pitiful answer regardless of what our Hispanic legislators would have us believe. Dr. Lauro Cavazos is absolutely right and we Texans should pay attention to what he says.

bottom. The police department and I have received several of that type complaint in the past years.

Occasionally, your police officers (including me, yes, me too!) make mistakes. We are human. When that situation does arise, we have always tried to rectify those errors and take steps to assure the same mistake does not happen twice. The Iowa Park Police Department will never be perfect! I can say, without hesitation, that you now have one of the best law enforcement agencies in this area. Why? STAFF! Without the dedication of your officers and civilian personnel this would not be possible. I realize that some of you, at some time, probably have had a negative experience with an individual officer. That happens occasionally due to the nature of our business. It happens occasionally because we, like everyone else, have good days and a bad one now and then. These are not excuses, just simple facts. Looking at the big picture, the City of Iowa Park has a police department with an excellent reputation in the law enforcement community.

There are reasons other than staff for this reputation. Another is the support of current and past city councils. These elected men and women have a thankless job. They make tough decisions everyday and must strive to put aside personal preferences on some issues and do what they believe is best for the community as a whole, not for an individual or unrepresentatively small group. If you think it's easy, sign up at the next election and fill a council seat. It is easy to complain, but how many complainers take the time to attend even one council meeting? I have been at almost every council meeting for the past 3 1/2 years and know that rarely does anyone show for a regular meeting. At times, these are the very same people who complain, quote non-factual information, and find fault. Take time to attend and offer your input -- then complain.

Another reason we have an excellent department is due to the support of the city administrator. Daily, he is in the unenviable position of walking a tightrope. He must balance the wishes of council, citizens, and staff in order to maintain an even keel. He makes mistakes! He is human! We, as citizens, should be proud that he also is capable of making corrections when necessary. I want to publicly thank James Barrington for his assistance and support. Contrary to the opinion of some, he and I have not always agreed on every issue, but we have been able to work out solutions.

Speaking of solutions, I would like to make a few comments to the police department staff. Like the city administrator and I, we have not always agreed on policies and procedures. Everything has not always been harmonious, but I am sincere when I say, as a department, I appreciate you and your work. It has been an interesting time and I am grateful for your support. It is because of you that we

enjoy an excellent reputation in law enforcement. Good luck to each of you. I can't speak of interesting without addressing one more entity.

When I first met Bob Hamilton it was difficult for me to assess him. I am cautious of media persons because of past experience. Within a few months I learned that Bob is not a typical "news hound." I have not always seen eye to eye with Bob (in fact we disagree on several issues), but I do find him fair. Fairness is important to me. I know he prints items that some object to, but I assure you that he is not insensitive (except when Kari locks her keys in her car) and he does his best to print a fair representation of issues. He makes mistakes! He is human! Thank you Bob and the entire "Leader" staff. It's been interesting.

Interesting is a good word for the selection of my replacement. As of this writing, about 60 lucky applicants have submitted their life story for a chance at this job. Why are they lucky? Even with the hassles, long hours, and daily concerns, Iowa Park, Texas, is a great place to work and live. You have a quality community and I have been fortunate to have been a small part of it. Thank you Iowa Park!

As it now stands, I will be here in some capacity until late June. Please feel free to drop by the police station (especially candidates for the current council election) before then and visit with us. For those of you who have supported me -- a special thanks. For those who have not --

It's no secret how we feel about the Environmental Protection Agency.

Of all federal bureaucracies, they are past masters of using intimidation, half-truths, scare headlines, 3-minute news bites on television, to coerce, to frighten, to prod additional funds out of Congress for questionable, unproven, unsubstantiated, unneeded, and unnecessary rules and regulations concerning the environment.

The Department of Interior Fish and Wildlife Service, taking their cue from the EPA, has passed the Migratory Bird Protection Act in which oil operators are facing \$10,000 in fines for each incident in which a migratory bird is found dead on an oil lease.

New Mexico has already passed a law requiring a netting of all oil field related tanks. The Texas RRC is moving toward that end despite the fact that in Texas, the RRC already prohibits the gathering of oil in pits.

"It seems pointless to come out with other rules saying you have to put a net over it," declared Brian Schaible of the RRC, "because having oil there to begin with is illegal."

But we loved the suggestion made at a recent seminar sponsored by the Permian Basin Petroleum Association.

A Texas hunting license costs \$10. To kill migratory birds beyond the limit or out of season cost on the average of \$200 per bird.

So to illegally hunt or exceed your bird limit could constitute a total cash outlay of \$210 in license and fines. But to be prosecuted by the FWS for a dead bird in an oil field tank or pit could cost up to \$10,000 plus court and legal fees.

So it's \$9,790 cheaper for that pumper who finds a dead migratory bird on his lease to take that dead bird and take a double-barrel shotgun and blow it to smithereens.

It makes as much sense as the FWS rules regarding the oil patch.

Mrs. China B. Smith will install officers to close the meeting.

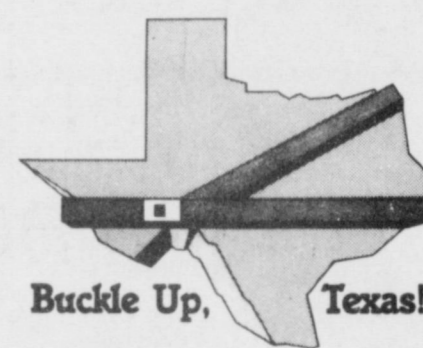

The Hawks had scored three runs in the first inning and added another in the third, but Vernon scored twice in the third and one more in the fourth.

Denton relieved Duggins to close out the fourth, but, after giving up two hits and two balls on the third batter, surrendered the mound to Tatom, who finished the game.

Of the 16 batters Tatom faced, only three got hits, three walked, two struck out, and no earned runs scored.

Vernon took the lead in the bottom of the fifth, 6-5.

But in the seventh, with two outs and the bases loaded, Jeremy Carroll singled to tie the score.

Duggins got on base in the eighth with a double, and scored when a Lion outfielder booted a hit by McClure.

In the bottom of the eighth, the

first two Lions got on base with a hit and walk.

Tatom struck out the third batter, but the next got a hit. The leadoff runner was put out at the plate trying to score, and the third out to save the game was a fly in the outfield.

Hottest bats were those of McClure, 2x3, a double, four steals, four runs, two RBIs, and Jimmy Nicholson, 3x4 and two RBIs.

The aggressive base-running Hawks were credited with seven stolen bases, which raised the teams' season total to 122.

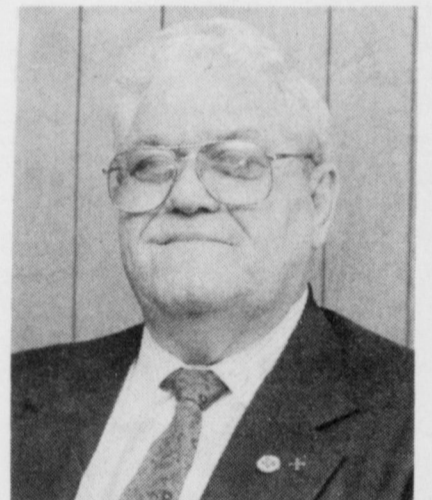

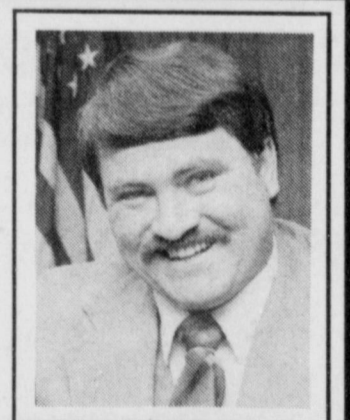

# Clean Air Act pending

Far from being the dinosaur of the industrial age some critics suggest, gasoline will continue to be the power source for American mobility and economic growth for many years to come. One day solar cars, electric vehicles or alternative fuels may play an important role in the nation's transportation systems. But that day has yet to arrive.

However, environmental concerns already have arrived, and, with increasing frequency, these concerns are setting the ground rules for future U.S. industrial production and consumer selection. Nowhere is this more evident than in the debate now raging over advanced automobile engine designs and alternative fuels--particularly reformulated gasoline and methanol.

President Bush has called for legislation that would require domestic car companies to manufacture and sell 500,000 alternative fuel vehicles in 1995, another 750,000 vehicles in 1996 and one million vehicles annually from 1997 to 2004.

Washington is likely to pass a

clean air bill by mid-1990. The petroleum industry supports the intent of the President's recent proposal, just as we have worked for many decades to meet consumer needs and government standards.

In the last two decades alone, industry scientists have identified the chemical components of auto emissions, removed lead and phosphorous additives from gasoline to improve the performance of catalytic converters, and reduced vapor pressure in order to cut emissions. Our latest attempt to reformulate gasoline and reduce auto emissions simply marks another evolutionary step in auto fuels research--not a rearguard action against other alternatives.

Existing cars and light trucks could burn reformulated gasoline. Some already do. And while Americans log a modest 7 percent of their total annual mileage on pre-1975 cars and light trucks, burning reformulated gasoline in these vehicles--which now emit 25 percent of the nation's ozone-causing hydrocarbons and 29 percent of its carbon monoxide--could significantly

reduce urban pollution. By contrast, to use methanol and other alternatives would require building an entirely new fleet of vehicles at costs for vehicles and fuels which could be very high.

More can and should be learned about methanol and reformulated gasoline, as well as other potential alternatives, such as compressed natural gas and propane. That is why the petroleum and automobile industries recently launched a major joint effort to build a larger, more comprehensive database about the environmental benefits and cost-effectiveness of 26 gasolines in 34 gasoline-fueled vehicles and 3 methanol fuels in 20 prototype flexible-fuel vehicles. Included in the testing will be additives such as ethanol and MTBE (Methyl Tertiary Butyl Ether).

The first phase of the proposed research, supported by industry contributions of \$11.3 million, will examine auto emissions, air quality effects and the costs and benefits of various methanol blends in prototype vehicles and of various gasoline

formulations in 1983-85 and 1989 vehicles.

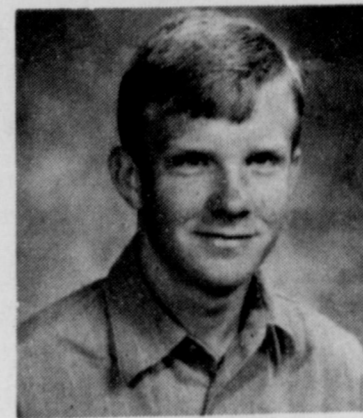
These tests will be conducted openly. The advice of the U.S. Environmental Protection Agency and of such regional environmental agencies as the California Air Resources Board and the Northeast States for Coordinating Air Use Management has been solicited and will be listened to. Eminent scientists from academia also will advise the auto and oil researchers.

Tests will be conducted on existing cars driven 10,000 miles or more. More than 2,000 tests will be carried out, and not just to measure ozone precursors to smog, but also airborne toxic chemicals. Results of these tests will be used in atmospheric chemistry and air quality models to determine the potential reductions in urban ozone from using any of the tested fuels.

As part of this joint effort, scientists will conduct the largest number of gas chromatographic analyses--an advanced method of measuring potential pollutants--ever carried out anywhere with respect to vehicle emissions. We will complete the first phase of our tests by August 1990--in time for the results to provide important information to those charged with the Clean Air rulemaking process.

Early next year a second phase will begin as researchers test advanced fuels and vehicles. The most promising fuels will be tested to find out which fuel/vehicle combinations produce the least amount of ozone and air toxics at the lowest price.

The results of this latest research are needed by industry--to build cleaner, more efficient cars and fuels. By consumers--so that the higher prices people pay for these advanced vehicles and fuels is money well-spent. And by government--so that new clean air standards and rules direct manufacturers and consumers toward solutions consistent with scientific evidence.

The seminar will be conducted in 84 locations across the nation with the purpose of bringing a select group of students together with groups of distinguished leaders in business, government, education, and the professions so they can discuss present and future issues, using an informal question and answer format.

The specific goals are to: seek out and reward leadership potential in high school sophomores; encourage and assist students in their quest for self-development and self-identification; introduce potential leaders to recognized leaders of today through give-and-take discussions on a variety of current and critical topics, and provide through this exposure the opportunity to explore America's incentive system and our democratic process.

Seven seminar sessions will be conducted with a panel of speakers with evening management games and talent show.

## Finnell addresses landfill problem

Rep. Charles Finnell, chairman of the House rules committee, co-sponsored this week a House Resolution requesting the Environmental Protection Agency to conduct hearings in rural areas to consider authorizing states to grant variances to strict national landfill standards.

"Every community in our nine-county district has a critical landfill problem as a result of recent over-mandating federal EPA standards," he commented.

H.R.4 urges the federal agency to provide rural citizens the opportunity for public testimony and local input on the issue.

## Chamber sets 1990 budget

Board of directors of the Iowa Park Chamber of Commerce, in their monthly meeting Monday, approved the organization's annual budget.

The 1990 budget calls for expenditures of \$11,862, down slightly from the previous year's budget of \$11,978.

Secretary Susan Dillard reported she had begun leaving packets that are offered new residents for distribution at city hall.

She explained the newcomers can get their packets when they sign up for utilities, and that process would be better than her difficult attempts to find the people at home in the evenings.

Other items discussed included contacting businesses which have not renewed their memberships, progress of the annual Clean Up Week, replacing shrubs in front of the Chamber office which died during the winter, and a plaque marking the site where the centennial time capsule was buried in front of the Chamber office.

# Drunk drivers sought

Officers are working under a contract with the State Department of Highways and Public Transportation which provides overtime pay for the off duty officers so they can focus in on drunk drivers.

Drunk drivers beware! You are in the spotlight in Wichita County now as off duty officers of the sheriff's department make an all-out effort to take you off the streets and highways.

Sheriff Tom Callahan said, "We are committed to this effort. The latest statistics show Wichita County to be the twelfth in DWI related injury/fatal accidents and Wichita Falls sixth. Our people will be taking drunk drivers off the road and hopefully the statistics will show some great improvement."

Capt. Grady Smith, who will supervise the program for the sheriff's department, says he won't be advertising when or where his officers will be working, but he says, "I guarantee they'll be out in numbers and for more than one day a week. We'll be working in the city and in the county ... and we'll be very visible."

Dale Terry, who coordinates the program for the highway department here, says the sheriff's office is highly trained in drunk driver detection with most officers trained in field sobriety testing (horizontal gaze) and in the operation of intoxilizers.

Terry added that city police officers, under a similar program in 1988, increased drunk driver arrests by 287 percent with 584 arrests in an eight-month period.

Funding for the program at the sheriff's department will be for six months with options to renew at the end of the period.

## AREA OIL & GAS NEWS

Pumping 20 barrels of oil with five barrels of salt water per day, the No. 3 Munger "A" has been completed in the Wichita Regular Field by Singleton Production Co. of Iowa Park.

Location is about one-half mile north of Kamay.

Singleton perforated for production at 1,570 to 1,580 feet into the wellbore.

Two 2,000-ft. developmental wells are slated in the Wichita Regular Field by Tommy Swanson of Electra. The wells will be known as the No. 1 Cato "B" and No. 59 Cunningham, located six and five miles southeast of Electra, respectively.

The Cato well is in the HT&BRR Survey A-131, while the Cunningham is in the H&GNRR Survey A-146.

The No. 34 Kemp-Kempner has been brought on line as a pumping oiler in the Wichita Regular Field, one mile south of Kamay. Raymond's Operating Co. of Kamay is the operator.

It made eight barrels of oil per day, pumping on an open choke. Production will be from two sets of perforations at 1,758 to 1,788 feet into the wellbore.

Pumping 16 barrels of oil per day on an open choke, the No. 6 L.K. Holman has been completed in the Wichita Regular Field, about two miles south of Burkburnett.

F.T. Felty of Burkburnett was the operator.

The well will produce from two sets of perforations, 1,210 to 1,218 feet into the hole and 1,415 to 1,526 feet into the hole.

Water production totaled five barrels daily.
