## FOUR POLLS IN AREA -

# General election Tuesday

The four voting polls in the Iowa Park area will be open from 7 a.m. to 7 p.m. Tuesday for the casting of ballots in the general election.

Polls will be located at the county agriculture building on West Park for Precinct 32 voters; Faith Baptist Church for Precinct 33; West Wichita Coop Building at Valley View for Precinct 34, and Chaparral Baptist Camp for Precinct 60.

The ballots will include races all

the way from federal to state, district and county offices. There is also one amendment to the state constitution on the ballots.

Federal offices will be those of senator and representative.

State offices include the governor, lieutenant governor, attorney general, comptroller, treasurer, land commissioner, commissioner of agriculture, railroad commissioner, three supreme court seats, five appeals court judgeships and one representative.

On the district level will be one judgeship, district attorney and clerk.

County positions include the county judge, two court at law judgeships, Precinct 4 commissioner, clerk, treasurer, and Precinct 3 justice of the peace.

The lone constitutional amendment on the ballot states:

"The constitutional amendment to clarify the authority of the senate to consider certain nominees to state and district offices and to provide for filling vacancies in those offices."

## Residents complain decorations damaged

Mixed among the entries on the police blotter during the past week of criminal mischief complaints were notations of three arrests having been made.

The arrests were not related, however, to the complaints of pumpkins being shattered and home decorations strewn over yards and streets.

William Rumisek, 34, was taken into custody Wednesday afternoon of last week on a warrant issued by the county sheriff's department for driving while license was suspended. His fine was \$279.50, and he was turned over to a deputy to be taken to county jail.

intoxication and possession of a prohibited weapon.

Howland was released on a personal recognizance bond.

Hester Sisk Jenkins turned herself in at the police station Tuesday evening on warrants issued by the sheriff's office for harassment. Jenkins, 52, was later turned over to a deputy to be transported to county jail, according to the blotter.

An attempted burglary at Davis Laundry, 309 W. Bank, was investigated shortly after midnight Monday. Indications were seen where someone had attempted to gain entry into storage rooms and coin machines, but nothing reportedly was missing.

## News Briefs

### Iowa Park band marches today

The Mean Green Marching Machine will be competing in the regional marching contest at 4 p.m. Thursday in Wichita Falls Memorial Stadium.

Iowa Park and Graham won the district competition Oct. 20 to qualify for the regional.

Most of the other bands that will be competing are unknown, because their district events were not held until Monday.

The top two bands at regional will advance to the state contest.

### Census takers 'count' 6,057

The Census Bureau did not change its preliminary figures on the population of Iowa Park, so the city's signs for the next decade will state 6,057 reside here.

Preliminary figures released early in September gave the same figure, and

also stated that on Jan. 1 there were 191 vacant housing units counted inside the city limits.

The new figure is 116 fewer than the 6,173 counted in 1980.

City administrator James Barrington said he was unaware of any plans of the city council to contest the count.

### Work to close Victoria block

The 100 block of South Victoria will be closed to traffic shortly after noon Tuesday and remain closed all day Wednesday, according to Mike Price, city public works director.

Burlington crews will be rebuilding the spur which crosses Victoria, requiring all traffic to be routed around that area while the work is underway, Price said.

### 23 donors contribute blood

Six donors reached gallon plateaus Monday when the Red Cross Bloodmobile was in Iowa Park.

They were among 23 donors who gave blood.

Those reaching plateaus included: Robert Sumner and Eva Parker, three gallons; Wade Coffee, two gallons, and one each by David Dietrichson, David Sheppard and Gloria Logan.

## Former Green Beret likes yard puttering

Janus, the patron of beginnings and endings in Roman mythology, seems to have had an influence on the activities of Garry Stamm.

January, the month named for the Roman patron, has figured prominently in the beginnings and endings in Stamm's life.

They have had many beginnings and endings in trying to get their yard started. But, perseverance has paid off and as a result their yard was named Yard of the Month for September by Iowa Park Garden Club.

The Stammers bought their home at 1510 Bentwood in 1987 and had the yard landscaped. Because of an extremely cold winter (part of it in January) many of their shrubs died. So they had to start over.

They decided they would do the work themselves. Stamm was not well acquainted with the soil in Texas. In his home state of Nebraska, he says,

"All you have to do is drop a seed on the ground and it grows." He hasn't exactly found that to be true in Texas.

Stamm bought oak trees and set them out only to have them die. He decided maybe they were too young, so he bought larger ones and planted them. They are doing well.

Their flower beds and planters are a riot of color with periwinkles, dwarf mums, geraniums, petunias and zinnias. Crescent shaped beds in the back are lined with dwarf mums and small Japanese boxwood.

The Stammers have lived in Iowa Park almost 13 years, moving here when he retired after 20 years with the U.S. Army as a Green Beret.

His entry into the military was the beginning of his January experiences.

Stamm was born on a farm in Nebraska. He graduated high school in 1952, worked on a farm and did construction work until 1958. At that time he enlisted in the army.

Friday night's Dist. 4-AAA game at Breckenridge promises to be a defensive battle royal, as both clubs have proven to be stingy with opponents.

Kickoff time in Buckaroo Stadium is set for 7:30 p.m.

It will also mark a renewal between the two clubs as conference opponents.

Though Iowa Park and Breckenridge have played each other 10 times in the past (each has won five), only in 1986-87 were the two schools members of the same district.

And their record as conference opponents is also even, as the Buckaroos won 20-6 in 1986, but the Hawks

came back to even the score in '87 with a 20-7 decision.

Their win-loss records are not the only similarities. Each school's colors are green and white, the melody to their school songs is the same, and both have similar histories of success in the sport.

Abilene Wylie was the only team both the Hawks and Bucks faced in a nonconference. Breckenridge tied that game, 14-14, while the Hawks were edged, 29-21. Both those games were played at Wylie.

Breckenridge has only one win at its own stadium this year. They lost to second-ranked Ballinger 42-34 and

powerful Stephenville, 28-0, before finally defeating Bridgeport 21-0 before their home fans.

The third and fourth games of the season were on the road, and the Bucks posted one-point victories in both. They bested Fort Worth Boswell 14-13 and Mineral Wells 15-14.

After opening district play with a win over Bridgeport, the Bucks were back on the road, losing 24-21 to Bowie and last week 28-0 at Vernon.

Against Vernon, the Buck defense proved its strength by holding the top-ranked Lions to only 251 yards on the ground and 26 more through the air.

But the Buck offense had its prob-

lems with turnovers Friday, as did the Hawks in their 9-7 loss to Bowie. Breckenridge lost possession three times on fumbles and three more on pass interceptions.

The Bucks, held to only 30 yards rushing on 27 attempts by the Lion defense, turned to their aerial game. Quarterback Curtis Stanley completed seven of 20 attempts for 93 yards.

Besides being short on the number of seniors this season, the Hawks have had major problems with injuries. At least 15 players have missed one or more of the eight games thus far.

### PHYSICIAN SAYS:

## Flu shots suggested

Months recommended for persons to take flu shots have varied in the past, but one physician now says November is the recommended period.

Dr. Earl Watson said a package insert provided by the manufacturer of the vaccine says November is the time for the shots.

"We used to start giving flu shots in August when the vaccine was received," he recalled. "Teacher physical exam forms used to say September. Then October was suggested."

"No one knows when the worst of the flu season will arrive, so we shouldn't wait too late. The flu shot won't help if you already have the disease," Watson said.

Senior citizens will receive a \$10 discount on their flu shots Tuesday, immediately after the lunch period at the Friendly Door.

Residents at the nursing home are receiving flu shots, without charge.

Pneumonia shots are still considered "permanent," Dr. Watson said for the information of those who have already received them.

They are to build protection against 23 kinds of bacteria that causes pneumonia. "A person weakened by flu may actually die of pneumonia, so one should have both for best protection," Watson said.

Every 10 years, diphtheria and tetanus shots should be taken, and can be administered at the same time.

Hepatitis B immunizations are being given as a disease preventative for the health care workers in the city.

"But these are not as necessary for everybody to consider as are flu, diphtheria, tetanus and pneumonia shots," the physician said.

## Region Nine services explained to Lioness'

Mr. and Mrs. John Sibley presented an informative program on Region IX Education Service Center Thursday for the Evening Lioness Club.

Hostesses were Mmes. Herb Adcock, Alan Bennett and Gerry Thurlo.

The program featured narration and a video developed at the Center. Mrs. Sibley is involved in special education for the handicapped.

She described the Center, one of 20 in Texas, and explained that it was established to provide literature and consultant services for teachers and school administrators in 11 counties of Region Nine. She added that teachers and workers with the handicapped in 13 counties benefit.

Mrs. Sibley listed the two major components of the Center as administrative and instructional. Thirteen people are employed in special services at the Center and also assist with screening children for hearing and vision.

She pointed out that Region IX has an extensive library and has developed a transition curriculum, work skill stations, and graduation transition video for special education students.

Mrs. Sibley noted that prominent educators, public figures and some who have excelled in spite of handicaps are brought as speakers for the Public

Handicapped Awareness sessions that are held for parents and teachers of handicapped children.

"I'll Say a Word," was title of the video developed in classrooms for the handicapped in Burkburnett, City View and Iowa Park schools in the Wichita County Co-op.

At the beginning of the business session, Mrs. Don Jagger presented the devotion on "Friends" and read two poems which show that friends are one of life's greatest treasures.

During the business session directed by Mrs. Kenneth Via, club members voted to give a monetary gift to the Lions Camp for Crippled Children at Kerrville as an honorarium for Mr. and Mrs. Sibley.

In other business, members voted to give a memorial gift to the Texas Lions Camp for the late Joe Kennedy, and \$75 to the Ministerial Alliance.

Mrs. C.L. Thompson attended the district meeting held recently at Breckenridge. She reported that the Evening Lioness Club won first place in contest points.

The Noon and Evening Lions Clubs will have a joint meeting Nov. 29. The program will be provided by North Texas Mens Chorus, directed by Darrell Dick.

They are ideal for the fast-approaching Thanksgiving and Christmas dinners. The recipe for "German Fruit Cake," that Karla got from her mother, is especially delicious and different, she said.

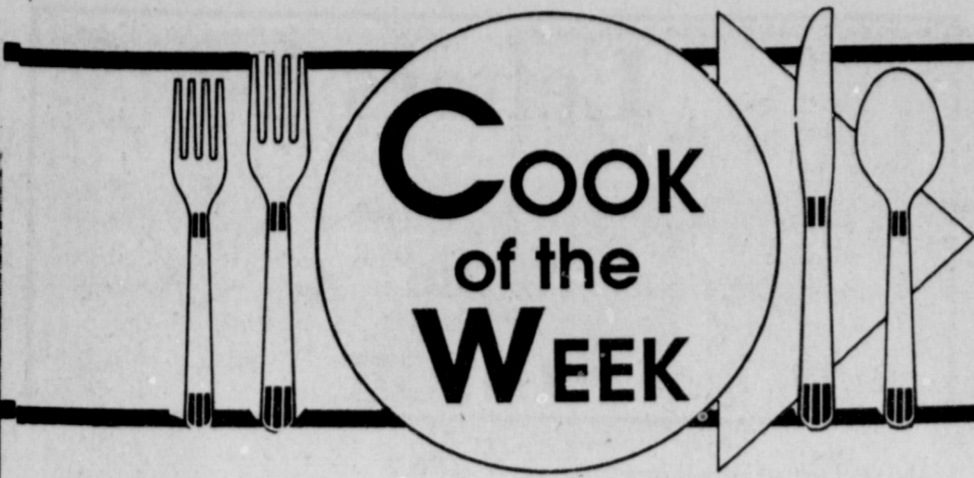
**SOUTHERN PECAN PIE**

Beat 3 eggs thoroughly with 2/3 cup sugar, dash salt, 1 cup dark corn syrup, and 1/3 cup butter or margarine, melted. Add 1 cup pecan halves. Pour into 9-inch unbaked pastry shell. Bake in moderate oven (350 degrees) 50 minutes or till knife inserted halfway between center and edge comes out clean. Cool.

**MICROWAVE BROWNIES**

2 eggs  
1 cup sugar  
1/2 tsp. salt  
1 tsp. vanilla extract  
1/2 cup melted butter  
3/4 cup flour  
1/2 cup cocoa  
1 cup chopped nuts

In a small bowl at medium speed on mixer, beat together eggs, sugar, salt and vanilla, about 1 minute until light. Add melted butter. Continue beating until thoroughly blended. Mix in flour and cocoa at low speed. Stir in nuts. Spread evenly in 8-inch greased square microwavable dish. Microwave High 6 to 7 minutes, rotating dish 1/4 turn every 2 minutes. When done, top looks dry and will spring back when touched. Cut when cold. Makes about 20 brownies.



**Cook of the Week**

**GERMAN FRUIT CAKE**

3/4 cup oleo  
2 cups sugar  
4 eggs  
Cream oleo and sugar; add eggs. Sift together:  
3 cups flour  
1/2 t. allspice  
1/2 t. cinnamon  
1/2 t. nutmeg  
Add to first mixture, alternating with:  
1 cup buttermilk with 1 t. soda added  
Fold in:  
2/3 cup cherry preserves  
2/3 cup apricot preserves  
2/3 cup pineapple preserves  
1 cup chopped pecans  
1/2 t. vanilla  
Bake at 325 degrees 1 1/2 hours.

**FRUIT SLUSH**

1 large can pineapple juice  
2 cans frozen lemonade  
1 can lemon juice  
1 pkg. frozen raspberries  
3 pkg. raspberry Kool-Aid  
4 cups sugar  
Mix all of the ingredients (undiluted) in a giant canister. Then fill canister within 1 inch of top with water; mix well. Seal and freeze. To serve, thaw to a "slushy" consistency and pour into glasses.

**BAKED BEANS**

6 slices bacon  
1 medium onion  
1 can stewed tomatoes  
2 small cans pork & beans  
1/4 cup ketchup  
1/4 cup brown sugar  
Cook bacon; remove bacon from skillet; chop onion and saute in bacon grease. Add stewed tomatoes, ketchup, brown sugar, and simmer 10 minutes over low heat. Pour mixture into casserole dish and add beans. Lay cooked bacon over the top and bake 1 1/2 hours at 350 degrees.

# As I See It . . .

Tuesday is general election day in Texas, and I hope you all have studied the candidates and the issues and will be ready to cast your votes, if you haven't already by absentee.

I decided a few years ago to not endorse any candidates. In order for this newspaper to endorse someone, we would first have to have a meeting and decide whom we would choose.

So, to shortcut that issue, I do my own thing in my column, and explain for whom and what I will vote.

For some reason, a lot of people tell me they are interested in my opinions. I'll list them. In some cases, I'll give some explanations, and in others I'll just pass it over with a name.

In general, my vote will be cast for those who have been in business and have paid salaries out of their pockets. And there will be those professional politicians who flat don't need to be returned.

So, here they are:  
U.S. Senator - Phil Gramm. His philosophy about taxes are similar to mine, and I feel he's done a good job in Washington for us all, not just Texans.

U.S. Representative - Dick Waterfield. Most of his adult life has been as a businessman; his voting record in the legislature is as I would wish it; I feel comfortable conversing with him, while I have never with Bill Sarpalus.

Governor - Clayton Williams.  
Lt. Governor - Bob Bullock. I have had my problems with him ever since he was elected comptroller, accusing him as being self-serving. But, for all his faults, I feel he will be the most effective of the candidates.

Attorney General - Dan Morales. He took the time to visit with me in my office, answered any and all questions I had, and I liked each of his responses. His leading opponent, as far as I am concerned, is trying to take advantage of his name identification with a shoe manufacturer.

State Comptroller - Warren G. Harding Jr. His opponent is another of those professional politicians who lost me while on the railroad commission.

State Treasurer - Kay Bailey Hutchinson. After all these years with the current commissioner of agriculture, I'll throw up with another of the same name. And it's that name identification that the candidate is hoping will pull her through.

Land Commissioner - Wes Gilbreath. I've had it with Mauro and his effort to appeal to environmentalists.

Agriculture Commissioner - Rick Perry. He knows agriculture, and that's a fact. Hightower is more interested in being returned to office by the field hands than he is by those who hire them and invest in feeding and clothing the nation.

Railroad Commissioner - Beau Boulter. He did an outstanding job while in congress and made the political mistake of giving it up to run for the senate. Krueger has been trying to get elected to one government job or another most of his life. I doubt he's ever paid a salary in his life.

Chief Justice, Supreme Court - Tom Phillips. He's demonstrated his talents and should be returned. The problem is,

his opponent, Oscar Mauzy, one of the most liberal politicians in Texas history, will be allowed to retain his present seat on the court the balance of his term even if he loses this race. Incidentally, I voted against Mauzy when he was elected to the court.

Justice, Supreme Court, Place One - John Cornyn. His opponent, Gene Kelly, is another of those attempting to use name identification, yet is unqualified for the post he seeks.

Justice, Supreme Court, Place Two - Bob Gammage. I just don't like Charles Ben Howell.

Judge, Court of Criminal Appeals - Place One, Frank Maloney - Place Two, Oliver Kitzman - Place Three, Bill White - Place Four, David Berchelmann - Place Five, Louis Sturns.

Justice, second Court of Appeals - John Hill.

On the county level, I will be casting my votes for these contested races:  
Barry Macha, incumbent District Attorney. I have personal knowledge of the attention he has given one family in a major case, plus I like the way he has

worked over the years.  
Judge, 30th District Court - Bob Brotherton. He was appointed to the bench some 18 months ago, and is still working like he doesn't own the job. I just wish all the other district judges in the county worked as hard.

County Treasurer - Marsha Watson. I feel her experience in that office will make for a smooth transition.

County Commissioner Precinct 4 - I don't have a vote in this race, because I don't live in the precinct. But if I did, it would most certainly be for Buck Buchan. I don't feel his opponent should be rewarded for all his years as a worker in a political party, and is attempting to take advantage of that plus his name identification.

And, on the only amendment to the state constitution on this year's ballot, which is a relief, I would vote for the change, which would "...clarify the authority of the senate to consider certain nominees to state and district offices and to provide for filling vacancies in those offices." I don't believe a simple attorney general's ruling is adequate over the years, as is now used.

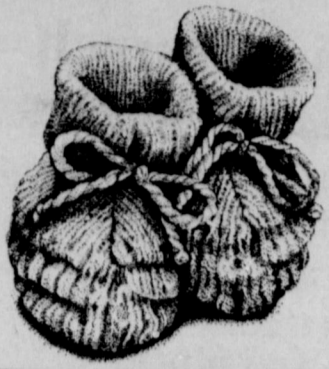

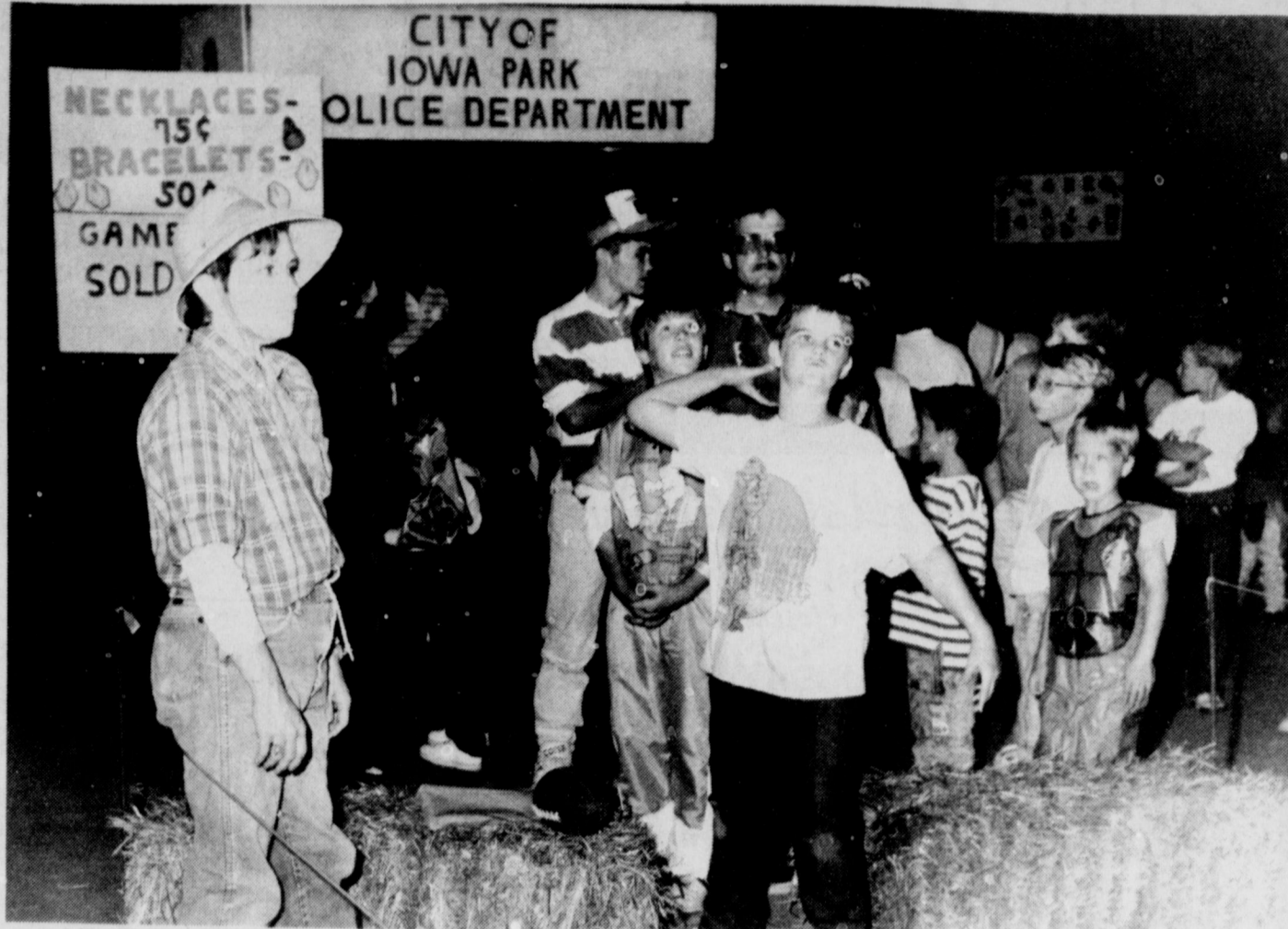

**SCHOOL SCENE**

Information prepared by Iowa Park School Counselors

Critical decisions in children's lives, such as whether or not to use drugs or to stay in school or drop out, are affected by their sense of self-worth - their self-esteem.

Helping children develop good self-esteem is probably the most important thing parents can do for their children, because self-esteem is the foundation on which children build the rest of their lives.

\*People with high self-esteem are capable of making good decisions, proud of their accomplishments, willing to take responsibility and able to cope with frustration.

\*Self-esteem is closely tied to family and environment. When children feel that they are listened to, taken seriously and genuinely cared for, their self-esteem is high.

15 ways to help children like themselves

1. Reward children. Give praise, recognition, a special privilege or increased responsibility for a job well done. Emphasize the good things they do, not the bad.
2. Take their ideas, emotions and feelings seriously. Don't belittle them by saying, "You'll grow out of it" or "it's not as bad as you think."
3. Define limits and rules clearly, and enforce them, but do allow leeway for your children within these limits.

4. Be a good role model. Let your children know that you feel good about yourself. Also let them see that you too can make mistakes and can learn from them.

5. Teach your children how to deal with time and money. Help them spend time wisely and budget their money carefully.

6. Have reasonable expectations for your children. Help them to set reasonable goals so they can achieve success.

7. Help your children develop tolerance toward those with different values, backgrounds and norms. Point out other people's strengths.

8. Give your children responsibility. They will feel useful and valued.

9. Be reasonable. Give support when children need it.

10. Show them that what they do is important to you. Talk with them about their activities and interests. Go to their games, parents' day at school, drama presentations, awards ceremonies.

11. Express your values, but go beyond "do this" or "I want you to do that." Describe the experiences that determined your values, the decisions you made to accept certain beliefs, the reasons behind your feelings.

12. Spend time together. Share favorite activities.

13. Discuss problems without placing blame or commenting on a child's character. If children know that there is a problem but don't feel attacked, they are more likely to help look for a solution.

14. Use phrases that build self-esteem, such as "Thank you for helping" or "That was an excellent idea!" Avoid phrases that hurt self-esteem, "Why are you so stupid?" "How many times have I told you?"

15. Show how much you care about them. Hug them. Tell them they are terrific and that you love them. Remember the Power of Praise!

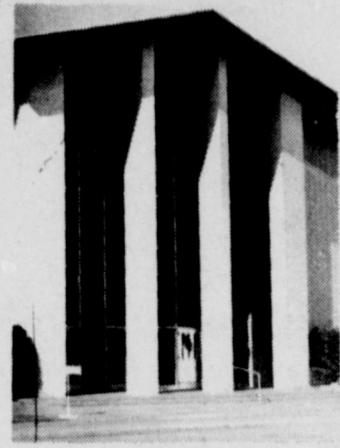

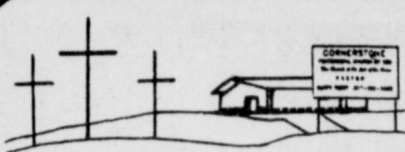

"Marital collapse seems to follow predictable steps toward the ultimate destruction of the marriage. This is verified in a study of marital burnout which lists the stages:

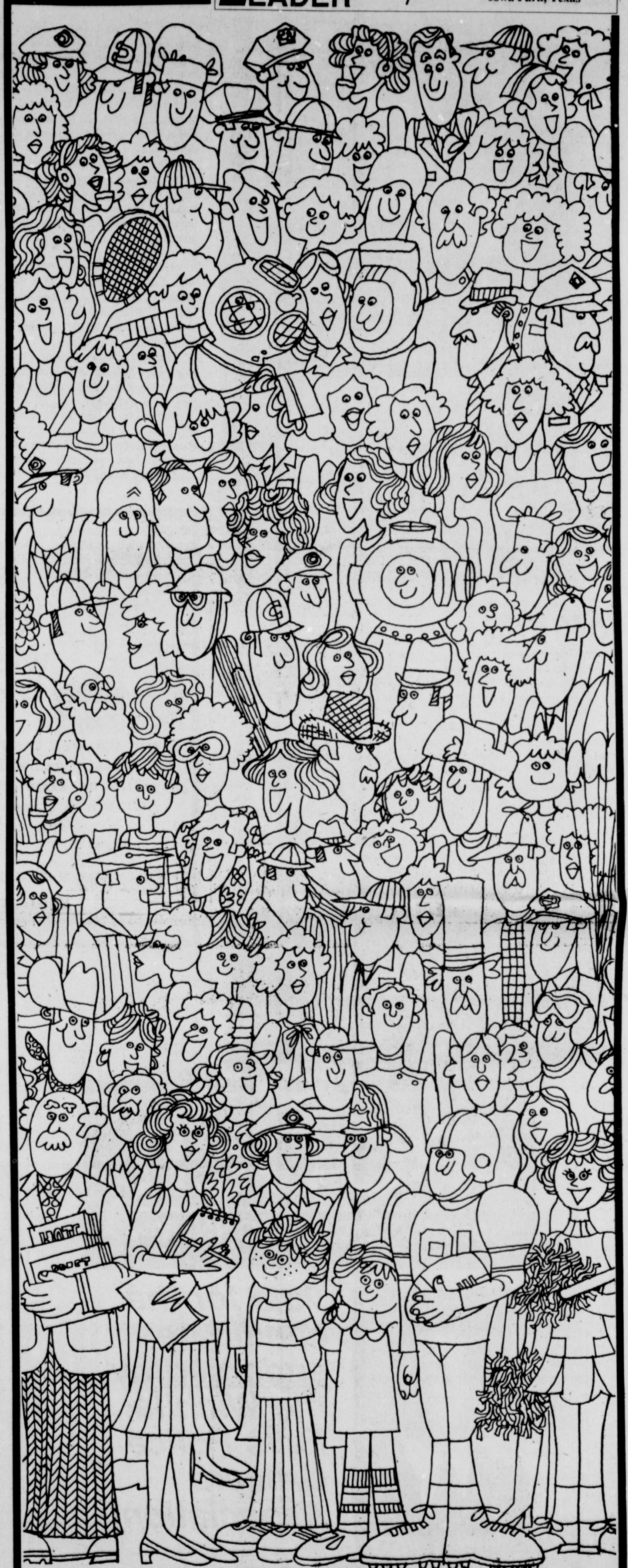

want to live in Nebraska.

Kinuko had a friend she grew up with in Okinawa who was married to an airman stationed at Sheppard Air Force Base.

Stamm had never been to Texas other than to fly in and out of San Antonio. But they decided to come to Wichita Falls and visit her friend.

The Stammers still had not made up their minds where they wanted to settle, but they thought they would like Texas.

Since it was time to get their children in school, they decided they

would put them in school here and see what the future would bring. That was almost 13 years ago and they say they have never regretted their decision.

Kinuko, better known at Kim, works as a finisher at Howmet. She likes the United States and Texas in particular, even though it is so different from her homeland.

She has not had difficulty with the English language. It was required when she was in school while Okinawa was under control of the United States, even though Japanese is the native language of the small island.

Okinawa is 65 miles long, ranges from 13 to 17 miles wide and is the largest in the chain of the Ryukyu Islands.

Kinuko has three sisters and two brothers in Okinawa. She has returned only once, in 1984, and has not been able to talk her siblings into coming to the States.

When she went home, Stamm thought he wasn't going to get her to stay as long as they planned. She worried about him and the children, even though he assured her they were doing fine and the children were staying in school.

Kinuko said it was very different when she went back. By then the Japanese were in control of the island again. "Everything was so much higher than when I left I couldn't believe it," Kinuko explained.

Stamm interjected, "I plan for her to go back home in 1992 and then when we both are ready to retire, we will all go and stay."

Judging by the way his attractive wife looked at him, she's skeptical about that statement. Kinuko says she misses her family and her homeland, however, she is satisfied here and en-

joys her work.

Stamm works with contract brokers out of the commissary at Sheppard AFB. He says it is sort of like being TDY in the service, away from your unit and not attached to another.

The Stammers have two children. A daughter, Pamella, started this year at Midwestern State University. She is interested in becoming a real estate agent.

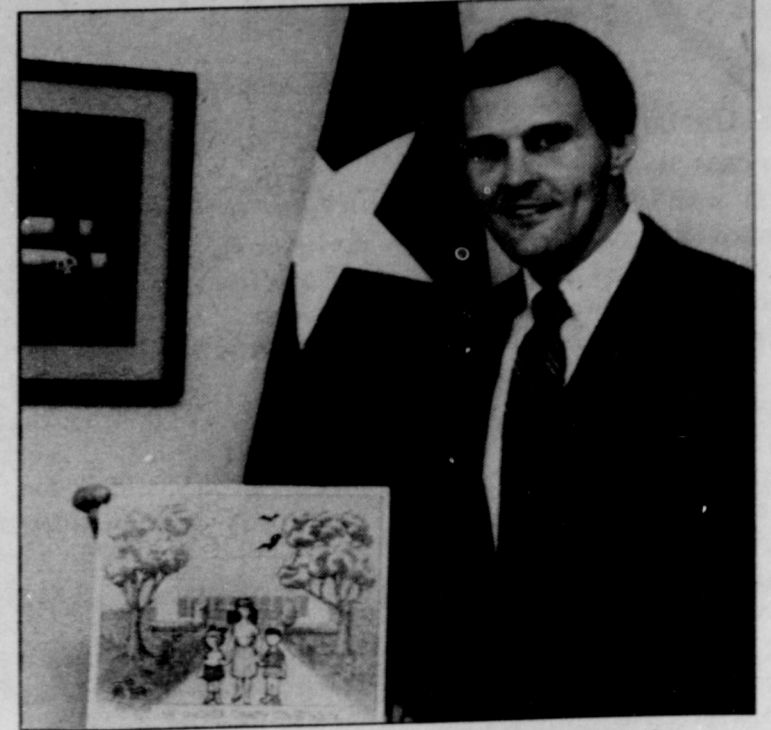

**Hares squeeze past Hawks**

Seven quarterback sacks, four turnovers and the loss of two starting linemen led to the 9-7 Hawks' loss here Friday to Bowie.

The defeat, only the second-ever to a Jackrabbit team, virtually eliminated any hope Iowa Park may have had for a playoff berth. The Hawks are now 1-2 in district and 2-6 on the season.

When Bowie scored its touchdown in the third period to take the lead, it was only the first touchdown given up by the Mean Green defense to a Dist. 4-AAA opponent.

Quarterback Robert Denton was sacked by the aggressive Hare defenders seven times for 49 yards. The junior also suffered three interceptions, though none of them aided Bowie's scoring.

The fourth turnover, a muffed handoff from Denton to Johnny Duggins on the Hawk 15 early in the second period, did set up the visitors' 35-yard field goal.

Iowa Park scored on its second possession to cap a 67-yard drive. Greg Steger sprinted around his right end four yards with 36 seconds remaining in the opening quarter, and Todd Pulley added the extra point.

En route to the goal line, Steger caught a pass for 23 yards, Pulley scampered 16 yards, and two penalties against the Jackrabbits were major plays.

On the first of the two penalties, Steger

had lost a fumble after a five-yard gain, but Bowie was called for being off sides when the ball was snapped. Then, three plays later, sophomore Chris Williams had picked up four yards to the eight, and one of the Bowie players was charged with unsportsmanlike actions and four more yards were tacked on, setting up Steger's run from the four.

After the Hawks' fumble at their own 15, Charles Jolly caused a fumble that was reclaimed by Bowie at the 18. Two pass attempts fell incomplete, and Bowie was forced to kick for its first points.

Shortly after Bowie lit up the scoreboard with its three-pointer, the first of the two Hawk linemen left the field. Tackle Jeremy Pruitt walked off the field on his own with a shoulder injury.

Unable to pick up a first down after taking the second half kickoff, the Hawks were forced to punt. Joel McIlroy, who handled the punting chores in the game, sailed the ball to the Bowie 32. But his brother, Don, arrived a bit too early and was flagged for interfering with the punt's receiver.

That advanced the ball to the Hares' 47. From there, Bowie alternated runs and passes until they reached the Iowa Park

seven yard line.

There, on second down, Bowie was held to no gain, but sophomore tackle Scott McNeely suffered a season-ending injury on the play. His right leg was broken just above the knee, coaches report.

On the next play, Bowie completed a seven-yard pass to score, with 5:32 remaining in the third period. The extra point kick was blocked, and Pulley caught the ball and was pulled down from behind, 17 yards downfield.

The Hawks earned six first downs in the first period of the contest, and only two more the rest of the evening, one each in the third and fourth periods. Bowie's only first down of the opening half was on the first play of the second quarter. The visitors picked up four on the touchdown drive, and added two more in the final 12 minutes.

Steger wound up being the Hawks' leading rusher with 35 yards on 12 carries; Duggins had 23 on eight. Steger also caught three of the five completed passes for another 43 yards.

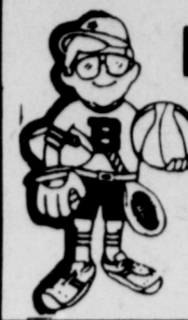

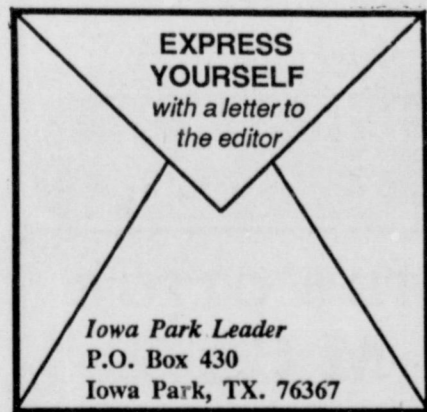

Lozipone to Brent Brown started the second period scoring. Byrd's kick for the extra point failed.

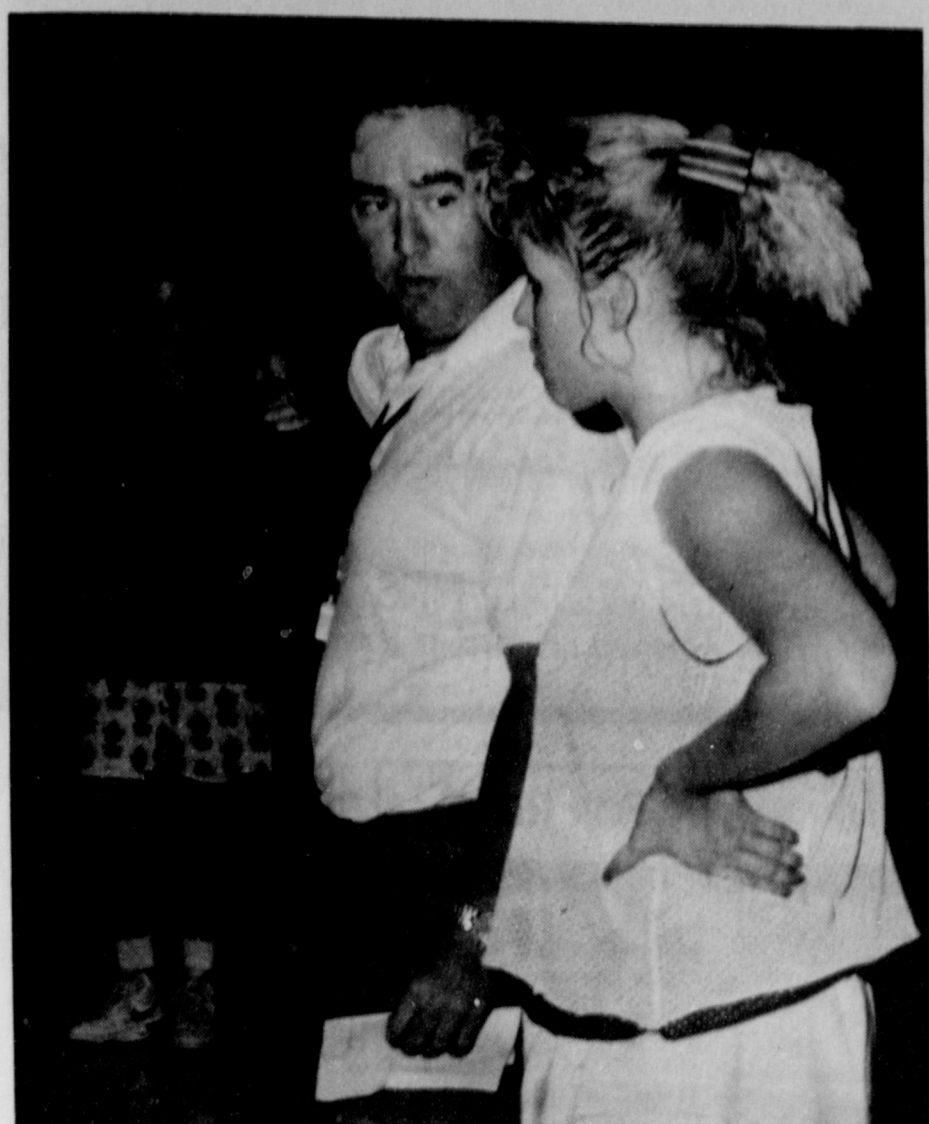

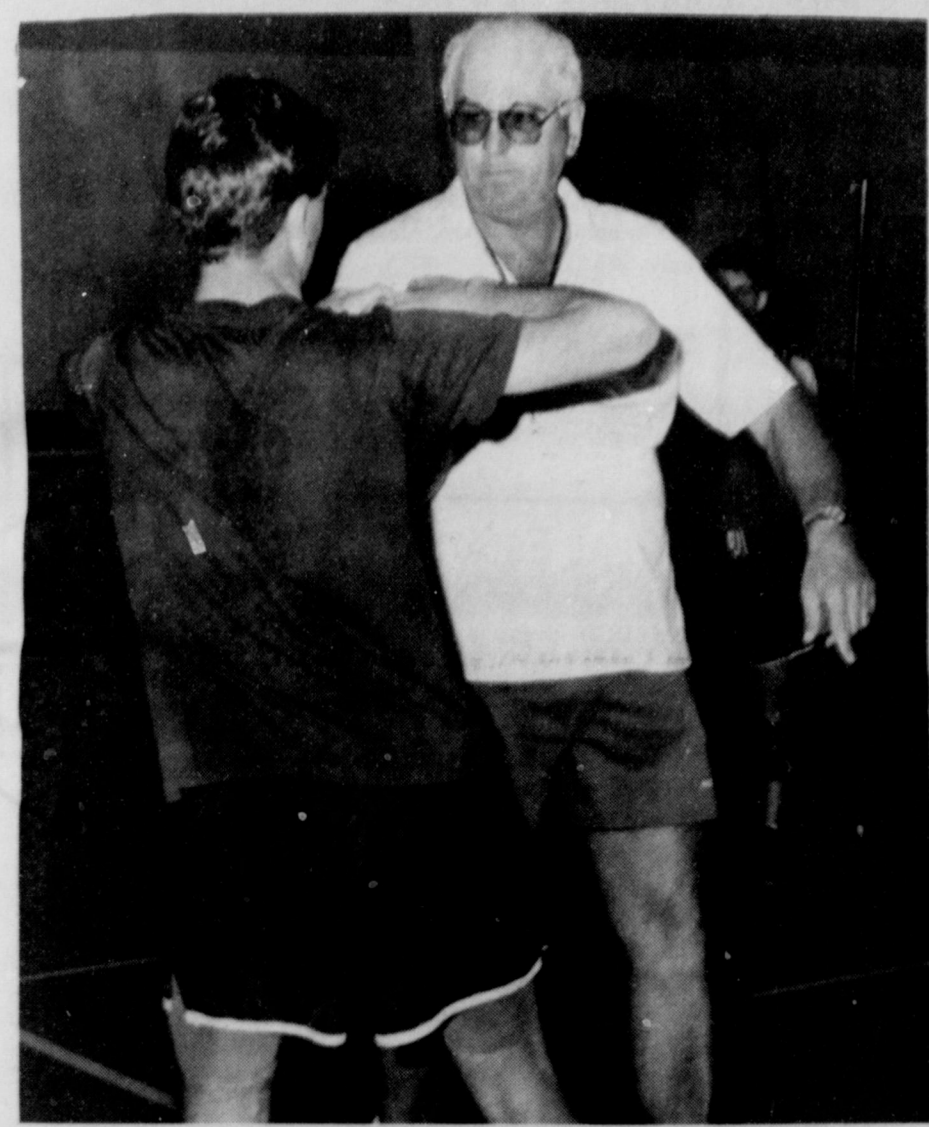
Tatum and Witherspoon each had interceptions.

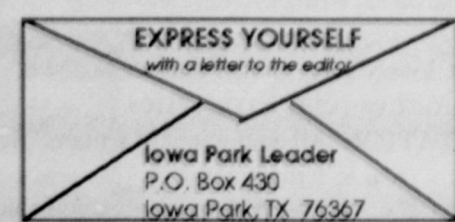

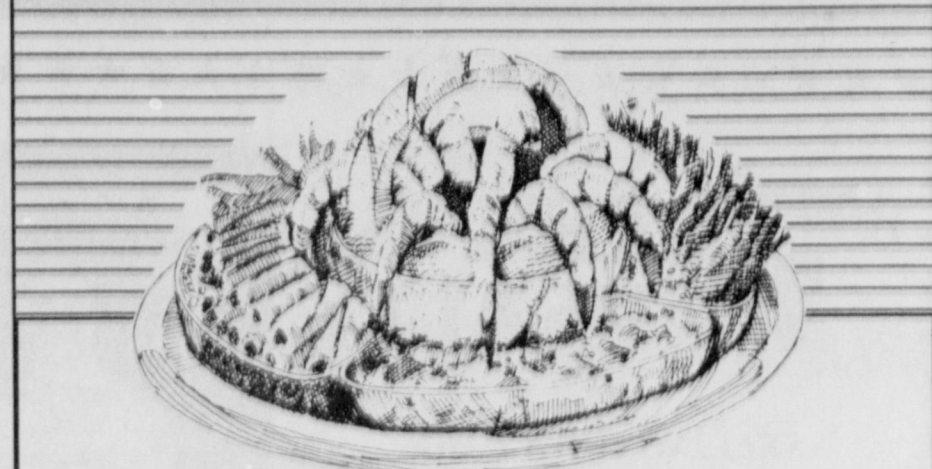
