An exceptionally high early voting count has been reported in the May 2 city election.

Early voting in that election, as well as the school's, will end Tuesday.

As of noon Wednesday, 50 early voting ballots had been cast at city hall, and one to be returned by mail was yet undelivered.

There were only 52 early vote ballots counted in last year's city elec-

A similar amount of interest has not been indicated in this year's school board election, where only 17 ballots had been cast. There were 37 early votes counted in the 1991 election.

Citizens can cast early voting ballots as late as Tuesday, if requested before the end of office hours.

Early voting poll in the city election is city hall, while the school administration building is the early voting poll for that election.

Two candidates are seeking the post of city mayor. One is incumbent Wayne House, who is completing his first term of office. He is being challenged by Mike Grubbs.

Two alderman positions are on the ballot this year, but only one incumbent is seeking re-election.



# Leader's first typesetter named Wichita Falls'

# Teacher of the Year

From the field of print media, beginning as a typesetter, to a very successful classroom teacher of journalism, Annetta Reusch has earned the recent honor of being selected Teacher of the Year in Wichita Falls secondary schools.

Annetta was chosen for this honor from 38 secondary teachers, grades seven through 12 in the Wichita Falls Independent School District.

She now is in competition for Texas Teacher of the Year title to be selected in October.

"I'm very thrilled and humbled that I was recognized and nominated by my peers for my work," Annetta says. But teaching journalism thrills her. She says she would not want to do anything else.

About the only things to vie with journalism for Annetta's love and attention are her 600 varieties of iris.

And, the array of perfect rainbow colored tall bearded iris now in bloom in her side yards and those that encircle the back yard show that she has shared a little. But, Annetta casually suggests, "Iris thrive on neglect."

She has received numerous awards on her "neglected" exhibits in the iris shows.

Annetta raises roses and some daylilies. Since roses are so much more time consuming, because they are so susceptable to diseases and attract aphids, the has limited her number of rose bushes.

Mrs. Reusch grew up Annetta Hawkins in Quanah and was introduced to iris by her mother, also an iris lover. However, she didn't become interested enough to start raising iris until the latter part of the

"I've always had an appreciation for flowers and when we moved back to Iowa Park in 1978, I became more interested in raising iris," Annetta

She became good friends with the late Bertha McDonald, former Iowa Park school teacher, and the late Mr. and Mrs. Lester Brooks, who were well known for their beautiful

Annetta proudly says " When I started raising iris 14 years ago, one of my first beds came from Mrs. McDonald." She has been as successful raising iris as she has been an

Her home decor also attests to her love of the iris. She has paintings of iris on her walls, her bedroom paper has prints of iris, with matching bedspread and bed linens.

Annetta graduated Quanah High School in 1959 as salutatorian and in the fall entered McMurry College as

That was where she met her future husband, Earnie, now a teacher of math at Iowa Park High School, who also was a McMurry student.

Before long they were married and Annetta decided to go to work and help Earnie get his degree.

His first job was in Lamesa and Annetta got a job with the Lamesa Daily Reporter . From there they moved to Hamlin where he was coach and she worked for the Hamlin Her-

Next, Earnie and Annetta moved to Iowa Park in 1969, the same year The Iowa Park Leader started operation here and she was hired as the first typesetter for the newspaper.

The same year Annetta entered Midwestern University as a sophomore. This was the first time they had lived close enough to a college for her to complete work for her degree.

She graduated Magna Cum Laude from Midwestern University in 1973 with a bachelor of science degree in education with a major in English and a minor in journalism.

She also has some graduate hours from Sul Ross State University in Alpine and WFSID Teacher Institute.

In 1972 the couple moved to Andrews and Annetta got her first teaching job. She taught English and journalism at Andrews Middle School. In 1978 they returned to Iowa Park and Annetta taught journalism in the Holliday school system. She has taught at Wichita Falls High School for 11 years.

Annetta has been nominated three times for Texas Journalism Educator of the Year; Texas Press Association

nominated her for the Dow Jones Na tional Journalism Teacher of the Year Award, and she has been nominated the UIL sponsors award.

She said, "I am very fortunate to have a husband like Earnie. Thank goodness it has been a cooperative effort throughout our marriage. When he was coaching he was gone all hours when the children were small and I was at home alone until

"When I went back to get my degree he helped care for the children. Now, I'm the one who has to be gone until late a lot of times, and he is here alone."

Earnie was selected Teacher of the Year in Iowa Park in 1983.

Annetta's philsophy on teaching is that education is more than just learning knowledge. She believes it is providing the opportunity for success and directon or re-direction as needed to insure the success for every student.

"I believe every student should be taught the responsibility for his own education, with teachers as facilitators, to provide motivation and information and the experiences necessary for the student to achieve that success," Annetta explained.

She added, "I believe that journalism students have that opportunity for hands-on training and knowledge to produce a product."

Annetta has been successful in devising a point evaluation system, where each student is responsible for keeping a record of his accomplishments and failures.

She says "This allows students to see where changes need to be made. It insures accountability and pride of a job well done. Also I try to impress on them their work is more in view of the public than just in an English class."

Annetta selects her own staff. But, the student must maintain a B in conduct in order to stay in her class. Before she selects her staff they have to fill out a job application and then she interviews them before the final decision is made. This gives the student practical experience of what to expect when they are ready to apply for a job.

Affirming her method of teaching is the feedback she gets from many of her students.

An example is from a former student now Communications Writer for Nielsen Retail Information Group



Thank you from Jack Skinner's Family Dessie & Fay Brott Willis & Jan Skinner Danny & Frances Skinner though John Parker had built a stockade fort around their seven houses to provide protection from Indians, a band of Comanches came one day asking for beef and then attacked. They killed most of the people and captured Cynthia Ann and her brother

Mrs. Davis continued the story of Cynthia Ann, who was taken to northern Texas. In time she forgot how to speak English. She became Palux and thoroughly Indian in actions and thought.

Chief Peta Nocona chose her for his wife. Their first son was born in the springtime and Cynthia Ann, or Palux, named him Quanah, which meant "fragrant" or "sweet-smelling." Two years later they had a second son and named him Pecos.

Palux later had a little girl that

she named Prairie Flower. Chief Nocona was not as proud of his daughter as he was of his two sons.

Texas Rangers later attacked the camp. Among the captives was a woman with blue eyes and her baby. Many came seeking a relative who had been captured. Col. Isaac Parker thought this might be his niece. When Cynthia Ann heard her name, she said: "Cincee Ann. Cincee Ann."

Her family was glad to have her back home, but she was unhappy. She had been "Palux" too long. Most of all she worried about her two sons.

Word came that Chief Nocona and Pecos had died and she did not know where Quanah was. Then when Prairie Flower died, Cynthia Ann Parker had no wish to live.

She never knew that Quanah became a strong Comanche leader, respected by white people and Indians. As a young man, he led his people in a fight for freedom and later helped guide their business affairs on the reservation in Oklahoma.


Quanah did not forget his mother and he advertised in Texas papers to find a picture of her. The Ranger captain who had recaptured Cynthia Ann sent him one. Later a prominent Texan had a oil portrait made from that picture and Quanah gave it a special place in his home, and to honor his mother, he took the last name of Parker.

This particular year, the merchants, trying to make the event even bigger and better, agreed to sponsor cash prizes for a certain number of marked eggs.

The Boy Scouts had always handled the chore of hiding the eggs in that big park. And they did it that particular

The problem wasn't apparent until the following week, however.

Seems the majority of prize eggs, which had to be presented to the various sponsoring businesses, showed up in the hands of Boy Scouts.

That was definitely not an indictment of Boy Scouts in Hereford. But of a small hand full. Scouts continued to flourish in that community through the years, but not with a certain hand full who had claimed Easter egg prizes.

# Council to study changes

In addition to these, her students do a lot of printing for the schools, such as programs for choir concerts, tickets, and brochures. "I let the students do all of this for their experience and to teach them composition and how to use the computer."

Annetta says she does not have the discipline problems some of the other teachers do. "I am very fortunate to have the kids I have. I love my job. It is hard to teach when your efforts are not appreciated and one thing I have is a lot of good, positive feedback from my students.'

She says the biggest problem she has is not to become too involved with the students, who come from such varied backgrounds.

"For instance, I have one students whose mother is an alcoholic. The student works on a full time job, while going to school, just to help financially and the mother gives her child no encouragement at all. I

would bring that one home with me in a minute if I could."

Annetta is now on level three of the career ladder. Since 1984 the school has had different ranks of evaluation and she has reached that level.

Mrs. Reusch serves on the TEA Textbook Committee for Journalism textbooks, and the Wichita Falls Advisory Committee for Instructional Programs. She has served on the Textbook Selection Committee for Wichita Falls and on the Communications Committee and Positive Action Committee.

She has conducted teacher training sessions on using the MacIntosh in Journalism; Using the Newspaper in the Classroom, and one on Photography for Taylor Publishing Co.

She has served as state secretary of the Association of Texas Professional Educators, vice chairman of Texas Education Agency Committee to study open enrollment in Texas, as president of ATPE Wichita Falls Local; president of ATPE, Region IX, chairman of the ATPE State Membership Committee, chairman of ATPE State Educational Policy and Curriculum Committee; has served as faculty president and UIL director, chairman of the Teacher Benefit Committee and is a member of the Texas Association of Journalism Educators.

Annetta is a member of the Amity Study Club of Iowa Park and has served as General Federation of Women's Clubs Project Chairman for the Prevention of Child Abuse. She has served on the Advisory Committee of the WF Teen Communication Theatre STAGE.
