Hot air balloon makes forced landing here

Police are always called on to work unusual situations, but Iowa Park officers may have had one for the books Wednesday of last week.

How often does a peace officer have to report a hot air balloon "crash" inside a city?

A hot air balloon had been launched in Wichita Falls, piloted by Rick Kevin Boone, 42, of that city, with two passengers.

Boone reported he began experiencing problems with his "flamer," which is used to heat the air that keeps the craft aloft, and began losing altitude.

He skillfully manuvered the westbound craft over the electrical wires along Third Street, and sat it down on the playground of Kidwell Elementary, before it could have hung on lines along Fourth Street.

Boone and his two passengers were spilled onto the ground from the basket, but none was injured. It was reported to the police dispatcher at 7:34 p.m.

A "chase" vehicle arrived within 15 minutes, packed the equipment onto a truck, and returned to Wichita Falls.

There already was a large number of youth on the playground, but area residents said later it appeared more than 250 persons converged on and around the campus to witness the event.

Two thefts were reported to police during the past week, and both involved athletic equipment. In both cases, the reports were received days after the incidents were believed to have taken place.

The first report was received Thursday, when a citizen said four bats and some 20 softballs in a bag had been taken the evening of May 15, while his pickup had been parked at Woodbriar Apartments.

Friday, police were told that the lock on the Little League equipment building on West Magnolia had been damaged by someone apparently trying to force entry.

The entry attempt was unsuccessful, but police were told a theft had been committed four days earlier.

Taken in that burglary were two cases of Diamond Little League baseballs. Each case contains 12 balls, and the total value was set at \$78, besides replacement of a new lock.

The owner of a pickup reported the vehicle had been criminally vandelized sometime Wednesday of last week, while parked on the west side of the high school building.

The owner said the vehicle's battery cables had been disconnected, and a cellular telephone antenna taken from the rear window.

Police were called to a residence in the 300 block of West Pecan Saturday afternoon, where a fight was in progress.

They arrested Randy Lee Gregory, 27, on a charge of Class A assault. He was taken to the county jail, where he later released after posting a \$500 bond.

The alleged victim was treated at a Wichita Falls hospital for a mild concussion, according to police.

Saturday is 'splash day'

Saturday will be splash day at Iowa Park Bicentennial Swimming Pool, to open the facility for the season, and the gates are to open at 12-

And it'll be half price swimming on the first day. General admission is regularly \$2 for all except children three years and younger.

But Saturday, the price of admission will only be \$1.

Regular hours this year will be 12-6 weekdays and 1-6 Sundays.

Full season memberships for families can be purchased for \$75,

while \$25 will pay an individual's season pass. To encourage more families to

use the pool, which was opened in 1976 on the west side of Iowa Park High School, a special fee of \$1 per member will be charged if they don't have a season pass.

The pool can be rented for private parties for \$50, for a two-hour period.

There are 103 candidates for graduation this year, according to Richard Davis, school principal.

Should weather not permit the event to be held out of doors, it will be moved into the school's auditorium. Each member of the class has been issued tickets for family members and guests, because of limited space.

This year's commencement address is to be delivered by George Collins, high school English teacher.

Counselor LaRae Collins is to make the presentation of honors, and school board president Keith Fisher is to present graduates their diplomas.

The traditional school key will be handed over to Brent Brown, next year's student council president, by T.J. Bean, senior class president.

Bean also is to give the invocation and Jolene Hodges the benediction. Davis will present the graduating class to Supt. Glen Mitchell.

The school song, processional and recessional will be played by the Hawk Band.

The Eighth Grade promotional ceremony is to get underway at 7 this evening, in the high school auditorium.


Cherri Halady, president of the student council at Iowa Park High School, is to be the guest speaker.

City to aid housing development

The city council Monday night verbally agreed to assist in the initial phase of a proposed housing develop-

Appearing before the council to explain the project were local realtor Tommy Key and Wichita Falls developer Tommy Hammond.

They requested the city participate in the initial phase, by paving and installing sewer and water, primarily as an "indication of the city's desire to have such a project here."

The development, to be constructed on an 88-acre tract on the north side of Country Hills Estate, is planned in four phases, and eventually would have 200 to 340 homes, depending on the size of lots once plans are finalized.

The city would recoup its investment as each lot in the initial phase was sold. And, should all the lots not be sold within a three-year period, the balance owed the city for its investment would be paid off by the developers, aldermen were told.

Hammond was agreeable to a suggestion that only a portion of the first phase shown the council on a map be initiated, and interest of homebuyers could be realized before further investment was made.

That would include some 26 lots. Price range of homes is yet to be determined, Hammond said, but they could likely range from \$70,000 to \$100,000.

A contractual agreement will be drafted for consideration of both the developers and city, before work is begun. The city likely would have to borrow the money to do the work, it was pointed out.

Hammond told the council of interest in new homes in both Wichita Falls and Burkburnett. He said he has three projects underway in Wichita Falls, and at one of them, the houses



Facts About Cholesterol

- A high level of cholesterol in the blood, over 240 mg/dl (milligrams per deciliter), could indicate the presence of heart disease.
- · A cholesterol level of 200 to 240 is borderline for risk of heart disease. Half of U.S. adults have cholesterol levels of 200 or greater.
- If your blood cholesterol level is 200 or less, you can assume that as far as cholesterol goes, you are at a low risk for heart disease.
- Cholesterol contains HDLs and LDLs. HDLs are considered "good." It is believed that they take cholesterol away from the arteries and back to the liver where it can be removed. LDLs are "bad" because they may deposit cholesterol on artery walls.
- Cholesterol is an odorless, tasteless, white, powdery substance present in all foods of animal origin.
- The three major dietary influences on blood cholesterol are saturated fat, cholesterol, and polyunsaturated fat. Saturated fat and cholesterol raise the blood cholesterol level. Polyunsaturated fats lower it.
- A low-fat diet can lower cholesterol levels. To cut down on saturated fat and cholesterol, eat more fruits, vegetables, grains, and starches.
- Eat only moderate portions of fish, poultry, and lean meats. Remove skin from chicken before eating and fat from meats before cooking. Avoid organ meats, sausage, bacon, and processed luncheon meats.
- Use low- or non-fat dairy products. Eat fewer than three eggs a week.
- Avoid commercial baked goods and fried foods.
- With you doctor's permission, exercise. Aerobic exercise, in particular, has been shown to lower blood cholesterol levels significantly.
- Maintain a normal body weight and quit smoking.
- Your cholesterol can be easily measured from a small amount of blood. Follow you doctor's advice on how often to have it checked.

AUSTIN - After more than eight hours of debate, the Texas House last week tentatively approved a multiple-choice school finance bill loaded with amendments unrelated to funding. The vote was 89-44.

Lawmakers repeatedly rejected attempts to use state money to establish woucher programs. They also defeated an attempt to dedicate state lottery proceeds to education.

The House measure attempts to satisfy a court order to equalize per-pupil funding by requiring the 109 districts with the highest property wealth to use any of five options to reduce the wealth to \$280,000 per pupil.

The districts could: ■ Consolidate their tax base with other districts.

Lower the wealth by sending a check to the state.

Pay to educate children in other school districts.

• De-annex property and transfer the tax rolls to a property-poor neighboring district.

The Senate, which earlier passed a business transfer tax plan, is expected to reject the House bill.

Party Host Not Liable

People who host parties have no legal responsibility for the death, injuries or property damage caused by guests who depart drunk, the Texas Supreme Court said in a 6-2 ruling last week.

In the majority opinion by Justice John Cornyn, the court said legal liability will remain with guests at social gatherings and not be extended to their hosts.

"The guest is in a far better position to know the amount of alcohol he has consumed, his state of sobriety, and the consequential risk he poses to the public," Cornyn wrote.

Dissenting Justices Bob Gammage and Lloyd Doggett said the majority was letting a "rattlesnake loose on the public streets and highways."

"The television commercial says, 'Don't let friends drive drunk.' Gammage wrote. "But today the majority says, 'Intoxicate your friends and send them out upon public streets and highways to drive drunk. Don't worry, you won't be

Senate OKs Gun Bill

After a five-hour filibuster last week, the Senate approved a bill that will allow voters to decide whether Texans should be allowed to carry handguns.

Adopted by a 23-8 vote, the Senate version of the controversial measure includes a provision that would allow only registered voters who pass a drug test to get licenses to carry a concealed weapon.

Although the House is expected to approve the Senate bill, Gov. Ann Richards says she will veto the measure after the Legislature adjourns May 31. Thus, lawmakers will have no chance to override her

Abortion Amendment Fails

With women casting the deciding votes, the Texas House last week narrowly rejected a proposal to require women to wait 24 hours before getting an abortion.

The proposal, a surprise showdown on abortion rights, came as an amendment to a "sunset" bill reauthorizing the State Board of Medical Examiners.



Perkins D.A.R.E.'s to keep kids off drugs

Attractive, vivacious, and looking sharp in her uniform of the Iowa Park Police Department, Laura Perkins isn't in that uniform to patrol the streets looking for law offenders. Rather, she is D.A.R.E.-ing to keep kids off drugs, and to prevent criminal acts.

Laura is D.A.R.E. Officer/Crime Prevention for the Iowa Park Police Department.

She has just completed teaching a 17-week D.A.R.E. session to fifth graders at Bradford Elementary School. More than 160 students have been involved in the program.

To be certified to teach the Drug Abuse Resistance Education sessions, Laura took an 80-hour, two week intensive training course at Kerrville.

This week she is in Dallas where she is taking a one week 40-hour course in Crime Prevention at the Dallas Police Academy.

Laura began working for the Police Department in November 1988 as a part time dispatcher, later going into full time and then to communications supervisor.

She has never been on patrol. She says, "I have always perferred public relations."

The Wichita Falls native has lived in Iowa Park 12 years and is married to Jackie Perkins. He is an employee of Associated Milk Producers in Windthorst. They have two children, a son Jacob, 12, and a daughter, Lynette, 8.

"Last year when DeeDee (Alderson) was going to quit teaching the D.A.R.E program, I was beginning to get tired of dispatching. I wanted to do more, so a applied for her job," Laura said.

She admitted another factor that sparked her interest to teach the program was that Jacob would be in the fifth grade the current school

The Perkins family is active in Floral Heights United Methodist Church in Wichita Falls. Their children are involved in sports, and Lynette sings with the Youth Choir. Laura also is active in the Student Outreach Program sponsored by the Iowa Park RAC.

Laura loves the job she is doing, just like she thought she would.

When she returned from her training in Kerrville, which included the study of the D.A.R.E. curriculum, classroom management and public speaking, she began planning for the classes and the materials she would need.

"Actually," Laura said, "it was more of a 'wish list' because I felt sure I could not have it all.

"I believe incentives are extremely important for children, so I filled out an order form that included T-shirts, workbooks, diplomas, rulers, bookmarks, bumper stickers and ID bracelets."

In a report Laura gave at a recent City Council meeting, she told council members she was given a check for approximately \$1,100 from the school board's Drug Education Fund.

The D.A.R.E. education program is unique in that it is taught in public schools by a uniformed law enforcement officer. It began in the Los Angeles Unified School District and is now nationwide.

D.A.R.E. program training for police officers is provided by the school district in conjunction with the police department.

Lessons for the program are structured by the national organization. The curriculum teaches students the skills necessary to resist drug experimentation.

Laura explained that the officer must follow guidelines on how to present the curriculum, or the program cannot be taught. A classroom teacher must stay in the room with the D.A.R.E. officer, a requirement of the state.

Although there is a D.A.R.E. program curriculum designed for K through fourth grades, it was thought best at this time to target fifth grade students, nearer the time they will be facing peer pressure in the higher grades, Laura said.

During the school year she spent about eight hours each week in the classroom during the Health and Science class periods.

She also spent time with the students in the cafeteria and on the playgound, helping to encourage a friendly relationship between the students and the police department.

Students also are allowed to discuss their feelings with their peers and there is a relationship of trust built with the officer.

She said, "Drug peddling and the number on drugs is not as bad here as places with a larger population, but the kids WILL BE approached to try drugs, not MIGHT BE."

Laura added "I believe I can safely say there is no drug use here among fifth grade students."

Those familiar with the D.A.R.E. program seem to agree with the LA

police department where it started, that it is the most promising long-range solution, and "holds great promise for producing future generations of young adults who not only have no appetite for drugs, but who also have strength of character to dissuade others from drug abuse".

They also agree that the most important partners in this effort are the children's parents to achieve the promise that D.A.R.E. makes.

Laura said, "The D.A.R.E. program is a substance abuse prevention education curriculum and focuses on accurate information about tobacco, alcohol and other drugs; decision-making skills; ways to resist a drug offer; negative peer pressure resistance; alternatives to drug use; using positive role models; life-coping skills, and building self-esteem."

The D.A.R.E. officer is adamant on the subject of building self-esteem. She says it is one of the biggest issues with children and drug abuse as well as to keep them from joining gangs. "Children and teen-agers definitely need a support system working for them," Laura said.

In discussing the "support system" Laura explained "It is much easier for a child to be a confident and assertive person when one feels good about himself.

"When it is all wrapped up, D.A.R.E. teaches that everyone needs affection, a feeling of belonging and recognition.

"The sense of belonging is simply the need to be treated with dignity, regardless of differences in viewpoint, dress or background. Parents need to recognize their children need to be noticed for the things he or she does right as well as what they do wrong, and they need to have affection shown under adverse conditions," she continued.

Laura suggests that along with their parents, a child's support can also come from a Sunday School

teacher, their classroom teacher, a coach, an older role model, or through family activities, and from family members.

"If a child, or anyo

"If a child, or anyone, but particularly a child or young person constantly has his self-esteem knocked down, is not recognized for good achievement, constantly is told he is no good, or compared to others and asking why they can't be like them, whether it is a sibling, or some other child, before long his self-esteem will be gone," Laura continued.

"If kids belong to a gang, or join some of their peers in drugs, they are made to feel good about themselves, "because you are one of us", she added.

Along with the D.A.R.E. program there is a guide book for parents which presents the concept that "it is difficult being a parent today, but so is being a kid."

The booklet has three sections, "Recognizing Drug Use", "Prevention" and "Parenting Skill Tips".

Many parents may not recognize the signs and symptoms of drug use in their children, or even in their spouses. The booklets list some of the signs and symptoms that go along with substance use and abuse, such as behavioral changes and school changes as well as physical evidence.

It also lists 15 ways to help children like themselves and have self-

The D.A.R.E. officer, committed to her job, is already beginning to work on her classes for next school

The essence of a speech made in 1986 by former First Lady Nancy Reagan to Just Say No Clubs is as true today as it was seven years ago, and is as necessary for children facing the problems today.

She said, "There is a drug-abuse epidemic in this country, and no one is safe from it--not you, not me, and certainly not our children.

"Drugs steal so much. Every time a drug goes into a child, something else is forced out, like love and hope and trust and confidence. Drugs take away the dream from every child's heart and replace it with a nightmare.

"That courage needs our encouragement. Each of us must put our principles and consciences on the line whether in social settings, or in the workplace--to set forth solid standards and stick to them. Where drugs are concerned, there is no moral middle ground. Indifference is not an option."


