Council accepts bid to build storm drain

The city council Monday night accepted the lowest of four bids to install a storm drain system on Douglas, with an aim toward relieving flooding problems.

Aldermen approved a bid of \$89,218 submitted by Zack Burkett to install the drain system. The bid did not, however, cover the cost of repaving the street under which the system will be installed.

Administrator Mike Price said the city's street crew could do the base work atop the drain, and Burkett could resurface the street at an additional cost of \$20,000 to \$25,000.

The project can be paid for without the city having to borrow the money, even though it was not in this year's budget.

Mayor Wayne House said the city has \$166,600 held in escrow, mostly from excess receipts above budget and monies unspent during the previous fiscal year.

Because the work will be done on Douglas, residents in that area will not be able to use the street to reach their homes. Instead, Price said the alleys will be worked over and vehicles can be parked there.

Residents, especially those on the

west side of Douglas, have always had problems with water rising over the curb during heavy rains, and sometimes it even reaches inside garages.

No resident has ever reported rising water reaching inside a home on that street, however.

The project has been discussed by previous councils. In fact, plans were drawn at the same time Johnson Road was re-built, and it was that plan that was used for the bidding process.

The other three bids on the project ranged from \$114,010 to \$125,255.

Council members held a lengthy discussion on problems at the city's sanitation convenience center. That is where residents dump tree trimmings and other debris, now that the city does not operate its own landfill.

The center is located along the old landfill road. Primarily it consists of a large metal roll-off container, provided by Bell Processing.

Price reported that the container is being filled primarily by dumpers other than city residents. Most of the volume is produced by roofing contractors, he told the council.

The container, which was anticipated to serve the needs of residents with adequate space to be dumped once

a week, Price said.

However, as many as 200 container loads are anticipated, because of use by commercial groups. And that could drive up the cost of service to private residents.

No decision was reached during the discussion, but the matter will be on the July 13 meeting agenda for possible action.

That action could possibly be the prohibiting of commercial users from using the convenience center. In that case, they would be required to rent the large containers from either of two available sources, it was explained.

Also the subject of another discussion was the proposed housing addition expected to be developed north of US 287 and on the west side of FM 368.

Alternatives for extending sewer and water service to the site were discussed, some of which could cut the initial cost of \$120,000 to \$160,000 by as much as 25 percent it was explained.

An ordinance providing for stop signs at Richland and Texowa, Richland and Garden and Aldine Court and Third

Mayor House read a proclamation expressing gratitude to Chuck Dyer for his voluntary assistance in helping with his welder when the water line connection was made recently on Johnson Road. "He saved us more than an hour," said House.

House and aldermen Johnny Crawford and Bud Mercer were officially sworn into office. All were unchallenged in the recent city election.

After Crawford asked to not be returned to the position of mayor pro tem, because of personal projects he expects in the near future, council members elected Mercer to that post.

The mayor also said he would develop a proclamation to be read on Friday, June 3, the day Barbour Trucking will be observing its 75th anniversary in Iowa Park.

Hawks thump Denver City; area game next at Lubbock

After defeating Denver City 6-4 in Bi-District Thursday, the Hawks now return to Lubbock for their Area showdown against Sanford-Fritch.

The game is scheduled for 5:30 p.m. Saturday, on the campus of Lubbock Christian College.

The winner advances to the regional semi-final, which must be played by Wednesday of next week, according to Coach David Fuhrman.

Sanford-Fritch, a consolidated school district near Borger in the Panhandle, defeated Muleshoe 10-5 to advance its season record to 18-9. The Hawks are now 17-8.

To reach the Lubbock Christian College campus, when entering Lubbock from Idalou, take the loop to the right to the Brownfield exit. Turn east under the loop, and LCC is about a mile from that point, on the right.

In their Area game last year, the Hawks battled back from a 5-0 deficit in the sixth inning to defeat previously

undefeated Canyon 7-6, and sent the Eagles home with a 28-1 record.

Following that, Brent Brown walked, and Tony Lozipone doubled to left field, racking up two more RBIs. Lozipone went home on a single by Robert Klinkerman.

When Clint Scobee blasted a single that was too hot for the third baseman to handle, Denver City called on its relief pitcher.

But David Hollis brought Scobee home with a single to left field, for Iowa Park's sixth run.

The Mustangs managed to score

one more run in the bottom of that frame.

In the sixth inning, the Mustangs' leadoff hitter reached first base safely, and the next batter clobbered a double off the 365-foot outfield wall.

Coach Fuhrman then decided to relieve starting pitcher Jason Young, who had thrown 108 pitches already, with Brown.

On his fourth pitch, the ball got past catcher Scobee, and DC's third run scored. But Brown struck out the next batter and the third grounded out to retire the side.

Brown gave up one more run in the seventh, but it was short of what Denver City needed to complete its rally.

The Hawks, led by Hawkins' two hits, got to Denver City pitchers for eight hits in the contest, but allowed nine Mustang hits.

Iowa Park was charged with three errors.

In one of my remaining duties as president of the Texas Press Association, I was in Port Aransas last week to attend the Gulf Coast Press Association convention. During that meeting, I had an opportunity to hear both sides of a problem that is a growing concern.

The problem, as phrased by one side of the debate, is lawsuit abuse. A member of the Bay Area Citizens Against Lawsuit Abuse contends that frivolous lawsuits cost the citizens of Texas over \$2,500 per household each year.

On the other side of the debate was a law professor and former president of

the Corpus Christi Bar Association. His defense was that all citizens should have access to the courts to settle damages.

After listening to both sides of the debate, I decided that three things needed to be done to stop the amount of money society spends on legal matters. Every product we buy carries a cost of liability insurance.

No citizen should be denied access to the courts, but that is not the reason a suit is filed. There has to be money available to pay the lawyers' expenses. You may have been overcharged a nickel for a loaf of bread at the corner store and have actual damages, but no lawyer will take the case because of the small amount involved.

Two things have greatly contributed to the increase in lawsuits filed. The first is the concept of "joint and several liability." Under that legal concept all parties are equally responsible for damages. It is also known as the "deep pockets" legal theory.

You may remember a few years ago a poultry processing plant in North Carolina caught on fire and a number of people were killed in the fire. One of the main reasons that the number of deaths were so high was that a truck had stalled outside the main entrance of the plant, blocking the door.

There is now a suit in the Texas courts seeking monetary damages against the company that supplied the fuel for the truck. If it is found that the fuel was even slightly responsible for the truck stalling, then the company will have to pay a large amount in damages.

The practice of "joint and several liability" should be ended by the Legislature. Instead, each party involved should pay only their percentage of the actual liability.

Another factor driving lawsuits is the payment of punitive damages. Those are funds ordered by the court to be paid by the loser of a suit to "punish" the individual or company.

Ironically, those funds are paid to the person that brought the suit and are included in the total settlement on which the lawyer handling the case is paid a commission. A better method would be for punitive damages to be

paid to the state, just like any other fine for wrong doing.

Finally, one of the major problems with our legal system in Texas is that most of the rules governing the courts were written by lawyer members of the Legislature. They are decidedly slanted in favor of trial lawyers.

Once a lawyer is admitted to the bar, they should be considered an officer of the court and member of the judicial branch of state government. As such, according to the separation of powers in the Texas Constitution, they would be ineligible to serve in the legislative branch of government.

Those three changes would go a long way toward reforming our legal system in Texas without denying anyone their day in court.

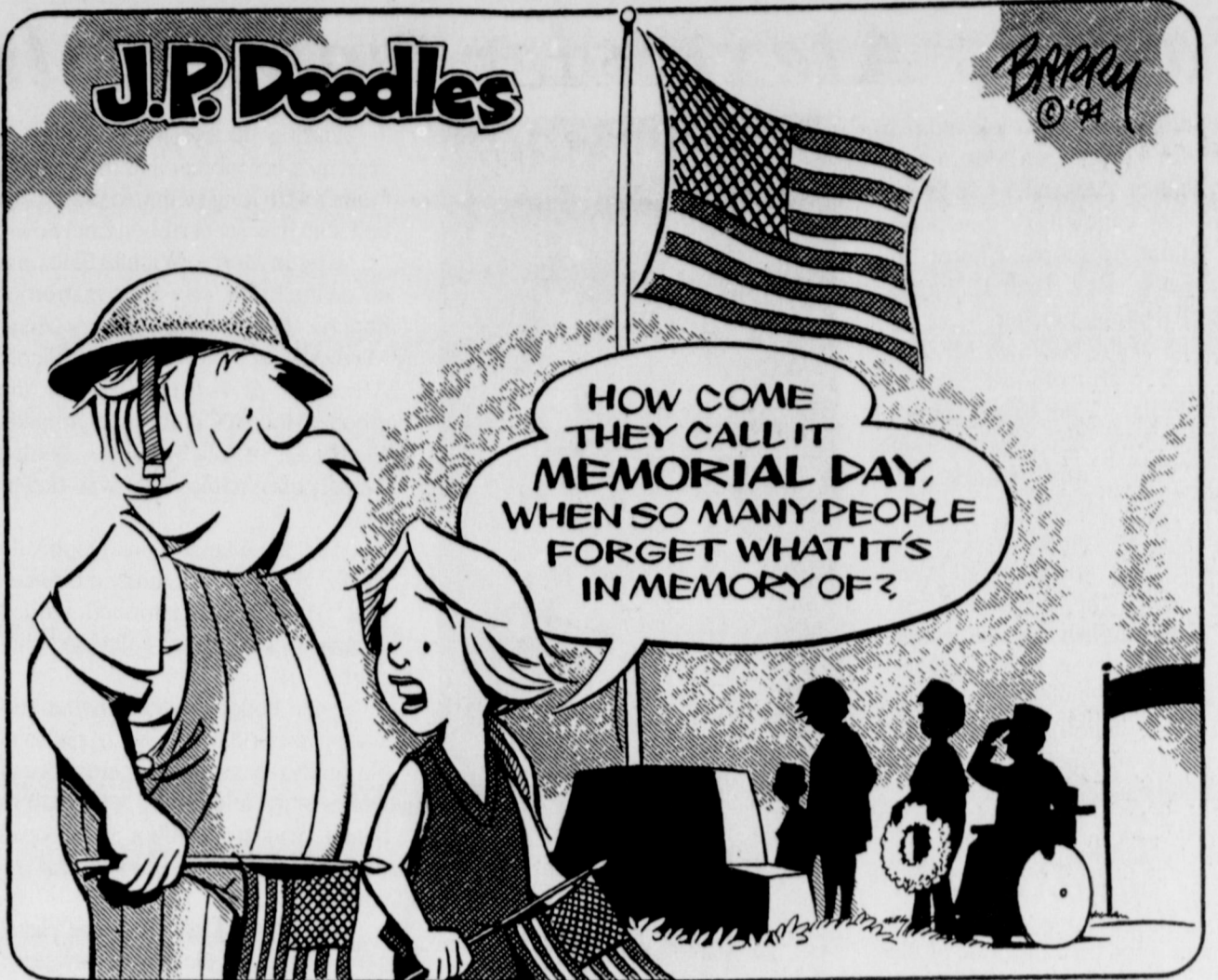

Long, hard process becoming a doctor

A young California girl of Russian and German descent had her sights set on a career in the medical field. She graduated San Diego County Hospital's School of Nursing as a Registered Nurse.

Nurse Elsie Smith went to work at Riverside County Hospital where she stayed two years. There she became very interested in anesthesiology. When she found out that nurses could give anesthesia, she immediately began pursuing that phase of the medical field.

And, through dedication, determination and many hours of hard work, Dr. Elsie Smith saw her career advance to a much wider field.

She began sending applications several places in the southern states because she did not want to go north where it gets so cold.

Dr. Smith learned that Charity Hospital in New Orleans offered a course in anesthesia for nurses and immediately contacted the hospital. She was accepted.

This was a nine months course and when she finished she was offered a job in Liberty, Texas by a general practitioner. She began working for him and did all of his anesthetics. But she still wanted more.

In 1946 she applied to the University of Texas at Austin for pre-med studies. She was accepted and graduated there in 1950.

Next she enrolled for four hard years at Southwest Medical School in Dallas. "It was fortunate that I had a profession to help me get through my four years there," Dr. Smith said.

She had met a nurse who was in charge of a small hospital in East Dallas and was doing all of the work herself. She hired Dr. Smith to work weekends so she could have some time off.

Dr. Smith worked as a nurse anesthetist during the summer months to have enough money for the next school year.

In 1954 Elsie Smith graduated

Southwest Medical School and became Dr. Smith. She did her internship at Baylor Hospital in Dallas and also her two years as a resident anesthesiologist.

She completed her residency in 1957 at the age of 39 and began her own practice. Later she began working with three Dallas doctors.

In 1964 Dr. Smith came to Wichita Falls and began working at Bethania Hospital.

About 1970 Dr. Smith formed a partnership with Dr. Clark Bondurant of Iowa Park, who was the father of

Alyce Bondurant, Iowa Park attorney. Together Dr. Smith and Dr. Bondurant formed the present North Texas Anesthesia Group.

"I have always loved the work I chose for myself," Dr. Smith said, "and I still love it and am interested in keeping up with the latest trends in that field".

Dr. Smith retired in 1987 at the age of 70.

But there has been more in Dr. Smith's life than anesthesiology. She

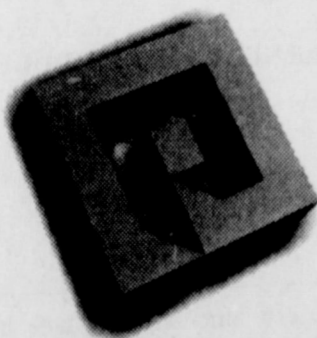

Children's eating habits important

Habits are learned. Undesirable eating habits are learned or formed the same way as healthful eating habits. It's the kind of foods provided that makes the difference.

What you bring home from the grocery store will decide the kinds of foods your children eat. You are in control of what's in the refrigerator.

When you have a selection of tasty, nutritious foods on hand, your children have the opportunity to enjoy them. When foods such as potato chips, candy, cakes, soda pop, sweetened cereals and sugary cookies are available, kids learn to eat these kinds of empty calorie foods.

It's important that you provide a wide variety of nutritious foods yourself. Children learn from adults. If you snack on empty calorie foods, your child is likely to do the same. If you drink water or fruit juice

more often than soda, your child will learn to enjoy these beverages.

Take time to look more closely at your own eating habits and decide how you might change them to set a better example.

Involve children in planning and preparing meals and snacks. This helps them feel that they can make a real contribution.

Help your child develop an open, adventurous attitude toward trying foods. Be relaxed about it. Help your child use the appetite and desire for food that he or she was born with.

If the foods you provide your children are basic, nutritious foods the human body was designed to eat, chances are your children's health won't suffer even if it seems as though they don't eat enough to feed a bird.

If you are concerned about your child's eating habits because he or she isn't growing or seems tired, pale or

irritable most of the time, check with your doctor.

Usually, a child who likes all kinds of different foods is more likely to be well-nourished than one who does not.

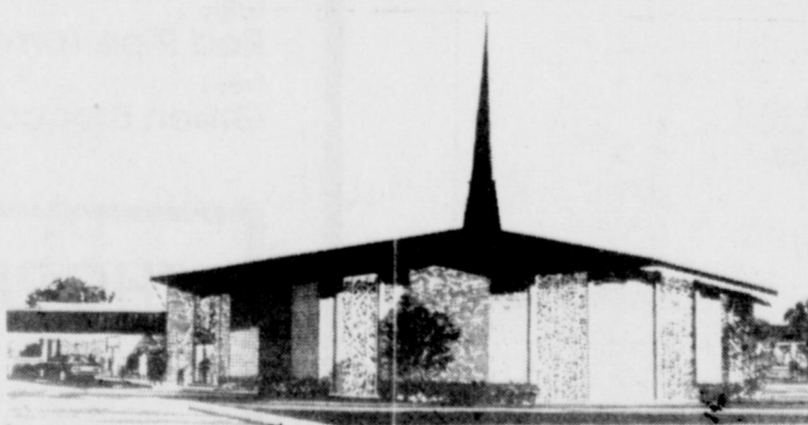

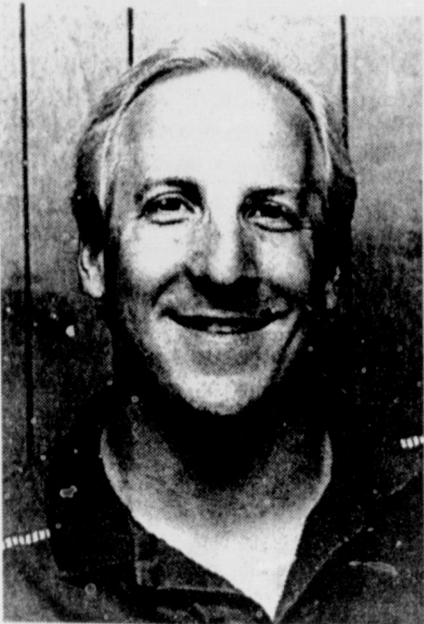

Our featured cook, Jim Murfield, has a great love of the outdoors, and lists golf, softball, rafting, scuba diving and hunting as his favorite pastimes.

Jim's interest in hunting is reflected in some of his recipes, such as "Roast Duck" and "Grilled Catfish." Although lately he has been preparing "healthy" foods like pasta salads, spaghetti, vegetables, etc., he said occasionally he has to give in and have "Mom's Enchiladas."

The son of Jim and Sharon Murfield, Jim has lived in Iowa Park most of his life. He is a 1978 graduate of Iowa Park High School, and attended Midwestern State University before going to work at Cryovac 15 years ago.

Jim has a son, Parker, who is 10 years old, and a seven-year-old daughter, Jordan. He is the coach for his son's Little League baseball team.

Jim said that he has been cooking about four and a half years, and got most of his recipes from his mother.

Grilled Catfish

- Catfish fillets (as many as wanted)
- Lemon
- Pepper
- Butter

Light the cooker and let the coals cook down. Cover the grill with foil and cut vent holes in foil. Grease foil with butter.

Baste the fish in butter, lemon and pepper to taste. Put in 300 degree oven 15 minutes.

Put fish in cooker, cover, and let cook until flaky.

COOK OF THE WEEK

Roast Duck

- 4 wild ducks, cleaned
- 2 tsps. salt
- 1/2 tsp. pepper
- 2 Tbsps. flour
- 1 cup water
- 2 Tbsps. butter, melted
- 1/2 cup chopped onion
- Lemon slices (optional)

(Jim soaks the ducks in milk, a few hours or overnight, to get rid of the gamey taste.)

Place ducks, breast side up, on a rack in a large roast pan, folding neck skin under.

Combine salt, pepper and flour and stir well. Sprinkle ducks with flour mixture. Combine water, butter and onion. Pour into roasting pan.

Bake uncovered at 400 degrees for 1 hour, or until drumsticks move easily. Garnish with lemon slices, if desired.

Orange Sauce

- 2/3 cup firmly packed brown sugar
- 2/3 cup sugar
- 2 Tbsps. flour
- 2 Tbsps. grated orange rind
- 2 cups orange juice
- Dash of salt

Combine all ingredients in a saucepan; cook over medium heat until thickened. Great when served with Roast Duck.

Mom's Enchiladas

Heat 4 - 6 cans of chili without beans. Spread a small amount in bottom of large pan - just enough to cover.

Brown 3/4 to 1 lb. of ground meat. Add salt and chili powder. Drain and put in a bowl.

Finely chop 2 medium onions. Grate 1 block Cheddar cheese and 1 block American cheese or Monterey Jack cheese. Mix together.

Heat oil to medium hot and dip corn tortillas in and out quickly. Drain on paper towels. Only do 3 or 4 at a time.

Place a spoonful of meat on 1 side of tortilla; add onion and cheese. Roll up and place seam side down on chili in pan. Continue until pan is full. Makes 2 - 2 1/2 dozen.

Cover with chili, then cover with cheese. Cover with onion. Cover with foil and bake 30 minutes at 350 degrees.

Can be made ahead and refrigerated or frozen, and then cooked.

has led an interesting life away from the hospital also.

Not long after she and Dr. Bondurant formed a business partnership, they purchased 100 acres of land north of Iowa Park. Dr. Smith eventually purchased Dr. Bondurant's one third interest in the place.

She has 60 acres planted to wheat and raises cattle. In the past she has had riding horses.

For several years Dr. Smith and her neighbor, who lives south of her in the home place that belonged to the original owners of the land, did all of the work on the farm. They worked the land and with the livestock.

Dr. Smith's interesting brick home was moved to the farm from Harrison and what is now Kell in Wichita Falls. It is a lovely, comfortable home with many books and art works.

It is a simple matter of deduction to know that until her eyesight began to fail Dr. Smith was an avid reader because of the books on the shelves that line the wall in the den.

She also was a gardener, both vegetable and flower gardening was a speciality with her. This is the first year she has not planted her garden herself.

When she lived in Colonial Park in Wichita Falls, before moving to the farm, she had a beautiful Oriental garden.

Another interesting hobby Dr. Smith has had in the past—she was a rock hound. She had all of the equipment a rock hound has to work with. She had taken a course in jewelry making at the Y in Dallas, and created several pieces of jewelry from polished stones. She loved hunting rocks with the same enthusiasm she has for everything else she spends time with.

Another interest she had when she could undertake it was doing carpentry work.

In looking around her home and the art work, I noticed an unusual shaped stringed instrument somewhat like a guitar. I had to question what it was and another interesting bit of Dr. Smith's background was revealed.

She explained to me that it was a Balalaika, a Russian stringed instrument that she remembered so well her father playing while she was growing up at home.

Then she told me that her mother and father both came to America from Russia. Her father was born in Russia and her mother was born in Germany. "She came to America, to Los Angeles in 1912", Dr. Smith said, but she isn't sure the year her dad came.

Her mother's ancestors had mi-

grated from Germany to a German Lutheran Community in southern Russia in the 1700s while Catherine the Great was reigning in Russia. Dr. Smith's mother was very young when she met and married her father in Los Angeles.

Dr. Smith's father's name was Aleck Kuznetsoss. The last name when translated means blacksmith. Her father kept his given name, but changed the last name to Smith.

Dr. Smith has an intriguing collection of frogs displayed on her large dressing table in one of the bathrooms. The wallpaper in that room also has a whimsical frog pattern.

The frog collection came from all over the world that she has purchased on her many travels.

Dr. Smith's sister, Vera Davis of Wichita Falls, moved to Texas from California after her retirement in 1980. She and Dr. Smith have done a lot of traveling, taking one big trip each year.

They have travelled many countries, including France, Austria, Germany, Portugal, Chili, England, Ire-

land, Russia twice, the Greek Islands, Anartica, Japan, and Hong Kong, among others, and in addition to three Caribbean cruises.

Dr. Smith said she thinks the last trip they took in 1993, was the best. "It was marvelous," she said. "We had the most marvelous accomodations, thanks to the cruise line. We gave up our reservation for someone and got a lot better deal. They put us in a lovely three room apartment on the 12th deck.

"We left San Pedro, Calif., and went through what is called the Mexican Riviera, and through the Panama Canal. We ended up in Puerto Rico and flew from there to Dallas, and it was wonderful all the way".

Dr. Smith is active in First Step. She is a member of Redeemer Lutheran Church in Wichita Falls and was active in the Braille program of the church, which her sister supervises.

Since the past few months Dr. Smith has not been able to attend church services, her sister always brings her a tape of the sermon. She has been cooking her meals lately and

comes out every afternoon and stays several hours.

Although Dr. Smith has had to curtail her activities for the time being, she still maintains an active interest what is going on in the world and on her farm.

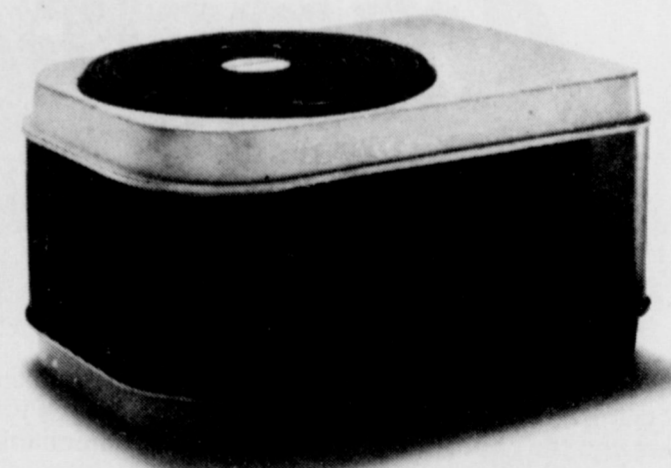

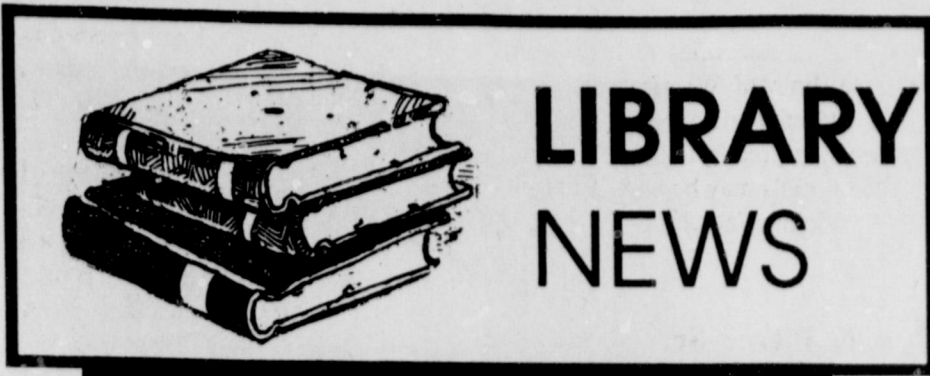

AUSTIN — Gov. Ann Richards last week defended her administration against reports that the state has done a poor job of handling a \$10 million grant that has been suspended by the National Science Foundation.

The governor said funding for the grant to help the state teach math and science was halted by the Texas Education Agency to expand the program statewide rather than have pilot programs on a few campuses.

But Republican gubernatorial candidate George W. Bush's campaign said the suspension of the grant indicates the governor has done a bad job of administering education in Texas.

"The TEA stands front and center for mismanagement and jeopardizing federally funded grant programs. The TEA train is off the track," said Bush spokeswoman Deborah Burston-Wade.

Jack Fackler, a Texas A&M chemistry professor, told the *Bryan-College Station Eagle* that the program had failed so far in Texas because of "ineptness on the part of our state agencies and our governor

to administer the issues that needed to be addressed."

The program, developed by the University of Texas, was put in place in the 1992-93 school year. Education Commissioner Lionel "Skip" Meno asked last year that funding be temporarily stopped so he could redesign the program.

Richards and Meno said they hope funding will be restored once

the National Science Foundation hears their side of the story.

KBH Releases Tax Returns

U.S. Sen. Kay Bailey Hutchison released her federal income tax returns for the past two years, but her Democratic opponent in the November general election, Richard Fisher, does not plan to do the same.

Financial disclosure statements required by the Senate show that in 1993, Hutchison and her husband, Dallas bond lawyer Ray Hutchison, had a combined adjusted gross income of \$643,842 and paid taxes of \$211,942.

In 1992, the Hutchisons' gross income was \$233,102 after losses of \$560,012 from real estate and oil and gas investments. They paid \$114,327 in taxes that year, with \$89,151 to be applied to their 1993 tax bill.

After Hutchison disclosed her tax returns May 17, Texas Republican Party chairman Fred Meyer of Dallas suggested that Fisher do the same. But Fisher's spokesman, Martin Johnson, told *The Dallas Morning News*, "At this point we have the same position as before. There are no plans to do that right now."

McKenna Seeks GOP Post

A third candidate joined the race for the chairmanship of the state Republican Party last week.

Dolly Madison McKenna, 45, a two-time congressional candidate, joins two others seeking the post: U.S. Rep. Joe Barton of Ennis and Dallas lawyer Tom Pauken.

The next chairman will be chosen at the party's Fort Worth convention in June.

A Houston businesswoman, McKenna said she wanted to offer Texas Republicans a more moderate message. She supports abortion rights, while her opponents oppose abortion except in cases of saving the mother's life.

Gonzalez Gets JFK Award

U.S. Rep. Henry B. Gonzalez, D-San Antonio, who almost lost the chairmanship of his congressional committee when he blamed bank executives and regulators for the savings and loan scandal, will receive the John F. Kennedy Profile in Courage Award.

The honor recognizes people

who show political courage and is conferred by a committee that includes the late president's children, Caroline and John F. Kennedy Jr.

Gonzalez, 78, used his seat on the House Banking, Finance and Urban Affairs Committee, which he later became chairman of, to speak out against deregulation he predicted would lead to the crisis in the savings and loan industry.

Other Highlights

Richard Fisher spent nearly \$1.8 million, including \$1.4 million of his own money, to win the Democratic nomination for U.S. Senate, according to a report issued by the Federal Election Commission. Sen. Hutchison, a Republican, spent \$1.7 million on her re-election campaign, without using any of her own money.

GARDENING HINTS

By MARK TERNING, COUNTY AGENT - HORTICULTURE

Pecan crops require special protection during late May to early June in the local area.

Pecan nut casebearers, the most damaging pest of pecans, can destroy your developing pecans if not controlled. The first generation of this pecan pest is the most detrimental to young nutlets.

Based on predictions of first significant nut entry, orchard monitoring and weather data the time frame of May 25 to June 5 will be the period for applying control measures in the Rolling Plains region.

Remember Memorial Day as a reference date for spraying to control this pecan pest.

Homeowners can use malathion for control sprays. Commercial grow-

ers can utilize Lorsban, Guthion, Sevin, Ammo, Cymbush, Asana or Malathion. Follow all label directions and rates when applying pesticides.

The best time to control the pecan nut casebearer on a specific tree or in a commercial orchard should be determined based on inspection of the developing pecans at the location.

Trees should be inspected beginning now.

Eggs should be tagged so hatch can be monitored. When a nut entry is found for every 100 clusters inspected, insecticidal control measures should be applied.

A single carefully timed application will often provide adequate control of first-generation casebearers. However, a second application may be

needed if unhatched eggs are found seven to 10 days after the first application.

The greenish-white eggs are deposited on the tips and just below the bracts of the small developing nuts. Eggs become reddish before hatching in four to five days. The newly hatched larvae feed on buds for two days before they enter the nuts.

Second-generation casebearer eggs will be deposited in the grooves on the nut tip or bases, or on the buds, about 42 days after the first generation eggs are observed. Treatment for the second generation is suggested if two percent of the pecans are infested with eggs.
