Company Agrees To

Lease Hospital,

Hendricks

County Commissioners and Dr. Lawrence Gayao met with James Reese and Ron Hand, representatives of United/ McKenzie, a hospital management corporation based in Memphis, Tennessee, to negotiate leasing the Callahan County Hospital. Also present at the meeting was Bill McKennon, Hendrick Medical Center representative, and Larry Beam present hospital administrator.

Provisions in the lease requires United to pay in advance \$12,000 for a six months lease which the county will match one time. This money and future rent will go into an escrow and be used to buy equipment to update the existing services, such as lab equipment.

All purchases made will remain at the hospital as property of the county.

Mr. Hand stresses that there would be no drastic changes in personnel, except those that are not properly licensed. The hospital has lacked the proper personnel to perform some of the duties that are required for surgery. It is a possibility a surgical team could be brought in on a once a week basis.

One of the first changes that will be made, will be to remove 6 beds from rooms that don't meet foorage require-Extends 15 Days ments for two beds. Rooms will be renovated and possibly electric beds installed.

> Changes that are made or equipment installed will comply with the needs of the hospital and doctors.

> City attorney, Robert McCool, suggested some redefinitions to be made in the lease before Commissioners sign.

Mr. Hand asked Hendricks to extend their stay 15 days in order for the hospital to stay open and operating until proper license could be obtained.

As it stands now, United will take over operation of the hospital October 1, 1982.

# Shooting Spree Leaves Two Dead, One Critical

Bobby N. Williams, 49, of Dudley shot and fatally wounded his Common-law wife and young step-daughter. A nephew of the dead woman was also shot and was at press time in critical condition at Hendrick Medical Center.

Linda King, 32, and her daughter, Nikki King, 9 were pronounced dead at the scene by Justice of Peace, Lee Savell. at 1:06 p.m. Tuesday afternoon. Mrs. King suffered a chest wound and the child received the fatal shot in the head.

Michael Haney, 17, a step-son, of the dead woman's sister, of Dosset, Texas, ran to a neighbors house, Betty Johnson, and reported the slaying to her, himself critically wounded.

Callahan County Sheriff's Department received a call from Mrs. Johnson at 12:10 p.m. at which time officers responded to the murder scene. APB was put through to Abilene on the suspect at 1:06 to all law enforcement officers.

At approximately 1:12 p.m., Williams drove by the scene of the crime and neighbors pointed him out to deputies. After a short pursuit county deputies apprehended the suspect at 1:15 p.m.

Williams told deputies that he had been given only 6 months to live by Dr Gayao about six months ago, and due to family problems and cancer he was fed up with it all. After driving around Potosi trying to purchase more shells for the 22 automatic rifle he had usec earlier, and being unable to buy more he then drove back by the Dudley residence.

. Charges of 2 counts of murder and 1 count of attempted murder have been brought against Williams. Bail bond for the murder charges is \$50,000 each and \$30,000 for the attempted murder. Subject is in custody at Callahan County jail at this time.

## County Cities Recieve Tax Share Refund, All Show Increase

State Comptroller Bob Bullock Monday sent checks totaling \$97.9 million to 967 Texas cities as their share of the onepercent city sales tax for August.

"So far, these monthly rebates of local taxes are running nearly 12% ahead of last year's totals," Bullock reported. "As we predicted last month, the oil glut has slowed down the pace of this growth





## Postal Services Gives Tips For **Mail Fraud Prevention**

Theft of mail is a vio- prevent theft of mail from lation of Title 18, United States Code, Section 1708, which carries a maximum penalty of five years imprisonment and/or a \$2000 fine. Unfortunately, criminals pay little attention to the consequences of their immediate actions.

The Postal Inspection Service is attempting to



all sources by informing and educating as many elements of society as possible. The United States Postal Service is a principle victim but the ultimate victim is a business or individual who depends on mail for their livelihood and existence. The loss of a social security or retirement check addressed to an elderly or retired person can have devastating emotional and financial significance.

Mail is most volunerable at the point of delivery. An extra effort should be made by mail recipients to know their carrier's schedule and make every effort to be at home to personally accept delivery of caluable mail. Retirement and social security checks are delivered on a fixed schedule which is known by the addressee and criminals as well. Have a neighbor retrieve your mail if you cannot be available and do the

same for your neighbor. Also, deposit your mail for collection at a post office or collection box. If this is inconvenient, place letters on your house letterbox for collection shortly before your carrier arrives. Your personal mail can be used most effectively to defraud your bank, consequently creating a very inconvenient situation. Make every effort to protect your incoming as well as outgoing mail by using these common sense suggestions.

Crime prevention can be a community effort. Everyone receives mail almost on a daily basis. This provides common grounds for neighbors to become better acquainted and watch our for each others mail and mailbox. If a concentrated effort is made to protect your mail, potential mail thieves will not be given the opportunity to make you a victim.

If you have information regarding theft of mail, contact your local Postal Inspector or Postmaster.

#### FREE EDUCATION AND THE UNDOCUMENTED WORKER

On June 15, 1982, The Supreme Court ruled, 5-4. that Texas and other states must provide free public edu cation for the children of undocumented workerspeople in this country illegally.

Our current Lt. Governor. Mr. Hobby, was happy with the decision, praising it as the "only rational decision" the court could have made.

On the contrary, I think it was a wrong decision that defied both law and logic.

One of the principal underpinnings of an orderly society is that one should not benefit from breaking the law. All around the world. thousands of people stand patiently in line at our embassies, waiting for legal entry into this country. By its recent ruling, the Supreme Court told these people that. if they are smart, they will ignore our immigration laws. find some other way to enter. and then there's a good likelihood all manner of taxpayer-supported benefits

will be open to them and their families.

We can all feel sympathy for people driven to emigrate by desperate economic conditions. And I believe we should be compassionate toward the children of undocumented workers who are here through no fault of their own. We have been told we must educate these children and we will: it is our duty.

But I am deeply concerned about the effect this will have on our school systems and the quality of education. We have only a certain amount of desks and dollars with which to address the problems of educating Texas' children.

The court was essentially establishing social policy under the guise of ruling on a constitutional question. The result was bad law and bad social policy. It should now be up to the Federal Government to help pay for the mess they have created by not properly policing our

#### **Public Safety** Gives **Accident Report**

The Texas Department of Public Safety reports that for the first six months of 1982, 65 persons have been killed in traffic accidents in the Abilene District of the D.P.S. The Abilene District comprises 25 counties in this West Texas area including Callahan County. These 65 deaths were the result of 53 fatal accidents. For the same period in 1981, records indicate that 66 deaths resulted from 56 fatal accidens.

In Callahan County for the first 6 months of 1982, the D.P.S. has recorded 4 deaths out of one fatal

accident and 67 injuries as the result of 89 injury accidents. D.P.S. troopers in Callahan County have investigated a tital of one hundred-twenty-three traffic accidents for the first 6 months of 1982.

For the same period in 1981, in Callahan County, D.P.S. records indicate that 4 deaths resulted from 4 fatal accidents and 32 injury accidents occurred with 56 persons injured. A total of 106 accidents occurred during the same period last year.

A survey of the fatal reports for the District shows that driving while intoxicated and speeding was listed as the contributing factor on more of the reports than any other single factor.

### NRA Wins First Round Legal Battle In San Francisco

The California Court of Appeals today granted a National Rifle Association legal request and ordered the city of San Francisco to prove that it's newly passed handgun ban is not illegal. The court set September 22 for a hearing date.

In Washington, NRA officials were jubilant over their first round victory.

"It's a major step towards knocking out the ban," said J. Warren Cassidy, executive director of the NRA Institute for Legislative Action. "Our attorneys maintained the ban violated several provisions of California law, including the state's gun control preemption statute.

Now it is up to San Francisco to legally justify this atrocious ordinance."

The court did not issue a temporary stay against enforcement of the ban, which technically took effect today, since the statue gives citizens 90 days to surrender their handguns. A decision on the ban's legality is expected prior to that time.

The NRA brought suit against the ban July 19 on behalf of city residents George Soracco, William Capilos, Beau Hickory and the San Franciso Gun Exchange, a federally licensed firearms dealer. The San Francisco firm of Pillsbury, Madison and Sutro is handling the case.

Congressman Hightower serves on the conservation, credit, and rural development subcommittee within the Committee on Appropriations. He will speak about 12:30 p.m.

Jim Boykin, district conservationist for SCS at Baird, said the public is being invited to the event. The center serves both Texas and Oklahoma.

Guided tours will be conducted through the 90-acre center from 9:00 a.m. to 2:30 p.m. The center is

located on FM 1292, 2 miles north and 21/2 miles west of Knox City.

A barbeque lunch will be available on a prepaid basis at \$4.50 per plate. Payment should be sent to Ms. Doris Crownover, Chamber of Commerce, Box 91, Knox City, Texas 79529 by August 20.

Seed or rootstock from native plants that show potential for solving specific soil and water conservation problems are collected, then grown and evaluated at the Knox City Center. The more promising ones are then tested under field conditions by farmers and ranchers cooperating with local soil and water conservation districts. Selections which pro-

ve superior to commercial varieties are then released to seed growers. These producers then grow seed and sell it to the public.

Sevaral hundred strains of grasses, legumes, forbs, and woody plants are being tested at Knox City.

SCS also operates a plant materials center at Kingsville in cooperation with the Caesar Kleberg Wildlife Research Institute, Texas A&I University, and the South Texas Association of Soil and Water Conservation Districts. The South Texas center was established in 1981.
