## City purchases equipment to help storm warnings

Sixteen years to the day after Wichita Falls was struck by a disastrous tornado, the Iowa Park city council approved purchase of equipment to assist in watching approaching bad weather conditions.

And as ironic as the 16-year anniversary of the Wichita Falls tornado was the fact that earlier Monday, the entire area had been under a tornado watch situation.

Aldermen voted to purchase the Data Transmission Network Weather Center, a piece of equipment that was acquired a year ago by Burkburnett.

Making the recommendation were City Administrator Mike Price and Police Chief Ray Smock, who explained they had observed the equipment at Burkburnett and returned impressed with its capabilities.

The annual expense will be \$818.88, following a \$295 initiation fee, aldermen were told.

Another purchase approved by the council was a four-wheel diver tractor/

loader for the waste water treatment plant.

Though the bid of \$14,835 submitted by Texoma Tractor Co. was not the lowest received, council members said they wanted to be sure to buy equipment that would do the work expected of it, and over a long period of time.

Price told the council the company had agreed to replace the loader bucket in the bid with a larger unit, and not increase its price. The larger bucket was needed, according to the administrator.

The Housing Advisory Committee appointments were made by Mayor Wayne House. Besides himself on the committee will be Price and Alderman Johnny Crawford.

Seven applications have been received for consideration, under the first-time ownership program, Price said.

A resolution accepting the water works contract project completed by Bowles Construction was approved.

The project included construction of water and sewer service to Highland Park Addition, on the north side of US 287.

During general discussion, the mayor expressed several projects he would like to achieve this fiscal year, including: purchasing paper weights to be given as gifts on certain occasions; overlaying asphalt on the downtown business streets; establishing at least four more gas lights in the 200 and 300 blocks of North Wall, and possibly replacing some sidewalks in the downtown area, including ramps to meet requirements of the Americans with Disabilities Act.

## Arrests keep police busy

Of the eight arrests made by Iowa Park police during the past week, five of them were made Sunday, according to the police blotter.

All of Sunday's arrests were made during a four-hour period. Three were for public intoxication and the other two were domestic disturbances.

The first of the arrests was recorded in the blotter at 2:28 a.m., during a traffic stop at Park and Bell. Julian Tovar, 29, was taken into custody on a public intoxication charge, and released at 8:40 a.m. after paying a fine of \$280.

Then, at 2:41 a.m., two occupants of a vehicle were arrested in the 200 block of North Victoria on public intoxication charges, and a computer check determined both were wanted on outstanding warrants.

John William Johnson, 23, had an outstanding warrant for public intoxication, and received a second charge for that offense. He was released at 9:40 a.m. after signing a personal recognizance bond.

The other occupant, Audrie Wheeler Meissner, 24, was charged with public intoxication. Two outstanding warrants against her included violation of seat belt for occupant under four years of age, and seat belt violation. She was released on personal recognizance at 9 a.m.

Police were summoned to the 200 block of West Pecan at 4:50 a.m., where a domestic disturbance was underway in the front yard. Michael Gene Benson, 21, was arrested on a Class C assault charge, and released at 11:10 a.m. on personal recognizance.

Carrie Lewis, 19, was taken into custody in the 500 block of North Pacific at 6:02 a.m., and also charged with Class C assault. She was released

## Vandals inflict heavy damage

A Caterpillar bulldozer and crane, owned by the county and located at the county's rock quarry, sustained heavy damage at the hands of vandals last week.

A county employee discovered the damage last Wednesday when he arrived at the quarry, located just west of Highland Cemetery.

It appears that one or more individuals entered the quarry area between March 31 and April 5, and with rocks and bars completely demolished all the glass, lights, instruments and gauges on the equipment. According

to Gordon Griffith, County Commissioner, over \$5,000 worth of damage was caused.

A similar incident occurred at the quarry in 1992, when equipment was vandalized.

Anyone with information regarding the vandalism may call David Duke, Wichita County Sheriff's Dept., 766-8170.

Also, according to Duke, up to a \$1,000 reward is being offered through Crimestoppers for information leading to the arrest and indictment of the individuals involved. No name must be given to Crimestoppers.

## Contracts, plans on board's agenda

The bulk of tonight's regular monthly meeting of the school board is contracts for support employees and proposals for the 1995-96 school year.

The meeting, which is not scheduled to commence until 8:00, will be held in the junior high school library.

Following a session which will be closed to the public, trustees are to consider 1995-96 contracts for auxiliary employees.

Considerations for next year include:

- \* entering into a written agreement with the Band Booster Club to purchase a new equipment trailer;
- \* funding for Saxon Math program at the junior high; and,
- \* proposed boys' and girls' basketball tournament trips.

Also on the meeting agenda, other than the usual monthly reports on transportation, cafeteria and enrollment, are a proposed fifth grade gifted and talented student trip May 19 to the Science Place in Dallas, and a transfer request of a student who has been in the

district all this year.

Both the math program for the junior high and band trailer proposals were discussed during last month's meeting, but further study on both was requested.

Between then and Thursday, a trip was to have been made to trailer manufacturing plants in Oklahoma, to determine quality and design, so a specific recommendation is to be made.

Trustees voiced no opposition to adopting the new math program at the junior high level, because it is already in place through the fifth grade.

The board is to decide whether to adopt it in all three junior high grades at one time or one year at a time, as this year's fifth graders advance.

Also under consideration is whether the district is to fund the Saxon Math books, which are not funded by the state because the state textbook committee has not adopted them.

Legislation is being considered in Austin to allow districts to choose the textbooks of their choice, and the state fund those purchases.

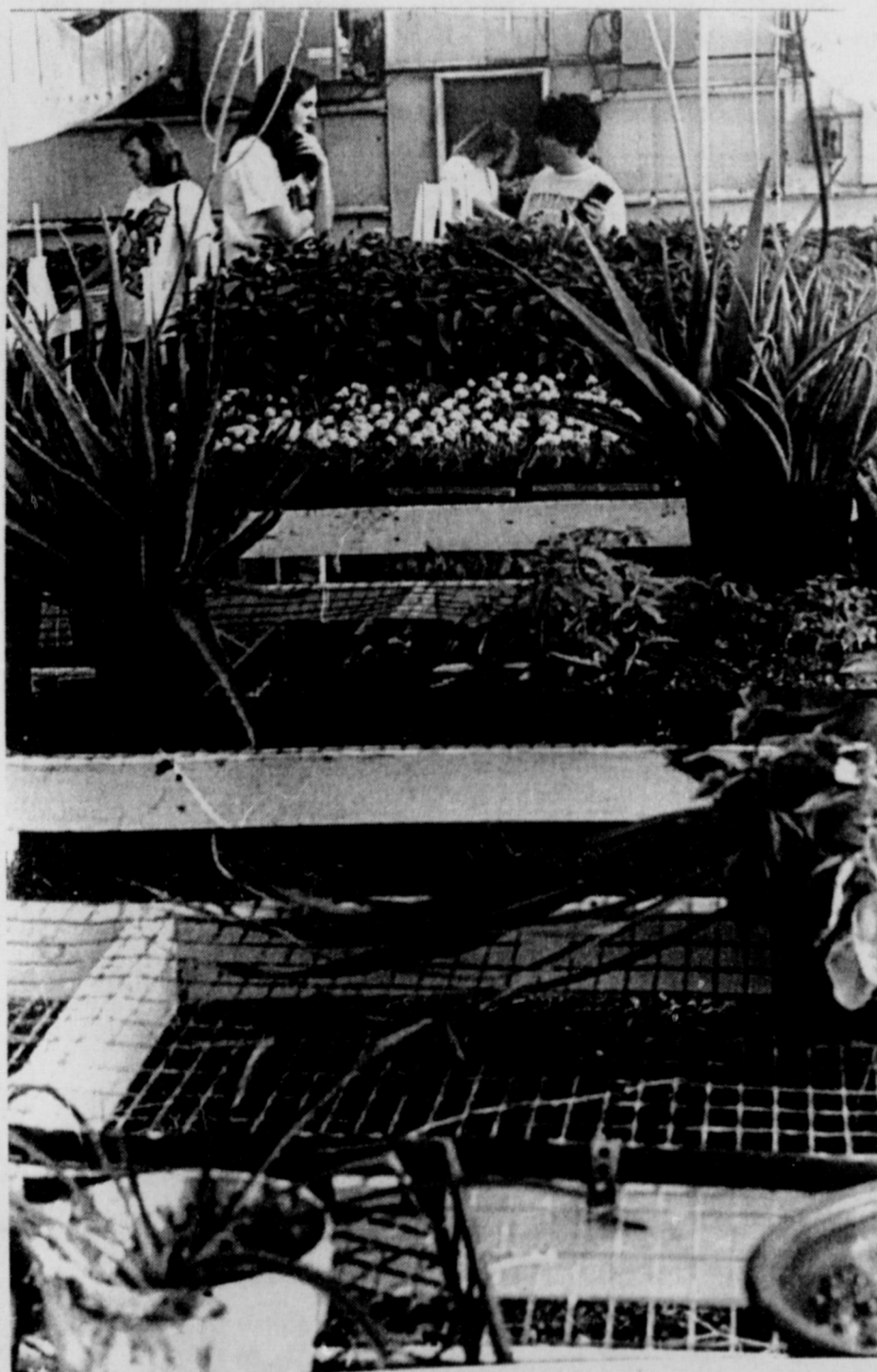
Because of the early printing, all deadlines will be moved back one day: display advertising, 4 p.m. Monday, and 12-noon Tuesday for classified advertising.

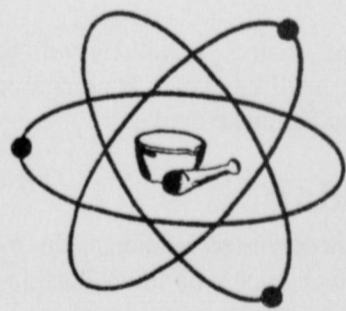

Best man was Bennie Bernard of Devol, Okla. Ushers were Eddie Kuykendall of Randlett, and Les Vassar of Wichita Falls.

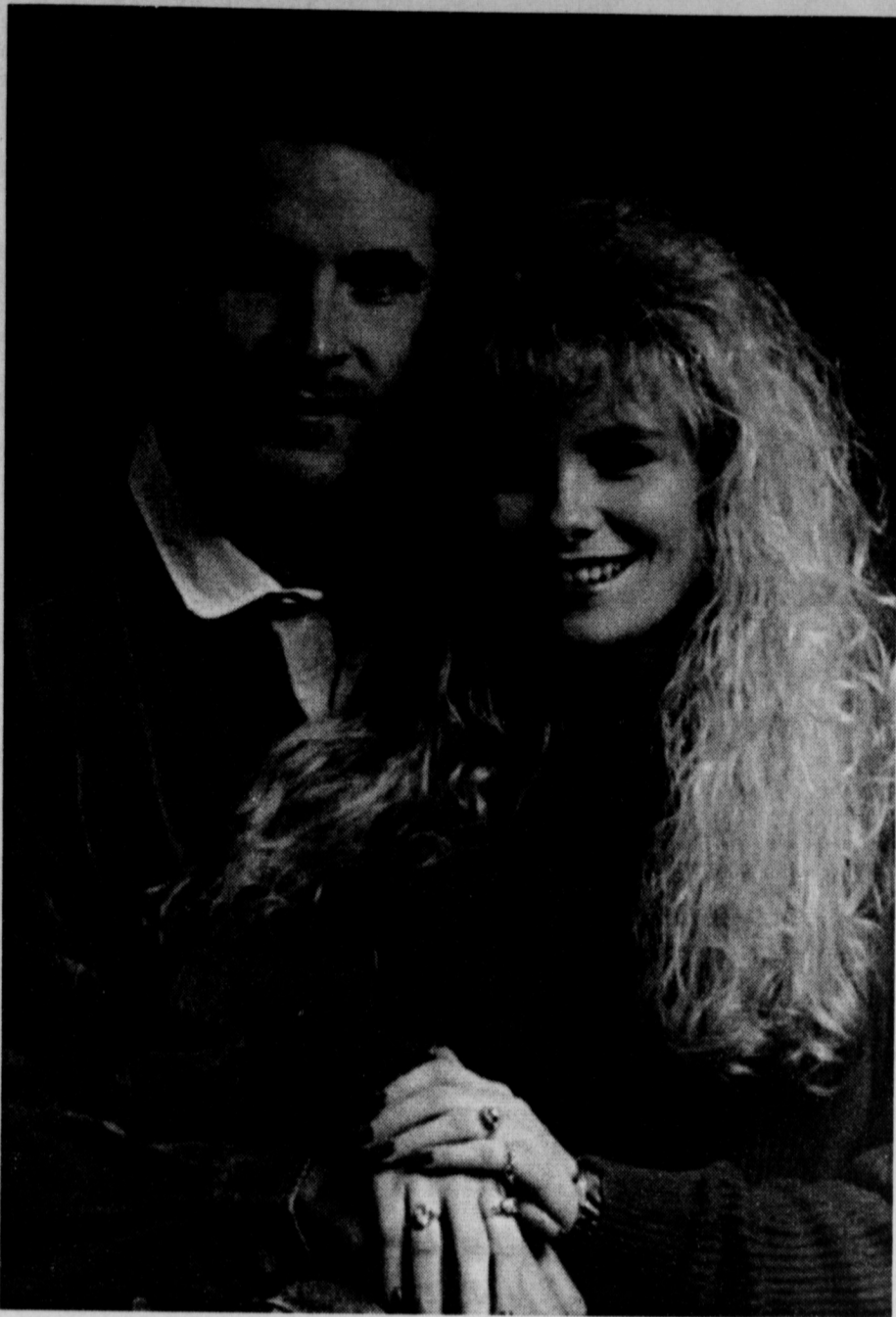
Male attendants wore black Wranglers with white shirts and rose printed black vests.

# As I See It... By Bob Hamilton



For some reason or another, remembering things from the past has been occupying my mind recently. I guess it's because of the season and news reports.

Few of those topics I'm remembering relate to each other, however. For instance, can you remember your first Easter egg hunt?

As best as I can recall, my first was in 1935. It was in a wheat field, between the highway and railroad tracks and on the immediate east side of Grandfield, Okla.

Those weren't candy eggs all us kids were searching for, but boiled

colored hen eggs. It was a scramble, and it seems like we were limited to one apiece.

Thinking about that hunt reminds me of another such hunt about 1941 in Hereford.

The reason that one comes to mind was because it led to a major embarrassment for some of the town's leading families.

There were a number of prize eggs to be found, but the problem was, only one or two were turned in for collection by anyone other than a group of Boy Scouts. Those Scouts had been delegated the responsibility of hiding

all the eggs in the park for the hunt.

National news media this week have been recalling the death 50 years ago of Pres. Franklin D. Roosevelt, and that brings about another memory.

Along with several hundreds of other people, I stood in a mild rain drizzle at Amarillo's Elwood Park in the late 1930s, when FDR was there personally campaigning for re-election.

Though he wasn't in a wheel chair, as I recall, it did take a lot of assistance to get him up the five-foot stairway to the platform from where he spoke over a public address system.

Another current topic of news out on the South Plains this week is a referendum to finance control of the dreaded cotton boll weevil.

That area produces a tremendous amount of cotton annually, and it is estimated that the weevil will cut production by several million dollars worth this year. And by the turn of the century, if left uncontrolled, it will cut income of that area's farmers by more than \$100 million.

Now comes the memory party.

I ran a story sometime between 1962 and 1964 about an Extension Service entomologist making the first discovery of a boll weevil above the Caprock.

The find, as I recall, was underneath a mesquite on the northeast side of Lubbock.

Experts back then theorized that the weevil could not survive over winter in the cold atmosphere of the High Plains, and were astonished at the find.

But they said then that it would be only a matter of time before they adjusted. And apparently they have, big time!

Remembering things like that is a lot of fun. But instant recall can be a frustrating situation for me these days.

For instance, don't ask me someone's name, and expect an immediate response.

The United States is a Constitutional Republic. Our Constitution is the Supreme Law of the land. Any law not in agreement with the Constitution (should) mean(s) nothing.

I believe it is time to call your Members of Congress and ask them if they really know what our Constitution says, and most importantly, what it means.

It's not surprising that Jan and Greg Fuselier are good at Cajun cooking. They both grew up in Louisiana, he always brings back a large supply of crawfish.

Jan grew up and graduated high school in Baton Rouge, and received a Bachelor of Science degree at Louisiana State University.

Greg is a native of Mamou, an area of the state that is considered Cajun-French. He, his parents and grandparents are French, and they all speak the language. Greg is also a graduate of L.S.U. with a degree in Business.

Jan, a registered nurse, works part-time at Bethania Regional Health Care Center. Greg is an agricultural chemicals representative. They have been married here about six years.

They have three children: Renee, Phillip, and Phillip. Renee is a senior at Iowa Park High School where she is a member of the student council and a cheerleader. Simone, a seventh grader, lives in the junior high band, basketball and track. Phillip is in the fifth grade, and participates in the gifted and talented program at Bradford Elementary.

Jan enjoys gardening, takes piano lessons, and sings in her church choir. Greg and Greg are members of various professional organizations, and Christ the King Catholic Church. In addition to singing in the choir, Jan is a member of I.F.T. (Ladies in Faith Together), gives religion classes, and helps with youth groups.

Jan says she learned to cook from her mother-in-law, but emphasized that she is a true Cajun cook. He has a pot and boiler that he takes along when he calls on customers. "He's always boiling shrimp (50 pounds or more) for his customers and their families," she said. When he goes to Louisiana, he always brings back a large supply of crawfish.

Louisiana, he always brings back a large supply of crawfish.

Jan said in southern Louisiana they grow and harvest crawfish, in the rice fields, just like a crop. After the rice is harvested, they spread out old straw and other organic matter, flood the fields, and seed them with infant crawfish. When it's time to plant rice, they drain the fields and start the cycle over again.

For recipes that call for a roux (a foundation for many sauces or gravies), Jan says it can be bought in jars already made up, and she doesn't make it from scratch anymore. Also she said most of the ingredients for her recipes, including the large tiger shrimp, can be found locally. She has included a recipe to assist in using up all the boiled eggs leftover from Easter egg hunts.

### Baked Shrimp

5 lbs. raw shrimp (26-30 ct. per lb.) We prefer tiger jumbo shrimp since we can't get L.A. fresh.  
1 stick butter  
8 oz. olive oil  
1 bag crab boil  
1 lemon sliced thin  
2 onions sliced thin  
2 cloves garlic

Spread raw shrimp out in a baking tray or dish. Salt extra heavily.

Combine other ingredients in a sauce pan and simmer 30 minutes or until onions and garlic become soft.

Pour sauce over shrimp. Put into 400 degree, pre-heated oven. Cook 20-30 minutes. Baste frequently.

### Shrimp & Crabmeat Casserole

2 sticks butter  
1 bunch shallots (green onions) chopped  
1 lb. Swiss cheese  
1 lb. fettucini noodles  
1 lg. onion, chopped  
1/2 lb. crabmeat  
1 lb. shrimp, peeled & deveined  
1 pint half & half  
Tony Charchere's creole seasoning

liquid crab boil to taste

Saute shallots and onion in butter. Stir in half and half. Stir in cheese until melted. Add crabmeat and shrimp. Cook until shrimp is pink. Mix with boiled fettucini and bake at 350 degrees 20-30 minutes.

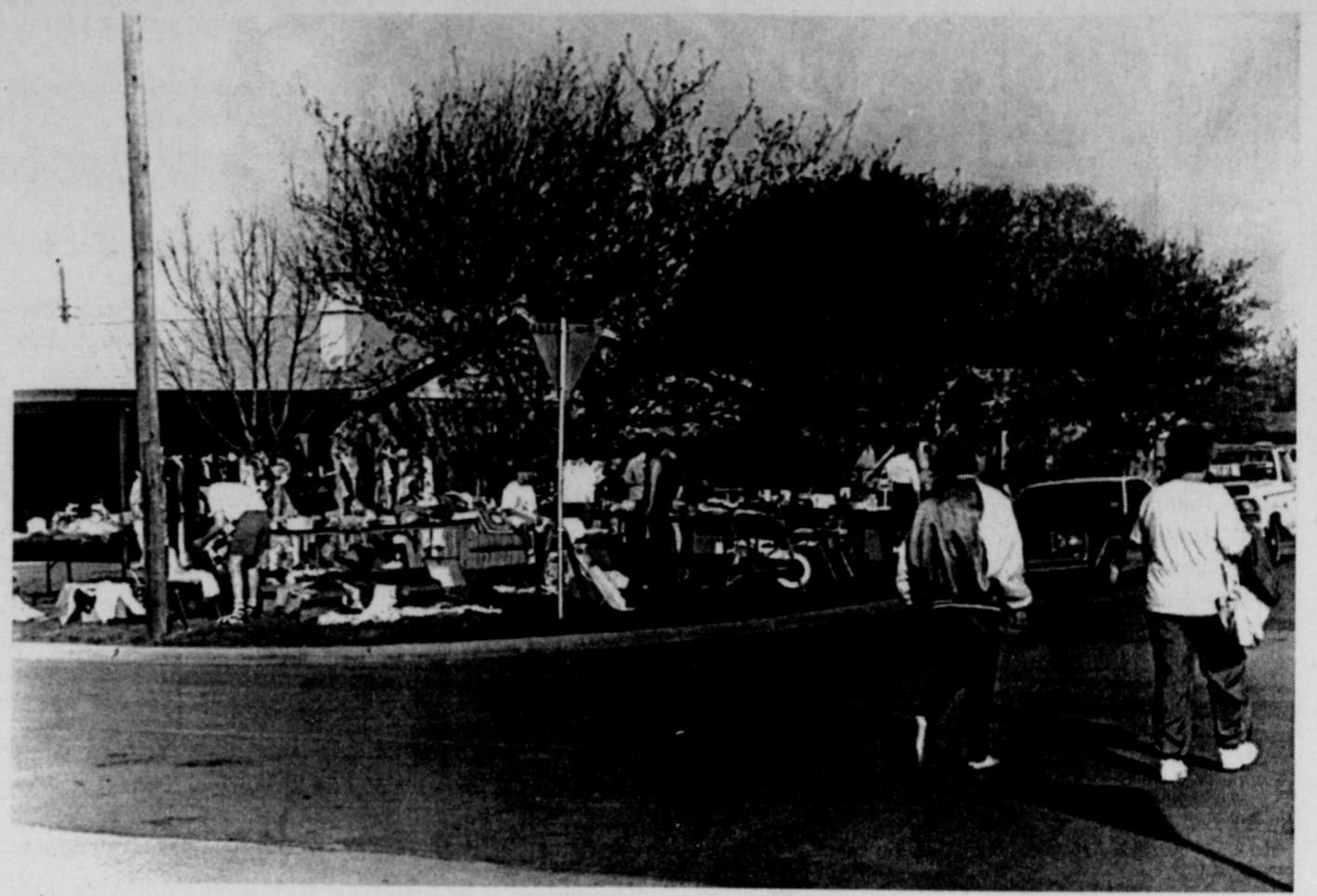
### Crawfish Etouffe

1 chopped onion, onion tops (shallots) & parsley  
1 chopped bell pepper  
1-2 stalks celery, chopped  
1-2 cloves garlic  
Roux  
1 - 1 1/2 lbs. crawfish tails  
1 can tomato sauce  
Tony Charchere's seasoning

Several hours ahead of time, or even one day ahead of time, rinse crawfish tails in warm water until clean and odorless. Season heavily with Tony's seasoning. Refrigerate until ready to cook.

Saute chopped onion, bell pepper, celery, garlic in small amount of oil. When onions are clear, add 1-2 tablespoons of roux. Stir in with 1/2 can tomato sauce. When well mixed, add small amount of water.

Add crawfish and simmer 15 minutes. Add chopped onion tops and parsley when cooked. (Like all French cooks, everything is approximate and judged based on experience. I add more tomato sauce or roux based on color of sauce. You want it to have a rust color.) More water is added if sauce is too thick - crawfish releases a lot of water. If too thin, I use a gravy thickener like Gold Medal Wondra extra fine flour for sauce and gravy. Serve over rice.

1 dozen eggs  
1 cup water  
Sugar  
2 cups vinegar  
1 tsp. salt  
1 tsp. pickling spice  
1/2 tsp. celery seed  
1 clove garlic, minced

Place shelled eggs in clean, sterile gallon jar.

Simmer together other ingredients over low fire. Remove from heat. Cool. Add garlic, red & black pepper. Pour over eggs. Marinate 1 week.

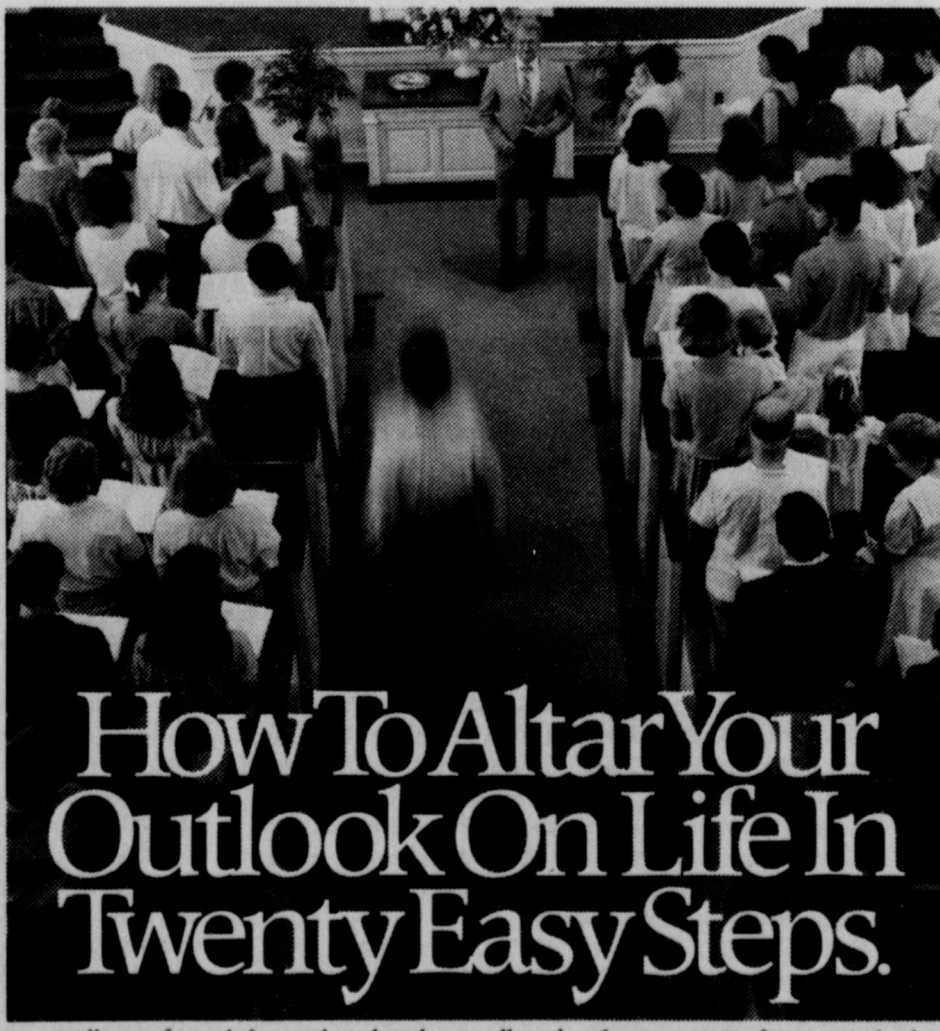

# Just call him Bill

You can call him Dr., or you can call him Professor, or Mister, or even William Fred, and he would answer to any of the monikers, and any one would fit.

But, the native Iowa Parkan would rather be called just plain "Bill". That is the name Bill Mahler has answered to in this town the better part of 65 years.

Mahler was born in a frame house built by his father, Herman, for \$1700 that still sits on its original site on Aldine Street, about three blocks north of Tom Burnett Memorial Library. That was before Magnolia Street was a street. Their house was the end of the settlement on Aldine.

Bill's birth certificate is signed, Aug. 30, 1930, by Dr. N. N. Dean, who lived over the Maier Bakery on Cash Street in the building next door west of Bangs and Thangs Beauty Shop. He maintained his office above the Rexall Drug Store, located on the opposite side of the street.

Bill's maternal grandparents were born in Besarabia, Russia. They came to the United States as German-Russian immigrants and settled in Kulm, N.D., where his mother, Maggie, was born.

Her family later came to Texas and settled in Wichita Falls where they owned a dairy located where Lucy Park is today. Bill's mother told him she had to milk 22 cows by hand every morning.

Bill's paternal grandmother was born in Zurich, Switzerland, where her family were ship builders. His grandfather came to this country from Germany when he was 16 years old.

Eventually he migrated to Texas and Bill's dad was born in Temple. His Mahler grandfather was a traveling preacher of the Evangelical conviction, that has now joined with the Methodist Church.

Bill's mother's brother owned the John Maier Bakery. Around the time of Herman and Maggie's marriage, Herman bought a quarter interest in the bakery and they moved to Iowa Park in 1928.

Bill had diversified job experience when he was growing up around the environs of Iowa Park. And, varied experiences in his chosen field of endeavor after high school.

In 1935, when Bill was five years old, he began "working" at Maier's bakery. "I got a nickel and a sweet roll for working from early in the morning until I could quit at about 1 o'clock. I cleaned out the cases, swept the floor and did anything they told me to, unless it was to stay out of the way."

Bill continued, "I finally got up to making 50 cents when sweeping the sidewalk was added to my duties. I remember there was a crack in the sidewalk and I always had trouble getting the dirt out. But, I was also allowed to eat everything they didn't get scraped out of the bowls."

In 1941 or '42, they sold the bakery and Bill began working at Metz Cafe, washing dishes. "I had my first restaurant steak there. They gave me my meals."

He worked for Earle Denny, cleaning his insurance office and doing odd jobs. The insurance office was located in the building Bangs and Thangs now occupies.

When Bill was 13, the late Raymond Cope got him a job with him at the Texas Agricultural Experiment Station. "Lester Brooks was superintendent at the time, and he would hire high school boys to do odd jobs," Bill explained.

Bill mowed the lawns, thinned peach trees, and learned to milk cows by hand. In reverie, Bill began laughing. "They still used mules out there to farm with. Raymond lived on the farm and knew more about doing the things that had to be done than I did."

"We had to fertilize the crops and other vegetation with a mule drawn fertilizer spreader. Of course Raymond got to drive the mules and I had to shovel the manure out of the stalls to use for fertilizer."

"Lester finally let me drive a team of mules to haul hay. But, I turned the wagon too quick and broke the tongue. Needless to say, I didn't get to drive the team anymore."

"About that time--it was 1945--a new 'guy' was hired, and he and his wife came to live in the little house on the farm. He taught me how to graft pecan trees." Bill related. The "new

guy and his wife" were Virgil and Faye Woodfin.

That was the year Mahler was 15, and his dad bought what was known as the Sunday House, where he still lives. He purchased it from the Sunday Estate. The house had been built in about 1918. At the time the Mahlers lived in a house back of the W.F. George High School.

The Sunday House was an ideal location for Bill's mother. It was at the east end of Clara Street and very close to Gordon Lake. Maggie loved to fish. When the lake was opened for fishing, Bill, his brother John and their mother would go to the lake and fish nearly every day they could.

"Sometimes we would get home from school and there would be a note from mother telling us she had gone on to the lake and for us to change clothes and come on," Bill said.

Bill's Uncle John Maier had sold Bill and his brother each a gun, a 410 shotgun and a single shot 22. "Uncle John never gave anything away. He sold them to us for \$1 apiece."

The brothers would kill rabbits, clean and dress them, and take them to Wichita Falls to their aunt who would give them 15 cents each for them.

"Mother would make us eat everything we killed, or see that someone did," Bill said. "I remember one time I killed a mud hen and she cooked it and I had to eat it. But, that was the last one I ever killed."

City water had not been piped into the Sunday House yet. The house had a room that was to be used for a bathroom and already had a bathtub in it. A tank outside caught rainwater and was piped in for baths. A tiny room had been built on the back of the house where there was a commode.

"There was still an outhouse out back, equipped with an ornamental frosted glass door that we were told the previous owner still preferred to use. He could see outside, but no one could see in."

"We never knew if what we heard was truth or fiction," Bill said.

After the Mahlers bought the house Herman put the commode in the bathroom. And Maggie said the next thing was to get water piped into the house as soon as it was available.

There was a barn with the house and Herman sold it to Miles Thompson who used the lumber to build on to his house. Mahler tore down the garage and used that lumber to help build a two-story apartment house., next to the Sunday House.

After it was built he found out it was partially on the property of his next door neighbors, Dave and Lucille Gay. But they worked that out. They were told that sometimes they had to fit the boundaries around the existing property.

Bill graduated W.F. George High School in 1947. The seniors always made a trip to Craterville Park in Oklahoma. That trip didn't turn out to be very fun for Bill. He was riding a horse and the horse went under a tree limb and Bill went over it and fell on his hands and knees.

He got up and sat down on a tree stump, and thought he was alright. He managed to get back home in a car, but found out he had broken his neck in

two places. He spent the summer with his neck in a cast and playing dominoes at Jim George's house under a tree.

"For some reason Jim took me under his wing, and he didn't lose many domino games. People would come by and stop to play when someone lost a game," Bill said.

Some of the other varied jobs included driving a tractor, plowing and sowing wheat and digging cacti for Albert Johnson north of town, working for O.R. Kelly at the ice house, which was located at the end of Cash Street, about where Allsups is now. Water had to be hauled from Wichita Falls because the water here would not make good, clear ice. Bill hauled the water.

He worked for Curtis Hill Motor Co., greasing cars. That was when Hill's sons, Donald was a mechanic and Richard was bookkeeper.

Although he would have a lot of experience in future years about editing and writing, he knew very little when George Huckaby, publisher of the *Iowa Park Herald*, let Bill write articles each week on conservation.

Following graduation Bill enrolled in Hardin College in Wichita Falls. He was still wearing a neck brace. He worked on the college farm milking cows, but with a milking machine.

After three years, he decided to enlist in the army and was sent to Ft. Benning, Ga. From 1950 until 1953, Mahler served with the 14th Ranger (Airborne) Infantry Co. Hdqs. Co., 8th Infantry Regiment, 4th Infantry Division, in the U.S. and Germany.

Bill was in Germany 21 months assigned to I&R. He was in charge of all classified and top secret documents and was the one who allowed a request to see these documents.

An interesting highlight on his time in Germany, Bill got to get together with two of his Iowa Park classmates. Dean Jackson, now living in Pasadena, was stationed about 40 miles from Bill. They managed to get time off together and went to Paris where Billy Gene House, brother of Mayor Wayne House, was stationed. House showed them around Paris, while they caught up on "old times".

Bill got out of service in September 1953, and went back to Hardin College, which by then had become Midwestern State University.

During 1954 and 1955, Bill did odd jobs. He began roughnecking with John Farris and Bill Overbey for Mitchell Drilling Co. It seemed to be understood when a "greenhorn" roughneck came on the job he "got the works". Farris and Overbey saw to it that Mahler was thoroughly indoctrinated in roughneck ways.

Bill laughed as he told how when he went into the doghouse to rest a few minutes, or to take a short nap, the two would tie his feet together and then get outside the house and yell for him to come help.

He was still so near asleep he wouldn't realize his feet were tied together and he would jump up, only to fall. He laughs about it now, but didn't say what he did then.

# Bill Mahler

After Bill got out of service he met Lorene Lindesmith, a hairdresser who worked with Essie Johnson in Pauline Steele's Beauty Shop, and in their own. Bill and Lorene met in the old Rexall Drug Store owned by Fenton Dale and "Dr" Tommy Clark, where there were probably a lot of matches made through the years. They were married in 1955.

Lorene was from Addington, Okla., and lived about two miles down Dry Creek from where John Farris now lives and where the couple own a farm.

Bill received the B.S. degree in Agriculture from Midwestern in 1955, with a Soil and Plant Science major and an Animal Husbandry minor. "I knew then that if I went back to get my Masters, that it would be in Biology, because of Dr. Beyer.

Bill got a job in Balmorhea surveying, mapping and laying out an irrigation system, but neither he or Lorene liked living there, so in eight months they were back in Iowa Park. Their first child, Brenda, was born. She is now Brenda Connittus of Dodge City, Kans., and has two children, Matthew, 6, and Rebecca, 4.

For a while Bill helped his dad paint and do some carpenter work. In 1958 he was offered a graduate teaching assistantship in the Botany Department at Oklahoma State University at Stillwater.

In 1960, Bill received the M.S. in Botany; Plant Taxonomy from OSU, and was immediately offered an assistant professorship at Hardin Simmons University in Abilene, teaching Botany.

Part of his duties was to establish a herbarium at HSU. He was with the Department of Biology there six years. Their son, Shawn was born in Abilene in 1961.

Bill's brother, John had received his Ph.D from the University of Texas in 1964. He went to work for Shell Oil Co., in California and later spent 10 months in downtown New York. That wasn't for him, so he told them he was quitting. The company sent him back to Houston where he remained until he suffered a massive heart attack in 1978.

In 1966 Bill was offered an assistantship in Agricultural Biology (Research) Department of Agricultural Biology at the University of Tennessee in Knoxville, where he received the Ph.D in Botany; Plant Taxonomy in August 1968. He was especially trained in plant identification.

Upon his graduation from the University of Tennessee, he went to Southern Methodist University as an assistant professor and assistant curator of the herbarium.

As Dr. Mahler, Bill recruited and supervised the students who sorted and mounted plant specimens, and worked closely with Dr. Shimmers until his death in 1971.

As acting director of the herbarium from 1971 until 1987, Dr. Mahler inherited a collection of about 328,000 specimens. During the next 17 years, an estimated 72,000 specimens were added, which brought the collection to about 400,000.

In addition to taking charge of the herbarium, Dr. Mahler received stewardship of *SIDA, Contributions in Botany*, the journal which was pri-

vately published by Dr. Shimmers. He originated the journal as an outlet for scientific research, and Dr. Mahler expanded the readership. *SIDA* is now read in more than 85 countries.

Dr. Mahler also completed Lloyd Shimmers work, *Shimmers Manual of North Central Texas Flora*, which Shimmers was unable to complete before his death. The book is used as a laboratory/text manual in college and university botany classes.

In 1987 SMU placed the herbarium and library in the care of a newly created organization.

The organization is The Botanical Research Institute of Texas (BRIT) and Dr. Mahler was named director. Dr. Mahler took early retirement from the classroom in 1988 to become director of the Research Institute, a position he held until 1993. When Dr. Mahler retired and became director emeritus, his position was assumed by Sy Sohmer, who is the current director.

From October 1987 to June 1991, the herbarium and library were located on the SMU campus.

The present building that houses BRIT was restored in 1991 and the collections were moved to Fort Worth. It is located in downtown Fort Worth at the corner of Fourth and Pecan Streets.

BRIT is an international botanical resource center, and its influence is felt around the world. With a current collection of 450,000 dried plant specimens, BRIT has the largest independent herbarium in the Southwest. Its botanical library houses more than 50,000 volumes of books and journals from more than 80 countries.

BRIT's mission is to expand the knowledge and understanding of the plant world by making its collections available to both the scientific community and the public for research and cultural, educational and environmental enhancement.

Valued at \$10 million, Lloyd H. Shimmers Collection in Systematic Botany, is on permanent loan from SMU in Dallas. It was opened to the public in 1991.

Dr. Mahler said BRIT is used by scientists, physicians, students, teachers, ranchers, farmers, business executives, attorneys, artists, and others who seek information about plants, working either independently or with the staff.

He said from a poison center needing to identify a plant to a water colorist wanting to study the magnificent botanical plates in century-old books, people in Texas and throughout the world rely on BRIT as a primary source of botanical information and interpretation.

Mahler says when appropriately preserved and handled, plant specimens will last indefinitely. The oldest specimen in the BRIT herbarium is a heliotrope, a member of the forget-me-not family, gathered in Mexico in 1791.

Dr. Mahler has dedicated his career to teaching, and directing the herbarium and library collections.

He has authored 10 books, more than 30 scientific articles, and numerous reports and reviews.

Dr. Mahler was the first recipient of the Harold Beaty Award, Texas Organization of Endangered Species, in 1988. In 1991 he received the Donovan Stewart Correll Memorial Award from the Native Plant Society of Texas, for his authorship of *Shimmers Manual of North Central Texas Flora*.

While Bill was with SMU and the herbarium, they lived in Richardson and Plano. Lorene worked in the Dallas County Tax Office 12 years.

They came back to the area in 1991 and stayed in Iowa Park and on the farm in Oklahoma to decide where they wanted to settle when Bill quit work.

They returned to Fort Worth and stayed in a hotel eight months. "That

was pretty much fun for about two months, getting to eat out all of the time and having maid service, but after that it was pretty boring," Lorene said.


They made their decision to come back to Iowa Park to settle down. In 1992 they bought the Dave and Lucille Gay home next to Bill's dad's apartment and renovated it.

Although not actively involved in the collection of specimens or overseeing BRIT, Bill still goes down pe-

riodically for the directors meetings and can become very enthusiastic about BRIT and what its mission is to the public.





## TEAMS FINISH SECOND

### Goin, Morris win district in singles

Both Iowa Park varsity tennis teams finished in second place behind perennial power Vernon in Saturday's Dist. 3-3A tournament.

Iowa Park's Dani Goin and Stephen Morris earned the singles titles, and will advance to the regional meet. Contributing to the girls' 20 points were two doubles teams that played each other for third place.

In the boys' point total, Iowa Park also had 20 points, as the Hawks had a third-place finish.

Vernon's girls' team accumulated 40 points and the boys had 35. Graham had the other five that were awarded. Goin, a senior, defeated Vernon's Lisa McManigal 6-3, 6-0 for the championship.

After drawing a first-round bye, she bested Audra Anderson of Graham 6-0, 6-0, followed by Cheryl Furr of Graham, 6-2, 6-4, to reach the finals.

Hawk junior Morris battled Vernon's Richard Gooch for his crown, winning 7-5, 7-5.

After a first-round bye, Morris bested Bridgeport's Brad Garrison, 6-0, 6-3, then Todd Stewart of Graham, 6-0, 6-2.

The Iowa Park Hawks got off on the right foot Friday as they beat Bridgeport 1-0 in 10 innings in the opening game of district play, but couldn't keep things going Tuesday as they fell 3-1 to Vernon, and now stand at 6-9 and 1-1 in league play.

Even though baseball is a team sport and it takes nine players on the field to be a good team, you could sum up the Hawks' win over the Bulls Friday in just two words:

Chris Norris.

Norris went the distance allowing only two base hits and walking none and picked up 12 strikeouts along the way to pick up the win. He allowed only three base runners for the game and didn't let anyone make it as far as third base.

The Hawks played solid defense behind him as they committed only one error in 10 innings. The two hits Norris gave up were to the same hitter.

But no matter how stellar a job Norris did on the mound, if you don't score, you can't win the ballgame.

The Hawks out-hit the Bulls 7-2 for the game with two of the Hawks' hits coming in the top of the 10th inning.

Norris led off the inning with a sharp single to right-center. Shaun Campbell came on to pinch run and moved into scoring position on a sacrifice bunt by Casey Moser. Rudy Hawkins followed with an RBI single to right that scored Campbell without a throw to the plate to give Iowa Park and Norris all they needed to post the 1-0 shutout.

"This was one of the best games I've pitched in a while," Norris said. "I threw a lot of fastballs and some curves and just kept the ball around the plate."

"He was good to say the least," head coach David Furhman said. "He had great command of his pitches and

changed speeds well. He was in control throughout the game.

"I was real pleased with our defense," Furhman added. "We only made one error and that was on a tough play where we dove for a ball and then had to hurry our throw. We knew they didn't swing the bats real well, but Norris had a lot to do with that today."

Tuesday's game started out just like Friday's. Neither team scored a run through five innings of play with Hawkins doing the job for the Hawks on the mound.

But Vernon managed to get on the board first in the top of the sixth when they put together four of their six hits and took advantage of an Iowa Park error to put a three-spot on the board.

Iowa Park looked to rally when the Hawks loaded the bases with no outs in the bottom half of the sixth. Clint Scobee led off with a single to center and was followed by Dusty

Owen and Robert Klinkerman who both walked to load the bases for Corky Petty.

Petty smashed the ball to deep left field where the Vernon outfielder was turned completely around yet still raced to the fence and made the catch allowing only the one run to score to cut the Lion lead to 3-1. The next two hitters went down on strikes to end the inning.

Petty came on to relieve Hawkins in the top of the seventh and retired the side in order but the Hawks also went down in order to end the game. Iowa Park picked up only two hits but left a total of eight men on base.

"We just left too many guys on base today," Furhman added. "We just couldn't come up with that big hit when we needed to. I guess it wasn't meant to be. Vernon made some great plays in the outfield because of all their speed out there. They made a great play on the ball hit by Petty and earlier they robbed Klinkerman on a shot to the gap that the kid ran down and made a great play on."

The Hawks will have to hit the road for their next two district games as they travel to Jacksboro Tuesday then travel to Bowie that Friday to take on the Jackrabbits. Both games are scheduled to start at 4:30 p.m..

## Girls third, boys fifth in district golf play

Both the Lady Hawks and Hawks golf teams dug themselves a hole to start the district tournament by falling behind by 29 and 30 shots respectively, but both rebounded and finished with a flurry in the final rounds.

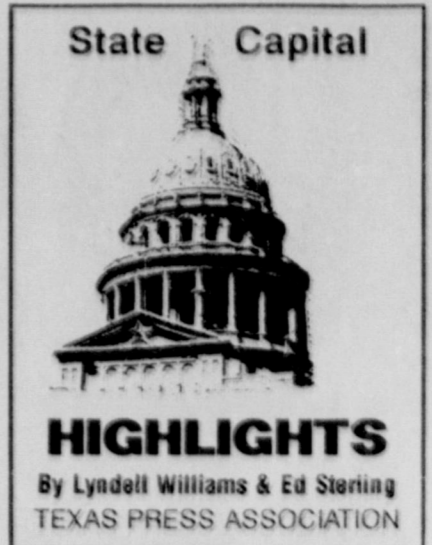

AUSTIN — An \$80.2 billion state budget proposal for 1996-97 was unanimously approved by the Texas Senate last week.

Without raising taxes, the Senate version would increase funding for schools, prisons and health and human services, while giving the state's lowest-paid teachers a modest pay hike and reducing the number of state employees.

The proposal is \$2.6 billion more than a state budget bill approved a week earlier by the Texas House.

The Senate budget outspends the House version in three major areas: \$1 billion more for health and human services, \$757 million more for education and \$474 million more for prisons.

\$92 Million Teacher Raise The Senate's proposed pay raise for teachers would cost \$92 million, an amount far below the across-the-board hike in pay and benefits teachers sought, which would have required the passage of an \$800 million tax bill to fund.

Sen. John Montford, D-Lubbock chairman of the Senate Finance Committee, said the budget, if combined with the state's 1994-95 budget, puts \$3.4 billion in new money into Texas public schools.

"Now," he told the Houston Chronicle, "I hope, from the bottom of my heart, that some of that money is filtering down to teachers."

Of the \$80.2 billion, \$45.5 billion comes from state sales and business taxes and lottery proceeds. Of the \$45.5 billion, 59 percent is going to public and higher education, Montford said.

Regarding anticipated funding cuts in federal welfare programs, Montford suggested that the state set aside \$250 million. If as expected, the U.S. Congress changes welfare funding to a block-grant method, the Legislature likely would go into special session to consider ways to gain adequate funding, Lt. Gov. Bob Bullock said.

Bullock, who presides over the Senate, told the Dallas Morning News, that the approval of the budget opens the way for consideration of other bills that have been on hold at the committee level, such as parental notification of abortion.

Bush Names 2 Appointees Gov. George W. Bush has nominated Austin lawyer Roderick Bordelon his choice for Texas' public insurance counsel.

If confirmed by the Senate, Bordelon, 36, will become the state advocate for insurance consumers, replacing Mark Kincaid, an appointee of former Gov. Ann Richards.

Also, Bush nominated Dallas lawyer David M. Laney to the three-member Texas Transportation Commission, which oversees maintenance and construction of state roads and highways.

If confirmed by the Senate, he will replace Ruben Cardenas of McAllen.

**GARDENING HINTS**

By MARK TERNING, COUNTY AGENT - HORTICULTURE

Pecan trees require zinc sprays for healthy growth.

This is true for landscape pecan trees as well as commercial orchards. Untreated trees produce small leaves and rosetted shoots characteristic of zinc deficiency.

Soil applications of zinc have not given satisfactory results. Foliar sprays are the most effective means of applying zinc to pecan trees.

Foliar zinc sprays should be applied now while pecan leaves are young. Zinc is needed for leaf growth so the most critical time for zinc sprays is normally in late April to May when the young leaves are developing.

Spray mature, bearing trees two to four times in the spring period (April to May). Young, vigorously growing trees should receive zinc at two to three week intervals from late April through August.

Common choices of zinc materials that can be sprayed include zinc sulfate, NAN or zinc nitrate. Avoid spraying in midday, especially on hot windy days.

To get adequate penetration of zinc into the foliage, the spray needs to remain wet on the leaf as long as possible. Certain other plants, including peach trees, are readily damaged by elemental zinc sprays, so limit the zinc sprays to pecan trees only.

Zinc does not move from leaf to leaf, so spray coverage of the entire canopy is important.

Examples of inadequate spray coverage are common -- especially in yard trees. Such trees have a thick canopy of healthy, large leaves on the lower limbs where spray coverage was good.

Above that, where spray did not reach, the canopy will be thin with small leaves and often the characteristic twig dieback of zinc deficiency.

Good nitrogen and zinc management are only one part of a successful care program to grow healthy pecan trees. Irrigation, weed control (especially around young trees), pest control and proper training are all vitally important to develop healthy trees.
