No increase expected in school's tax rate

Based on comments by individual members of the school board Tuesday night, trustees will likely not make any change in the current tax rate when they hold a called meeting this afternoon.

The board is scheduled to convene at 4 p.m. in the administration building to adopt a tax rate for the 1995-96 school year.

Also during today's meeting, a second public hearing on the proposed year's budget will be held, followed by amending the 1994-95 budget, adopting the new budget, and also acting on bids to purchase a new pickup truck and van.

Five trustees expressed a desire Tuesday night to keep the tax rate at \$1.16. They included Keith Fisher, Burt Williamson, Randy Catlin, Jeff Watts and Dennis Yeager.

Martha Dudley spoke in favor of adopting a rate of \$1.1899, and Larry Dutton was absent.

Supt. Glen Mitchell had asked the board to approve a rate of \$1.20, pointing out that the increase would amount to \$20 on a \$50,000 home, for a total of \$600 next year.

The new budget calls for expenditures of \$8,945,128, as compared to the 1994-95 budget of \$8,075,341. His original budget proposal, offered before a series of studies by the board, was for \$9,039,376.

In a prepared presentation the superintendent gave the board, he explained the \$964,035 increase the new budget has over the old budget.

That includes \$343,813 the legislature requires in a bookkeeping procedure to show how much money the state puts into the teacher retirement system, though no money actually is received or paid out.

The other increases include

\$274,828 in payroll (state-mandated and two additional teacher positions); \$60,000 for an elevator at high school; \$22,500 for a bus and band trailer; \$40,000, cocurricular/extracurricular; \$24,547, the district's share of West Wichita Cooperative; and \$89,199, for computers and software.

In making his point to justify a higher tax rate, Mitchell said only 77 out of the 1,042 school districts in Texas have a lower rate than Iowa Park.

Only three citizens in the audience asked questions or made comments during the public hearing on the budget.

Denny McCarthy said he felt the increased tax base of the district should be able to fund an adequate budget to operate, and continue a good educational program.

Marc Carter questioned the need for an elevator at the high school.

Bob Hamilton proposed that the board set a rate that would produce at least three months of operating expenses on which to begin a school year, adding that the carryover could be used in case of an emergency.

Two topics were addressed during a general discussion period. One concerned the future of the Valley View school grounds, and the other land adjoining the high school campus which may be purchased by the city for a golf course.

Not all of the 24 acres of Valley

City adopts budget, lowers tax rate

The city council Monday night formally adopted its 1995-96 budget and set a tax rate of 76-cents, which is

a three-cent reduction from the previous year. In other business, aldermen voted

to contract with a firm to conduct a feasibility study on a proposed golf course, held the first of two public hearings to discuss renewing the franchise agreement with TCI Cablevision, and abandoned part of the right of way on a street.

The city experienced an increase in taxable values during the past year of \$8,688,322, raising the total to \$108,459,736.

The budget includes \$1,880,900 in revenues and expenditures for the general fund, and \$1,135,600 for the water and sewer fund.

The three-cent reduction in the tax rate for next year represents a 12.5-cent cut in the rate over the past 12 years, Mayor Wayne House said.

The increase in values, even after lowering the rate, will still allow the city to make numerous improvements, which were detailed by the mayor.

"The city's in good financial shape," he said.

Aldermen approved an expenditure of \$7,500 to contract with Flatt Golf Services, of Overland Park, Kan., to conduct a feasibility study on a proposed golf course.

The proposed course would be located on the property between US 287 and the railroad, and west of Johnson Road. The city has taken a 90-day option on the land, with the intention of purchasing it for that purpose.

Flatt, a native of Wichita Falls, offered in his study to provide:

- * the primary and secondary geographic market areas and potential tertiary market for a public golf facility will be identified and defined;

- * an assessment of golfing trends and projections of play in the market areas based on an analysis of the demographic characteristics which influence participation in golf will be conducted;

- * research and prepare an analysis of the existing market demand, including: data on fees, level of play and conditions of play of the competition in the market area and the impact of such competition on the proposed public golf course;

- * an analysis of the unserved

Police make four arrests

block of East Highway. Toby was later transported to the county jail.

Thomas Cecil Sims, 30, was taken into custody at 11:35 a.m. Tuesday in the 1000 block of Mary Drive, on two outstanding warrants.

One of the warrants was issued locally, for disorderly conduct, and the other was issued by the sheriff's department, for attorney off bond on a charge of credit card abuse, with a bond of \$10,000.

Sims was transported two hours later to the county jail, after signing a personal recognizance bond on the Iowa Park warrant.

The theft report filed was received Thursday morning, when a resident in the 200 block of West Texas complained ceramic ducks had been taken from the front yard.

A resident reported the paint on her vehicle had been damaged Friday, while she was working at Pizza Hut.

15 students overlooked in count

Somehow, 15 students at Iowa Park High School were not added in on the campus' first-day enrollment report last week, Supt. Glen Mitchell said.

That increased the district's first-day enrollment total to 2,109, instead of 2,094.

There were actually 624 students enrolled on the first day, instead of the 610 reported.

Though it still was the district's fourth-highest first-day enrollment ever recorded, the total was one less than the third-highest on record, which was in 1973.

The correct numbers of students by grade at IPHS were: Grade Twelve, 121; Grade Eleven, 141; Grade Ten, 170, and Grade Nine, 192.

The record was reported in 1970, when 2,292 students reported for classes on the first day of school.

Parents will experience an unique format tonight, when they attend open

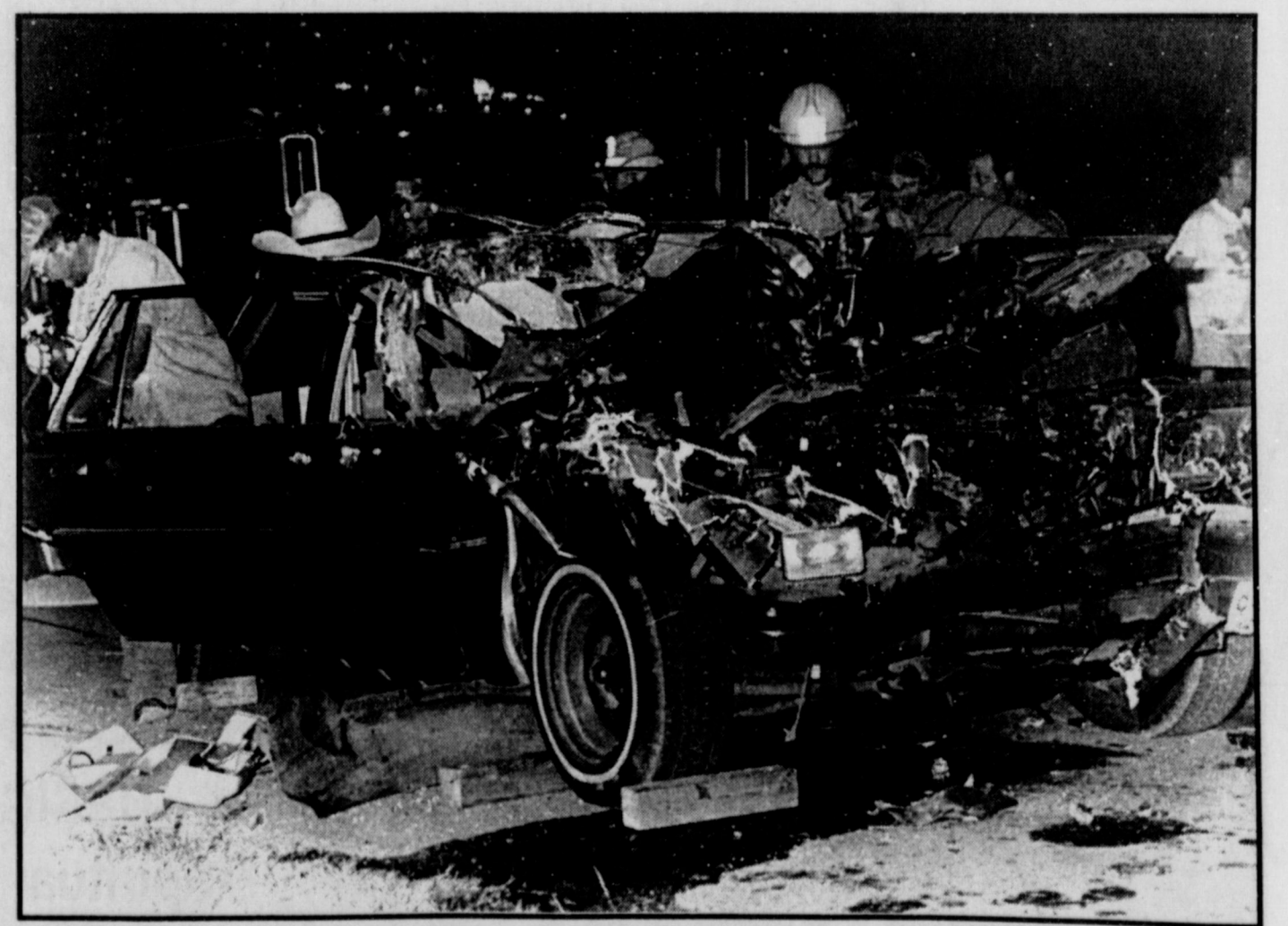
house at Iowa Park Junior High School.

Library offers program to develop reading skills

Tom Burnett Memorial Library has joined libraries around the country in a national program that encourages parents to give their children a "JumpStart" at the library.

The program, sponsored by The Prudential and Friends of Libraries U.S.A. (FOLUSA), is designed to promote library card sign-up and use among first, second, and third graders.

The JumpStart newsletter, distributed in September (National Library Card Sign-up Month) offers parents practical information and ideas on reading and learning; and a chance to win a \$50,000 college grant in Prudential's JumpStart Sweepstakes.

When students bring their official library cards to class, they get to "sign in" on "I Got a JumpStart at the Library!"

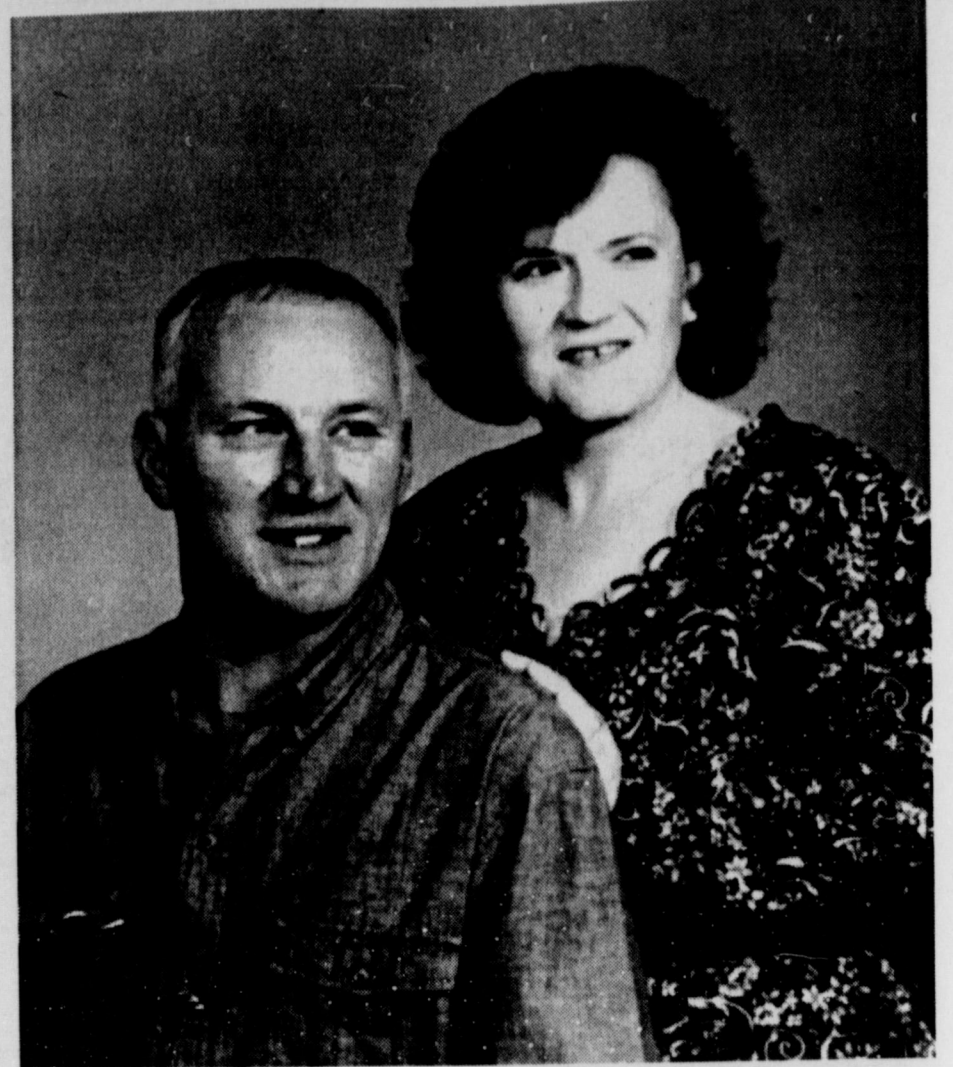


Glenda K. Boyle and Jerry R. Walsh are engaged to be married Oct. 6.

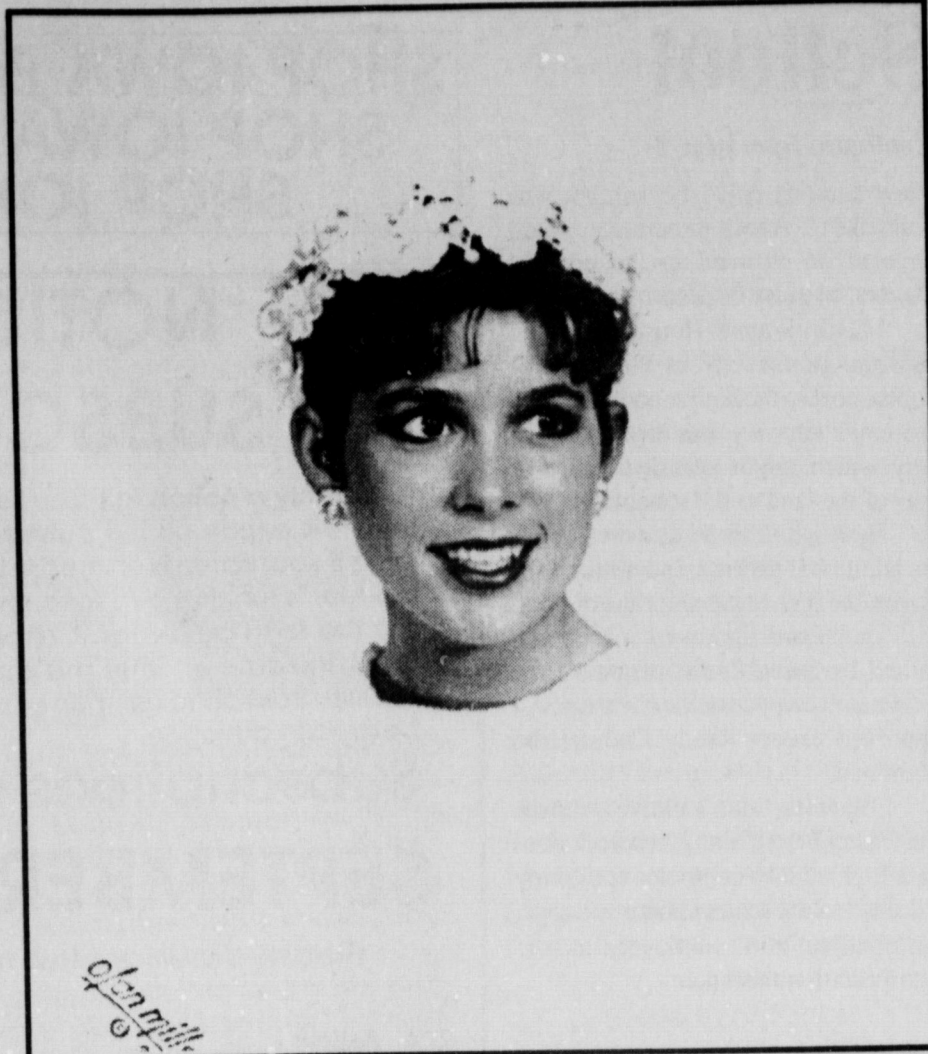

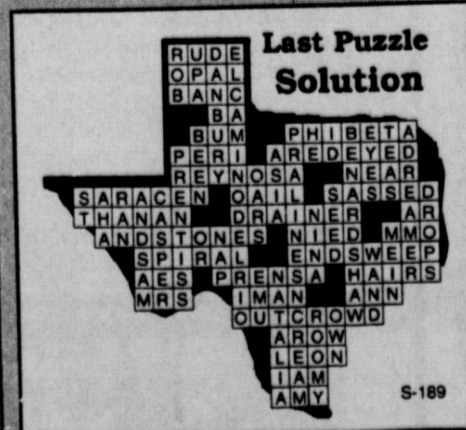

View campus could be sold, it was pointed out. About three acres would have to be returned to the original owners, because of deed restrictions.

Mayor Wayne House discussed the goal of the city to build a golf course next to the high school, and said the city's attorney was working on a way which might permit transfer of part of the land to the school.

He was told six acres were desired for additional parking, and 40 acres for a possible fifth campus for the district.

The board approved a bid submitted by Steve Catlin Insurance for workman's compensation coverage. All approved except Randy Catlin, who abstained.

Following an executive session, trustees approved hiring Renato Pedon, as a high school computer technology aide, and salary scales for maintenance, custodial, cafeteria employees and the transportation mechanic.

market demand that would be available to the proposed golf course, and the demand will be projected as a number of rounds available and presently not being served by existing and planned public golf facilities for each market opportunity;

* prepare projections of potential revenue for the golf facility, indicating the anticipated number of golf rounds and projections of revenue from green fees, cart rentals, concession sales and pro shop retail sales;

* projections of potential operating and maintenance costs, including costs for personnel, commodities, contractual and capital outlay;

* proforma indicating revenues, expenditures, and projected levels of play over a 10-year period.

The study is to be completed and printed report ready within 60 days.

Ray Denney, manager of TCI, was on hand for the public hearing on his firm's request for franchise renewal.

In response to numerous questions, Denney pointed out that his proposed new agreement includes all mandates which have been enacted by the federal government, including basic rates.

An addition which was not in the current agreement, which will not expire for three more years, is that the company will guarantee service requested when at least 15 residences are within 1,320 "cable-bearing" strand feet of the firm's trunk.

The proposed agreement seeks a 20-year extension, while the present agreement was adopted for 15 years.

The next public hearing on the agreement is expected to be on the agenda for the next meeting, Sept. 11.

Two aldermen, Johnny Crawford and Mark Raby, were not present Monday night.

couple of cases, some didn't even open because the cost would have been more than what little income might have been taken in.

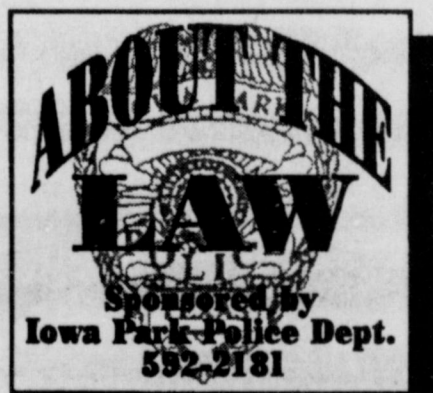
The cost to Iowa Park taxpayers was approximately \$600, including \$400 for police to direct traffic.

Jaquita Barnett

Jaquita (Mrs. Charles) Barnett, who was taught the basics of cooking by her mother, says she always cooked country-homestyle food until her husband (better known as Barney) got sick. After his illness, he was an insulin dependent diabetic. "I had to learn how to cook all over again," Jaquita said. "I wanted to learn how to prepare food that he would enjoy and not feel deprived." She is constantly on the lookout for new recipes to use so there will be a variety in the menu.

Jaquita grew up in Muskogee, Okla., where her parents still live. When she graduated high school, she received a scholarship to Baptist Memorial Hospital School of Nursing in Oklahoma City.

Since she received her RN degree 32 years ago, Jaquita has accumulated a vast amount of experience in the field of nursing. She has worked in pediatrics, Intensive Care, Coronary Care, emergency room, recovery room, surgery supervisor, house supervisor, and since 1992, has been Vice President of Nursing at Wichita General Hospital.

Jaquita and Barney were married at Muskogee in 1968, and moved to Iowa Park in 1970.

Barney, a full-blood Creek Indian, was born in Eufaula, Okla. He attended a variety of Indian schools and graduated from high school in Holdenville, Okla. After serving four years in the Marine Corps, Barney worked as a printer. When he retired in 1989, he was working as printer in Civil Service at Sheppard AFB. "Now his full-time job is fishing," Jaquita said laughing.

Jaquita and Barney have a 24-year-old son, Cody, who is in the radiology program at Midwestern State University and plans to become a medical doctor.

Barney has three grown children who are all married with families of their own. A daughter, Sandra Casey, and a son, Jay Todd, live in Wichita Falls, and a son, Charles Barney, Jr., lives in Okemah, Okla.

Jaquita has many interests. She likes to paint with oils, using mostly country or western scenes as her subjects. She also likes to read, do needlework, and ceramics. She has a variety of collections which include pottery, pitchers, dishes, pumpkins, and cookbooks. Jaquita said she has always wanted to play the piano and someday hopes to take lessons.

The organizations she belongs to relate to her profession. She is on the board of directors of Texas Organization of Nurse Executives.

Following are some of the recipes she has found that meet Barney's approval.

COOK OF THE WEEK

Coconut Custard Pie

4 eggs
1/4 tsp. salt
2 cups skim milk
18 packets artificial sweetener
2 tps. coconut extract
1/2 cup flaked coconut
* Reduced fat pastry for 9-inch pie follows.

Roll pastry on floured surface to circle 1-inch larger than inverted 9-inch pie pan. Ease pastry into pan; trim and flute edge.

Beat eggs and salt in large bowl until thick and lemon-colored, about 5 minutes. Mix in milk and remaining ingredients. Pour mixture into pastry.

Bake pie in preheated 425 degree oven 15 minutes. Reduce temperature to 350 degrees and bake until a sharp knife inserted halfway between center and edge of pie comes out clean - 20 to 25 minutes. Cool on wire rack. Serve at room temperature, or refrigerate and serve chilled.

Makes 8 servings with a 40% calorie reduction from traditional recipe.

Reduced Fat Pie Pastry

1 1/4 cups all-purpose flour
3 packets artificial sweetener
1/4 tsp. salt
4 Tbsps. cold margarine, cut into pieces
5 to 5 1/2 Tbsps. ice water

Combine flour, artificial sweetener, and salt in medium bowl. Cut in margarine mixture resembles coarse crumbs. Mix in water, 1 tablespoon at a time, mixing lightly with a fork after each addition until a dough is formed. Refrigerate until ready to use.

TIP: Double recipe for double crust or lattice pie.

Maple Syrup

1 1/4 cups cold water
1 Tbsp. cornstarch
1 tsp. maple flavoring
10 packets artificial sweetener

Put the water, cornstarch, and flavoring in a saucepan. Bring to a boil. Remove from the heat and allow to cool. Add the artificial sweetener at this time. Stir well until dissolved. Serve hot or cold over pancakes or waffles. Stir before serving. Two tablespoons several times a day is allowed. Makes 12 tablespoons.

Spiced Tea

1 tsp. cinnamon
1/2 tsp. cloves
1/2 tsp. allspice
Boiling water

Mix dry ingredients together, stirring well. Measure 1 tablespoon mixture into each 8-ounce mug; fill with boiling water and stir.

Store remaining mixture in covered jar.
Makes 20 servings with a 90% calorie reduction from traditional recipe.

Strawberry Jam

1 cup sliced strawberries unsweetened (about 5 to 6 ounces)

3 packets sugar substitute

Mash strawberries. Add soda and bring to a boil. Cook 1 minute.

Remove from heat. Stir in gelatin dessert until dissolved. Stir in sweetener.

Pour into clean hot jars; seal and store in refrigerator. Makes 1 1/4 cups.

Combine applesauce, cider, and spices in electric frying pan, or in iron or cast aluminum skillet or pot.

Simmer slowly, stirring frequently, 2 to 3 hours until spreading consistency is reached.

Cool and sweeten to taste.
Store in covered container in refrigerator. Makes 10 servings.

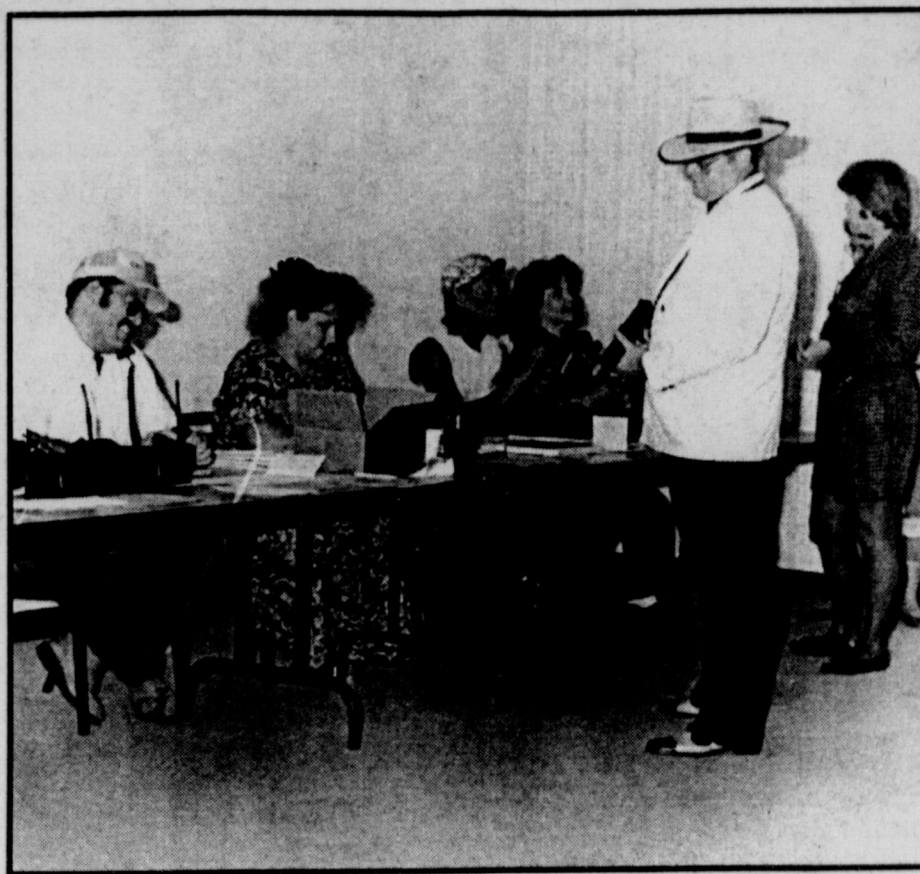

GARDENING HINTS

By MARK TERNING, COUNTY AGENT - HORTICULTURE

Common questions last week at the county Extension office are as follows:

Q. Is it time to spray for pecan weevil control? My pecan trees are loaded! Will you hold another pecan weevil field day?

A. This weekend through next week looks like key times for weevil control applications. Area commercial pecan producers started spraying last week. Use Sevin as a control spray. One to three treatments at 10 to 14 day intervals are needed for heavy weevil infestations. More information will be available Thursday, August 31 at our Pecan Weevil Clinic. We will hold this program at the Ellis Orchard at 808 Pecanway Rd. in Wichita Falls at 6:30 p.m. T.D.A. pesticide license holders will receive two CEU's for attending. Bill Ree, pecan entomologist, will review weevil control and update growers on the statewide crop. Everyone with an interest in pecans is invited.

Q. Why are all of my periwinkle flowers dying? Enclosed is a sample.

A. Unfortunately, there are numerous cases of periwinkle and even

petunia death similar to your problem. A soil-borne water mold fungus which is called Phytophthora has taken its toll on periwinkles. A good friend of mine in Tulsa, Oklahoma is a landscape contractor. His company used to plant 125,000 periwinkles each year. They now plant zero due to this disease. Fungicide applications have not offered a great deal of control. Planting late in the spring (mid-June) and using raised beds with drip-irrigation will help. Do not try to replant periwinkles in an area that has had past problems with this disease.

Q. Why are my pecans dropping off my tree?

A. Pecan drop has mainly been due to water stress. A mature pecan tree requires a great deal of water to mature a large pecan crop. The Texoma crop looks good this year and some additional pecan drop can be expected. Second generation of casebearer also resulted in some of our area pecan drop. Water regularly and deeply at the dripline of your pecan tree to reduce pecan dropping.

Genealogists have a choice of projects.

PEDIGREE--Most start with a pedigree which identifies only direct ancestors of one person.

A pedigree consists of parents, grandparents, great-grandparents, great-great-grandparents, and on backwards in time.

This doesn't include siblings, although they may be older than the person tracing a pedigree, and does not include aunts, uncles, nieces, nephews or cousins of this person.

LINEAGE--Or, one line can be traced from the pedigree. This highlights only one particular person in the line of ascent or descent, such as the pedigree person, one parent, one grandparent, etc., or the other way around.

DESCENDANCY--Neither the pedigree nor the lineage has as many people as a descendancy, sometimes called one's genealogy.

When a genealogist identifies his or her pedigree lineage back in time, most genealogists become curious about others descended from an ancestor, and this is when the number of people in the descendancy explodes.

The descendancy begins with a progenitor, which is a person with dependants, or a person who begins a

dependancy. So now we have the progenitor's children who are siblings. They marry and more are added, and don't forget the aunts, uncles, cousins and their families.

Remember, a pedigree goes back in time, a lineage can move both ways, while a descendancy moves forward from someone identified as the progenitor.

A pedigree is easier to document but the research will generate piles of notes that will need to be organized properly--the notes eventually stimulate more notes and more documents.

William Dollarhide has four basic rules pertaining to research notes.

(1)--Control sheet size, 3-hole 8 1/2 x 11

(2)--Separate sheets by surname

(3)--Separate surname by place of origin.

(4)--Give each sheet a page number so they can be filed and retrievable.

All scraps of notes and copies of documents (some may need to be photocopied to reduce size, or folded) are taped or pasted on the 8 1/2 x 11 sheets and filed. All this organizing will be invaluable when further research is continued.

Finnell maintains perfect attendance

State Rep. Charles Finnell completed the 74th legislative session without missing a roll call or vote taken on the floor of the House.

This marks the eighth consecutive session that Finnell has maintained his 100% record of being present and participating, according to the public records of the Chief Clerk's office.

This session, Finnell says he purposely limited his legislation to seven initiatives in order to focus concentration on the proposed reforms in juvenile justice, welfare, lawsuits and education.

"I feel the responsibility to be there and representing my constituents at all times," Finnell said. "These vital reform issues and other important legislation addressed during the session certainly deserved the full attention of all members of the legislature, and indeed, all Texans as well."

The only time Finnell missed a legislative vote was in April, 1979, when the massive tornado in Wilbarger, Wichita and Clay counties killed 49 people and caused millions of dollars in property damage.

He and then-governor Bill Clements flew from Austin to the disaster area immediately to assess damage and to facilitate relief to the storm's many victims.

In Iowa Park, Finnell's northern district line is the railroad tracks. The northern part of the city, which he had represented since being elected, was taken out two years ago in redistricting and issued to John Hirschi.

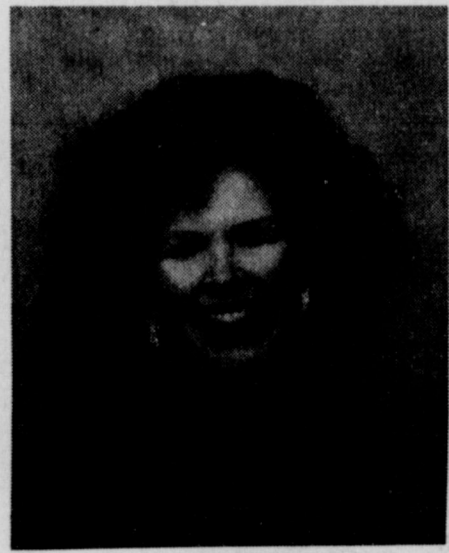

Saxon Math has positive results

(EDITOR'S NOTE: This is the first in a three-part series of articles on Saxon Math, which is now being taught in Iowa Park schools to students in grades kindergarten through eight.)

Saxon Math was first piloted in a third grade classroom in the Iowa Park schools during the 1992-93 year. The program expanded in just three years to include all students in grades K-8.

Supt. Glen Mitchell said the reason Saxon Math is being taught, rather than using the state-adopted textbooks, is because local teachers believe it is the best method for students to learn math.

The Saxon Math philosophy is that math is not difficult. Mathematics is just different. Students learn the Saxon way by doing.

The majority of class time is spent allowing students to demonstrate that which they are proficient and to practice that not yet understood.

John Saxon said the most effective way to teach students is to use gentle repetition extended over a considerable period of time. The Saxon books concentrate totally on review.

Saxon said we review everything in every lesson for the entire year. As the problems become familiar, students can look at a new problem and recognize it by type.

This recognition evokes conditioned responses that lead to solutions. To students, homework suddenly becomes a game at which they can suc-

ceed and through which they find satisfaction and self-worth.

This makes the math classroom a place where they are allowed, every day, to show off mastery of previously-learned skills. Many of these skills take a long time to develop, and the students can be rightfully proud of their accomplishments.

Students who use Saxon textbooks are not afraid of mathematics because they are successful.

Mitchell said student math scores increased on the TAAS tests at Bradford Elementary this year, and he believes the math scores will increase at the junior high as well.

The superintendent said he is especially pleased with the positive response from teachers and students to Saxon Math.

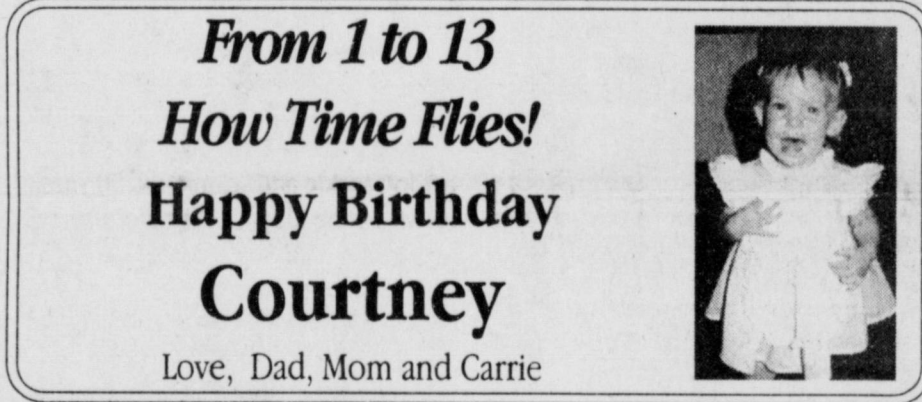
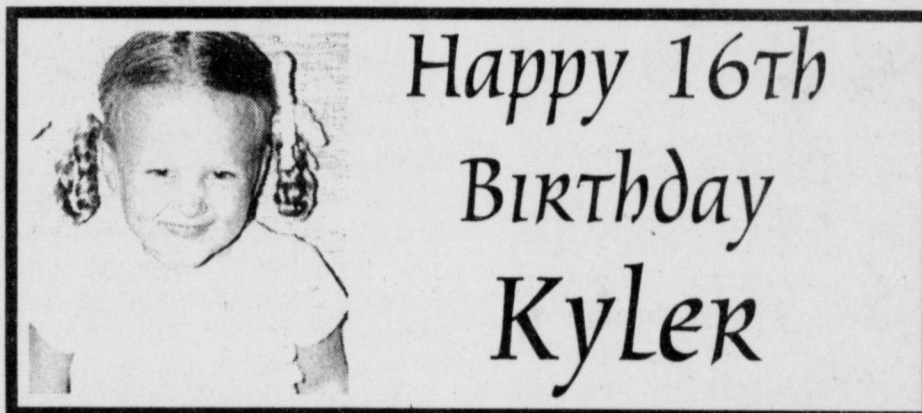

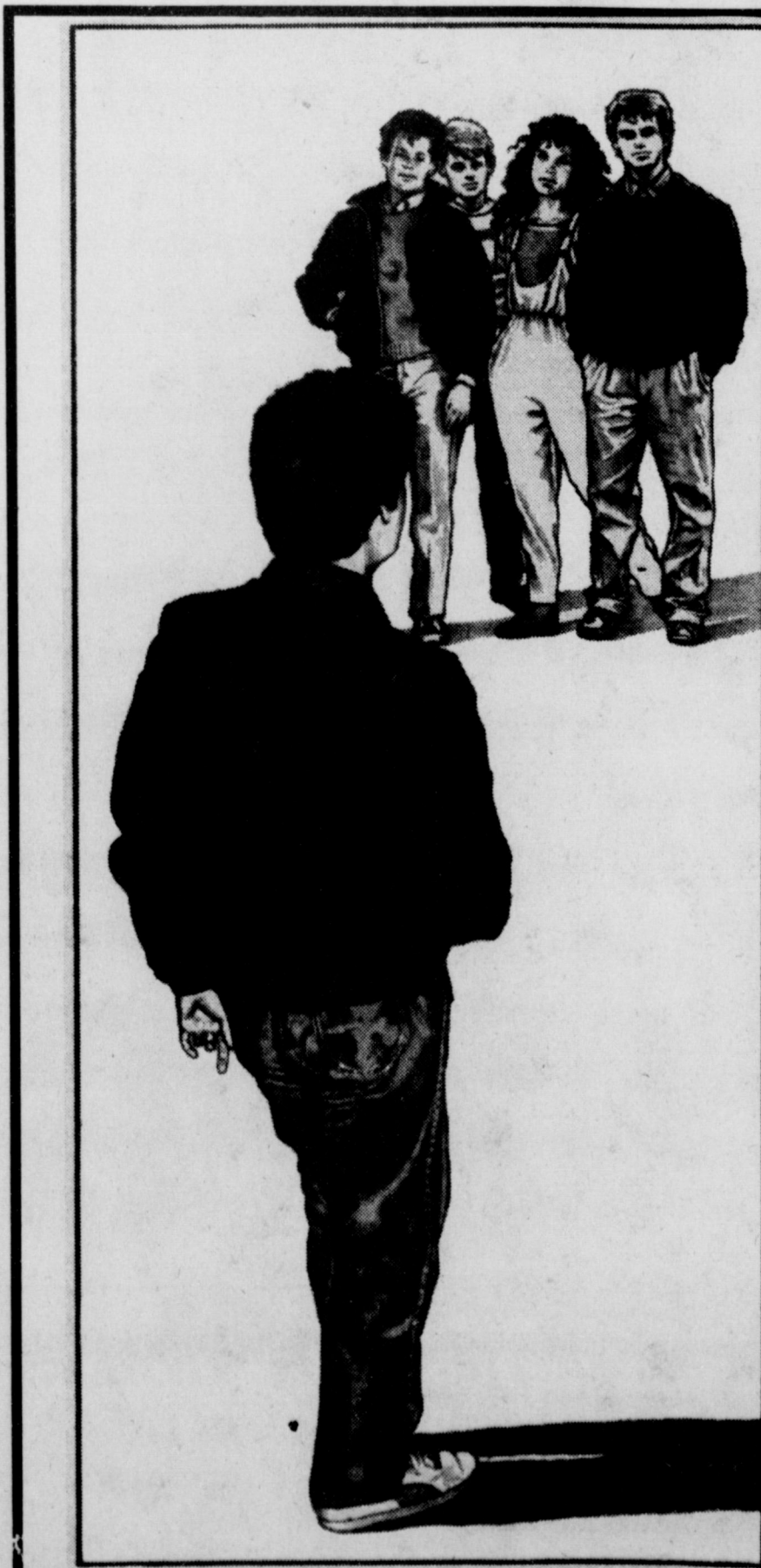

Hawks hold their own against 4-A Coyotes

Travel to Childress tonight for final scrimmage

To a lot of people, a pre-season scrimmage is not very important. But to a team that is coming off an 0-10 season, it is the first chance for the coaches, players and fans to see what the upcoming season will look like.

And for a town like Iowa Park that has as many football fans as anybody, there were a lot of them on hand Friday night at Memorial Stadium when the Hawks took on Wichita Falls High School in the first scrimmage of the season.

And they didn't have to wait long to see what they all came to see as Iowa Park scored a defensive touchdown on the second play of the scrimmage and went on to tie the Coyotes at 3-3.

Clancy Lalumia, a senior defensive back, stepped in front of a pass and returned it untouched 32 yards for the first score of the evening to put Iowa Park on top 1-0.

Following the Hawks' touchdown, the Coyotes took over at their own 30-yard line and three plays later Iowa Park forced a fumble that was recov-

ered by Tyson Spruiell to stall WFHS on its second drive of the game. The Coyotes finally got on track following the fumble and tied the game at 1-1 on their next drive on a 53-yard touchdown run.

WFHS made it 2-1 two drives later on a 15-yard run that capped a 7-play drive.

"We felt real good about our first scrimmage," head coach Weldon Nelms said. "I thought our kids performed well in all areas of play and we saw a lot of bright spots out there. I thought our kids gave a superior effort from the freshmen squad all the way up to the varsity. We've got a lot of decisions ahead of us on starting positions, but that's a problem any coach would like to have."

The Hawks didn't get their offense going until their third drive of their first series when they moved inside the Coyotes 30-yard line but failed to convert on a fourth-and-three from the 27 to end the nine-play drive.

Iowa Park held the Coyotes to

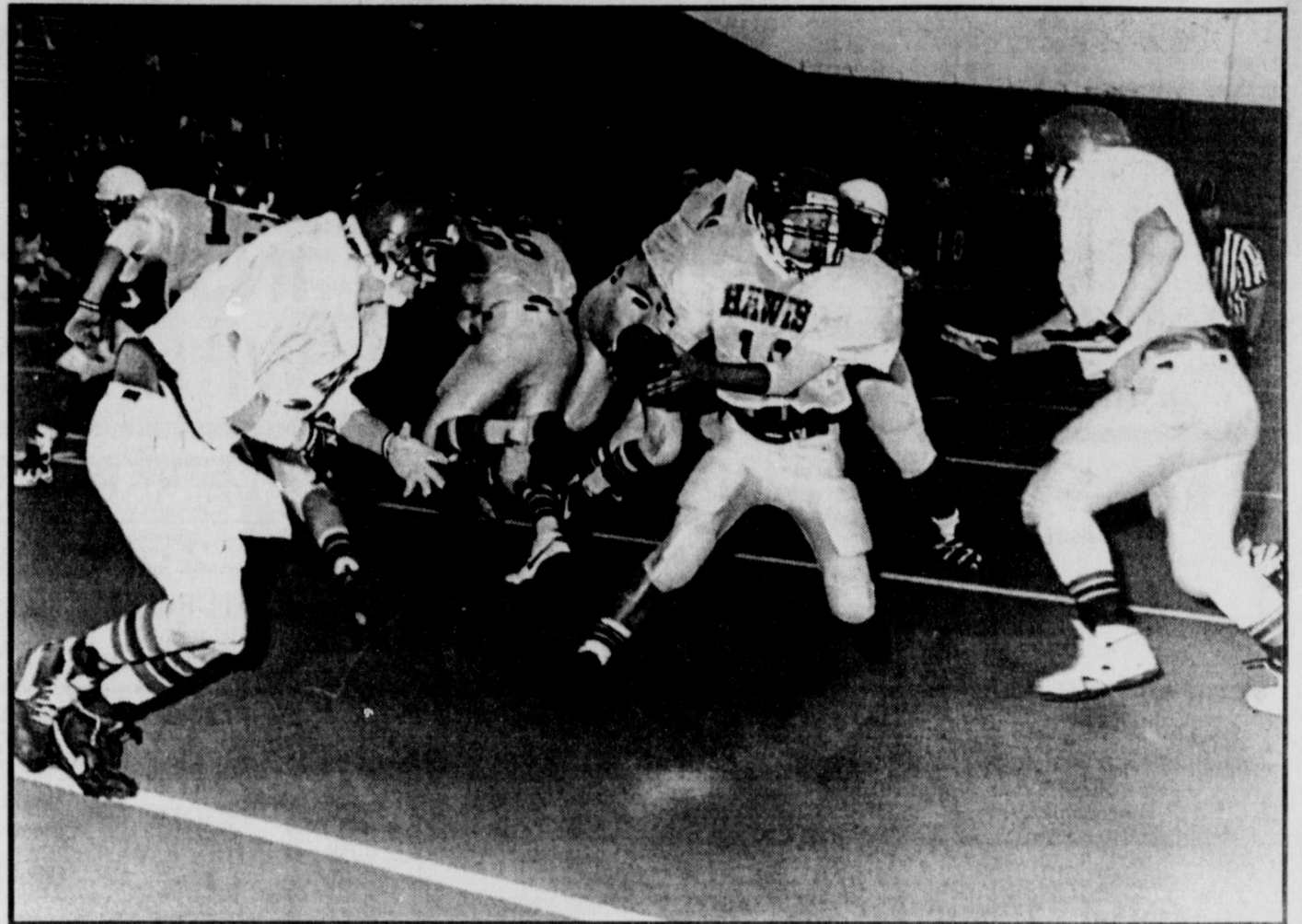
only 20 total yards in their next 15 plays to keep the score 2-1.

In the Hawks' next offensive series of plays, they racked up 82 yards of offense and put the tying touchdown on the board when Dusty Owen, a senior fullback, dove over from the one to cap an 11-play drive covering 70 yards. Jed Taylor grabbed a pair of passes from Jason Yeager on the drive for a pair of first downs.

WFHS lost two more fumbles in its next three plays as the Hawk defense continued to put pressure on the ball. The Coyotes got out of a hole with a big 40-yard pass play to set up their final score of the scrimmage which came on their final offensive play, a 5-yard run off tackle.

With Iowa Park trailing 3-2, the Hawks took over on their own 30. Brandon Campbell hit Owen with a swing pass that covered 18 yards to the 48 yard line. Two plays later, Owen broke loose up the middle and rambled 41 yards into the end zone for the game-tying score.

"Dusty did a good job for us in his

first game at fullback," Nelms added. "We've got a lot of depth in the backfield and right now our two quarterbacks are both looking real good. They both made some big plays and it's a pretty even battle right now. The Childress scrimmage will help us decide on a starter. I thought our offensive line played a solid game and I feel good with our first unit and some of the backups will come on and give us some depth there as well. Defensively, Jackie Miller had a good scrimmage. He's going to be tough for our opponents to handle with his speed and strength and is someone they'll have to account for on every play."

Following Owen's second TD of the night, the Hawks were not content with the tie and moved into position to win the game when Corky Petty broke off left tackle and scampered 50 yards down to the Coyote 20 before being dragged down from behind. But the Hawks couldn't punch it in from there as they ran out of plays with the ball at the WFHS 15.

With the Childress scrimmage tonight, the Hawks will be looking to

fine tune their game for the season opener at Burkburnett next Friday night.

The freshmen and junior varsity are scheduled to get underway at 5:30 today with the varsity to follow at 7 p.m.. The freshmen and JV will play at the same time on different fields.

"We won't go as many plays as we did against the Coyotes," said Nelms. "We'll probably run about 40 plays on both offense and defense with most of

the starters seeing action in the first 20 plays. We'll use the next 20 to get another look at some of the players that are pushing for the starting spots. Childress was ranked #8 in the pre-season polls so this should be a good challenge for us. They had to replace some kids off last year's playoff team that lost to Springtown in the third round but they've always done a good job at filling holes so we're looking forward to a tough ball game."

Measure your catches

Starting September 1, Texas anglers will have to be aware of changes in the fishing regulations, according to Mike Wilkerson, fisheries biologist.

Major changes for Wichita Falls area anglers are limited to catfish.

Channel and blue catfish minimum length limits are being raised from nine to 21 inches, meaning that those measuring less than 12 inches must be released.

The daily bag limit remains at a total of 25 channel and blue catfish per day.

An exception to the daily bag limit occurs in lakes that Texas Parks and Wildlife Department has designated as Community Fishing Lakes.

These are small impoundments located in urban areas that TPWD annually stocks with advanced fingerling catfish (8-10 inches). These lakes have a 12-inch minimum length limit and a daily bag limit of five

catfish per day.

Community lakes in Wichita Falls include Williams Park and Plum Lake near the softball complex.

The minimum length limit for flathead catfish is being reduced from 24 to 18 inches with a five-fish daily bag. TPWD manages flathead catfish differently from other catfish species because they grow slower and become

sexually mature at older ages.

Largemouth bass regulations remain the same with all lakes near Wichita Falls having a 14-inch minimum length limit and a daily bag of five fish.

The only exception is Lost Creek Reservoir near Jacksboro, with a 16-inch minimum length limit and a five-fish daily bag on largemouth bass.
