WITH WARM REGARDS - Virtually all personnel of the Iowa Park school district and a great number of townspeople were on hand Friday afternoon for a reception honoring Glen Mitchell, who is retiring after a career of 41 years in public education, the last 11 as superintendent of this district. held in the junior high library, following the traditional end-of-school luncheon for school personnel. Mrs. Mitchell, on the left, reportedly will teach at least one more year at Bradford Elementary. Highlighting the event were the presentation of a gold wrist watch and Walkman headset.

Tradition carries on for police

There was no break in tradition this past week for the Iowa Park Police Department.

Tradition holds that Memorial Day Weekend, coupled with the end of school, is a busy period for police.

Nine persons were arrested, three thefts reported, one apparent suicide attempt, and seven juveniles issued warnings for violating curfew.

Steven Henry Luna, 17, was arrested last Wednesday on a charge of having stolen an amplifier May 19 from a vehicle on South Texowa. He was transported to the county jail under a \$2,500 bond.

Also arrested that day, at 7:18 p.m., was Rodney Eugene Parker, 26, in the 300 block of East Cash, on a charge of Class C assault. Parker was released at 2:39 a.m. the following day after paying a fine of \$132, according to the police blotter.

When an officer stopped a vehicle at 3:02 a.m. Saturday in the 200 block of North Jackson, he was given permission to search it, and found drug paraphanelia.

James Fallon, 24, was charged with the possession, and released at

6:33 a.m. after paying a fine of \$83.50.

Two men in a vehicle stopped at 2:12 a.m. Sunday in the 1000 block of East Highway were both arrested.

Phi Van Nguyen, 30, was charged with DWI, and Doc Xuan Le, 30, was charged with public intoxication.

Nguyen was transported to the county jail under a \$750 bond (first offense), and Le was released at 10:54 a.m. after paying his fine of \$132.

Raymond Lee Gooch, 23, was arrested on a Class C assault charge at 11:24 a.m. Tuesday, at 701 Johnson. Police released him at 2:30 p.m. after he signed a personal recognition bond and promised to appear in municipal court June 11.

Officers were called to a residence in the 700 block of West Smith at 10:31 p.m. Tuesday, and a subject was taken into custody on an outstanding warrant issued by the Wichita County Sheriff's Dept.

Robert Dale Kenedy II, 21, was wanted by the county for bond forfeiture on a charge of theft over \$500, which carries a \$2,000 bond.

Kenedy was turned over to a

deputy at 11:39 p.m. to be transported to the county jail.

Billy Paul Griffin, 24, was taken into custody at 10:42 p.m. Tuesday in the 1400 block of Johnson, after it was determined two outstanding warrants had been issued for him by the local department.

The warrants were for having no motor vehicle inspection and no drivers license.

Griffin was released at 12:47 a.m. yesterday after signing promises to appear in municipal court on June 11.

Also arrested Wednesday of last week was Victoria June Houston, 21, on a charge of filing a false report with police. She was transported to the county jail.

Two of the three theft cases reported were in the same neighborhood in the northern part of the city.

A contractor told police Friday that someone had taken 50 pieces of 10-foot metal roof guttering, valued about \$100, from a location in the 1600 block of Johnson.

Saturday, a resident on Surrey

reported the theft of a role of four-foot chain link fence and 35 posts, which had been dismantled. Value was set at \$200.

The third theft was filed Friday afternoon, of a boy's bicycle, from a residence in the 200 block of West Magnolia.

Three juveniles were picked up at 12:46 a.m. Friday in the 300 block of West Bank, one at 1:06 a.m. Saturday in the 200 block of South Bond, and three more at 12:15 a.m. yesterday in the 200 block of East Alameda.

In all three instances, the juveniles were issued warnings for violating the city's curfew ordinance, and held at the police station until their parents picked them up.

Police and emergency medical personnel were summoned to a residence in the 700 block of Johnson at 3:23 a.m. Monday, where a female had reportedly attempted suicide by drinking bleach.

She was transported to a Wichita Falls hospital and later administered counseling.

Consultant presents lengthy pay report

Iowa Park school trustees spent the first three hours of a lengthy called meeting Monday night listening to the presentation of an employee pay plan.

The presentation was made by Dane Adkinson with the Texas Association of School Boards (TASB).

During their meeting March 14, the board had authorized the T.A.S.B. to conduct an employee pay study for the local school district for a fee of around \$4,000. The presentation Monday night was a result of that study.

Board members said they needed time to digest the information and would discuss it further with Adkinson at the next board meeting, on June 13.

For the past nine years, specialists in the Personnel Services Division of T.A.S.B. have been helping schools in restructuring and improving employee pay systems.

In other business, Assistant Superintendent Robert Palmer was appointed authorized representative for the National School Lunch and Child Nutrition Program. Georgia Moore was named alternate representative.

Superintendent Glen Mitchell said that Palmer is responsible for the lunch

program and he should be the one to sign the reports rather than the superintendent.

An item on the agenda that involved selling excess property in a garage sale at the old bus barn on June 1, and at Valley View School on June 8, was tabled. Board member Dennis Yeager suggested contacting an auctioneer to see if it would be feasible to have an auction. The others agreed, and a report will be made at the June 13 meeting.

A list of 30 students from City View who had requested a transfer for the 1996-97 school year was approved.

The trustees rejected a Special Warranty Deed for a portion of the Valley View School property, but approved a Quick Claim Deed.

The action by the board was made necessary because there is no deed on record for a small tract of land in the Valley View School property which was recently sold to the high bidder, Eula A. Collier.

No action was taken following a closed session which, as listed on the agenda, was to (a) accept resignations, and (b) employ personnel.

Annual golf tourney draws 40 contestants

Competition in the Sixth Annual All-Iowa Park Golf Tournament is set to get underway at 1 p.m. Friday, at River Creek Golf Course outside Burk Burnett.

Only one of last year's three big winners is among the 40 entrants this year.

Kathy Woods is returning, but Earl Bennett, who won the low scratch competition for the third time last year, and Ron Needham, low handicap, are not entered. Woods won the ladies competition in 1995.

The tournament is sponsored by the Iowa Park Chamber of Commerce, and contestants must either reside or work full time in the Iowa Park school district.

Two winners are named each year in the men's division. They are for the low scratch score, and low handicap net, as determined by the Callaway system.

Prizes include IP Bucks, which can be redeemed at virtually all Iowa Park Chamber members' businesses, golf balls, two putters, a bubble-shaft driver, and \$1,000 cash.

The \$1,000 prize is being offered for the first time by the Iowa Park Leader, and will be presented to the first entrant recording a hole in one on the par three 16th green.

The golf balls are sponsored by Cryovac, a putter and driver by Rob-

ert Palmer, and the second putter by Second Hand Sports of Wichita Falls.

Because River Creek no longer allows "shotgun" starts, all teams will commence teeing off on the first tee.

Customers whose last names begin with the letters A through M are asked to water on odd-numbered days of the month. Customers whose last names begin with letter N through Z

are to water on even-numbered days of the month.

Letters were distributed Tuesday to all customers outlining the schedule, stating that because of "extremely dry conditions, water usage is very high...your cooperation with this schedule is very important and will assure an adequate water supply for everyone."

Cook of the Week



Evelyn Ward

The recipes Evelyn brought in for this week's column are some of her family's favorites.

The "Children's Cherry Dessert" was always a favorite of Joe Jr., and Evelyn likes to make "Bubble Bread" for holiday meals and family gatherings.

Children's Cherry Dessert

- 1 cup sour cherries
- 3/4 cup sugar
- 3 Tbsps. flour
- 1 1/2 cup oatmeal
- 1 1/2 cup flour
- 1 cup brown sugar
- 2/3 cup shortening
- 3/4 tsp. soda

Cook cherries, sugar and 3 tablespoons flour until thick. Let cool. Mix remaining ingredients like a pie crust. Put 3/4 on bottom of a 9x13-inch pan. Add cherry mixture on top, then sprinkle remaining crust on top. Bake in 375 degree oven until slightly brown.

Easy Version of Children's Cherry Dessert

- 1 can cherry pie filling
- 1 can tart cherries, pitted
- 1 box white cake mix
- 1/2 cup pecans, chopped
- 1 stick oleo

Pour pie filling and cherries into large baking dish and mix. Sprinkle the box of cake mix on top of this. Melt 1 stick oleo and pour evenly over mix. Sprinkle with chopped nuts. Bake at 350 degrees 35-40 minutes.

Bubble Bread

- 24 frozen dinner rolls
- 1 pkg. regular butterscotch pudding
- 1 cup light brown sugar

- 1/4 cup sugar
- 1 tsp. cinnamon
- 1/2 cup pecans

Layer frozen rolls into greased bundt pan. Mix other ingredients together and sprinkle on top of rolls. Pour 1 stick melted margarine on top; cover and let set overnight. Bake at 350 degrees 20-25 minutes. Let cool 10-15 minutes before serving.

Mexican Cornbread Casserole

- 1 cup yellow corn meal
- 2 eggs, well beaten
- 1 cup sweet milk
- 1 #3 can cream style corn
- 1/2 tsp. soda
- 3/4 tsp. salt
- 1/2 cup bacon drippings
- 1/2 lb. ground meat
- 1 large onion, finely chopped
- 1/2 lb. grated cheese
- 4 chopped jalapeno peppers

Preheat oven to 350 degrees. Combine corn meal, soda and salt. Add eggs, milk, cream style corn, and bacon drippings; mix well. Saute ground meat and drain. Grease large black iron skillet and heat. Sprinkle thin layer of corn meal in bottom of skillet and brown in oven. Pour 1/2 batter into skillet. Add meat, onion, cheese, and peppers. Pour remaining batter on top. Bake 45-50 minutes at 350 degrees. Serves 8-10.

(This is Bonnie Medlinger's recipe. My family enjoys this with pinto beans.)

Manicotti with Cheese

- 14 pieces (8 oz.) Manicotti, uncooked
- 1 3/4 cups (15 oz.) part-skim ricotta cheese
- 2 cups (8 oz.) shredded mozzarella cheese
- 1/4 cup grated Parmesan cheese
- 2 Tbsps. chopped fresh parsley
- 1/2 tsp. salt
- 1/4 tsp. ground black pepper
- 3 cups spaghetti sauce

Cook pasta according to package directions; drain. Cool in single layer on foil. Heat oven to 350 degrees. In large bowl, stir together cheeses, parsley, salt and pepper; spoon into cooled pasta tubes. Spread thin layer of sauce on bottom of 13x9x2-inch glass baking dish; arrange filled pasta in single layer over sauce. Pour remaining sauce over pasta; cover with foil. Bake 40 minutes. Remove foil; bake 15 minutes longer or until hot and bubbly. 6 to 8 servings.

Brownies

- 2 cups flour
- 1 tsp. baking powder
- 1/2 tsp. salt
- 2 cups sugar
- 4 Tbsps. cocoa
- 1 1/3 cup cooking oil
- 4 eggs
- 2 tsps. vanilla
- 1 cup chopped pecans

Preheat oven to 350 degrees. Mix together all ingredients. Pour into a 9x13-inch pan and bake 20 minutes at 350 degrees.

Club tours rose gardens

For their last meeting until fall, the Iowa Park Garden Club took a field trip to tour the rose gardens at the home of Glenn and Helen Miller.

The group of 16 members were invited into the Miller home for pink lemonade while Mr. Miller explained his success in raising roses.

"There is no one way to do anything, I just 'glob' the flowers in the ground and keep it damp around the root," he said.

Each of the 367 rose bushes are plainly marked as to the type and color. "Roses are tough," said Miller,

who fertilizes them once a month and sprays each week with a different fungicide.

He said roses need to be kept cut in order to produce more blooms. However, six weeks before freeze time, he quits cutting and fertilizing so the bush will go dormant. This is when he surrounds the roots with dirt to keep them from freezing. In February, the roses are cut back, leaving the center open for air circulation.

High winds during the daytime might not be unusual, for a three or four day period. But all day and all night?

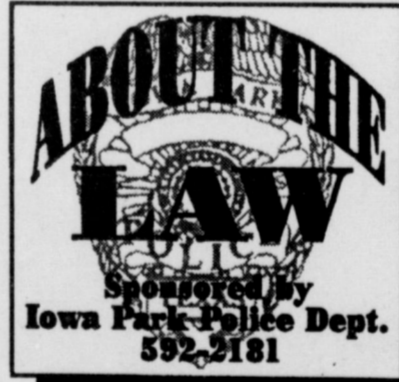

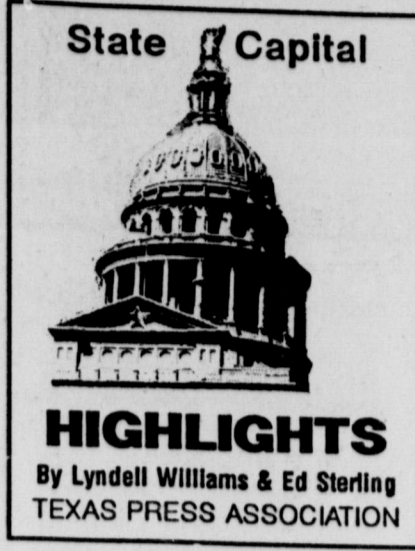

AUSTIN — Gov. George W. Bush said he will oppose any effort to alter the 1995 school reform law when the state Legislature convenes in January.

Though he said he was addressing no group in particular, Bush made the statement after a group of 21 House members asked the State Board of Education to continue screening textbooks despite provisions in the new law that put textbook selection under the authority of local school districts.

Members of the group told reporters they may seek to change the law in the 1997 legislative session.

Bush urged lawmakers to give the new law a chance to work before putting the state's public schools through more sweeping changes.

"Last year we passed one of the most far-reaching reform packages in the United States. ... We need to give people a chance to adjust to the new environment. I will frown on anything that tries to structurally change Senate Bill 1."

"The worse message we could send to educators in Texas is we will pass a law and two years later we will fundamentally change it again," Bush said.

Despite his caution against tinkering with S.B. 1, Bush told reporters certain provisions in the law need fine-tuning. In particular, he said, the student disciplinary policy ought to be clarified in the legislative session.

Also, Bush said he would support a measure in the upcoming session to increase the number of state-granted charter schools. The 1995 reform package limited the number of charter schools to 20.

Lone Star Card Is Success

Welfare fraud is on the decline and the Lone Star Card is getting the credit.

Texas Comptroller John Sharp said that since the card was initiated two years ago, more food stamp dollars are being spent on approved foodstuffs, such as milk and cheese, and less is being spent on cigarettes and beer.

Texas' food stamp rolls have been cut by nearly 32 percent in two years, apparently without hurting the needy, the *San Antonio Express-News* reported.

Tom Smith of the government watchdog group Public Citizen, said the program is "basically working," the *Express-News* reported. "Every once in a while a government program actually works. Everybody's shocked."

Much like the bank cards used in automatic teller machines, the Lone Star Card is used by recipients of food stamps and Aid to Families With Dependent Children. Their benefits are credited to an account that is accessed with the card at checkout counters.

Meanwhile, last week, Sharp's office unveiled a test program in which welfare recipients will be fingerprinted as a fraud prevention measure.

The \$270,000 test program is to begin Sept. 1 in Guadalupe and Bexar counties. A computerized system will check digitized fingerprints to detect fraud when welfare applicants file their applications.

Court Rules Against Firms

The Texas Supreme Court rejected an effort by Allstate and Farmers insurance companies to stop a TV commercial by policyholders suing the companies for \$109 million.

The commercials now running in Dallas-Fort Worth and Austin, announces a May 30 court hearing involving as many as 4 million current and former policyholders, the *Dallas Morning News* reported.

The ads are being broadcast far from where the lawsuit is filed — in sparsely populated and plaintiff-friendly Zavala County, on the Mexican border.

Policyholders are seeking reimbursement and damages against the insurance companies for allegedly improperly computing premiums for Texas drivers by using a prac-

tice call "double rounding."

But the insurance companies contend that since the early 1970s, they have been required by the Texas Department of Insurance to calculate premiums by double-rounding.

Plaintiffs' lawyers have said that double rounding might lead to overcharging a driver \$35 over a 10 year period.

Though Insurance Commissioner Elton Bomer came to office in 1995, he confirmed his department had informed insurance companies — as recently as 1991 — that double-rounding was the law.

Companies Seek Venue Change

Tobacco company lawyers expressed their wish last week to move Texas' \$4 billion lawsuit against cigarette makers from Texarkana.

Jack Maroney, an attorney for Philip Morris, one of the defendants, told the *Dallas Morning News*, "It makes no sense to try the case in Texarkana," and added that it would be a matter of convenience both to the attorney general's office and the defendants to move the trial to Austin.

But Special Assist Attorney General Harry Potter dismissed the idea of moving the case as nothing more than a delay tactic by the defense, and he argued that the case could proceed more quickly in Texarkana because the federal court docket is less crowded.

Attorney General Dan Morales filed suit against the tobacco companies in late March, seeking reimbursement of billions of dollars in Medicaid money the state spent in treating Texans' tobacco-related illnesses.

Helpful Hints

The running or roaming at large of any dog, cat or other animal within the city has been declared a nuisance and positively prohibited, and it has been made unlawful and deemed a Class C misdemeanor for the owner or keeper of any dog, cat or other animal to allow the same to run or roam at large within the city.

Bicycle safety stressed during summer months

Longer daylight hours and warmer temperatures unfortunately means more bicycle-related injuries and deaths.

"Summer is the peak season for these types of unnecessary accidents," said Dr. Tom Jaksic, a pediatric surgeon at Baylor College of Medicine in Houston. "If kids and drivers would take a few important precautions, bicycling would be much safer."

The best advice, said Jaksic, is to always wear a helmet when biking. Although helmet compliance is particularly low among teenagers, statistics continue to show a dramatic link between helmet use and reduced risk for injury or death.

"In most bicycle accidents, the head or neck is the most common area for serious injury," said Jaksic, who sees patients at Baylor's Pediatric Injury Center.

The Brain Injury Research Center of Baylor and The Institute for Rehabilitation and Research say helmets should meet industry safety standards and should bear a sticker for ANSI, Snell or ASTM. Choose a light, bright color for better visibility, with a snug fit, but comfortable.

13 percent of all non-motorist traffic deaths. Pedestrians account for the majority.

Jaksic recommends that parents teach their children responsible bicycling. This includes always riding to the right side of the lane, except when turning left. If passing a parked car, keep four feet away to avoid opening doors.

Bicyclists should know the rules of the road, hand signals, and how to maintain a bicycle. Reflective materials on the bike and clothing add further safety at dusk or night.

Some states require a white light in front of the bike and a red light or reflector in back. Keep tires properly inflated, brakes in working order, and check the handlebars and wheels for any signs of "wobble."

"Biking is meant to be enjoyable," Jaksic said. "And with preparation, it can be safe as well."

Exercise increases energy

Want to get more zip in your life? Exercise.

A new brochure produced by the Office of Health Promotion at Baylor College of Medicine in Houston titled, "Vitality, Vim & Vigor: Six Steps to More Energy," recommends ways to boost your energy level.

"Believe it or not, exercise can make you feel less tired," said Dr. Ken Goodrick, an assistant professor of medicine at Baylor's Behavioral Medicine Research Center. "Adopting an exercise routine may not be easy, but it gets easier as you start enjoying the benefits."

Besides exercise, following a high-carbohydrate, low-fat diet, getting adequate rest, and controlling stress are important ways to reduce fatigue.

Decreasing caffeine is also important to avoid sluggishness, says Goodrick.

"Contrary to popular belief, caffeine can lead to a vicious fatigue cycle," he said. "Gradually decrease the amount of caffeine you drink by one cup of coffee or soda a day. You'll begin to feel more energetic."

Goodrick suggests a few lifestyle changes to give your mind and body a "jump start:"

- * Begin a reasonable exercise program. Check with your doctor before you start.

- * Remember that "no pain, no gain" is a myth. Slow down if exercise causes pain or makes you feel breathless.

- * Drink at least eight glasses of water a day.

- * Eat more frequent, smaller meals consisting of fresh fruits and vegetables, whole grain foods, lean meat, and low-fat dairy products.

- * Avoid late-night meals and snacks.

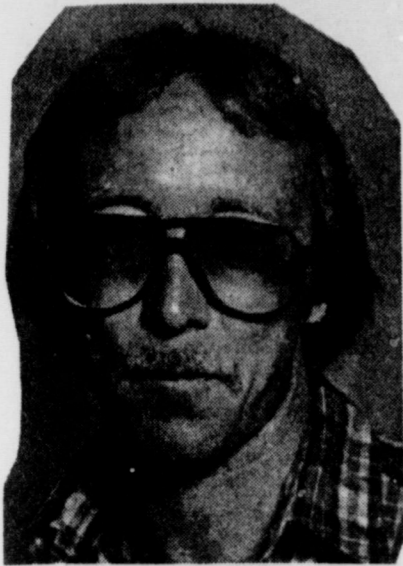

There are several good computer programs available. "Family Tree Maker" Deluxe Edition, is one.

Other advantages in using a computer, the printouts are easy to read. Corrections can be made easily and painlessly. It's impossible to fill out genealogy forms without mistakes that need correcting, hand written ones can become very messy

and need recopying, a tedious job in longhand.

Perryton eliminates Hawks from playoffs

Thursday's Area playoff game in Lubbock against Perryton had all the makings of a heavyweight title bout.

In one corner were the Rangers, with a 22-7-2 record and the ace of their staff, Feli Landeros (12-1) on the mound, while in the other corner were the Hawks, 24-6 overall and their ace, Chris Norris, also at 12-1, getting the call.

But just like in boxing, when the final bell sounds, only one team would be left standing.

Iowa Park fought back twice, scoring a run in the sixth to tie the game at 4-4, then again in the bottom of the seventh, when the Hawks scored twice to send the game into extra innings before finally falling to the Rangers 8-6 in eight innings at O'Banion Field.

The loss ended Iowa Park's season at 24-7, while Perryton advanced to play Brownfield in the Regional.

The Hawks' almost came back a third time in the bottom of the eighth. With two outs and runners at second and third, trailing by a pair, Chad Wright, who was 2x3 in the game, struck out to end the threat.

"I really thought we could come back one more time," said head coach David Fuhrman. "We came back to score twice in the seventh to send it into extra innings, and then we battled back to get the tying run on second in the bottom of the eighth after we had two outs.

"I was real happy because the kids didn't quit," Fuhrman added. "We had a great season, we won 24 ball games and I couldn't be happier with the way all the kids played, especially our seniors. It just didn't happen this time for us."

Norris opened the game by striking out the side in the first after allowing a two-out single to Cody Sunday.

In the bottom half of the first Iowa Park wasted little time in getting on the board. Norris led off with a single and scored one pitch later when Dusty Owen doubled off the wall in left-center to give the Hawks a 1-0 lead. Owen scored to make it 2-0 on a ground out by Clancy Lalumia.

Perryton quickly tied the game at 2-2 in the top of the second when the Rangers scored their two runs on three hits and an error by Iowa Park.

The Hawks broke the 2-2 tie in the bottom of the fifth when, with one out, Wright and Norris hit singles. Wright scored from second when Owen's fly to right was caught, but the throw missed the cutoff man allowing Wright to score the the breaking run.

The Rangers went on top 4-3 in the top of the sixth again, scoring two runs on three hits and an error to grab the lead for the first time in the game.

Iowa Park scored to tie the game

for the second time in the bottom half of the sixth when Lalumia reached on an error and later scored on a sacrifice fly by Robert Klinkerman, who came on to hit for Waylon Stewart in the inning.

Perryton's Sunday led off the seventh with a walk but was erased on a fielders choice. With one out, Norris' pick off attempt got away from Corky Petty allowing the runner to advance to second with one out. Tanner Alexander's RBI double scored Trey Duke to give Perryton a 5-4 lead. Thomas Trejon followed with an RBI

single to left to give the Rangers a 6-4 lead.

In the bottom of the seventh, Wright reached on an infield single with one out to start the Hawks' rally and was followed by Norris' single to right-center. Norris then delivered a 2- RBI single to tie the game at 6-6 with still only one out. Owen stole second to get into scoring position, then went to third on a groundout by David Waterbury before being stranded when Lalumia struck out.

In the top of the eighth, Perryton's Brandon Tower led off with a double

to right-center. The next batter flew out to Lalumia in right. Sunday singled and stole second to give the Rangers runners at second and third with only one out.

Landeros followed with a bouncing single over the head of Waterbury to score both runners and to give his team an 8-6 lead. Petty came on to relieve Norris and picked up the final two outs in the eighth.

In Iowa Park's half of the eighth, Petty led off with a walk but was erased when Klinkerman hit into a 6-4-3 double play. With two outs, Jake Dillard and Dusty Crawford each drew walks. Dillard went to third on an error by the catcher and Justin Swenson, who pinch ran for Crawford, stole second to put the tying runner on second with two outs before Wright's strike out.

The strike out was Landeros' 11th for the game, giving the big left-hander 208 for the season in only 106 innings of work. Norris struck out 10 for Iowa Park.

"You have to give them a lot of credit," Fuhrman said. "They really hit the ball well against us. We knew that they were a good hitting team because of their good batting averages, but at the same time, I knew

Norris was a dominating pitcher. But give them credit, they hit him. They hit him better than anyone did all year long."

The Rangers managed 14 hits off Norris, a season high by any team.

Iowa Park was led at the plate by Norris, who finished 3x4 with two runs scored, followed by Owen, who added a 2x4 performance with a run scored and 3 RBI's and Wright who went 2x4 with a pair of runs scored.

Volleyball camp slated

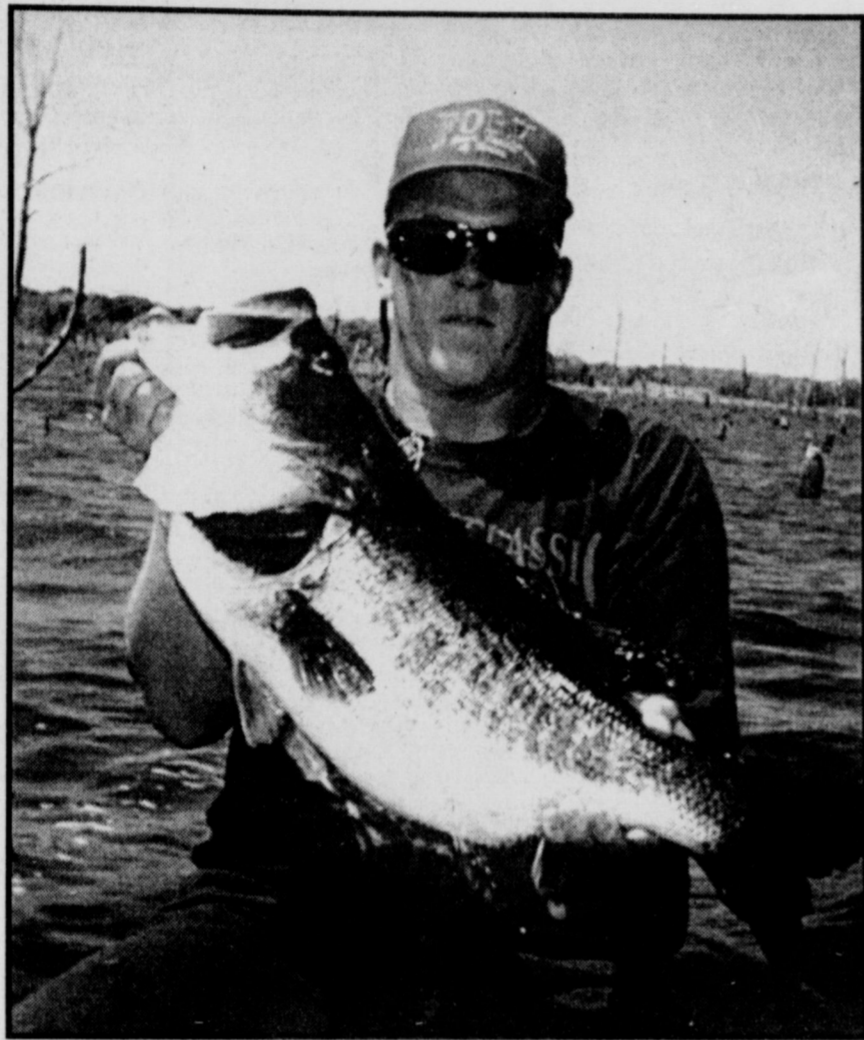
The Iowa Park High School will be holding a volleyball camp at the high school gymnasium, Monday through Thursday, June 17-20.

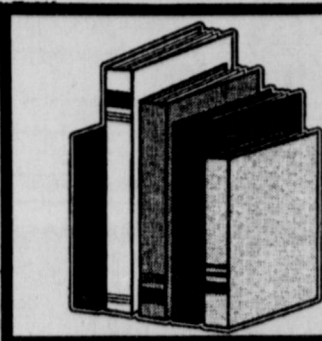


