# Atlantic Pact Soldiers Methodist Church Is Scene of Wedding of Number Local Men


Two Wichita county men serving in the army are among the first soldiers to arrive in Europe to augment Gen. Dwight D. Eisenhower's Atlantic Pact troops

Office of Price Stabilization. "Inflation cost the consumer

nearly 7 billion dollars during the last six months of 1950, exclusive of defense expenditures," said Ellis H. Boyd, district director.

During the past year price increases cost almost 17 billion dollars, excluding military spending. This amounts to about \$448 a family of four, or \$112 for every man wom-

an and child in the U.S. After the removal of price regulations in June 1946, the value of the consumer's dollar had declined to 76.4 cents by August 1948-a 25 per cent cut in pay if an individual's

ncome remained the same. Inflation has caused considerable increase in the price of defense goods. For example, before Korea an M-1 rifle cost \$41, now it costs \$64. Combat boots for infantrymen have doubled in price.

Price increases have leveled off some since the institution of price stabilization. Prices have been held to fractions of previous rises since the General Ceiling Price Regulation was issued in January, 1951. "The OPS does not claim all the

credit for stopping the inflationary spiral; other factors such as high inventories and credit restriction certainly helped," said Boyd. However he predicted terrific pressure to increase prices when government defense spending is
