B. H. Freeland For Mayor

B. H. Freeland's name was filed with the city secretary Monday morning as a candidate for mayor of the City of Baird in the April 6th election. K. V. Lewis, who announced in last week's Baird Star that he would be a candidate for mayor, also filed his petition with the city secretary that day. The names of C. W. Sutphen and Marvin Hunter were filed as candidates for aldermen.

B. H. Freeland signed his application after many friends urged him to run for mayor. His statement was that "if the people of Baird want me to be mayor, I'll take the job and do my best for the city if elected." Mr. Freeland has proven his interest in the town's progress many times over, and the citizens of Baird know him well.

Mr. Lewis is known to all the citizens of Baird, having operated Lewis Appliance store here for the past year, and doing plumbing work in this community for some time. He has been in the hotel and cafe business here as well as other lines.

Mr. Sutphen, owner of Sutphen Motor Company, is a leading business man of the town, and has served on the city council for a number of years. Marvin Hunter, publisher of The Baird Star, has never held a public office, and has had very little experience in connection with city government. Both Sutphen and Hunter signed the application for their names to be on the ticket only after large numbers of friends and citizens urged them to do so.

LEGION MEETING HELD TUESDAY NIGHT

The American Legion at its regular meeting, held on Tuesday night, voted to change the leasing requirements on the Legion Hut. Work To Start Soon On Highway East

Work is expected to start momentarily on a new stretch of U. S. Highway 80 between Baird and Mexia Creek, a few miles east of Baird, for which contract was recently let to Harry Campbell for \$485,000. The highway will require unusual excavation east of here.

A cut 58 feet deep will be made through the high hill east of town where the highway width will be 720 feet. Much of the cost of the new construction will be on this steep hill. At present U. S. 80 makes a southward swing in east Baird to the T&P high bridge, then gradually ascends on a long curve up the hill to the other side.

I. G. Mobley, commissioner of Precinct No. 3, says that contract for completion of U. S. 80 from Mexia Creek to the Eastland county boundary is being delayed due to removal of a large brick building at Putnam.

Mrs. Vena Shackelford is putting in a new wall in the building, the south end of which will be in the new highway right-of-way, as well as erecting a 60x60 quonset building to care for her implement stock.

In Putnam twelve lots owned until recently by the Texas & Pacific railway have been acquired on the north side of the railroad for the proposed new route. The county acquired twelve lots on the south side of the railroad which were exchanged for the 12 on the north side of the railroad, according to Mobley. It was hoped contract on the Mexia Creek and Eastland county stretch would be let sometime in March but it was feared that it may be several weeks before this can be consummated.

Ancient Building Is Torn Down

An ancient landmark in the city of Baird which has served the city long and well in various capacities, has fallen under the wheels of progress. The old Buckles house, now owned by W. O. Wylie, will furnish material for the new funeral home.

The old rock house, in the western part of town, is being torn down to be replaced by one more pleasing to the eye but which will fail to recall pleasant memories of childhood to the few remaining citizens who attended worship and public school under its roof.

The lot upon which this building was constructed was deeded by John C. Brown, Vice President of the Texas and Pacific Railway Company, for a consideration of one dollar, to D. A. Oldes, S. L. Ogle, N. P. Rice, W. A. West and W. H. Gilliland, as trustees of the Methodist Church of North America, as a site for a church building and parsonage.

The deed was dated May 29, 1882, and the building constructed during the latter months of that year. For a time it was used by all denominations as a place of worship. After the destructive fire of Jan. 4th, 1884, which destroyed the entire business section of the town from Holmes Drug location on the west side of Market Street, to the courthouse square, and all on the east side with exception of S. L. Ogle grocery, from the old bank building to the square, including the Cameron Lumber Company, which was located on the lot now occupied by W. O. Wylie Funeral Home, the old rock house served the town as a public school building. Flying sparks from the burning business buildings on Market Street ignited the roof of the school building, then located on the Cooke lot across the street east of the Presbyterian church, and soon the school building was totally destroyed. The officials of the Methodist church extended the facilities of the rock building to complete the school term.

It also served as a school building for the school year 1884-1885. By the fall of 1885, the new school building, which was located on the lot now occupied by the C. W. Conner residence, was ready for use and served the town until the construction of the present grade school building. The Methodist church sold the rock building on April 13, 1892 to Jeff Buckles, whose mother and children occupied at as a residence for many years. Among residents of Baird today who attended school in the old building is Mrs. E. C. Fulton.

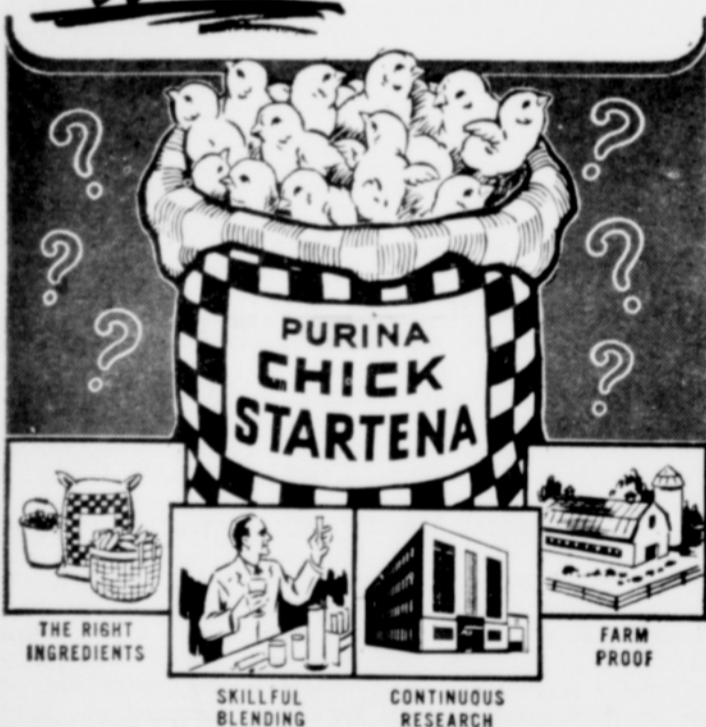

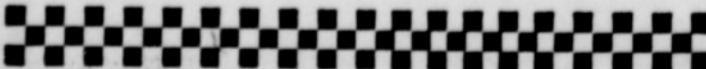

PUBLIC DEBUT FOR NEW PASSENGER EQUIPMENT

Dallas, Feb. 24 — Texas & Pacific Railway's first unit of postwar passenger equipment made its public debut this afternoon as it went into service at Fort Worth on the "Sunshine Special" operating between El Paso and New York. Officials at T&P headquarters in Dallas said the car would be used on that part of the transcontinental run between Fort Worth and St. Louis for the time being.

It is a sleeping car, "Eagle Island," first of the 19 all-room sleepers for use of the T&P's twin streamliners, the Texas and Louisiana "Eagles." "Eagle Island" consists of 14 roomettes, four bedrooms.

In announcing delivery of the railroad's first new passenger car since the order was placed in May, 1945, W. W. Fair, T&P passenger traffic manager, said that this particular sleeper and each of the 47 other cars needed to complete the "Eagle" trains would be put into service as quickly as they arrived from the manufacturers.

Citing this T&P equipment policy, President W. G. Vollmer explained: "We of the Texas & Pacific believe that the traveling public wants to enjoy the comfort of new passenger equipment as fast as we can get it to them. For that reason, we have adopted the policy of installing the cars in regular service as rapidly as we receive them, even though this means mixing them at first with conventional equipment."

With deliveries at regular intervals from here on, the complete consist of both trains will be in use by the end of the summer, Fair said. In fact, within the next month or so, the T&P through-service in conjunction with the Missouri Pacific expects to have a reasonably complete streamliner in operation, because Mopac is receiving new car deliveries coinciding with those of the T&P. This would apply mainly to the passenger run between St. Louis and Fort Worth.

In regard to exact scheduling of the two new "Eagle" trains which will run over T&P mainlines between Texarkana and El Paso and New Orleans, Dallas and Fort Worth, that point still is under study, according to C. G. Hayes, the railroad traffic vice-president. However, regardless of what final schedule con-

clusions are reached, the two "Eagles" as such will replace the T&P's long-advertised, crack passenger train, the "Sunshine Special."

Matching blue-and-silver Diesel-electric locomotives to pull the new T&P light-weight cars have been supplying motive power for regular passenger equipment since April, 1947, awaiting delivery of the \$5,800,000 worth of baggage and mail cars, coaches, diners, lounges and sleepers. This \$5,800,000 figure, T&P Purchasing Agent Howard Crouse stated is \$2,300,000 higher than when the cost originally was estimated by the manufacturers, Pullman-Standard (19 sleeping cars) and American Car & Foundry (the 29-car consist of diners, lounges, coaches, baggage and mail cars).

Besides all the up-to-date lighting, air-conditioning, interior fabrics and colors, the new T&P equipment has some other special features. The coaches, accommodating 60 passengers, are fitted with Rota-Cline seats and wide, clear-view windows with a glare-resistant glass. A few of the coaches have sandwich grills at the end of each car where passengers can sit at a counter and order light lunches.

Most of the diners are in combination with lounge sections, the dining room proper seating 24 persons, the lounge 8. The all-room sleepers, which eliminate the old-style section berths, offer roomettes, bedroom and drawing room accommodations, with the standard car consisting of 14 roomettes and four bedrooms like "Eagle Island."

Passage on the new equipment will be at the regularly published rates, depending upon the type of accommodation purchased — no extra fare charge.

Copies of the new Spring Edition are available to the traveling public at the Highway Department's main office in Austin, its twenty-five district offices throughout the State, and at its nine information bureaus operated at ports of entry into Texas.

Except for revisions in the road system and the new pictures, the edition is similar to others issued since the war which have been acclaimed among the best of the state road maps published throughout the nation.

Standard highway warning and directional signs are reproduced to the map to familiarize drivers with road markers.

Size of the Lone Star State is again graphically told by a table of comparative distances. The 868 miles from El Paso to Orange is greater than the 816 miles from El Paso to Los Angeles. It is also further than the 760 miles from Laredo to Mexico City.

Included also is a small scale map of the United States showing all state capitals and major federal highways.

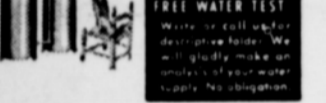
