



They were so elated over the improvement in the president's condition and the absence of any unfavorable symptoms that Secretary Root announced that he felt free to depart and that he had decided to go to New York tomorrow.

At the opening of the council meeting a communication from Mr. G. A. Taff was read. He offered to enter into a contract with the city. as follows:

To place the 20-inch pipe owned by the city and now on the ground in Beaver creek valley; construct the necessary dams for increasing the storage capacity of Lake Moraine to two and a half billion gallons, assuming that the present capacity is 492 million gallons; furnish all material and labor for building the dams and labor for laying the 20-inch pipe line from the intake on Beaver creek across Dead Lake divide for the sum of \$150,000.

This is a proposition that those who oppose the Seven Lakes proposition would have liked to have had looked into but the council took no action on it. It was referred to the water committee and the report of that committee later, recommending the purchase of the Seven Lakes, practically turned down this offer of Mr. Taff. The water that Mr. Taff proposes to carry into Lake Moraine by this pipe line is the water that would flow into the Seven Lakes reservoir. This amount of water would represent all the water that could be stored in Seven Lakes for use, subtracting from that lake which it is proposed to build the amount that can never be drawn off.

Several days ago Mr. Taff made a statement in the Gazette to the effect that he could get all the water from the Seven Lakes water shed into the city's system for \$150,000. One of the aldermen, a member of the water committee, said to a Gazette reporter that Mr. Taff ought to come forward with his proposition and let the council and water committee know about it. He came forward with his proposition last night \* and it was not considered. It went by default.

It may come up again, however, as the city can donate \$69,000 to the present owners and agents of Seven Lakes, then pay \$100,000 for the benefits of Mr. Taff's proposition and still get out for considerably less money than will be involved in improving the Seven Lakes.
