





MANUEL DELGARDO, who was one of the most noted smugglers of the Mexican frontier, was killed Friday night of last week at his ranch 20 miles below Eagle Pass, Texas. A Galveston dispatch gives particulars as follows: Sheriff Oglesbay, with Bob Dowe and Jim Oliver went to the Delgardo ranch, which has been famous for many years as a general rendezvous for the horse thieves and outlaws from both Republice. One gang of Mexican smugglers and desperadoes made it their headquarters. Arriving at the house, the officers found Delgardo asleep on the lower floor and crawled towards him. As they were just about to seize him, he awoke and fired at Dowe, grazing his head. The sheriff instantly fired and sent a bullet through Delgardo's heart. The fire aroused the gang, who drove the officers away. Reinforcements at 5 o'clock in the morning killed three Mexicans, but the rest escaped into Mexico, carrying the wounded and stolen horses with them. Delgardo had been a terror to the border and was very rich.
