LAST Saturday Governor Eaton issued a proclamation establishing a quarantine on the Colorado boundary lines against all cattle from Missouri, Illinois, Indiana, Kentucky, New York, Pennsylvania, Delaware, Maryland, New Jersey, Massachusetts, West Virginia and the District of Columbia. The proclamation absolutely forbids the importation of all cattle from those states or district unless accompanied by a certificate of health given by the State Veterinary Sanitary Board. All sheriffs, constables, and other peace officers along the boundary lines of the state are directed to keep strict watch and to be vigilant and see to it that the proclamation is obeyed and respected and arrest all persons offering the slightest violationof the same.

summit there is a roadway on which vehicles can travel around the vast erection in a spiral. The outside walls are built of granite blocks carefully tooled and bedded. A little further off is a hillock, with hundreds of caverns or chambers cut in it, from 5 to 15 feet wide and 10 to 15 feet long. They have no windows, and are entered by the roof. The walls are covered with hieroglyphics and curious pictures with the feet and hands of men. Stone utensils have also been found there. Who the builders of these ancient monuments were is still unsettled, but,
