## Greyhounds Beat Bobcats 15-14

### Greyhounds Play At Phillips Friday

The Gruver Greyhounds won a cliff-hanger at Gruver Friday night. They defeated the classy Sunray Bobcats 15-14 in a thriller.

Both of the North Plains football squads, neighbors and former district rivals were making their 1986 gridiron debuts in new conferences.

The difference in the hard fought contest came down to a single play, and extra point conversion, with 3:47 left in the football game at Greyhound stadium. Both of the Greyhound touchdowns came on outstanding plays to speedy Gruver backs.

The first was a 34 yd. scamper by Greyhound Halfback Loyd Cator putting Gruver on the scoreboard with 4:35 remaining in the first period. The conversion was good and Gruver led 7-0.

The Bobcats came back with a 86 yd. drive. With the ball at the Gruver 17 the Bobcats broke through the Greyhound defense to score a TD. The

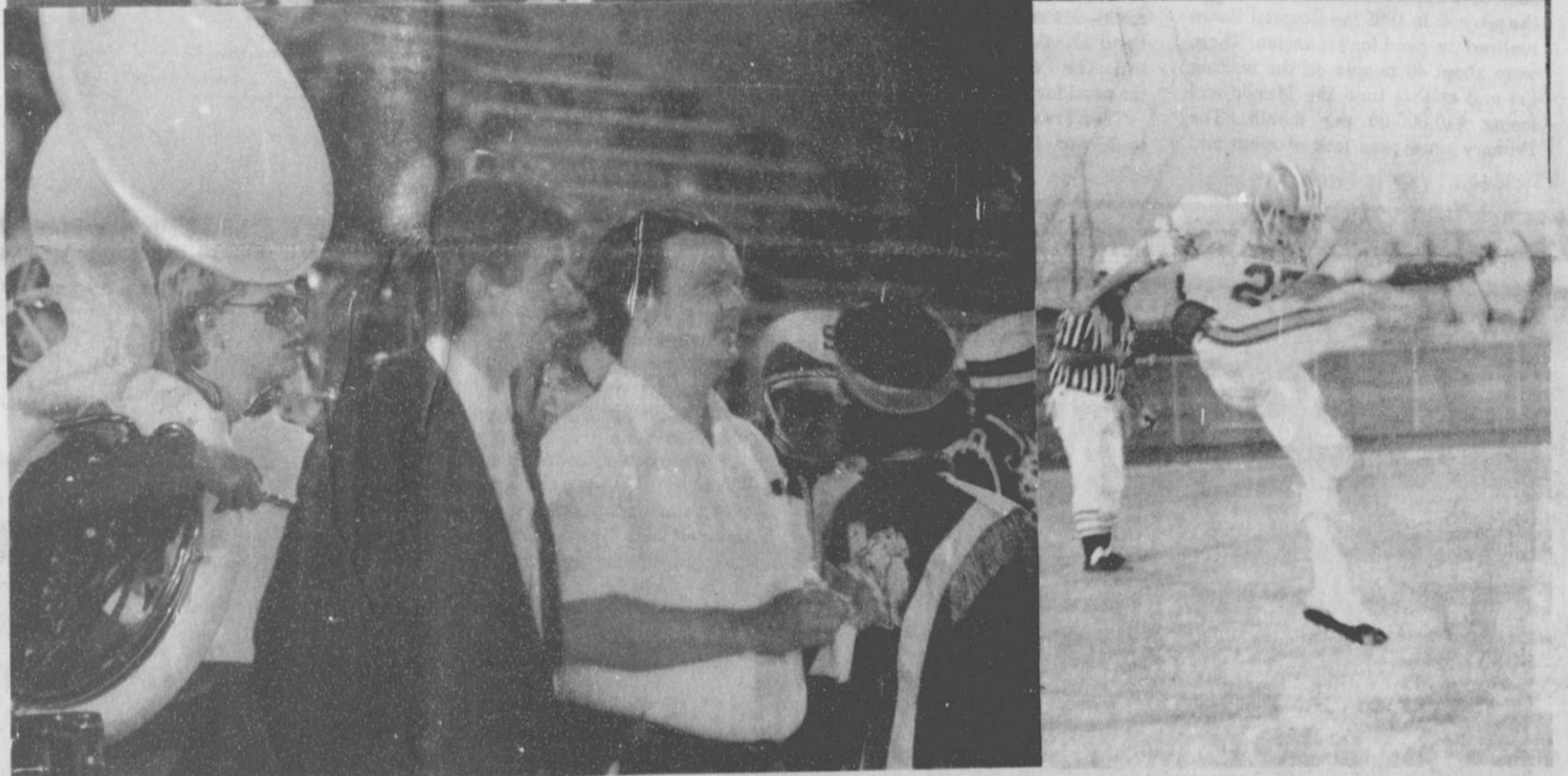
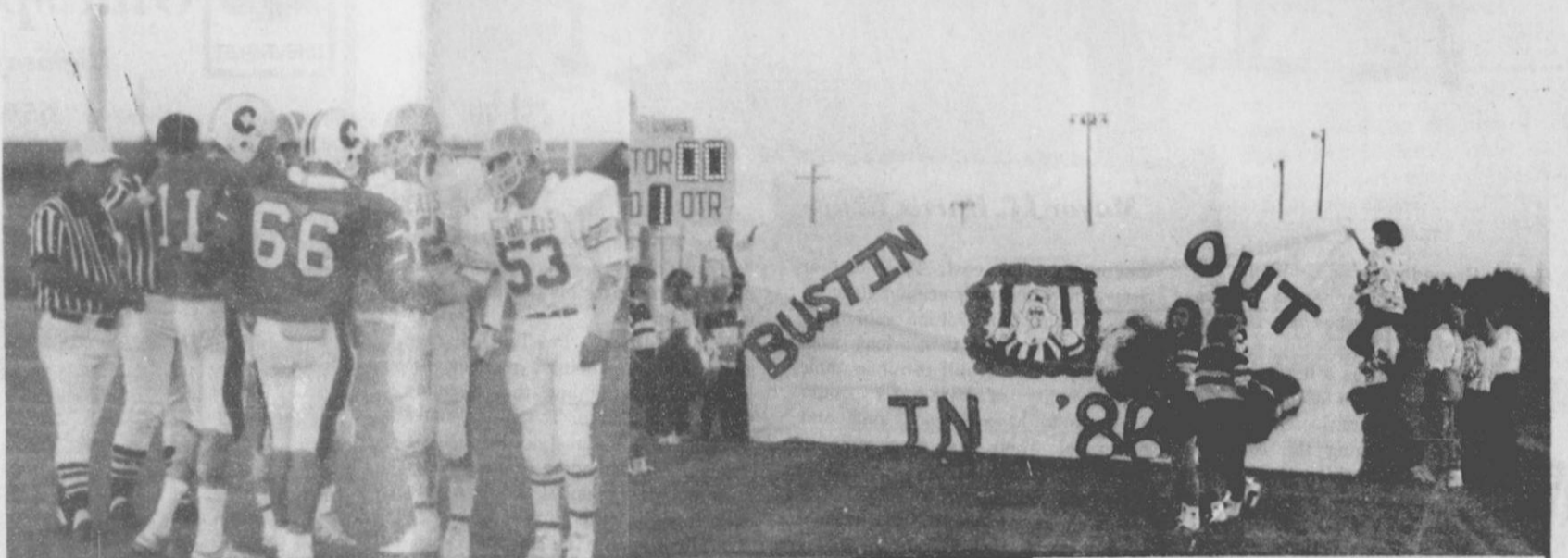
Bobcats went for two points to take the lead 8-7 with 11:55 left in the second period.

Before the record crowd at Gruver could settle down Gruver came back on a 76 yd. touchdown play, a pass to flanker Steve Duncan who raced up the side line for a six pointer. A two point conversion was good and Gruver led 15-8.

Seconds before half-time, Sunray had the chance to add more points to the scoreboard. With 2 seconds showing, the Bobcats lined up for a field goal at the Gruver 12 but Langley's attempt was wide to the left.

The Gruver Greyhounds will travel to Phillips Friday night for a very important game. Fans are urged to follow the Greyhounds.

The Gruver 7th, 8th, and J.V. Teams will play in Spearman this Thursday. A record crowd is expected to attend these games. First game will begin at 5 p.m. Thursday.

# Groundbreaking Ceremony Huge Success

The Groundbreaking ceremony for the new Hansford Manor addition was held Friday, September 5th at 2:00 p.m.

Then came the moment we had been waiting for. The Groundbreaking was held.

President Jack Oakes took the Golden Shovel and "Bit the Dirt." It was a momentous occasion.

Refreshments were served by the Ladies Auxiliary and it was delicious. Many thanks to all that attended.

Monday of this week the construction of the addition started by surveying and moving of equipment. The Company of Reid & Strickland will use the southside parking lot as the storage area for the equipment. 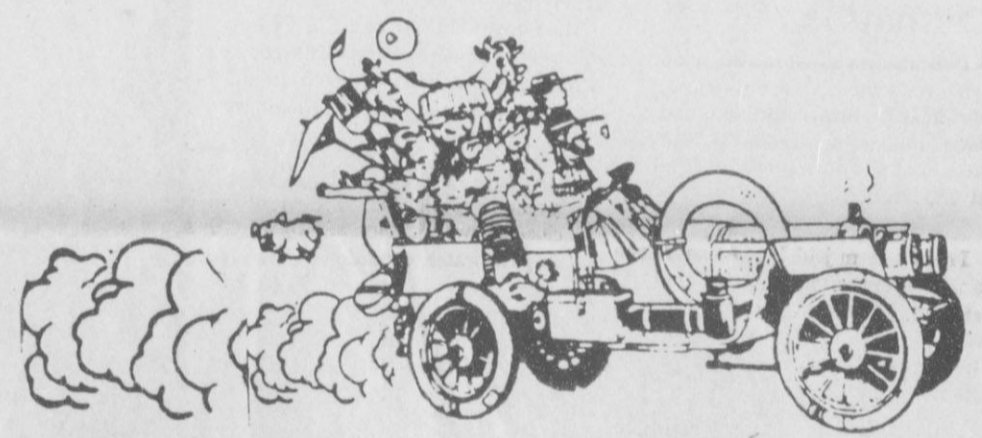

## PUBLIC NOTICE

BRIEF EXPLANATORY STATEMENTS OF PROPOSED CONSTITUTIONAL AMENDMENTS GENERAL ELECTION NOVEMBER 4, 1986

### PROPOSITION NO. 1 ON THE BALLOT

Senate Joint Resolution 15 proposes a constitutional amendment that would permit the legislature to provide by general law for the apportionment of the value of railroad rolling stock among the counties in which the property of the railroad is located for purposes of property taxation, and would delete the requirement that the Comptroller participate in making the allocation. To comply with both statutory and constitutional law, the apportionment currently is being made by the State Property Tax Board in conjunction with the Comptroller.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to allow the legislature to provide by general law for the apportionment of the value of railroad rolling stock among counties for purposes of property taxation."

### PROPOSITION NO. 2 ON THE BALLOT

Senate Joint Resolution 33 proposes a constitutional amendment that would replace the constitutional requirement that the subject of a bill be expressed in its title with a mandate that each house of the legislature adopt rules of procedure that would require the subject of each bill to be expressed in its title in a manner that gives the legislature and the public reasonable notice of that subject. Determining compliance with the rule would be the responsibility of the legislature. Cur-

rently, a law is invalidated if a court finds its caption is defective. The amendment would provide that past and future enactments may not be held void on the basis of an insufficient title.

The amendment also would eliminate the suggestion that the state's laws be revised every ten years, and instead would provide for continuing revision of state laws.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment requiring each house to include in its rules of procedure a rule that each bill contain a title expressing the bill's subject, and providing for the continuing revision of state laws."

### PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 73 proposes a constitutional amendment that would permit the legislature to authorize any county, city, town, or other political subdivision to use public funds or credit to pay insurance premiums on nonassessable life, health, or accident policies. Due to the prohibition in the constitution against the lending of credit and granting of public money, political subdivisions currently are prohibited from becoming shareholders in associations such as mutual insurance companies, in which policyholders are shareholders. A nonassessable mutual insurance policy does not allow a company to raise capital by assessing the policyholder an extra amount on a pre-

mium. This amendment will allow mutual insurance companies and stock companies to bid for life and health group policies of political subdivisions. Public liability will be limited to the payment of premiums specified in the contract.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment allowing political subdivisions the opportunity to engage in and transact business with authorized mutual insurance companies in the same manner as with other insurance companies."

### PROPOSITION NO. 4 ON THE BALLOT

Senate Joint Resolution 4 proposes a constitutional amendment that would repeal the prohibition against branch banking by state banks and would allow state banks and national banks domiciled in this state to establish and operate banking facilities at locations within the county or city where they are domiciled. The amendment would also authorize the Legislature to permit a state bank or a national bank domiciled in this state to engage in business at more than one place if it acquires a failed state bank or national bank domiciled in this state.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to provide that a bank may offer full service banking at more than one location within the city or county where its principal facility is located, subject to limitations and restrictions provided by law."

2 pkg. dry yeast  
1 tsp. sugar  
1 stick oleo  
1/2c. brown sugar  
2 eggs

2 C. all purpose flour  
1/2 C. Lukewarm water  
1 C. scalded milk  
1C. instant potato flakes  
1 tsp. salt  
2 C. whole wheat flour  
1/4 C. all purpose flour a knead in

In lukewarm water mix the yeast and 1 tsp. sugar. Let set. Put oleo, potato flakes, brown sugar, and salt in large mixing bowl. Scald milk and pour over the oleo. Cool. Add yeast and 2 eggs to mixing bowl. Beat with electric mixer until smooth. Beat in 2 C. Whole Wheat Flour. Stir in white flour. Knead for 10 minutes in 1/4 C. flour. Pour 2 tbsp. oil in mixing bowl. Roll dough over in oil. Cover with saran wrap and let rise 1 hour. Punch dough down and shape into rolls. Let rise 1 hour. Bake at 350 degrees for 15 minutes. Rub top of bread with a stick of oleo after you take the hot bread out of the oven.

**APPLE-WHEAT PINWHEEL**  
1 cup whole wheat flour LYNETTE WILLIAMS  
1/2 tsp. salt  
1 pkg. active dry yeast  
butter or margarine  
1/4 cup pecans  
3 1/2 cups all purpose flour (approximately)

1/4 cup sugar  
1/4 tsp. ground mace  
3/4 cup apple juice (unsweetened)  
2 eggs  
1/4 cup brown sugar

In large bowl combine first five ingredients and 1 cup all purpose flour. In sauce pan over low heat; heat apple juice and 1/2 cup butter until very warm 120 degrees to 130 degrees F. With mixer at low speed beat liquid into dry ingredients until blended; beat 2 more minutes. Add eggs and 1/2 cup flour to make thick batter, continue beating two minutes. With spoon stir in 1 1/2 cups flour to make soft dough. Knead on lightly floured surface, working more flour in. Shape into ball and place in greased bowl. Let rise until double in bulk. When dough is ready punch down. Cover and let rest on floured surface about 15 minutes. Grease large cookie sheet. Melt 2 tablespoons butter. Roll dough into 18"x18" square. Brush with melted butter. Sprinkle with chopped pecans and brown sugar. Roll up jelly-roll fashion. Place on cookie sheet. Shape into ring; press ends together to seal. Cut ring, in one inch intervals, up to but not through inside edge. Lift and twist each piece. Let rise until double. Bake at 375 degrees F. 20 to 25 minutes. Cool and frost with decorative glaze.

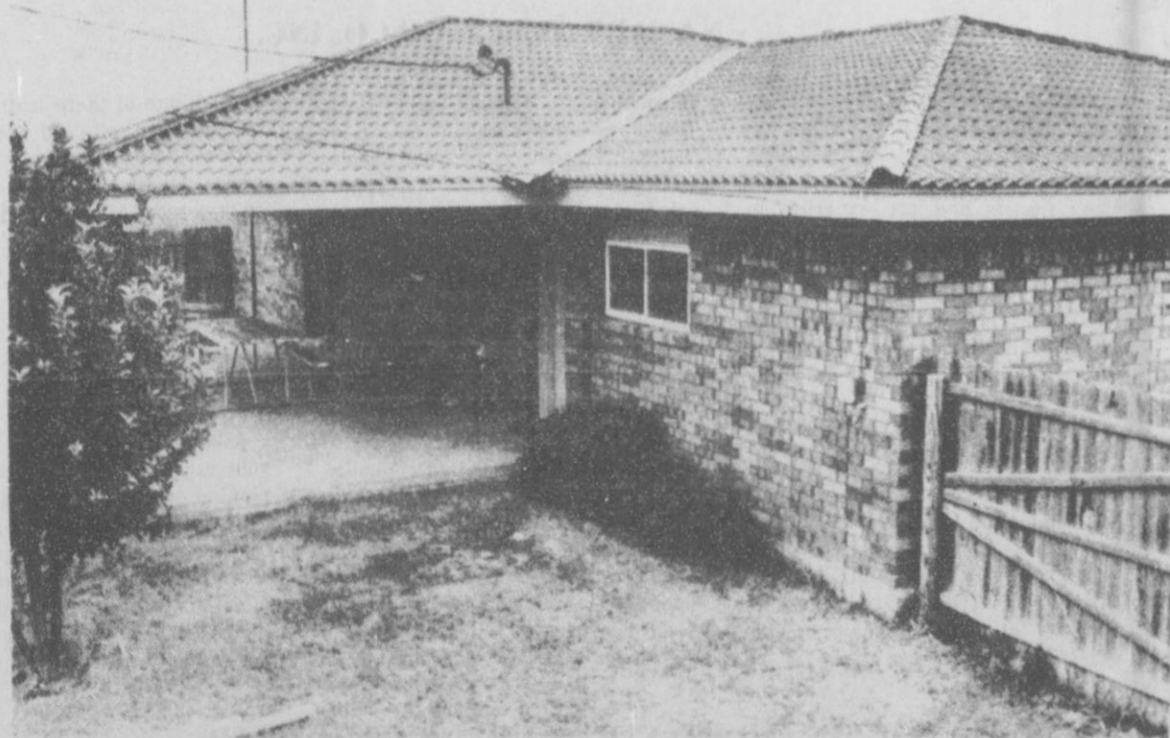
