Information for Settlers Who Wish to File on Desert Lands.

The legal phraseology which the desert land laws are expressed in, bother many people who would learn of the requirements of the law proving up on such lands. The Almagordo News, in its edition of last week contained the best thing we have seen on this subject and we take the liberty of publishing the article.

Residence upon a desert claim is not required. The sum of \$1 per acremust be expended each year in work done upon the land itself, and even though a sum much greater than \$1 an acre has been expended during the first year, other work must be done for the two following years equal to \$1 for each acre. As proof is required at the end of each year for three years, of work done and money expended, it is ruled that expenditures in excess of \$1 an acre made in any one year can not be applied to the following year or

Buildings of no character whatever can be included, in the state-ments of work done, but the purchase or actual acquirement of a water right will be accepted as an expenditure on the land

The government regulations covering these points are as follows:

The law requires an expenditure of not less than \$3 per acre, for the entire area entered, in the necessary irrigation, reclamation and cultivation of the land, by is of main canals and branch ditches, and in the permanent improvements upon the land.

During the first year after entry the claimant must file with the register proof consisting of his own affidavit and the seperate affidavits of two witnesses, that the full sum of one dollar per acre for the entire area has been so expended, and like proof must be made for each year thereafter until the full sum of three dollars per acre has been expended; and at acre has been expended; and at be end of the third year the text the land for the purpose of claimant must file a map or plan reclamation, the length, kind, and




