## Price and Brunson Returned To Board

Bruce Price received 44 votes, D. E. Brunson received 47, Bert Grundy had 11 write in votes and Wayne White received 1 write-in vote at the School Trustee election which was held last Saturday. The names of Price and Brunson were the only ones appearing on the ballot.

The Board of Trustees met in regular session Monday night and reorganized the Board.

D. E. Brunson was elected President, Cecil Reagan is the new Vice-President, and Bill Griffin, Secretary.

First business on the docket was the election of teachers for next school year. All the teachers were re-elected in the elementary grades: Mrs. Gladys Tipton, Mrs. Dora Hawkins, Mrs. Jim Baird, Mrs. Novelle Wise, Mrs. M. C. Jones, Wilburn Leeper and Jarrell Rice, who will again be Junior High Coach.

High school teachers re-hired were Elmer Berryhill, Mrs. Jake Merrell, and Mrs. Frances Wise. Mrs. Elmer Berryhill submitted her resignation as Home Ec teacher several weeks ago.

High School Coach Gene King was re-elected at the last Board meeting.

Grade School Principal Glen Sanders and High School Principal George R. Colvin's contracts were extended 1 year through the 1965-66 school year. Roy Smith was re-elected Custodian.

Supt. Johnny Mason said that one more high school teacher would be hired, position yet to be decided.

Lunch room personnel and bus drivers will be hired at the May meeting of the board.

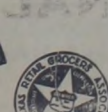
