Rather they see in his act a re-turn to Jeffersonian simplicity in high places. Jefferson, history relates, rode horseback to his inaugural. Garner's act will meet with appoval by the patriotic American citizen who sees a rebuke of the tendency to imperialistic customs now gaining such headway in officialdom. Less pomp and more simplicity, less red tape and more work by our rep resentatives, appeals to the average citizen. It is the American spirit. Let's have it, not only in the speaker of congress renouncing the speaker's car, but in all departments of the government.

#### **BAS THE CAPITALISTIC SYSTEM FAILED?**

Has the capitalistic system failed the country? Ask the jobless man and he will tell you that it has. Propound the same question to the man whe thinks - be he prefessional or busi. ness man-and he will give you the same answer. Ask the average business man and-but he is usually so engrossed in his private business he hasn't given the matter much thought from that angle to tell what makes the nation sick, but, he knows something is radically wrong. But, prepound the same querry to the multi-millionare, the captains or rather generals, admirals and pyratical commanders of finance, he will tell you the system is perfect. And each class has a good and sufficient reason for his opinion.

The jebless knows it is wrong because he is able-bodied. capable and efficient, and wants work but is denied an opportunity to "life liberty and the pursuit of happiness" by this self-same system, a system that deprives him of the means to support himself and family. The thinker knows the capitalistic system has been weighed in the balance and found a failure, becase he has arrived at this conclusion by study and observation without being biased by selfish reasons, other than that of loyality to his country and the welfare of his fellow-man. He sees business and industry prostrate for want of nourishment that can only revive the world by the injection of the life-blood of employment that the wheels of commerce may again revolve by the expenditure of the working man. The average business man, as stated abeve, has been caught between the millstones of depression. and is rained before he has time to analyze. But the manipulators or bond gamblers - those conscienseless individuals who care for self only-see in the system a great scheme to add to his billions, and place him master of a nation of serfs worse than the peonage of Mexico during its most benighted era-And the end is not yet. True, the commanders of finance may sense the danger of communism and perchance, may call a halt in the well laid plans of acquiring the earth and the fullness therof and declare a truce, for a brief period, that a firmer holt may be had on the resources and credulity of the nation. This is indicated by the general feeling that a revival in business may be expected during 1932. But this is just a part of their plans. To this end the world is being broadcast with propaganda to lull the people back to a sense of security while the capitalistic plans are being further propogated. But the longer the day of reckening is postponed the more disastrous the finality.

Already steps have been taken to repeal crtain laws that would check this bandit band that would despoil the entire nation, and unless the people are vigilant they will be removed ere the average man is aware of his betrayal by those whom he elects as his representatives in the congress and legislatures of the states. To accomplish this the representatives are subtlely approached and paid retainers by those concerns who would despoil the people., No, not bribery, for those giving out these retainers are too smooth to attempt to bribe your representatives, but they flatter him by telling him he is a great lawyer, and they wish to be sure of his services in case litigation should arise, and the poor sucker takes the bait, hook, line and sinker. Then he is done for -and so are his constituents.

So be vigilant. Before you cast your vote for any man as your representative in congress or the state legislature, ask him if he has ever accepted a retainer fee from a public service corporation, and if he answers in the negative exact a pledge from him that he will not do so while holding his commission as your representative. This is a serious situation, for we are admonished in holy writ that "where your treasure is there will be your heart also."

With this picture before you can you wonder that so many people today are advocating communism, and even anarchy?





Other activites of the club members included cultivation of potatoes from certified seed by fifteen members, conducting an experiment station, growing grain sorghum seed, and the cooperative buying of 5,000 pounds of other planting seed.

A splendid experience was related at the last meeting by W. J. Poe, who told of growing a fall crop of potatoes, and how he cared for his crop after harvesting. Mr. Poe said:

When we harvested the potatoes last summer only a few rows were dug at a time to prevent damage from hot sun. In gathering the crop I only saved the larger potatoes, throwing the culls back in the furrow, which were later covered with a plow. The best potatoes were housed under shelter and covered with dry sand. This kept them fresh all the year.

But the culls which were thrown back in 'the furrow, made a good yield this fall, making two crops from the same seed, and on the same ground."
