DEMONSTRATION PROVES SUBSOILING INCREASES CROP YIELD IN COUNTY

That crop yields may be increased by subsoiling was successfully demonstrated in Eastland county last year by both 4-H club boys and farmers who co-operated with the county agent. Sweet potatoes on subsoiled land made 400 bushels per acre, as against slightly less than 100 bushels on the acre alongside which was not subsoiled, but handled exactly the same otherwise. This increase was exceptional, and is not to be expected generally. A 35 to 50 percent increase should justify all trouble and expense of subsoiling. The fact that some of the crops in these demonstrations last year were drowned out by too much moisture proves deep plowing holds the soil water longer and will be of advantage in years of normal rainfall. The 1932 rainfall in Eastland county was 44 inches, as compared to a normal average of 27 inches.

METHOD OF SUBSOILING

In the absence of proper subsoiling tools, the method used in the 1932 demonstrations, was to bed the land, then run a bull tongue as deep as possible in the furrow, then at once bed back on this. At planting time this furrow was opened and the seed planted just above where the deep plowing was done.

The principle involved is that during our usual summer dry spell the plant roots follow this loose soil on down in search of soil water, laden with plant food, and do not turn up to the surface at every little shower, later to dry up when the sprinkle has dried out.

PLANT FOOD GOES TO THE CLAY

Also, it appears, that in our light sandy soils, the plant food goes down with the moisture to the clay and is there deposited, or filtered out, and when the roots are directed into this soil, which has been loosened, they are enabled to make use of this source of plant food. This is a theory that seems to be based on facts. Persons interested in acquainting themselves with the possibilities of real subsoiling equipment are urged to see in action the big tillage tool on the Bob Weddington ranch, north of Cisco.

No farmer has done his best to increase his crop returns until he has made some effort at subsoiling, and has checked his results with a plot alongside, handled in the same, except for the subsoiling. J. C. PATTERSON, County Agent.

Humble Official Told of Humbletown Water and Sewer Agreement

"I want to verify the story published in the Cisco Citizen of March 31 regarding the agreement of the Humble Company to make a bill of sale to the water and sewer system at Humbletown," said Bill Dill recently. "The matter had passed from my memory, for the time being, till I read the story in the Citizen. While a member of the board of equalization, myself and Roy Wilson, looked into this matter. We found the Humble Company was only assessed on a few hundred thousand dollars worth of property—\$400,000, is my recollection—when it was a matter of general knowledge that the valuation was much over \$2,000,000. Not being able to get all the facts, and to ascertain why only a fraction of their property valuation was rendered for valuation, and not being able to get this information from the officials at Humbletown, Wilson and myself had them to have their tax man to come to Cisco from Houston. I think it was Jack Dies, as I understand he was acting in that capacity at the time, who came before the board, and told us we were correct. That the Humble property valuation in Cisco was then in excess of four million dollars, but there was a written agreement between the Humble Company and the city of Cisco, that the city should collect on a valuation of only \$400,000 for ten years, and at the expiration of that time the company would give the city a bill of sale for its water and sewer system in exchange for a receipt in full to the excess taxes."

"As I remember we were on the equalization board for the year of 1926, or possibly 1925. I believe Dies, if he was the man, will verify this statement and that the company contracted just as the Citizen stated."


NEPHEW VISITS MAX ELSER WHILE PASSING THRU CISCO

CHASTAIN OPPOSED TO NEW OIL COMMISSION

Representative Chastain has announced that he will "oppose the new oil and gas commission if every voter in his district asks him to vote for it, as many signing petitions and telegrams don't know the difference between a barrel of oil and a barrel of molasses." Rather strong statement for a representative to make of his constituents in an oil county, don't you think, Oscar? Also, Chastain has announced that he will not vote for legal beer until the people have voted on the measure. Had congress taken that attitude the modification of the volstead law would never have been made. A citizen of Cisco stated the other day that he had in his possession a pre-election signed statement, bearing the name of Oscar Chastain, which

states the "signer will represent his constituents regardless of his personal convictions."

Chastain's attitude is at variance with that of Lotief, flatorial representative, who states that it is his purpose and desire to ascertain what the people of his district want, and to represent them and them only—as Bobby Burkett says.

The editor of the Citizen favored the creation of this new commission to handle the oil and gas situation, as we believed there was too much at stake to let this industry remain under the direction of the railroad commission, which was already overloaded. But we are not so sure now that it is the proper thing, since the Lone Star and the Community Natural hijackers have announced in favor of the new commission. It is a pretty safe plan to oppose anything those birds favor. They cannot be classed as friends of the people, therefore it behooves all to think before they vote on this measure.

But our legislators are elected, not to represent themselves, but the people who placed them in office.

In our opinion the gas and oil industry will fare better under a separate commission than to remain under the direction of the railroad commission, which has made a mess of the whole matter so far.

The bill has passed the first reading in the lower house, and was brought up for second reading and final passage Monday, when the final vote was postponed. Just when its fate will be decided is not known, as the graduated oil tax seems to be favored by the legislators, and may supersede the commission proposal.

APEX FOR GOOD PRINTING

CHURCH OF ENGLAND DISCUSSES SUNDAY MOVIES

The Lower House of the Convocation of Canterbury, in its consideration of Sunday movies in London recently, went on record as opposing this phase of Sabbath entertainment when it turned down on the proposal for a general opening of picture shows in England on Sunday.

Sunday movies have been much discussed and a vexed problem in Texas in recent years which resulted in the passage of the local option law on Sunday shows. While all seem to acquiesce in permitting Sunday shows, yet a few voice their opposition to this form of Sunday entertainment, even in Cisco, but no concerted move to invoke the provisions of the local option law for their closing is apparent. Any voiced opposition so far has been limited to the statement that "Sunday should be reserved to the churches for religious purposes."

However, under the Texas law the people of any community may call an election to determine whether theaters may not operate on the Sabbath. Should a majority of the people vote in favor of closing it will be a violation of the law to operate show houses on Sunday.

One of the slogans of the Convocation during the consideration of Sunday shows in England being "Hollywood shall not pass—on Sunday, at least." Another church dignitary stated, "better a Sunday parade than a Sunday cinema"

The Church of England might settle it on the Texas local option plan, and should the people of and British community want theaters closed on Sunday a majority vote will do the trick.



SIMPLE METHOD FOR CURING PORK DURING ANY SEASON OF YEAR

Auburn, Ala.-- It is no longer necessary to wait for a cold crisp morning to kill hogs. Any day may be hog-killing day now, due to a method developed for the use of ice in curing pork by the Experiment Station of the Alabama Polytechnic Institute. This method was worked out by J. C. Grimes, W. E. Sewell, and G. J. Cottier and is explained as follows:

"Obtain a molasses barrel or some similar container. Wash the barrel until it is clean and odorless and scald with boiling water. Dress the hog as soon as possible after it is slaughtered and divide the carcass into the different cuts. Rub each cut well with salt, especially around the ends of the bones, and place the meat in the barrel, skin side down. Apply chipped ice at the rate of 200 pounds of ice. When the ice melts a brine will be formed in sufficient quantity to cover the meat.

"Make a curing mixture of 40 pounds of salt, 10 pounds of sugar, and 9 ounces of saltpeter for each 100 pounds of meat to be cured.

"At the end of 24 hours take the meat out, rub each piece thoroughly with the curing mixture, and place back in the iced brine. Pour into the barrel any of the curing mixture which remains after the meat is treated. Weight the meat down with clean bricks or stones. Cover the barrel with clean boards and place in the coolest room available.

"Leave the meat in the brine for 25 days. If the live weight of the hog is more than 200 pounds leave in the brine for 30 to 35 days. A scum of mold will probably form on top of the brine but this will not necessarily injure the meat. At the end of the curing period take the meat out of the barrel and wash thoroughly in warm water."

**BROTHER OF R. L. AND
 W. J. POE WAS BURIED
 AT FONG BRANCH FRI.**

Nathan Isaac Poe, brother of R. Lee, W. J., of Cisco, and Capt. C. B. Poe, of Carbon who died in Eastland on Thursday, April 7, was buried at Long Branch last Friday, beside the grave of his wife, who passed away about 15 years ago. These brothers, natives of Arkansas, came to Eastland county together several years ago, and his passing is the first break in this fraternity quartet of splendid men.

The Eastland Telegram Sunday carried the following account of the last rites to this esteemed citizen:

Funeral services for the late Isaac Nathan Poe, aged 81 years and 5 months, were conducted at the First Baptist church in Eastland Friday afternoon at 1:30 o'clock, by Rev. H. A. Summers, pastor of the Baptist church of Abilene, assisted by Rev. O. B. Darby, pastor of the Eastland church.

A beautiful tribute was paid the decedent by Judge J. E. Hickman, and the 9:49 Bible class quartet, assisted by Mr. Trimble of Carbon, sang "In the Sweet Bye and Bye," and "We Shall Meet Beyond the River."

The choir of the Baptist church sang "Asleep in Jesus," as the cortege left the church, led in prayer by Rev. Summers.

Interment was in the Long Branch cemetery, with final services conducted by Rev. Darby.

**FISHING PERMITS WILL
 COST \$1.50 PER ANNUM**

The city commission has placed fishing permits for 1933 at \$1.50 per year, or 25 cents per day, where daily permits are only desired.

An ordinance was passed Tuesday night by the city commission closing the lease contract of 23 acres of land at Lake Bernie to Bob Key. He will erect cattle guards, and take care of all expense, and will pay the city \$10 per year for this land to be used for grazing purposes.

**COMMISSION DENIES PLEA
 READJUSTMENT GIN TAXES**

The city commission took no action Tuesday night on the application of the Bankhead Feed Mill to lower the taxes on the gin property here. Some time ago a rumor was afloat that the Bankhead Feed Mill contemplated moving away. Feeling that this was an enterprise that Cisco could ill afford to lose, President R. L. Poe, of the chamber of commerce, made a plea to the commission at that time to do all things in its power to prevent the gin from being moved. This is the only move that has been made to keep the gin here, as the application for reduction in taxes was interpreted as a bid to let the gin remain.

Perhaps there is not another enterprise of more importance to the farmers in the Cisco country than this gin, and should it be moved away, it will mean a heavy financial loss to the business folk of Cisco.

The application of Mr. Perkins, of the Blue Bird barbecue stand, for free water for parking at his place, was not acted upon.

The roll call resulted in Clements, Henderson, Burnett and Elliott voting in favor, and Winston in the negative. Before the voting Elliott said he thought it was probably all right to pay the account, but disliked the idea of people doing something without authority of the commission, and then sending in the bill.
