STERLING IMPEACHMENT PLANNED Decision in Cisco Football Case to Be Given Monday

ARGUMENTS ARE HEARD SATURDAY

Whether or not Cisco Loboes will be restored to the Interscholastic League is a question that is expected to be answered in 91st district court at Eastland Monday morning at 10 o'clock. That is the hour set by Judge Geo. L. Davenport for handing down his decision in the case after arguments by attorneys that consumed the entire day Saturday.

The case which originally went to trial before a jury on September 7, came early last week to a point where Judge Davenport was petitioned by each side to render a judgment. Both plaintiff and de-fendants filed motions for judgment by the court soon after a jury reported itself hopelessly dead-locked and was discharged Tuesday afternoon

Judge Davenport set 9 o'clock Saturday morning as the hour for arguments to be presented. Attorneys argued throughout the day concluding shortly after 4 o'clock in the afternoon.

Judge Davenport then announced he was undecided as to what judg-ment he should render and announced that he would take until Monday morning at 10 o'clock ' to make up his mind and hand down a

BOND RELIEF BILL SIGNED

AUSTIN, Sept. 17. - Gov. R. S. Sterling today signed the road bond bill, enabling the state to assume payment of county and district road bonds. The act became effective on signature.

The governor sent a message to both houses congratulating them on their "splendid work," and stating he "assumed" the legislature would complete its work today.

AMOUNT OF RELIEF TO BE DETERMINED.

Eastland county officials Saturday were unable to say definitely what part of the county's road bond debt would be lifted from the shoulders of the tax-payers by the action of the legislature in diverting part of the gasoline tax to reimburse the counties for current funds applied to payment of the bonds expended on state roads.
