Callahan County Clarendon

April 17, 1880

Quite a number of "cow-hunting outfits" have started out on their spring campaign of cow hunting. We regret that they have started the ball rolling quite so early as they have, for a great many cattle are very thin and weak and can but poorly stand being driven about, while in two or three weeks hence they would be in tolerable good flesh and could stand the drive comparatively well; still we do not censure those who are interested, for they are all anxious to find out how their cattle have stood the long severe winter. We trust that the loss will not prove as large as has generally been predicted.

Mr. Riggs and wife, whom we mentioned last week in connection with the polecat bite, came into town about a week ago and are occupying the pickett house owned by J.C. McCombs. They were both taken sick, and are both lying very low, especially Mr. Riggs, who has the pneumonia and it is thought cannot recover. They came here almost strangers and with little or no means. Drs. Thayer and Largen are kindly attending them and doing all that professional skill can do to alleviate their suffering. We cannot refrain from saying a word in this connection for our kind-hearted citizens. We called in to see the sufferers and found quite a number there, all doing something to ease the suffering of the patients. We have never lived in a community where the people were more ready to assist the needy, sick or unfortunate, than our generous, openhearted citizens. Upon making inquiries as to their having attention we were told that Clabe Merchant had secured the services of two competent nurses who will stay with them. The Clarendon is justly proud in heralding and lauding such true Christian like acts as these and Belle Plain has cause to boast of her citizens who are generous to a fault and have hearts as big as an ox.
