## **Clyde to become Bargin Captial**



**Baird ISD** considers renovations at school



The Baird Independent School District has, in the past few months, considered some renovations to the school's facility. With these considerations must come a decision on how to pay for the work, whether it be new construction or improvements to existing structures. A bond election seems to be at the head of the list for acquiring funding for these projects which brings the question of how much will this cost taxpayers.

Baird ISD's Elementary classrooms are in need of dramatic changes. The buildings, which were built in 1951, are too small to meet state standards, have classroom doors that open to the outside. have no closed hallways to protect children from weather, are poorly insulated, and are in need of roof repairs. Some grades have class in portable "temporary" buildings that have been in place since 1971. The projected costs of renovating the present buildings is near \$1,000,000. If new construction is chosen. Eighteen classrooms have been the number



#### Polo On The Prairie Saturday **Preparations Nearly Complete** For M.D. Anderson Fund Raiser

Final preparations are under way for Polo on the Prairie, which will liven up the Musselman Brothers Lazy 3 Ranch on April 19 in a fund raiser for The University of Texas M.D. Anderson Cancer Center.

Volunteers are completing the list of attendees and placing the final catering order, but much activity is also in the works setting up the ranch to accommodate some 1,200 guests who attend each year.

"We're keeping busy getting the last of it all together," admits Eastland's Mary Anne McCloud, who is chairing the event with her son-inlaw and daughter, Henry and Melinda Musselman, who reside with their three children in Midland. "But this is always such an exciting time of year."

Not your average fundraising affair, volunteers are in the midst of conquering a few unique challenges. They're preparing the ranch land itself, routing electricity and water out to the actual event site, shaping up three miles of ranch roads for unusually heavy car travel, patching up the year's cattle-grazing damage to the polo field, and building temporary paddocks to house each player's team of horses.

"We're also bringing in abut seven tons of hay and oats to feed the 100 or so polo horses that the players will be bringing with them," Henry Musselman says.

Hay won't be the only menu item on the ranch in large quantity. Joe Allen's of Abilene, which has catered the shindig

## AN AMERICAN HERO

#### **ROBERTO CLEMENTE**

Roberto Clemente will be remembered as one of America's all-time great baseball players - as well as a man who gave his life to help other people.

Clemente was born in Puerto Rico, the son of a sugar cane plantation foreman father and a grocery store manager mother. His childhood was happy and relatively prosperous. He would have become an engineer, but for his exceptional athletic abilities.

Clemente played amateur softball in the fields of his native Carolina, Puerto Rico, and was eventually spotted by a scout for a pro team. He played in Puerto Rico three years and after the 1953 season, was recruited by the Brooklyn Dodgers.

He played in the U.S. for the minor leagues in Montreal, but his talent could not be hidden. He was discovered and drafted by the Pittsburgh Pirates after the 1954 season.

He was one of the pioneer Hispanics in major league baseball. His difficulty speaking English often caused him problems in explaining himself to the press, and in the early years, cost him the recognition he deserved.

But once again, his talent could not be hidden. He became known as the greatest right fielder in the history of the game, and held the all-time record for assists from the outfield. He was selected to the National League All-Star team 12 times.

Clemente was a sports hero because of his fantastic talent. But he became an American hero because of his self sacrifice for others. Clemente's dream was to build a sports complex in Puerto Rico, so poor children could learn and grow. That work was in progress when a great earthquake struck Nicaragua. Clemente helped organize relief efforts in Puerto Rico, and was helping deliver a planeload on the fateful last day of 1972. The rickety airplane's engines failed shortly after take-off, and the plane crashed, killing all aboard.

He was immediately inducted into the baseball Hall of Fame. The Governor of Puerto Rico said Clemente died "serving his fellow man."

Q. My cat has always been very fastidious about her grooming. Her coat fairly shone and she felt like silk when I would pet her. A. The cause of Daisy's problems could be any number of things. However, first you must get her checked by your veterinarian. Perhaps her lack of interest in grooming is due to some illness. Do this right away.

Barring that, is Daisy overweight? A cat who is heavy isn't agile enough to groom herself and the result is what you described in terms of her coat.
