On The Corner

Take a 'Peak' at What's New

The masthead of the Cross Plains Review has received a facelift. Different type and format, accompanied by art work, gives the Review a new look. Don Tabor, publisher, originated the idea of using East and West Caddo Peaks for the art design. Lee Morris, layout artist for the newspaper, arranged the display. I suggested the art work and took the photographs.

East and West Caddo Peaks were chosen for the art subject because they are major landmarks in Callahan County. There is very little recorded history about the Peaks, but local stories abound.

A post office was established on May 13, 1878 at Caddo Peak. William H. Crawford was the postmaster. The post office was discontinued December 21, 1881. It was later re-established November 29, 1882, and closed again on March 30, 1907.

C. J. Oglesby, grandfather of Joe Oglesby, ran the post office at one time. He also had a general store and a cotton gin at Caddo Peak sometime around 1877. The store was located where Buster Winslett's home now stands. Mr. Oglesby closed the store in 1904. Mr. and Mrs. Joe Oglesby are proud to have some of the items which were originally used in the general store, including the medicine cabinet.

There was a log cabin schoolhouse at Caddo Peak, which many local residents attended. Some of the teachers were Miss Missouri Strahan, Raymond Steele, and Bart Coppinger. Mrs. A. L. Breeding told a story about her husband, A. L., riding home from school on the running board of Miss Missouri Strahan's Model T. She would slow down when they got to their homes and the children would jump off while she proceeded on her way.

One family who settled at Caddo Peak around 1881 was Clark William Gillitt and his wife, Hannah, and children. They began their journey to Texas in a covered wagon from Blue Earth, Minnesota. Some ancestors of this family are buried at the Caddo Peak Cemetery, north of East Caddo Peak. Clark Odell of Cross Plains is the grandson of the Late Mr. and Mrs. Gillitt.

The only building of original structure in the Caddo Peak locality is the two story home now owned by Martha Moore Horton of Springlake. It has been added to over the years, but the original house was built by Clara Nell Spencer's great uncle, W. R. McDermott, around 1875, before there was a Callahan County. Her

grandparents, Mr. and Mrs. Charlie McDermott, were married in this house.

Clara Nell said she was always told the story about Indians trying to get the horses out of the lots near this house. Caddo Peak was rough country back then.

Mark Adair, retired businessman, owns the property where East Caddo Peak is located. He said that a man from Cottonwood once told him that the last Indian fight which occurred in these parts took place on the north side of East Caddo Peak.

It is also told that the Younger Brothers, notorious outlaws, were known to protect the white people from Indians as they passed by Caddo Peak in covered wagons on their way to Fort Griffin. The pioneers had to pay for their services.

Adair says he recalls old timers talking about people picnicking and sight-seeing at the Peak on Sundays in the 1920's. They use to have motorcycle races to see who could get to the top of the Peak first. Mr. Adair said, "Of course, this was before we had televisions and people visited."

Another unusual fact concerning East Caddo Peak, is that this landmark was used by Robert Howard, noted author of "Conan", as the location for this imaginary fighting characters' battles. Some of the Howard fans, who were in town recently, drove out to view the actual place Howard described.

West Caddo Peak is located on the Caddo Peak Ranch owned by Dr. Edwin Middleton of Abilene.

Jake Childers, a farmer who lives just south of the Peak, shared some stories his grandfather told him when he was a boy. The Indians supposedly used the Peak for a look-out. His grandfather said that you would stand atop the Peak and see for many miles, for there was no brush or mesquites like we have now, only groups of live oaks.

Jake remembered climbing up the Peak when he was a boy and finding arrowheads near the rounded rock which has a cave underneath. When questioned about the "Caddo Critter", he laughed and said, "That was just a tale that someone started."

While shooting the pictures of the Peaks we didn't encounter the "Crittter", but did meet up with a 2½ foot copperhead. That will get your attention!

The lush green scenery unfolded as we drove through a shaded tunnel made by the trees touching on each side. You could visualize the Indians, on horseback, standing on top of the Peak as you pass by. Facts or folklore, it makes an interesting tale.

Crackdown Due On Delinquent School Taxes

Lee Thompson, Superintendent of Cross Plains High School, met with the Callahan County Commissioners Court to discuss using the same collection agency and mailing the

notices for property taxes and school taxes in a one-step procedure. This would prove financially more economical for the County.

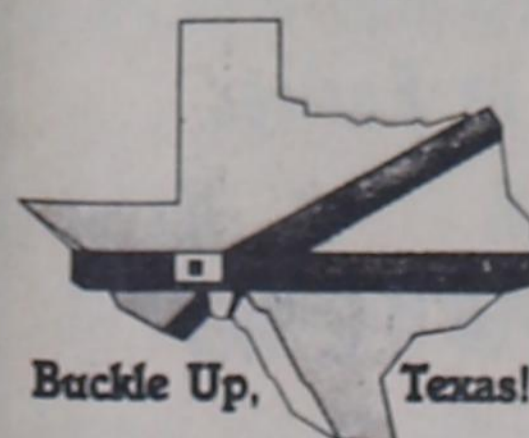
Sales Tax Totals Given

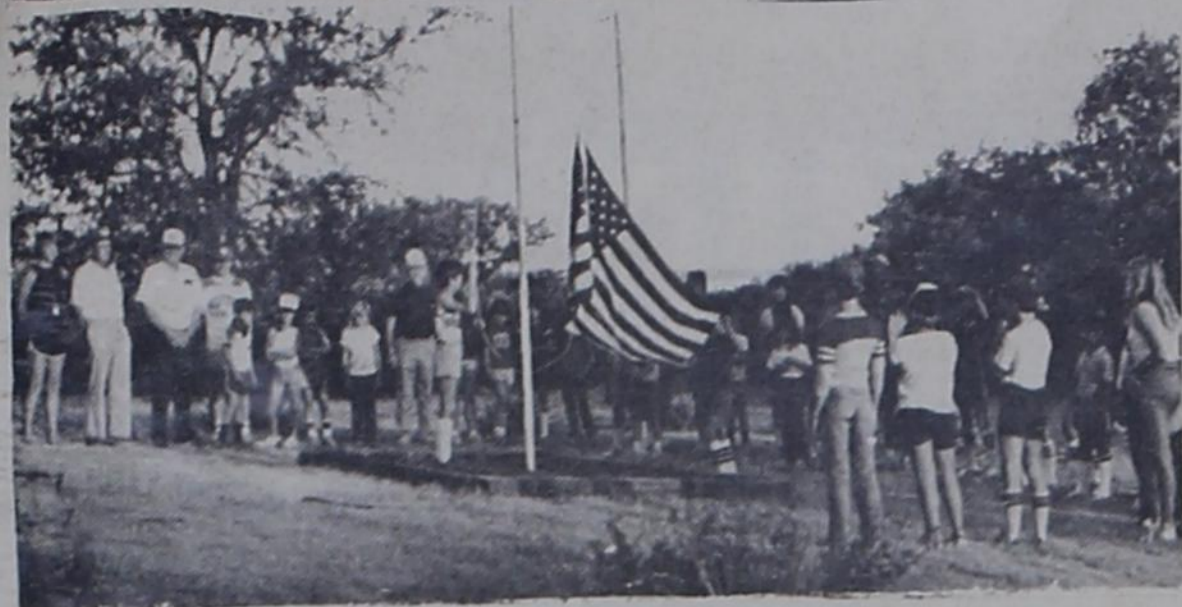
The latest sales tax figures released by Bob Bullock, Comptroller of Public Accounts, show Cross Plains 1986 payments to date were \$32,149.55 compared to \$32,800.52 1985 payments to date. This is a 1.98 percent decrease.

Baird had \$17,830.07 payments in 1986 to date compared to \$16,695.62 1985 payments which is an increase of

6.79 percent. Clyde was reported having \$46,510.24 1986 payments to date and \$46,178.91 1985 payments resulting in a .72 percent increase.

Putnam had \$6,354.54 1986 payments to date compared to \$7,799.30 payments in 1985 resulting in a 18.52 percent decrease.

Guidelines Released To Simplify Accounting For New IHC Act

AUSTIN, Tex. — State Comptroller Bob Bullock Tuesday released guidelines to county governments in Texas to simplify accounting for the state's new Indigent Health Care (IHC) Act. "It is our responsibility to provide a system that will make the paperwork easier for the Texas counties while they give health care to the areas that need it most," Bullock said. The IHC law, passed in 1985, requires county governments to provide medical assistance to the county's residents who cannot support themselves. The IHC act will affect 70,000 Texans who do not qualify for other federal or state health care programs. Texas counties are likely to spend as much as \$20 million in the 1986-87 biennium on medical services as a result of the IHC act, Bullock estimates. The Indigent Health Care Accounting Systems Manual is a step-by-step approach to deal with these funds.

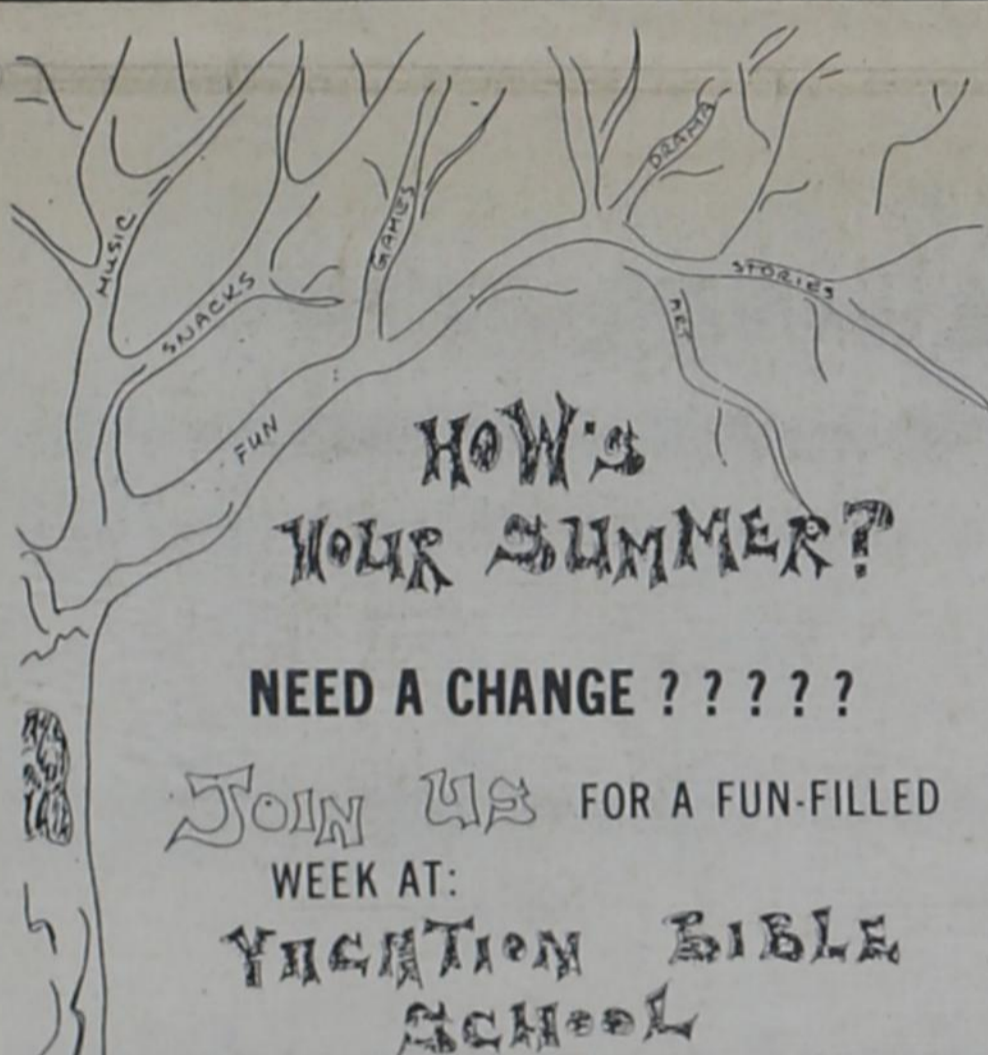

What Should & Should Not Be In Your Safety Deposit Box

What you keep in your safety deposit box is your business. Here are some suggestions that might be helpful, if you are uncertain.

WHAT SHOULD BE KEPT IN A SAFETY DEPOSIT BOX

all documents that would be difficult or impossible to replace such as a birth certificate, car titles, service records, insurance policies, passports, marriage certificates, family records, contracts, leases, deeds, trust documents, stocks, bonds, rare coins, stamps, jewelry, and family treasures. Your will should be kept in your box and a copy in your home, office, or with your attorney.

These suggestions are to be used as a guide. You can keep anything within reason in your box, provided it will fit. Keys should be kept in a safe place. If they are lost, the box must be drilled open by a locksmith, in the presence of the owner.

WHAT SHOULD NOT BE IN A SAFETY DEPOSIT BOX.....

Many boxes are sealed upon the death of the owner, documents which will be needed immediately, such as deed to cemetery lot, instructions of funeral arrangements should not be kept there. Leave out jewelry, bonds made out to bearer, heirlooms and other property which do not belong to the renter of the box.

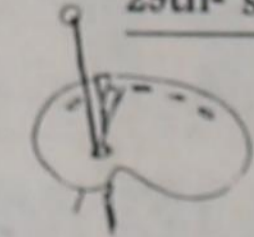

Somebody has stolen the flag of the United States right off the Mason County courthouse lawn.

If that somebody is apprehended any time in the near future he (or she) may wind up being attached to the same pole.

Toes first.

Glenn Marshall was so incensed by what he saw as "un-American" behavior he wrote the editor of the *Mason County News*. He hoped the thief might be literate enough to read his words. But Glenn had his doubts.

The thief, you would figure, could not be much of a reader - or classroom listener. To him, the name Jefferson would mean the family on a television sitcom. Washington would be a place where the Redskins play football. King would be a rock singer who drugged himself to death.

"Someone (or several), decided their personal gain was worth more than the respect and admiration the community has shown to the flag. So they stole the American Flag and the banner below it," wrote Marshall.

He holds little hope the criminal will ever be apprehended, fearing instead the flag will wind up as a curtain in a decrepit van.

He wants to believe the theft was committed by a transient who will never pass through the county again. "We certainly do not need that type of demented person in our county again," he says.

I don't blame Marshall for being angry. Americans have seen too many flags that were sewn into the crotches of Levis, or torched during acts of social defiance.

But rather than hanging the culprit by the toes - in the unlikely event he is ever apprehended - it might be better to educate him. Better yet, give him (or her) a choice. Jail, or history class.

Since it doesn't seem likely the flag was stolen as an expression of social or political protest, (kids aren't that political these days) we can probably assume the thief just liked the colors. Rather than a willful act of treason, we are probably dealing with an act of hard-earned ignorance.

Take up a community collection. Then find a local historian to escort the villain on a journey. Depending on the amount of money raised, it might be possible to lead him through the Civil War battlefields in Virginia. Or maybe just through the top museums in the country, or in Texas. If it's a rebel he aspires to be, introduce him to Robert E. Lee. He'll be impressed. If it's a macho man he admires, expose him to U.S. Grant.

When it's all over, have him write a paper. Have him include the number of U.S. war dead in each of those battles. Ask him to explain why anyone would be willing to chance a bullet piercing his heart for an intangible goal like freedom. Not the freedom to steal flags, but the freedom to work toward a democracy.

Let him know it didn't just happen, too.

Tell him we've been fighting wars - often with ourselves - while trying to define it. Sometimes the flag is the only thing united about us.

Let him know, though, when the squabbling stops, and we're all in agreement, we won't be interested enough to continue with the goal of democracy any longer.

He may want to mull that over for a while. But don't let him off with a shrug.

In the end, take him back to the courthouse square. Have him hoist the flag back to the top, if he hasn't already destroyed it. Otherwise, have him work until he can pay for a new one.

If, while he looks up at the flag, the people of Mason County see goose bumps where there ought to be goose bumps, I say spare him.

If the bumps aren't there, give him a cigarette and a blindfold.

Some people you just have to shoot.
