The Callahan County Commissioners, in the regular monthly meeting Monday, June 5, approved a bid from James Tollett of Baird to build a bridge on a county road 11/3 mile north of Putnam.

Commissioners approved the bid of \$49,850, by a vote of 4-0, for a 22 foot wide and 60 foot long bridge.

The bridge will have a 25 ton weight minimum for crossing. The bridge will be completed within 30 days of the time work begins.

Only two bids were received. The second bid was for \$69,000.

In other items, the County Commissioners:

-Voted by a 4-0 vote, to accept the bid of \$9,509.86 from Town and Country Pontiac-GMC in Baird for a 34-ton GMC pickup for Commis-

sioner's Precinct II. Town and Country Pontiac-GMC was the lowest among four bids received and was \$1,000 under the next lowest bid.

-Voted by a 4-0 vote, to appoint Mrs. Paul Dugan and Mrs. Vince Scaramuzzo as new members to the County Child Welfare Board.

-Approved, by a 4-0 vote, Eleazar Maciel as a board of trustee members of the Abilene Regional MHMR

-Heard a bid for the county employees group hospitalization insurance. No action was taken.

-Heard a report from Jon Herod of Clyde, who is doing the county's audit for 1985. Herod gave recommendations to improve next year's audit, but commissioners took no action.

The Dairy Queen wagon was pulled by two huge black mules named Pokey and Lassie and was driven by a lady mule skinner.

When it was time to head out the wagonmaster, Gary France, shouted, "Wagons, Ho! Believe me, he had the voice for it.

They paraded through downtown Albany on their way to Fort Griffin. The town was packed with people waiting to get a glimpse of the historical event.

We drove ahead of the procession of the next stopping point. Sitting atop a hill we could see the colorful wain of wagons wind its way down the hill several miles away. The United States and Texas flags were proudly flying in the breeze. It was a sight I will long remember and probably never witness again.

There were 75 to 100 wagons plus approximately 100 individual riders. You could pick out the ones who had been on the trail for nearly 6 months for they were baked brown.

There were wagons of every description. Some were original wagons and some more modern. My favorite was an authentic prairie schooner

Many other states were represented in the trail ride, too.

The kids loved the experience but they were tired and hot after the 8 mile ride. They said it was "rough".

This has been a great adventure to go back in time and live like the pioneers did. What a wonderful way to celebrate the 150th birthday of Texas. If you have a chance to view the wagon train make an effort to do so. You won't be disappointed.

Horton Named to West Point

James C. Horton, Jr., grandson of Ruby E. McCowen and the late Charlie M. McCowen, will be entering the United States Military Academy, West Point, New York in

West Point is a highly selective academy. Last year, over 13,000 applied, about 6,000 were nominated and only 1,415 were actually admitted, according to West Point.

To become a cadet, one must meet the requirements specified by public and must be qualified academically, physically and medically. Each candidate must also obtain a nomination from a member of

Horton received his nomination from Congressman Larry Combest of the 19th District.

"The mission of the United States Military Academy is to educate, train and inspire the Corps of Cadets so that each graduate shall have the character, leadership, intellectual foundation and other attributes essential to progressive and continuing development throughout a career of exemplary service to the

nation as an officer of the regular army," said West Point.

A West Point graduate is awarded a Bachelor's Degree and commissioned an Officer in the U. S. Army.

Horton received various honors and awards this school year. At Lubbock High School, he was named All-Western Boy, Senior's Who's Who and Outstanding Sprinter of the Track Team. He received the Fighting Heart Award in football and the Fighting Western Award, which is the highest athletic honor at Lubbock High School Horton received five varsity letters in football and track and was 3-5A All District Honorable Mention Defensive End. He was among 60 finalists for the 1985 Fina Texas Academic All-State High School Football Team.

Horton is a National Merit Scholar and Academic All American Scholar. he is a member of the National Honor Society and Who's Who in American

High School. Horton graduated with a 4.24 GPA and was ranked number 11 out of 367' graduating seniors at Lubbock High School. He is the son of Bonita McCowen Horton.

Water Rate Hike Okayed

Start Now to Stop Hoppers

Grasshopper numbers are above average this year and if you want to control them, now is the time to start, Greg Gerngross, County Extension Agent.

Many of the grasshoppers are small and, a whole lot easier to control before they reach maturity.

In home gardens, Malathion EC or 50W Sevin are the two insecticides recommended for control. A number other insecticides including Diazinon, Penncap M and Sevin XLR Plus are recommended for use on

ranges, improved pastures and around the edge of fields.

Be sure the insecticide you select to use is approved for the crop you are spraying and follow label directions.





ASCS Reminds Farmers To Report Seed Peanuts

When farmers certify their 1986 planted peanut acres, Scott Odom, CED of the Callahan County Agricultural Stabilization and Conservation Service, reminds them that 1985-crop peanut retained on the farm for seed or other purposes must be reported also.

To avoid being in violation of the peanut poundage program regulations, he said farmers who did not retain peanuts for seed must report the name and address of the person from whom their seed peanuts were obtained, in addition to the amount and type of peanuts.

Under the peanut price support program, the number of pounds of peanuts that can be marketed by producers for domestic edible uses is limited through poundage quotas. According to Odom, the Food Security Act of 1985 allows any person to grow peanuts anywhere in the country and market the peanuts for other than domestic edible use.

"Price support loans will be available for 1986-crop warehouse-stored peanuts from harvest time through January 31, 1987," the ASCS official said. Loans on farm-stored peanuts will be available through April 30, 1987.

Farmers who have questions regarding seed peanuts should contact the Callahan County ASCS office.

To obtain accurate acreage measurements and simplify crop reporting, Scott Odom, CED of the Callahan County Agricultural Stabilization and Conservation Service, suggests that farmers take advantage of producer services.

"This is a valuable service not only to producers participating in the 1986 acreage reduction programs, but to any farmer who desires an accurate acreage for any reason," Odom said.

Before farm program participants can qualify for price support loans, deficiency payments and other benefits, they are required to certify with ASCS the crops and acreages planted, the uses to be made of these crops, and the cropland acres to be devoted to the acreage conservation reserve (ACR). The information serves as documentation for program compliance and crop acreage bases.

"The loss of program benefits because of failure to comply is one gamble that a farmer should never take", Odom said.

With measurement service, he said a farmer can have his or her planted crops measured before certifying acreages. The service also includes measurement of ACR land, fields, subdivisions, total cropland and land acres for other purposes.

In Callahan County, the final certification dates for program crops are: Peanuts, July 15; Grain Sorhum, July 15; and Cotton, July 15.

"Our producer services are guaranteed for the program year in which they are taken," the ASCS official said. Fees vary, based on the type of service rendered.
