County Leaders Approve Tax Rate

Callahan County commissioners have recently approved a three percent increase in the county tax rate above the effective tax rate, the smallest increase allowed without calling a public hear-

The effective tax rate is the rate that will bring into county coffers, the same amount of revenue as last year.

Commissioners voted to set the county tax rate at .3299 cents for every \$100 of appraised property. The new tax rate includes .2532 cents per \$100 for the general county fund and .0767 for the county farm road fund.

The county tax rate is on \$257,964,921 in appraised property inside Callahan County.


Garden Club In Adopt A Highway Program




Apple made the final touchdown on a 2-yard run and also scored a 2-point

County Special Investigator To Be Hired

With a increase in the number of felony cases handled by Callahan County attorney Bob McCool's office, Callahan County commissioners Monday, September 28, voted to hire a special investigator for McCool's office, to handle the increased felony

McCool and Callahan County sheriff Bill Skinner met with commissioners asking for the new investigator. Commissioners agreed to hire the investigator with the condition that monthly reports be made to the commissioners, showing the progress of the new investigator.

The new office will cost the county approximately \$20,000 a year. The new investigator will receive a set salary, car allowance, mileage, insurance, social security and retirement benefits paid by the county.

The investigator will have statewide jurisdiction and will work closely with area law enforcement agencies. His duties include doing follow-up work on all felony case brought before the county attorney, questioning witnesses, victims and defendants, and helping the county attorney stay in close contact with each case. "This will allow me to take a harder stand on cases that might otherwise be difficult to prosecute for lack of information," McCool said.

"In the past, the sheriff's office has done an excellent job in helping with these cases, but like so many departments, they are understaffed and overleaded with their own cases, " McCool added. Until 1982, McCool handled only misdemeanor cases with Taylor County handling all Callahan County felonies. A recent state law now requires Callahan County to handle its own felony cases.

McCool is interviewing applicants and will consult with sheriff Skinner before making a final decision.

Other items brought before the commissioner's court include:

-Voted to appoint Debbie Strickland of Baird to the Callahan County Child Welfare board.

-Met with Mike McClure Jr. representing the Cross Plains Fire Department. He explained to commissioners of a need for a water tank and pump to be placed on a new resuce truck recently purchased by the department. Commissioners voted to contribute \$1,000 to the Cross Plains Fire Department for the additional equipment.

-Met with a representative of the Zion Baptist Church in Putnam requesting commissioners lower the church's county property tax. The church, disbanded since 1985, was no longer tax exempt with the owner unaware of the fact. The property was also appraised at four times the actual value. Commissioners voted to drop the penalty and interest on the delinquent taxes and the owner agreed to pay the taxes on the current appraised value of the property.

-Commissioners voted to contribute \$500 toward the burial of a Clyde woman by Bailey Funeral Home in Clyde.

-Commissioners voted to pay \$150 a month toward the cleaning of the Cross Plains justice of the peace office. Rolan Jones, Cross Plains justice of the peace, met with commissioners requesting the county compensate the county tax office employee in the Cross Plains office, Betty Lewis, to help with the paper work and the cleaning of the office. The office in Cross Plains is occupied by the justice of the peace, city marshall, Department of Public Safety, sheriff's department, county attorney's office, parks and wildlife department and is the county tax office for Cross Plains.


The Book Committee consists of Bransford Eubank, Irene Brown, Treasurer, Marie Stambaugh, and Estill Franklin Allen, Editor.



Callahan Divide SWCD Taking Windbreak Tree Orders

"With the windy season just a few months away, now is the time to start planning for a tree windbreak," says Tony Baeza, Range Conservationist for the Soil Conservation Service in Baird. "A windbreak will not only add beauty and protect your house, but it will also attrack wildlife and help reduce heating and cooling cost."

Currently the Callahan Divide Soil and Water Conservation District is taking orders for windbreak seedlings. Quality trees and shrubs of adapted species will be available at discount prices to landowners. With proper care many of the species will attain a mature height of 30-35 feet and provide protection for over 40 years.

Some of the seedling evergreen species that are available this season are Afghanistan pine, Arizona cypress, Austrian pine, Ponderosa pine, Red cedar, and Scotch pine. These trees are available at various sizes and price. Barerooted hardwoods available are Arizona ash, bur oak, desert willow, green ash, honeylocust, little walnut, Boisd'arc, pecan, redbud, red oak, and Russian olives.

Also available this year are wildlife packets. Each packet includes 100 seedling of various barerooted trees depending on whether your interested in attracking quail, deer, turkey, or squirrel.

Baeza encourages anyone interested in ordering windbreak trees to place their orders as soon as possible since many trees are in short supply.

For more information on planning, planting, and maintenance of windbreak trees, and how to purchase low-cost seedlings, contact the Soil Conservation Service in Baird or a member of the Callahan Divide Soil and Water Conservation District.



Others that played and contributed to the victory were: Earl Melroney, Stephen Williams, Buddy Rowen, Eric Blanton, and Doug Adams.



The I.R.S.?

It wasn't exactly the I.R.S., but it was an audit. Two weeks ago, an audit was conducted at both the elementary and high school offices at Cross Plains. The audit was done on September 22 and 23.

This audit was done by a team of auditors from the Texas Education Agency and the purpose of the audit was, to conduct an examination of student attendance and accounting procedures.

There were 7 Control Objectives covered, each ranging in a number of different questions. For example some of these questions were: the number of school hours for instructional purposes; number of transferred pupils if the students are pre-registered; whether absences are recorded on period absence slips; six weeks attendance records; or a daily absentee summary; the presence of any written job descriptions for district and campus personnel; and if the district's attendance accounting is done on an EDP system.

The auditors stated that our "pupil attendance and accounting system was very good and that we were in compliance with the laws and rules governing student attendance accounting." An audit can be conducted any time within a 3 to 5 years period.

Maybe I am over the hump - at least I hope so but today I started wondering what my 1988 unemployment tax rate would be --- can you give me any idea of what to expect?

Dear T.J.: I have been hearing from hundreds of employers in exactly the same situation. I wish the news I have to give you could be better, but here goes. There are two substantial law changes made by the last legislature which will affect employers begin-

ning in 1988. First, there was a change made in the method of computing the deficit tax. The deficit tax is one portion of an employer's overall unemployment tax rate. Previously, because of the computation formula, the deficit tax affected less than half of all employers.

Now it will affect all employers. Second, the wage base upon which an employer pays taxes has been increased from \$7000 to

\$8000 in 1988 and \$9000 in 1989.

In a nutshell, taxes will increase! In 1988, the minimum rate available under law is expected to approach 1%, and the maximum rate is expected to be about 8.5%. I am advising all employers to prepare for a tax increase but those who did not pay any deficit tax last year will be the ones to take the biggest hit.

Dear Commissioner Nabers: Is there anything that we as employers can do to lighten our tax burden for 1988?


Dear S.J.: The 0.8% FUTA (Federal Unemployment Tax Act) tax is due to decrease to 0.6% as of January 1, 1988. The additional 0.2% was imposed in 1977 to pay for extended unemployment benefits authorized by the Federal Government.

The House and Senate committees in the U.S. Congress have included among the options considered in writing a tax bill, the extension of this tax.

Since the purpose for which it was imposed has been satisfied, we think the extension would be a new tax which you as employers have every right to protest. The extension will cost the employers of Texas approximately \$89 million in 1988 or about \$14 per employer.

Write to your U.S. Congressmen and Senators now stating your objection. The next two weeks are the crucial ones as far as this tax is concerned.


The board of directors coordinates the conservation efforts of various local, state, and federal agencies and other organizations and has authority to enter into working agreements with these governmental agencies and private concerns to carry out its purposes.


As one of five individuals serving on the district board of directors, Cauthen will be responsible for district policies and procedures for carrying out the district program within the framework of the Texas soil conservation district

In other areas of leadership, Cauthen is active in farming and ranching in the Admiral community and also a full time employee in the Baird Post Office.

In Texas there are 206 soil and water conservation districts. Each is a legal subdivision of the state government organized by local agricultural landowners with the assistance of the Texas State SOIL and WATER CON-SERVATION BOARD. Unlike most other legal subdivisions of the state government, SWCDs do not have the powers of taxation or eminent domain. All conservation programs managed by the districts are of a voluntary nature to the landowner or operator.

Organized in April 1986 the CALLAHAN DIVIDE SWCD is currently involved in implimenting the different aspects of the 1987 Food Security Act. The District has determined that 54% of the farms within Callahan County contain highly erodible cropland and will require a Conservation Plan before 1990. The CALLAHAN DIVIDE SWCD encourages farmers to contact their local SWCD office in Baird for assistance in developing a conservation plan to meet the requirements of the program.
