## At Least You Don't Live In Oklahoma City

I'll give you some advice. If you're out of work and looking for a job, don't go to Oklahoma City

My wife and I visited friends there last weekend. It was our first trip to Oklahoma's biggest city.

My friend, Bill Schulte, recently took over as manager of a hotel there. He's one of the best hotel managers in the business, but he's got his work

cut out for him on this one. What with the oil depression and bad management, his hotel, the Hilton, has fallen far from its perch as

probably THE hotel in the city. Two floors of the seven-floor hotel are not in shape to be used, huge lighted signs on the outside of the

building don't have electricity, etc. Actually, the condition of the hotel mirrors pretty well the condition of the whole city.

The 21-story Founders Tower nearby is virtually vacant with a broken air-conditioning system, and is in receivership.

There are literally blocks of vacant buildings downtown and miles of closed oil-related businesses on the outer parts of town.

On Thursday night, we went to a good barbecue restaurant. There were only two customers in the place besides us. On Friday night, usually a busy one for restaurants, we went to one of the best restaurants in town. We didn't have to wait at all for a table.

Unlike most big towns, there is no highway bypass around Oklahoma City. There's part of one but it comes to an abrupt halt in the northwest part of town and I didn't see any signs that it is likely to be finished soon.

In fact, there is little construction of any kind visible. The only major construction I saw was on a horse race track which they are working feverishly night and day to get completed before Texas legalizes paramutual betting (which it may, or may not, do).

The big event going on while we were there was Red Earth '87, a big gathering of Indian tribes.

There were thousands of Indians in town but my hotel-manager friend said they must have come in campers because he didn't rent a single room to

The Cross Plains Review will feature a yard each week and Lois Garrett's was chosen this week due to her beautiful Daylily garden.

Upon calling Lois to receive permission for the article, she remarked, "I've tried to get people to pay attention to my Daylilies for years and no one would bother. You have really made my day." Now this is the kind of response you like.

She told me that she started planting Daylilies about 17 years ago in the garden behind her house on the west. This is where her special plants are displayed.

She had many, many different varieties of Daylilies which represent a wide range of colors including yellows, salmon, red, rose, and more. Song of David and Fabulous Prize are two of the names of the species which are as lovely as the plant.

the huge oak tree. She even has plants from five different states.

The plants are fairly expensive ranging from \$2 on up but she stated that the hybrid varieties do not multiply as well.

She has devised a systematic drip irrigation to keep the roots supplied with moisture. However, she hasn't needed this the last two weeks and said the rain had been great for them.

The Daylily blooms from mid May until July and is at its peak about now. The flower assumes its name from the fact that its blooms only last for one day, even in an arrangement. A different bloom will bloom to replace the one before. They face the direction the sun is received from.

I inquired why she chose this particular flower and she said, "I was in Austin at a flower show and I thought the arrangements were so outstanding, and I became interested in them.'

The visit with Lois was refreshing, as Lois said that each year she plants always, and she invites everyone to drive by 1365 Avenue D and look at her garden in front of her house and around prized possessions.

## Trash Dumping to Net Fine

Rolan Jones, Justice of the Peace for Callahan County, would like to announce that anyone dumping trash on other people's private property will be fined up to \$400 for the offense. In addition to the fine, they will have to pick up the trash, and apologize to the land owner.

Anyone failing to comply will be visited by the Deputy Sheriff.

It is against the law to dump in other people's pastures, under bridges, in creeks, and along the side of the road. If you pay a City water bill you are entitled to free dumping at the City Dump upon presenting a water bill A \$3 minimum charge is collected for

anyone not paying for City water. A higher fee will be imposed according to the size of the load.

The City Dump is open Tuesday, Thursday, and Saturday from 8:00 a.m. until 5:00 p.m. They are closed from noon until 1:00 p.m. for lunch.

You are encouraged to use the City Dump and help keep the community

free of unsightly litter.

## BROWNWOOD, TEXAS - Conan

Howard Tribute Due

the Barbarian and his originator -Robert E. Howard - will live again as this Central Texas area becomes once more the mythical land of Cimmeria.

Observing the 51st anniversary of Howard's death in June 1936, the Brown County Historical Society will dedicate its annual membership meeting to "A Tribute to Robert E. Howard." said Ronnie Lappe, Society President.

Robert E. Howard is probably one of the few internationally known persons to have lived in and be buried in Brown County, Lappe said. "We feel that his life is an important part of local history, and we want to have a Texas State Historical Marker placed at his grave in Greenleaf Cemetery."

By the time of his death at the age of 30. Robert E. Howard had written extensively, including short stories, poems, novelettes and a novel. But the novel was unpublished in book form, and most of his published works had appeared in "Weird Tales," a pulp magazine literary critics did not favor, although it carried the work of leading fantasy writers.

It was Conan and Cimmeria who caught the imagination of the publicthrough books, comic books and two movies—to bring posthumous fame to Howard. It was the "sweep of his narratives, the vividness of his imagery and his ability to convey mood, magic and mystery" that won him personal acclaim as a significant American writer of fantasy, said L. Sprague de Camp, author of Howard biography, "Dark Valley Destiny."

Howard was on the threshold of a brilliant literary career on June 11, 1936, when he ascertained that his mother would never again regain consciousness, got into his car at the family home and put a bullet through his brain.

Guest of honor for the tribute will be Novalyne Price Ellis, the author of a Howard memoir, "One Who Walked Alone," published by Donald M. Grant Publishers in 1986. A graduate of Daniel Baker College in Brownwood, Mrs. Ellis was the only girl Howard ever

#### **County Sales Tax Election Delayed**

Callahan County commissioners will hold off until their next regular meeting, a decision to call a half-cent sales tax election for Callahan County.

Commissioners, in their regular meeting Monday, June 8, tabled until July 13 a decision on calling the sales tax election.

Under law enacted after last year's second special legislative session, municipalities can add a half-cent to the sales tax for property tax relief.

The money raised from the sales tax would have to go toward reducing property taxes imposed by Callahan County. A half-cent sales tax would raise an additional \$88,274 for county coffers.

If a sales tax election is granted by commissioners; it would probably take place with the state constitutional amendment election in November.

If voters passed the sales tax measure in November, the county would start collecting the tax in January 1, 1989. Other items brought to the attention

of county commissioners Monday were: -Discussed the distribution to Baird, Clyde and Cross Plains, of 7,774 pounds of food commodities from the federal government. The give-away of butter, cheese, and rice was to have taken place Wednesday, June 10.

-Took no action on closing County Road 203 in Cross Plains precinct.

-Conducted a workshop on the 1987-88 county financial budget. No action was taken.

Present at the meeting were commissioners Joe Ingram, F.P. Shackelford, Lowell Johnson, Eugene Kitchens and county judge Mack Kniffen.


#### Reunion Booth Reservations Asked

Currently, the Foundation and the University are sponsoring a program in nuclear fusion research aimed at controlling thermonuclear reactions for the productions of electric power.

The goal of the Foundation and WTU is not research alone, but to also assist in the advancement of the knowledge of energy science of Texas schools. Of special interest to the sponsors is bringing to students and teachers a realization of the privileges, responsibilities and opportunities which scientific discoveries in the field of energy presents.


## Chargebacks Affecting Tax Rates Can Occur Up To 18 Months

DEAR COMMISSIONER NABERS: Our company just received notice of a claim for unemployment benefits on someone who has not worked here for about a year. How can this be? The form is called a Notice of Maximum Potential Chargeback. What should I do?

DEAR G.E.: Without getting into the philosophy or rationale behind the structure of the unemployment compensation system, let me just give you some basic

Anytime you put an individual on your payroll, your company has POTENTIAL liability for unemployment claims up to 18 months AFTER the person has left your employment.

The Notice of Maximum Potential Chargeback is telling you that someone who used to work for your company and then went on to work somewhere else has become unemployed, has filed a claim for unemployment benefits and is being paid. In order to determine whether your company should be charged for a portion

of the benefits, TEC needs to know why that person left your employment.

The notice gives you a certain time frame for responding. If you miss the deadline, your account will be charged, regardless of the reason for the work separation. If you respond in a timely fashion and indicate that the person either quit voluntarily or was fired for work related misconduct, your account will be protected.

Dear Commissioner Nabers: I have a small drilling company and, as you know, times are not the best in the oil patch. I have had to cut back the hours of my employees substantially and don't know when I'll be able to give them more work. Can they draw any kind of benefits and continue to work for me? I need to know

what kind of assistance may be available to them.

TRYING TO HANG IN THERE **ODESSA** 

DEAR TRYING: Your employees may qualify for partial unemployment benefits if the cutback in their hours has been substantial. Tell them to visit their local TEC office for information and assistance.
