Lt. William Young Awarded **Distinguished Flying Cross**

On the second day of the ground war in the Gulf, 1st Lt. William R. Young flew his UH-60 Black Hawk helicopter more than 160 kilometers behind enemy lines to rescue a Special Forces team with the 82nd Airborne Division from Fort Bragg, North Carolina.

His handling of the dangerous mission earned him a Distinguished Flying Cross, which Vice-President Dan Quayle pinned onto Young's uniform at a VII Corps welcome home ceremony in Erlangen, a Bavarian

town that serves as home to the 2nd Brigade of the U.S. Army Europe's 1st Armored Division.

The Flying Cross is awarded to soldiers who perform heroically in combat, voluntarily going beyond the call of duty while participating in an aerial flight.

Young said it was "an honor" to receive the award from the vicepresident, who was in Europe on a five-nation tour with his wife, Marilyn, and two of their children.

More than 1,200 troops and their families came to one of the Ferris Barracks motor pools, which usually houses M1-A1 tanks, to see Vice-President Quayle pin medals on Young and six other soldiers.

Quayle told the cheering crowd that he and his family came to Germany "to pay tribute and respect to the men and women of our armed forces."

Tasked with entrapping and attacking the Iraqi Republican Guard, the 1st Armored Division saw heavy combat during the 100 hours of the war.

BANKS OF CROSS PLAINS

The first bank of Cross Plains was a private bank with Tom Powell as president and S.F. Bond as cashier. It was organized in 1904 and became a national bank March 2, 1907. It was called The Farmers National Bank.

The officers of The Farmers National Bank in 1907 were T.E. Powell,

president, S.L. Driskill, vicepresident, S.F. Bond, cashier, and Taylor Bond, assistant cashier. Powell and Driskell were probably originally from Baird.

S.F. and Taylor Bond were brothers who came with their parents to Cross Plains in 1884. Samuel Foster Bond was born in Holly Springs, Mississippi, on March 16, 1873 and died in

Cross Plains, April 27, 1974 at the age of 101. During his long life, he established The Cross Plains Mercantile, was president of a bank, established a cotton gin, put in the first electric utility in Cross Plains, hauled freight from Brownwood, and many other activities. Taylor, born in 1882, was active in business and banking and died in 1937.

Directors of the bank were T.B. Vestal, E.J. Barr and his son, John A. Barr, and R.P. Odom. Descendants of the directors still live in the Cross Plains vicinity. Juanita Mayes, Vida Balkum, Lorena Wright, and Alma Armstrong are granddaughters of T.B. Vestal. Zelda Long and C.A. Barr are

grandchildren of E.J. Barr. Lerlene Fortune and John D. Montgomery are grandchildren of John A. Barr. E.F. and Morris Odom are grandchildren of R.P. Odom. There are greatgrandchildren who also live in the Cross Plains community.

The Farmers National Bank carried a large, front page ad in the Cross Plains Review from January 1911 through December 1929.

Morgan (Uncle Morg) Harlow was prominent in early phases of both banks.

In July 1931, the Farmers National failed and never reopened. It was located at the site of the present Citizens State Bank, when along with many others, the bank was a victim of the Great Depression.

In the parlor of Jim Coffman's in 1911, the Cross Plains Bank was organized with H.W. Kuteman, president, J.E. Spencer of Carbon, vicepresident, and Dodd Price, cashier. It was Mr. Spencer and his brother, W.E. Spencer, who were some of the men who formed the townsite company in 1910. The bank started in a little frame building near the banks of Turkey Creek. In January 1911, the bank moved to the townsite and opened its door as an unincorporated bank. An account could be opened for a one (\$1.00) dollar deposit. The bank was later called The Guaranty State Bank, The First State Bank, and eventually the Citizens State Bank. It always ran an ad in the Cross Plains Review in the opposite corner from the Farmers National Bank. The ad ran from 1911 through 1929. In 1922, George B. Scott moved to Cross Plains and became cashier, a position he held until his untimely death in May 1929. Mr. Scott who was the father of Jack Scott, Maggie Scott Cook, Baird, Texas, and Anna Myrl Scott McGowen, Sherman, Texas, was born in Clay County, Alabama, April 14, 1876. He came with his family to Texas in 1878. In the early eighties, the family moved to Cottonwood. Jack Scott served as a director of the local bank for twentyfour years. During the Great Depression, the bank closed in October 1931. The bank weathered the most severe financial panic in the history of the world. After reorganization the Citizens State Bank opened November 1, 1931 with R.C. Duringer as cashier. John Barr, for many years, was a director at both

said that he, his brother, Sam Barr. and other directors put in a great deal of their own money to save the bank. Following Duringer's tenure of Chief Executive were J.R. Patterson, the father of Exa McCord Williams. C.C. Neeb, Fred V. Tunnell, father of Jack Tunnell, Edwin Baum, Jack Tunnell, and W.G. McCoy, president of today's bank.


Ethel Sims went to work as a regular employee of the Citizens State Bank in 1937 with Fred V. Tunnell and remained for forty years as a very important part of the banking institution. Present directors of the Citizens State Bank are W.G. McCoy, N.L. Dillard, Tommie Harris, James Lawrence, Jim Skinner, Marshall Newcomb Jr., and Lynn Nabers.





skies were dark and dirty with smoke and ash from burning oil wells, greatly reducing Young's visibility and that of his co-pilot and an accompanying Black Hawk crew.

The pilots flew through enemy fire, and, as Young's crew chief tells, enemy radar locked onto the two U.S. choppers, putting both crews in danger of being shot out of the sky.

Adrenaline admittedly flowing fast, Young out-maneuvered the radar. He brought his helicopter down low to the ground to stir up dust so the enemy would lose him, and the maneuver worked.

Both Black Hawks flew back to their unit intact and with the Special Forces troops abroad.

"We were all hyped-up...and it was scary," said Young of the rescue mission. "But we were just doing our job. I think we were also real lucky."

When the cease fire was called two days later, Young said he and his crew

"Everything was going so fast and the battle was so violent, we were all on a high," he said. "All the bad stuff that was happening in the battle was happening to them, not to us. We were confident, because we didn't see people we knew getting hurt."

Young, who soon will be promoted to captain, has applied to law school, with Amy sponsorship, at the University of Texas at Austin. He has also been the recipient of two additional military honors, the Air Medal with 'V" for Valor and the Bronze Star.

He and his wife, Roxanna, a Corpus Christi native, have one son, William, and are expecting their second child shortly.

The Young family is expected to be in the United States on September 11 and will arrive in Cross Plains September 20. Bill and Barbara, his proud parents, are eager to see them after the long separation and perils of he war.

Of the surge of patriotism in the U.S. luring the war, Randy said, "It's been very good for the soldiers."

Co.Jail Plans Told


Callahan County Commissioners voted to hire an architect to continue preliminary plans for an addition to the Callahan County Jail to bring it into compliance with the Texas Jail Standards Commission.

County commissioners, in a regular meeting Monday, June 24, voted unanimously to hire the architecture firm of Franz, Jeanes, Lazo, Cora & Associates, Inc. of Fort Worth to proceed with plans for a remodeling and addition to the jail in Baird.

The county is being forced by the Jail Standards Commission to add several classification areas to the current jail.

In the present jail, there are currently four areas that prisoners can be classified into but with the addition and remodeling of the present jail, there will be a total of eight classification areas.

Plans call for an addition to be constructed on the northwest corner of the

President Bush has signed Public Law 102-25 in response to a request from the Secretary of Veterans Affairs to provide readjustment counseling eligibility for veterans of the Persian Gulf, and conflicts in Lebanon, Grenada, and Panama. The Chief Medical Director of Veterans Affairs, on behalf of the Secretary of Veterans Affairs and in conjunction with the Department of Defense, has determined that readjustment counseling is authorized for veterans who served in the following conflict zones:

Vietnam: From August 5, 1964, to May 7, 1975.

Lebanon: From August 25, 1982, to February 26, 1984.

remodeling project will take place on the first floor of the current jail to allow the county to house an additional 12 prisoners.

After the remodeling and addition is completed, 18 prisoners could be housed in the jail. The present jail facility can hold a maximum of nine prisoners.

There would be no remodeling of the second floor of the present jail building. Currently, up to nine prisoners can be housed on the second floor. There is no housing of prisoners taking place on the first floor of the present jail facility.

Total cost for the jail project is being estimated at between \$105,000 and \$110,000, including the architects fees. The architecture firm would receive a flat \$10,000 fee for its work, with 50 percent to be paid when the project is bid and the other half to be paid when the project is completed.

Callahan County Judge Bill Johnson said that the architects told the county commissioners that the addition could solve the county's jail housing problems for another 20 to 30 years. The next step is for the architecture firm to have the additional and remodeling plans finalized by the Jail Standards Commission.

The bidding of the project is not expected for another six months. Construction of the addition is not planned until possibly January of 1992 and the project would not be completed until the spring of 1992.

Judge Johnson said that there will be no bonds issued to finance the jail project. The jail addition and remodeling would be funded from the current and future budget plans of the county, Judge Johnson said.

Judge A. E. Dyer

BAIRD — Callahan County's former judge, A.E. "Colonel" Dyer Jr., 64, who enjoyed the comforts of living in a small town, died Tuesday, June 25, at an Abilene hospital.

Services were held at 2 p.m. Wednesday at First Baptist Church with the Rev. Daniel Moore officiating, assisted by the Rev. Jack Willoughby. Burial was in Ross Cemetery, directed by Parker Funeral Home.

A lifetime resident of Baird, Dyer, who inherited his nickname from his late father, A.E. Dyer Sr., was a thirdgeneration Callahan County rancher.

The Dyers raised Black Angus cattle and were the largest commercial Angus raisers in the state at one time. After building a large ranching operation, A.E. "Colonel" Dyer Sr., died in 1960. Judge Dyer graduated from Baird High School in 1944 and got in one semester at the University of Texas before volunteering for military duty. He served in the U.S. Navy and was discharged after 16 months of duty. He enrolled in Hardin-Simmons University and received his degree in 1949, majoring in math and minoring in chemistry. He later returned to ranching. In a 1970, Reporter-News interview, he recalled, "I knew I wanted ranching. And I knew I would go back home - that's where the land was." He ran for the office of Democratic party chairman in 1960 after a neighbor decided he was too busy to do the job. Dyer kept on running for office and kept getting elected. schedule and a statement certifying that all elementary teachers receive a 30-minute, duty-free lunch was submitted.

CLASS-TIME REQUIREMENTS

- District was asked to submit copies of elementary teachers' schedules and a statement certifying that Chapter 75 time requirements were being met. This required corrective/improvement action has been superseded by Senate Bill 1.

GRADING — A copy of its board policy and the student handbook reflecting detailed procedures for implementing a uniform grading policy. Evidence that staff development was held in October and November 1989 to ensure that teachers understood the procedure used was submitted.

SPECIAL EDUCATION - The district submitted statements to the Division of Accreditation addressing each of the four problems: (1) reviewing and processing for referring, diagnosing, and placing students in special education; (2) certified that the Admission, Review, and Dismissal (ARD) process was being conducted in accordance with the law; (3) Individual Education Plans (IEPs) are individualized and; (4) complete student folders are available for teachers. **DYSLEXIA PLAN** — A referral committee consisting of the counselor, referring teacher, and the appraisal person who has observed the student in regular class was established. The Slingerland Test is used in student referrals. Several students have gone through the referral process, and those identified are now being served under the Herman Method. Three teachers have received training in the Herman Method as of June 1990. **KINDERGARTEN PROGRAM** - The construction of the additional six rooms to the elementary facilities was completed before the beginning of the 1990-91 school year. Three rooms are used to house the kindergarten classes. Kindergarten teachers obtained instructional materials needed for the 1990-91 school year. An in-service training program was set up through the Region XIV Education Service Center (ESC). HEALTH SERVICES - The district submitted a statement certifying that school health services meet state regulations. Each campus is provided with locked cabinets to store medications. A record is being kept on all medications administered to students by designated persons. Vision, hearing, and scoliosis screenings were conducted. Health and immunizations records are up to date for all students. SAFETY REQUIREMENTS -The team found the safety features in the science laboratory to be adequate. **LIBRARY MEDIA SERVICES -**The budget for 1990-91 fiscal year

reflected an increased amount allocated to library media services. The 10 books per student was met. A certified librarian-consultant is on campus one day in every two-week periods, and a full-time library aide spends half of each day in the elementary library and the other half day in the high school library.

STAFF DEVELOPMENT — The planning for staff development involved cooperative in-service with the Brown County Schools and the ESC. Teacher appraisal records, faculty surveys, and the accreditation report were used in planning the programs.

LEADERSHIP GROWTH PLAN - An outline of its leadership growth plan for administrators based on district needs and individual leadership assessments were submitted.

CODE OF ETHICS - A resolution, signed by all the members of the board of trustees, to adhere to the School Board Members Code of Ethics was submitted.

BOARD POLICY MANUAL -The district was to submit a statement certifying that the board policy manual had been updated, organized, and adopted. On July 19, 1990, the Cross Plains ISD Board of Trustees met and adopted an updated board policy manual. The manual was prepared and presented to the board with the assistance of the Texas Association of School Boards. **BOARD AGENDAS AND EX-ECUTIVE SESSIONS** - Evidence of a change in the format of agendas and a statement that the board is complying with legal requirements in conducting executive sessions was submitted. BOARD MEMBER TRAINING - The district was to submit a plan for each board member to complete training in all areas of the Statewide Standards as required. All seven board members have complied to the specified number of training hours. CHAPTER 1 BUILDING - The team noted that kindergarten classes conducted in the Chapter 1 building at

the time of the March 1989 compliance visit and the October 1989 accreditation visit have been relocated. The use of the Chapter 1 building is now limited to the Chapter 1 Program as required by law.

BUILDINGS AND FACILITIES

- The team noted that the six classrooms had been completed as scheduled; and they were in use. Overcrowded classroom conditions have been eliminated.

HEALTH AND SAFETY HAZARDS - The district's facilities are free from health and safety hazards.
