Knowing why I'm wearing this uniform.*

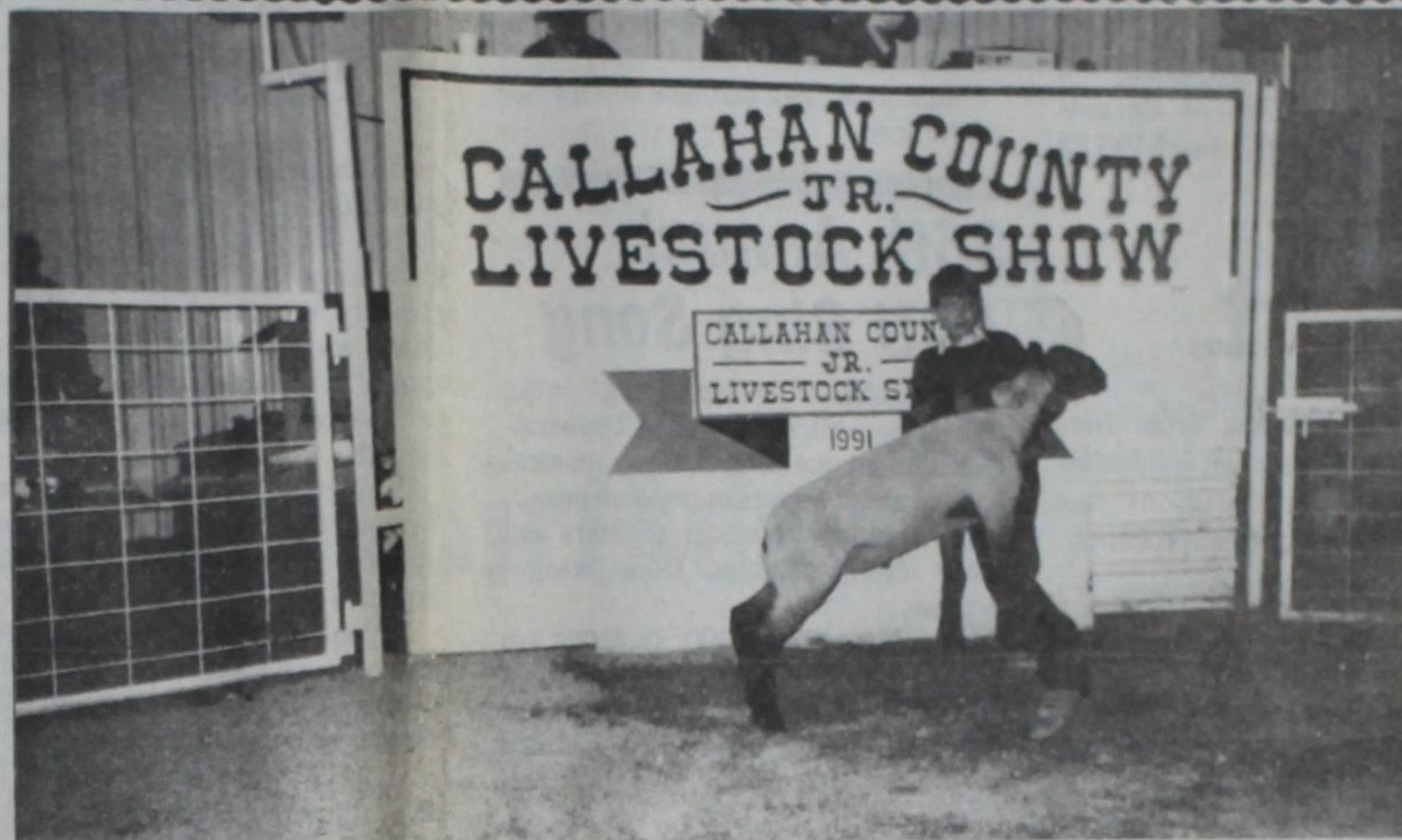

## Local Youths Show Top Animals At Callahan County Junior Livestock Show

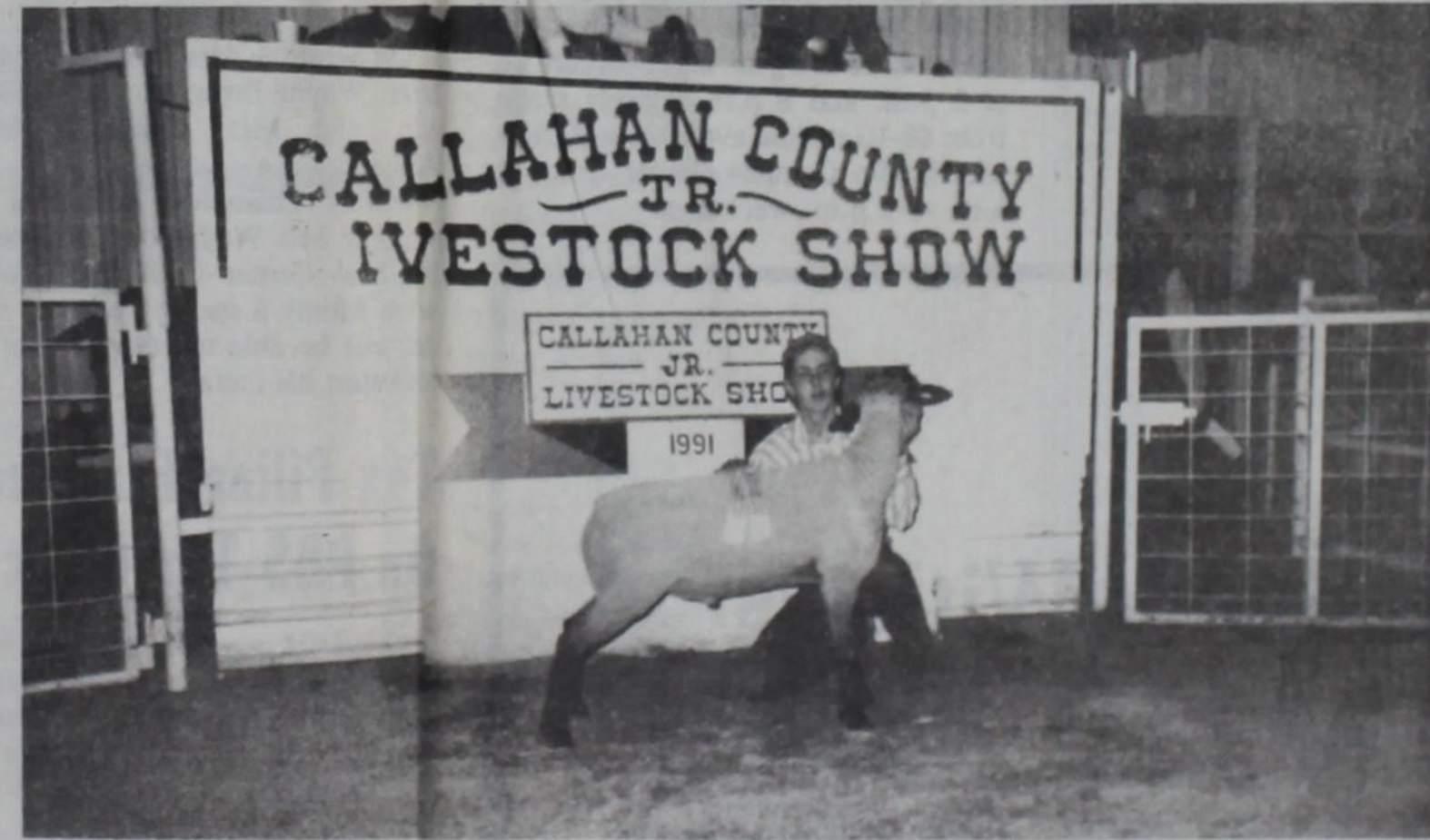

Once again the Callahan County Junior Livestock Show was a great success. The three day event was a highlight for Callahan County youths and the large number of spectators who attended.

A new look was the first noticeable change with the larger show ring located in the center of the building. The lamb barn is located on the west and a wall separated the swine barn to the south. The wall kept the noise level down from the pigs. The steer barn was moved to the north end and this change created a safer condition for steer transferring to the show ring.

The interior of the building had also been painted and the ground covering improved. The total facelift enhanced the show.

The weather this year was great. It seems as though since the gravel was placed around the building for parking and roads, the rain has not been a big factor. That is always the case. It certainly adds to the neat appearance of the show barn, which is an asset to the community.

## Tax Filing Featured On PBS Tax Clinic

A special one-hour program featuring federal income tax filing information will be on Public Broadcasting Service stations nationwide on Sunday, February 3, from 1 to 2 p.m., CST.

"Taxbreak '91: Raising Your Tax IQ" will be hosted by Today Show co-anchor Deborah Norville. Internal Revenue Service personnel and other tax experts will be featured. Viewers may join the studio audience in a tax quiz during the program.

Aimed at easing the task of tax return filing, the program highlights tax information for various groups of taxpayers, such as married couples, single parents, and the elderly. Program discussions include 1990 tax law changes, deductibility of medical expenses, electronic filing of tax returns, the earned income credit, child care expenses, and itemized deductions.

The importance of accuracy in filing tax returns is stressed in the program. "Taxbreak '91" also tells viewers how they can get a variety of free assistance with their 1990 tax returns. By videotaping the program, IRS says, viewers can use it as a guide when completing their tax returns.

Throughout the hour-long program and for one hour following, a toll-free telephone hookup will allow viewers to call in their tax questions to IRS tax assistance specialists.

one team was black, the other white. The black girls were tall, muscular and graceful...undefeated. The white girls were short, fragile and awkward...with many losses early in the season.

When the whistle blew to start the game, I expected an immediate surrender by the white team, for many of the black girls were a foot taller than their little opponents.

Before taking the floor to play, the white girls, one by one, kissed and hugged their coach — an old, baldheaded man, who had to be the fattest and the most inspiring coach ever to enter Gregory Gymnasium.

The fat man wore a tent for pants, a gigantic T-shirt, a pair of sandals, and a never-ceasing smile. For some reason, his girls treated him as though he were the most handsome prince of all time. He was worshipped by these children.

As soon as these undersized girls took the floor to play, a transformation came upon them — instead of being like Cinderellas, they seemed to be something more akin to Jekylls and Hydes. The intensity in their eyes soon possessed their bodies, playing like demons, not angels. Like pygmies overcoming a giant, they were everywhere at once, stealing the ball, making unbelievable baskets...unbeatable.

As the game wore on, it soon became obvious that the white girls had grown taller and more graceful, while the black girls shrank and became awkward. It was no contest!

At the end of the game, the fat man was lovingly hugged time and again by his girls and their fans. What affec-

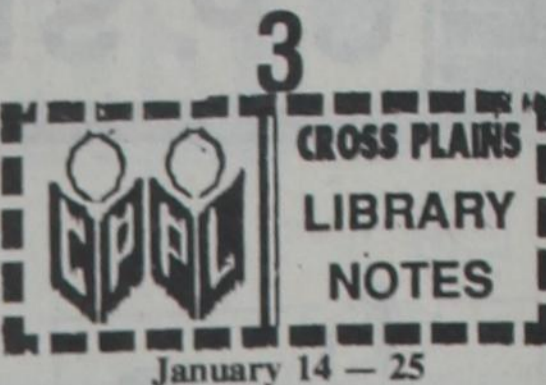

### It Seems To Be Working

By DANIEL CROCKETT

At the beginning of the 1990-91 school year, students at Cross Plains Junior High and High School were introduced to something new. For 30 minutes every day, (from 9:05 to 9:35) students are assigned to a designated HOMEROOM according to their grade level.

The HOMEROOM time serves a variety of purposes. Students may attend a 30-minute tutorial session for any subject, class meetings are planned and held during this time, other school related activities such as pep rallies are held then, etc. Those students who do not have an activity or tutorial class to attend use the time for a study hall.

High school principal, Leonard Wood, said that after this first semester of being in use, he felt Homeroom was serving a useful purpose, but he would like more students to take advantage of the tutorial session.

The teachers I spoke with like Homeroom because it gave them time to give make-up tests or go over work that a student may have missed due to being absent. They also appreciated being able to help students in a one-on-one situation if and when the help is needed.

In the junior high, the students are assigned to one of three different Homeroom teachers. At the high school, not every teacher is assigned a Homeroom. Those 7 teachers that are, rotate the grade level of their Homeroom each six weeks. Those that are not assigned a Homeroom are available for tutorials. During this year, the science, math and English teachers are not assigned a Homeroom in order to be available for tutoring.

The students I asked about Homeroom said they also enjoyed the 30-minute period so they could work on homework assignments and get help from their teachers in their different subjects.

The extra 30 minutes during the day for this Homeroom time came by taking 5 minutes from each class period, and adding 5 minutes to the lunch break. Classes are now 50 minutes and lunch has gone to 35 minutes. Several of the teachers said that at first they noticed the 5 minutes difference in the classes, but now everyone is well adjusted to the schedule and it seems quite normal.

Mr. Wood stated that it will be decided later whether or not Homeroom period will continue in the 1991-92 school year.

## Sales Tax Rebates Told

The City of Cross Plains is reporting 1991 one percent city sales tax payments running 32.34 percent higher than the 1990 payments of the tax. Cross Plains 1991 sales tax payments have amounted to \$3,163.69, while the 1990 sales tax rebates were \$2,390.63.

The city's monthly sales tax check for January 1991 was reported to be the same as the yearly total.

Other Callahan County towns reporting sales tax payments include:

—The City of Clyde's retail sales this year were reported less than one percent ahead of 1990 sales, according to city one percent sales tax information from State Comptroller John Sharp.

Sharp, the newly elected comptroller replacing Bob Bullock, said that sales tax payments in Clyde are running slightly higher than tax payments during 1990. He said that the sales tax rebates for the City of Clyde have amounted to \$4,730 so far in 1991. The 1990 payments to the city were \$4,708.27, a 0.46 percent increase in sales tax collections.

In 1990, the City of Clyde ended 1990 with sales tax rebates five percent lower than 1989.

—The City of Baird reported that sales tax payments in 1991 are 13.60 percent higher than 1990 payments. The city had received \$1,780.54 so far in 1991, while the 1990 tax payments to the city were \$1,567.39.

The town's monthly payment for January 1991 was also the same as the yearly total.

—The City of Putnam is reporting 1991 city sales tax payments amounting to \$1,127.75 so far, a 65.63 percent increase from tax payments to the city in 1990. The 1990 sales tax check to Putnam amounted to \$680.87.

Countywide sales tax payments for 1991 in Callahan County are running 15.56 percent higher than the 1990 payments to the county. Callahan County towns have received sales tax payments in 1991 amounting to \$10,801.98, while the 1990 payments

to the county towns totalled \$9,347.16.

Comptroller Sharp said, "This month's local sales tax rebates are positive proof that our Texas economy is steadily improving."

"A good portion of that increase is due to Texas' stronger economy, but some of the rise is because more cities collect sales tax this year than did last year. A few other cities have also increased their local tax rates which makes for higher rebate checks from the state," Sharp said.

Sharp recently reported in his Biennial Revenue Estimate to the state Legislature an increase of \$1.9 billion available revenue for fiscal years 1992-93 because of Texas' growing and increasingly diversified economy. However, Sharp also warned that the state could face a potential shortfall due to increased spending requirements.

Merchants collect the state and local sales tax and send it to the Comptroller's office with their tax returns. The state keeps its 6 percent share and returns the local one percent sales tax each month to local governments. Cities and counties may levy a combined tax of up to two percent above the state's sales tax, however, all Callahan County town's only levy a one percent city sales tax, Sharp said.

This month's checks reflect taxes collected on November sales and reported in late December by businesses filing monthly returns.

December rebate checks, encompassing the Christmas shopping season, will be mailed to Texas cities and counties next month.

All local sales taxes must be approved by local voters and may be used for any legal city or county expenses. Most areas put the money in their General Fund and use it for normal operations like fire fighting, maintaining roads and law enforcement, Sharp said. Some cities use an additional 1/2 percent city sales tax to help fund local economic development and to reduce property taxes.

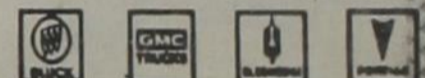
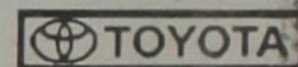

It has always been this way in war. Our government and military bend the truth to suit their purposes and our enemies bend it to suit theirs. And, it will always be this way.

The day after those first attacks, our financial markets were on Cloud Nine. Oil dropped ten bucks a barrel and the Dow jumped over a hundred points. How foolish. But you can bet somebody made some big bucks via manipulation during that day.

Old Side-arm Hussein is a tyrant on a par with Hitler, like Bush said. But, also like Hitler, he's not a fool. It took most of the rest of the world four years to whip Hitler. I hope and pray it doesn't take us that long to get Side-arm.

Before he started, in deference to my Air Force general brother, I thought we could win this thing from the air. Now I'm not so sure.

Where are all of Iraq's planes? Very few of them have been used against ours. Speculation is they are being hidden in reserve to be used against our troops should we launch a ground campaign.

If that happens, our days of wishful thinking are over.

When I walked to the highway this morning to pick up my Abilene paper, a neighbor went by in his pickup, honked and waved at me. That pleased me.

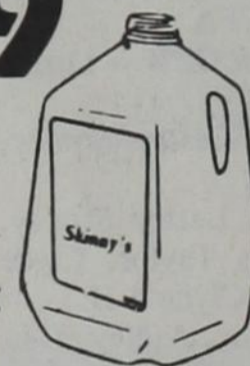

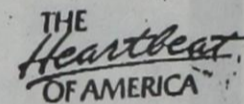
