



Korean Memorial: Veterans of the Korean War will be honored in Washington, D.C., on July 27, the 40th anniversary of the armistice.

The day's activities will include a "No Greater Love" tribute to families of Korean War dead or missing.

Among other scheduled events are a memorial service at Arlington National Cemetery and a banquet honoring Korean War Veterans. Officials will unveil a painting commissioned by Coors Brewing Company to commemorate the

Service-Connected Rules: Veterans injured while being treated by VA may be entitled to service-connected disability, according to newly defined legal defini-

Recent rulings of the Court of Veterans Appeals and the Board of Veterans Appeals require VA regional offices to consider all five categories of serviceconnected disabilities.

According to the National Veterans Legal Services Project, Veterans are also considered service-connected if:

A. Their service records show treatment or diagnosis of the condition while on active duty.

B. The condition that existed before the Veteran entered the service becomes worse during the Veteran's time in service. However, the Veteran must have served at least 90 consecutive days on active duty.

C. The condition or illness is listed as presumptive in the United States Code and the Code of Federal Regulations and manifests within a specific time from the date of discharge. For instance, if a Veteran is diagnosed as diabetic within one year of discharge, it is considered service-connected. For TB, it must appear

within three years. D. The Veteran suffers a secondary condition directly linked to service connected injury or illness.



# County's Portion Of Hays **Road Paving Lowered**

Callahan County and Clyde CISD officials received some good news Monday when they were informed the preliminary estimates to have a pipeline along Hays were completely out of line.

Callahan County Commissioners, in a regular court meeting Monday, June 28 discussed the paving of Hays Road with a representative from Chevron Pipeline. Also attending the meeting was Clyde CISD Superintendent Tony Reed, Charles Kitchell, the school district's architect for the intermediate school building project and Bill Jackson with the Texas Highway Department.

The Chevron Pipeline official told the commissioner's court that the \$75,000 figure the county would pay to move pipelines along Hays Road was not correct. The newest estimate is now between \$5,000 to \$6,000. The Chevron official said the pipeline would be unearthed and tested, which would cost \$65 per foot to perform on approximately 100 feet of pipeline.

Although county commissioners took no action, they agreed to go ahead and get estimates on getting the pipeline testing started.

No action was taken by county commissioners, however Chevron officials were to have a complete estimate of the cost within one week.

The Texas Highway Department will pay for the total cost of paving Hays Road from FM 18 north to the south access road of Interstate 20.

Since Hays Road is a county roadway, Callahan County would be responsible for paying all cost involved in moving all pipelines, telephone poles and obtaining right of ways for the project. Hays Road is located in County Commissioner Harold Hicks Precinct #1.

Clyde school officials are hoping to have Hays Road paved before the district begins constructing a new intermediate school campus building on property owned by the school district. The school district owns approximately
