This certainly has the feel of becoming a tradition, or does receiving Number 1 ratings for 5 years in a row qualify for tradition status? The Pride of Cross Plains High School Marching Band left at 7:30 Saturday morning, headed for Brady for the annual marching contest. A good size crowd of loyal band fans turned up at Brady to cheer on and encourage and, ultimately, see the best performance of the year by the hard working C.P. Band.

It's impressive to watch the many and varied performances of the different bands. The colors, the marching, the sounds are all exciting to the eyes and ears. Stenholm Made Brief Campaign Stop In Cross Plains

Congressman Charles Stenholm and his wife, Cindy, joined by a bus load of friends and supporters, visited briefly with a crowd of local residents and the high school government class students during his campaign Thursday morning. The lobby of the Citizens State Bank filled with those interested in hearing his views on various political issues. He asked if any students were eighteen and if they had voted yet? A few raised their hands.

A native of Stamford, he has represented the 17th District in Congress since 1979. He stated that he was in Cross Plains to thank voters for their past support and ask for their vote once again.

Community members asked a range of questions concerning his opinion on the Brady bill, foreign trade, energy bills, medical benefits, and the economy.

Stenholm stated that he did support the Brady bill, which consists of a five day waiting period for a person to purchase a handgun. He also favored tougher crime bills.

However, he remarked that number 1, 2, and 3 on his priority list was the deficit with health care ranking number 4. His response drew applause from the audience. He explained that reform bills concerning health care had been written and soon would be passed.

He noted that the United States military force is still ranked number 1 and he was concerned about too much build down on the military strength.

He favored import fees concerning oil and other industries.

The Congressman emphasized the need to balance the budget within the next five years, or the young people,

represented by the class present, would hate the circumstances they would be faced with. He expressed his dedication to balancing the budget, and felt that a change in the administration would be beneficial.

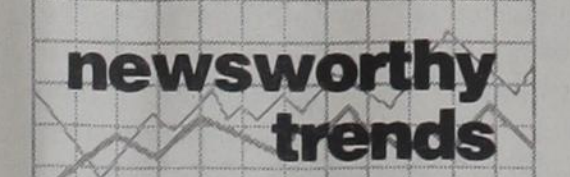

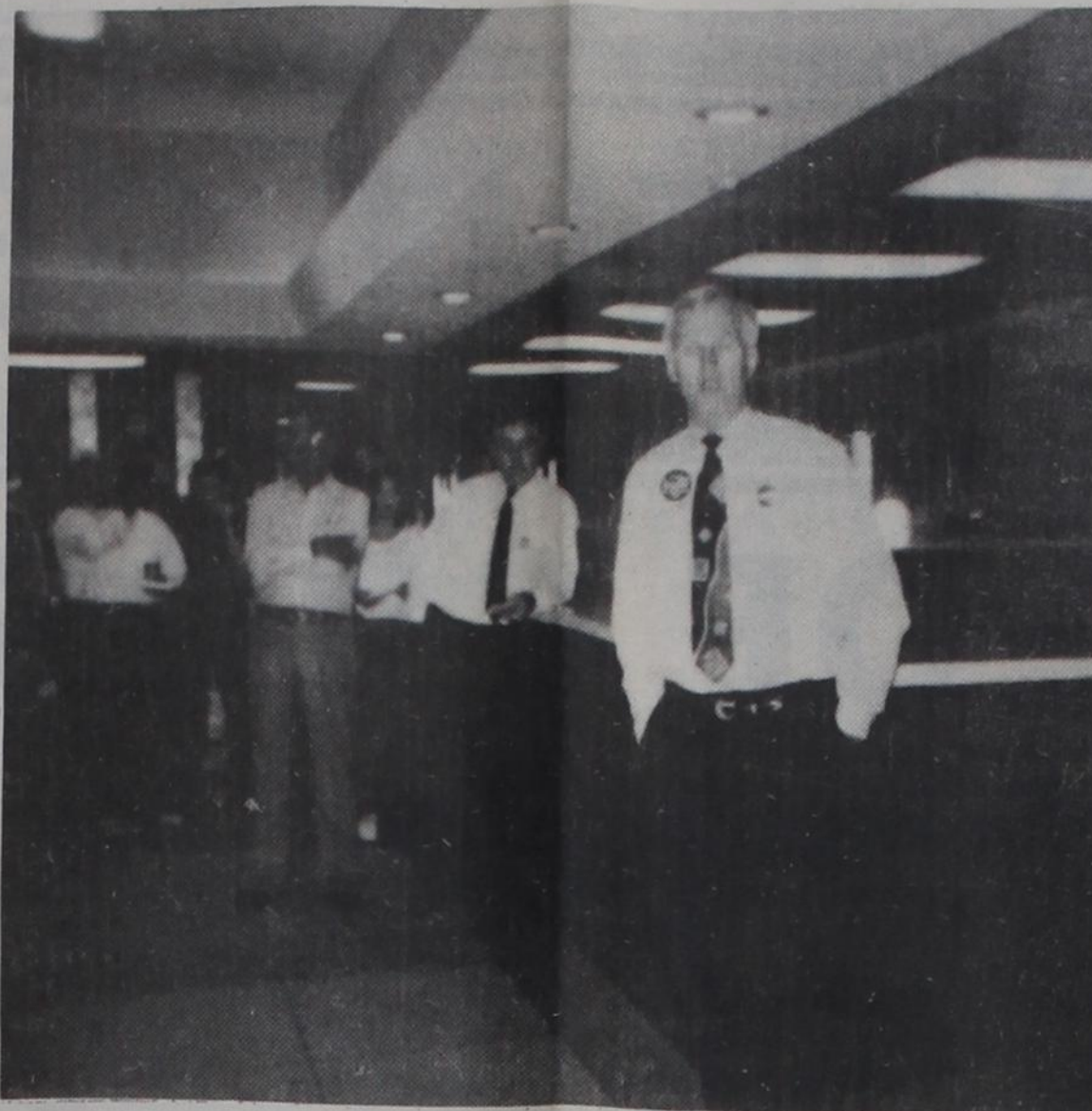

MARE-FOAL CLINIC SCHEDULED NOV. 14

Are you one of the many horse lovers who has a mare which will foal in the future? If so, you need to reserve the date of November 14.

The Erath County horse committee is sponsoring a mare-foal clinic to address areas which are of concern such as feeding, parasite control, weaning, and much more.

The clinic will begin at Tarleton State University Agricultural Auditorium, with registration at 9 a.m. The first speaker will be Dr. Steve Russell. At 9:30 he will discuss parasite control and herd health.

Dr. Pete Gibbs, Extension horse specialist from A&M, will then present the latest information on feeding the brood mare and foal. Feeding is one of the most important, but possibly least understood areas of horse production.

The well known and respected Dr. Ed Murray from Spur, Texas will be their featured speaker prior to lunch. Dr. Murray is a past president of the American Association of Equine Practitioners and is a leading authority in the cause and treatment of angular limb deformities in foals.

The noon meal will be at the Tarleton State University Horse Center, located at the college farm. The afternoon session will be held at the Horse Center with some demonstrations, as well as presentations.

Scot Jackson, local horse trainer, will demonstrate and discuss transporting the mare and foal. After waiting a year and spending the time and money to have a healthy foal, you will surely want to minimize the chances for any injury in transporting.

"Weaning the Foal" will be the topic to be discussed by Dr. Bill Jackson. Should you wean early and if so, when? Dr. Jackson is also well known as an authority when it comes to horses and raises a number of foals which he also shows each year.

All reported having a wonderful time at our first outing together.

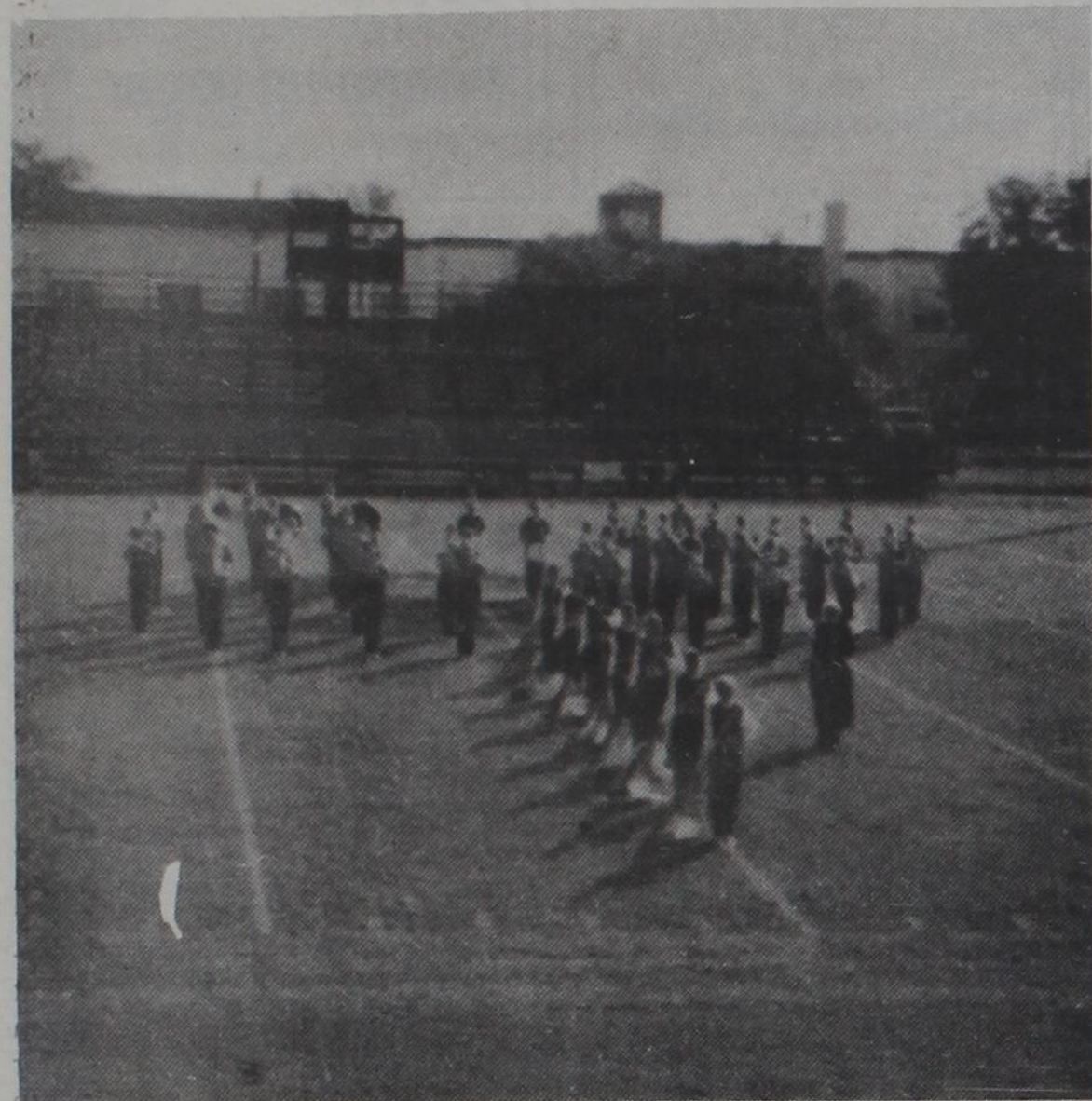

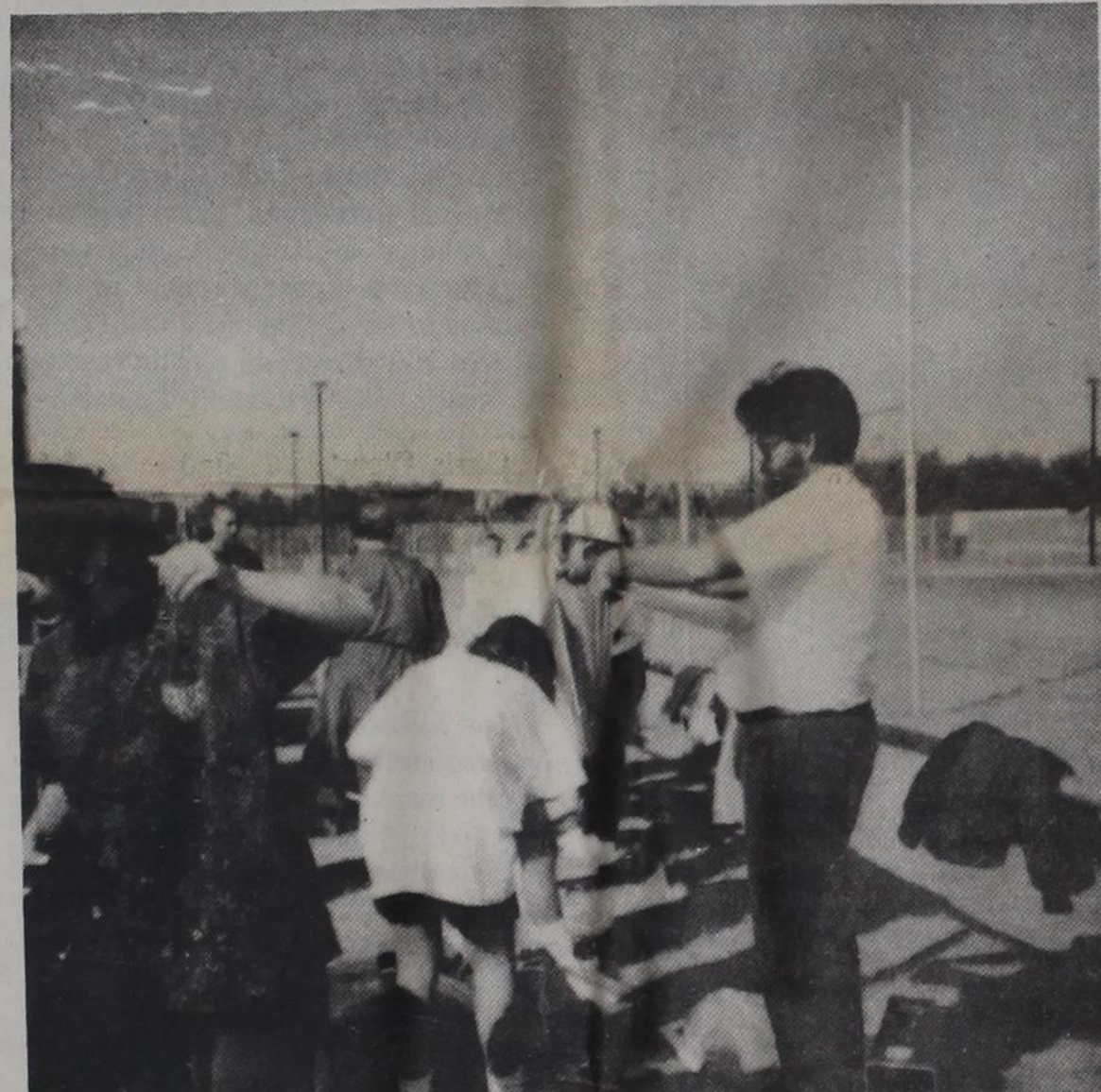

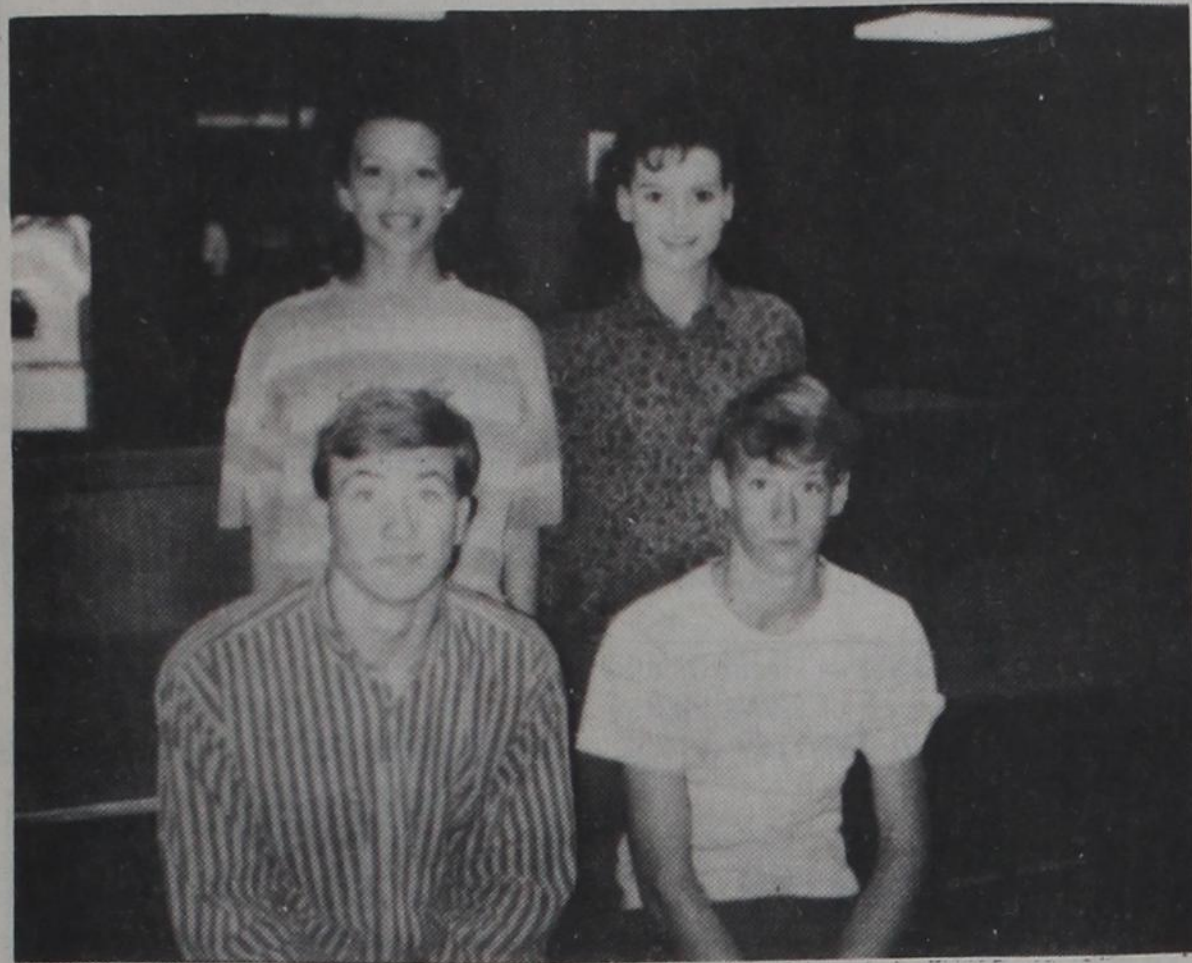

Varsity Buffs Score Third District Win

Do you realize that at this point in the season, the Cross Plains Buffalo Herd is tied with Gorman for second place in District 13A with a record of 3-1? The Buffs remained in that position by defeating Santo 31-6 in a game played at the Wildcat field on Friday, October 23.

With the smell of cooking hamburgers wafting towards the visiting bleachers all evening, the loyal Buffalo fans had the pleasant opportunity to watch the Herd dominate the game against a feisty but struggling Santo team.

Perhaps knowing that the band was leaving after half time (due to going to marching contest early the next morning) or maybe for some other reason, the Buffs provided an exciting first half in which they did most of their scoring.

C.P. scored 4 out of their first 5 possessions in the first half of play. The Buffs took the initial kickoff at the C.P. 15, advanced to the Wildcat 48, before stalling and having to punt. That was the only time they punted in the half.

Santo was unable to move the ball in their first possession and on 4th down, they tried for the fake punt, unsuccessfully. The Buffs were now set up in a very advantageous position...the Santo 29 yard line. Kevin Switzer gained the next 3 yards, and then quarterback Brock Walker kept the ball on the next play, scampered ahead of the defense for the 26 yard to run. Brock Walker then easily kicked the ball through the poles for the PAT. With 5:17 left, C.P. went out on top 7-0.

The Buffs held Santo to 4 plays before taking control again and getting their second TD. This drive started with a 50 yard punt return by Jason Fleming, putting the ball on about the Wildcat 5 yard line. A yard was gained by Switzer before the across-the-field 4 yard pass from Brock Walker to Michael to Michael Cowan for the TD. The PAT was unsuccessful; but, with 1:43 left in the first quarter, the

Buffs now led 13-0.

Santo's next possession ended shortly after it began when they fumbled. C.P.'s Billy Brown recovered, took off for the goal line, made the TD; but, a Buff penalty brought it back. The Buffs retained possession and now into the second quarter. C.P. was set at the Santo 24. After carries by Cowan and Fleming, a nearly intercepted pass attempt to Brandon Smith, and a successful pass to Donnie Dillard, Fleming made the final carry for the Buff's third TD. Switzer's attempted kick for the PAT didn't work, but the lead was now 19-0 with 11:25 in the half.

The Wildcats put it all together with their next offensive drive and moved the ball 60 yards for their first and only TD. They attempted to pass for the extra 2, but C.P.'s Jimmy Lee prevented that by a timely interception in the end zone.

In the Buffs last drive of the first half, they matched the Santo 60 yard drive with one of their own. Buckley Williams took the Santo kickoff, returning it 10 yards, putting the Buffs at the C.P. 40. Nine plays later, Cowan made a short, yet exciting catch, for the TD. Brock Walker attempted to run the ball for the PAT, but was stopped short. With 5:15 left, the score was 25-6.

The majority of the second half was defensive for both teams. There was only one TD made between the teams and it was by the Buffs early in the third quarter. That drive was finished by a good pass from Brock Walker to Fleming. The PAT carry for Fleming failed. That was the last score of the game; but, it put the Buffs well out in front 31-6.

The Buffs are in good shape going into this next game against Rising Star. This is an old traditionally exciting game, so plan on being part of the crowd to see not only a good football game, but you will enjoy the #1 rated performance of the Buffalo Band.

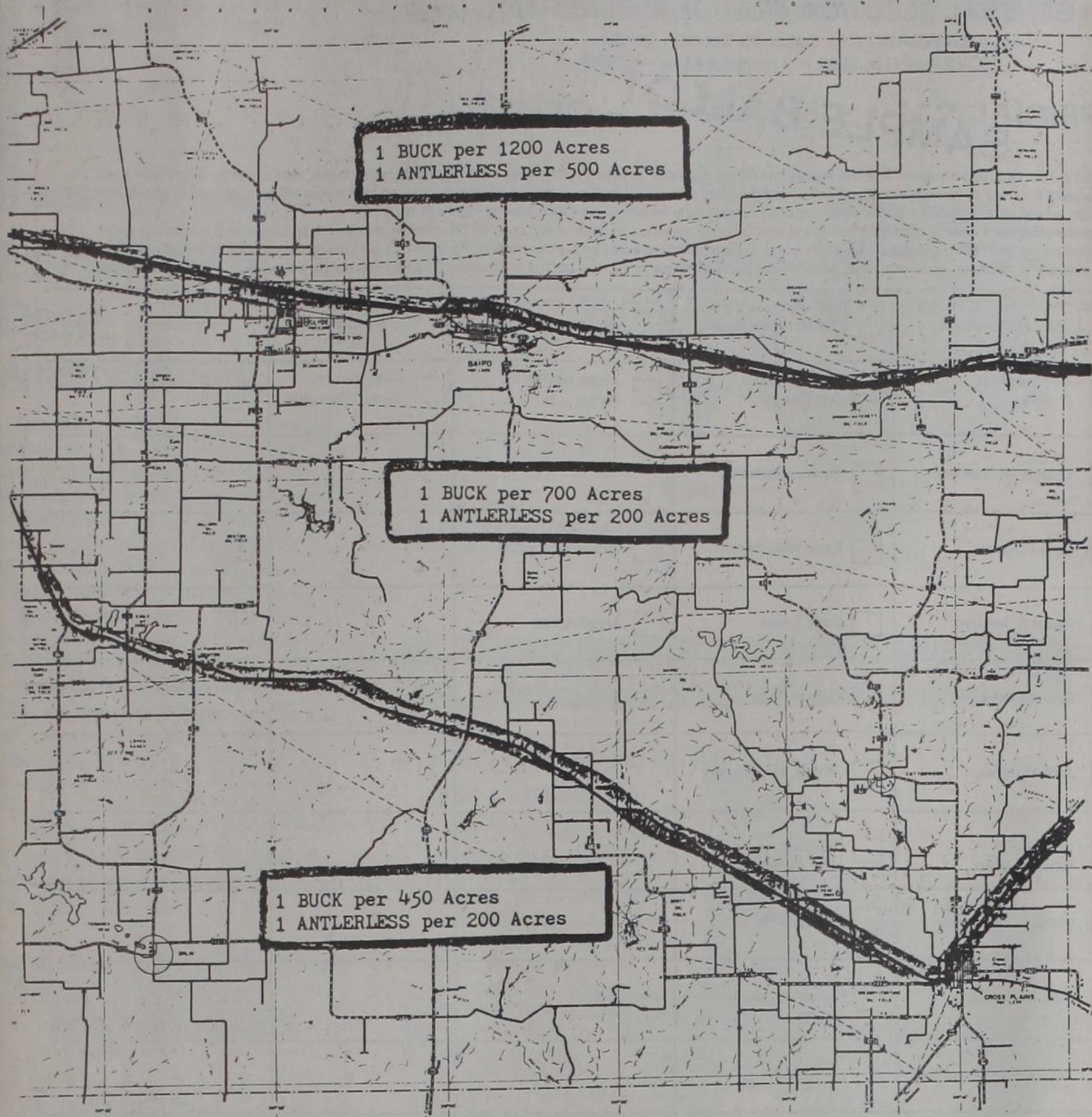

Deer Season Upon Us

According to area wildlife technician Trey Carpenter, we are in for an incredible deer season. The general deer season begins Saturday, November 7, 1992 and will run through Sunday, January 3, 1993. As in the past, no antlerless permits (either-sex) will be required and the legal limit for Callahan County is 1 buck and 2 antlerless.

"The mature deer (4 1/2 + years old) we have out there today are truly quality animals. These deer have had excellent range conditions throughout their lives. Antler production and body weights could be at an all time high," stated Carpenter. Male white-tailed deer respond to good range conditions by increased body fat rates and antler production. Females respond with increased body weights and increased reproductive potential. Trey states, "The total deer seen during our census efforts were down a little, but I feel that we just were not seeing many deer because of increased vegetation from the excellent spring and early summer precipitation. When the range conditions are as good as they are this year, deer do not move around much. There is no need for them to get out by the

roads when they have all they need right where they are standing."

The Texas Parks and Wildlife Department conducts deer surveys each year to determine overall deer density, reproduction and sex ratios. Because it would be impossible to survey by a ranch to ranch basis, standard aerial and spot-light surveys are conducted each year. These surveys yield valuable trend information necessary to make density estimates and general harvest recommendations. Carpenter stresses, "These recommendations are very general and should be used only as a guideline because deer densities vary greatly from area to area. Each landowner should look at his/her deer population to determine numbers to be harvested. Even though the legal bag limit is three deer in Callahan County, some areas need very few, if any, harvested. Under the either-sex system the landowner makes the final decision as to how many deer can be harvested.

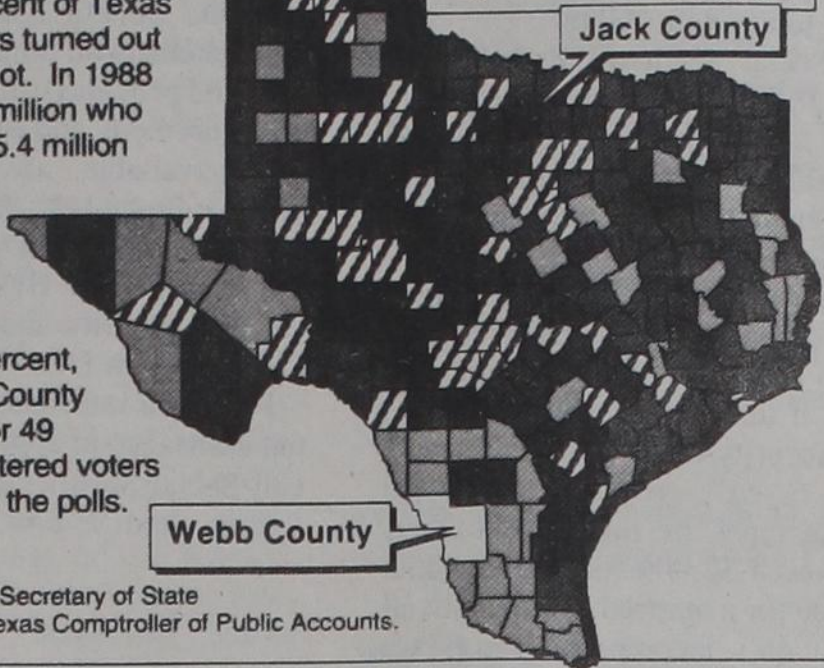
Keeping an eye on Texas

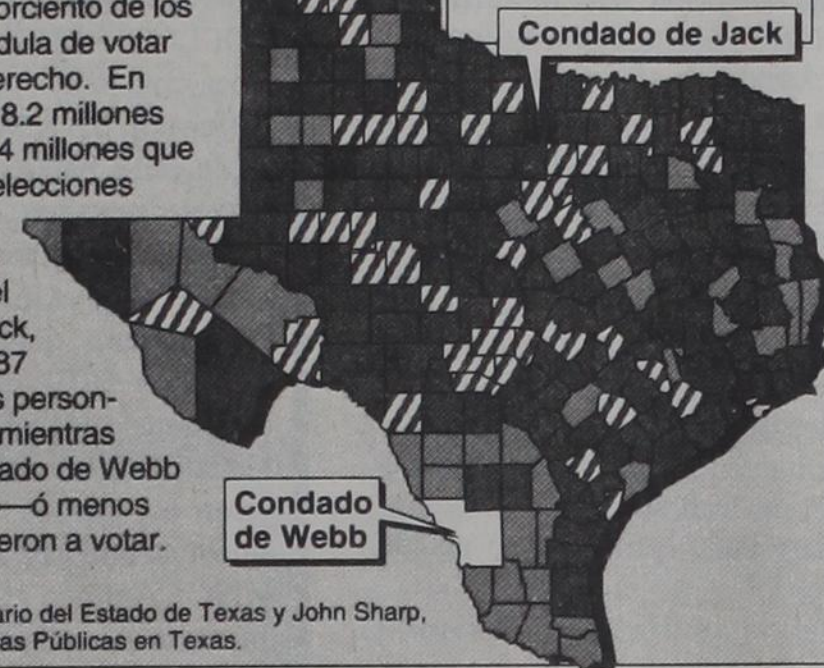

Thousands Seek Free Screenings For Breast And Cervical Cancer

Texas Department of Health (TDH) officials urge Texas women to schedule cancer detection checkups, either with their own physician or with public health care providers, during October, Breast Cancer Awareness Month.

Women who can not afford preventive or early detection health care services can take advantage of TDH's new no-cost program to screen for breast and cervical cancer.

An estimated 10,000 women sought

the free clinical breast exams, mammograms (X-rays of the breast) and Pap tests (tests for abnormal cells in the cervix) between January and June this year. Of these, at least 21 were diagnosed with cancer. They have undergone, or are undergoing, treatment. Because many diagnostic results are still pending, the number of women found to have cancer probably will increase.

"Many of the women we see, even those in their 50s and 60s, never have had a mammogram because they can't afford preventive health care or health care designed for early detection of disease," said Charlene Laramey, Director of the TDH Chronic Disease Prevention Division. "The response we've seen clearly demonstrates the pent-up demand for these life-saving health care services which many of us take for granted," Laramey said.

"Women and their families express relief, whether they've had cancer detected early so that it can be treated, or they've had a cancer-free report that gives them peace of mind," she added.

The program's services result from a cooperative agreement between TDH and the national Centers for Disease Control. TDH will receive \$5 million for the second year of the program, compared with \$3 million last year. The program also is supported by the Texas Cancer Council, the American Cancer Society's Texas Division, and the M.D. Anderson Cancer Center. Officials expect to serve 25,000 women during the current fiscal year, which began Sept. 1.

Based on the forms processed to date, about one-third of the women checked during the first year were age 50 or older. This is a targeted population group, because older women have the greatest likelihood of having cancer.

To qualify for the free cancer services, a woman must meet age and eligibility requirements. A woman who lives below 200 percent of the federal poverty level (less than \$1,135 a month for an individual, and less than \$1,532 a month for a family of two), and is age 40 or older will qualify for free breast cancer screening services. A woman who meets the same income and insurance requirements and who is sexually active or age 18 or older will qualify for cervical cancer screening services.

"When a woman first gets cancer, she can't tell that she is sick," Laramey said. "That's why regular check-ups are so important."

Free breast and cervical cancer screenings are offered at more than 230 clinics throughout Texas. A variety of health care providers, including primary care centers, family planning clinics and regional hospitals, offer these services. For the nearest location, call (512) 458-7644.

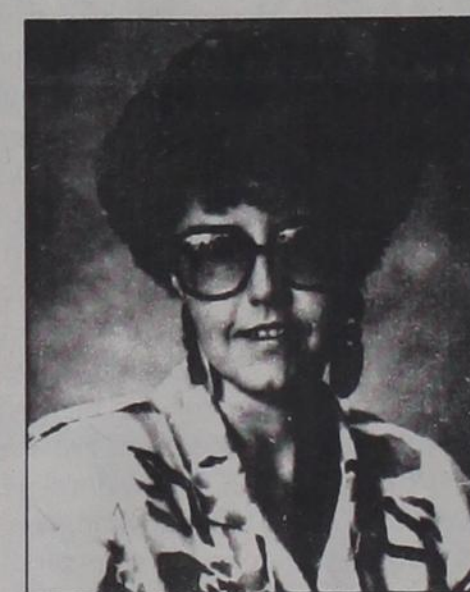

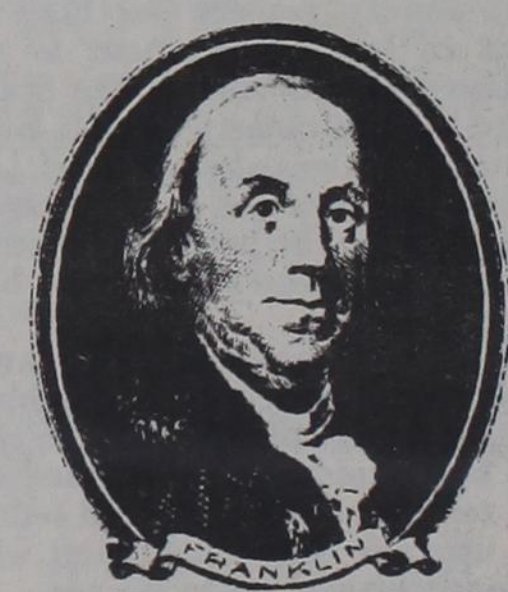

Hotline To Promote Affordable Housing

Eight federal agencies and government-sponsored enterprises have united in an effort to help thousands of persons, including very low- to moderate-income families, achieve home ownership.

Beginning October 15, the eight organizations will establish a joint

marketing information center in Dallas. Alfred A. DelliBovi, Deputy Secretary of the Department of Housing and Urban Development (HUD) and Chairman of the National Housing Advisory Board, said the center will operate on a six-month pilot basis to provide information on over 3,000 homes for sale throughout Texas.

By dialing the toll-free Housing Opportunity Hotline number, 1-800-362-2944, a caller will receive information on homes being offered for sale by the organizations anywhere in Texas.

Until now, persons interested in buying homes offered for sale by federal agencies and government-sponsored enterprises have had to contact each individual organization to learn what is available.

"President Bush and HUD Secretary Jack Kemp have established home ownership and affordable housing opportunities as a domestic priority to expand homeownership among very low- to moderate-income families," said DelliBovi. "This initiative will make it much easier for these Americans to achieve their dream of home ownership."

Last year the eight organizations involved sold approximately 200,000 homes, many of which qualified as affordable housing. These are homes that were acquired as a result of loan defaults, foreclosures, direct assignments, and seizures.

HUD will serve as principal coordinator for the project along with the Resolution Trust Corporation (RTC), and the Federal Home Loan Bank of Dallas will be the clearinghouse, or information center, for the project.

The Dallas Bank has acted as a clearinghouse for the RTC, the savings-and-loan clean-up agency, since 1990 and has handled information on about 13,000 affordable housing properties since that time. The RTC currently has more than 500 affordable housing properties listed with the clearinghouse.

In addition to acting as an information center for callers, the Dallas Federal Home Loan Bank will make information on the homes available to local housing authorities.

"If this pilot program is successful, which I am sure it will be, we will expand it nationwide," said DelliBovi.

While the Housing Opportunity Hotline offers numerous affordable homes for very low- to moderate-income families, some of the homes listed will be within the range of other buyers, as well.

The organizations offering property for sale under the pilot program are: Department of Veterans Affairs, Farmers Home Administration, Federal Deposit Insurance Corporation, Federal Home Loan Mortgage Corporation (Freddie Mac), Federal National Mortgage Association (Fannie Mae), General Services Administration, HUD, and RTC. The Federal Housing Finance Board, the Federal Home Loan Bank of Dallas, and the National Housing Advisory Board of the Thrift Depositor Protection Oversight Board are supporting the program.

Persons With Aids Can Get Government Help

Two programs through Social Security can make a difference in sustaining the financial independence of persons living with AIDS.

The Social Security Disability Insurance (SSDI) program pays monthly benefits to adults unable to work due to HIV infection — if they have worked long enough and recently enough in Social Security covered jobs.

The Supplemental Security Income (SSI) program makes payments to people who have HIV-related disabilities — even if they have never worked in Social Security-covered jobs. SSI is a "needs based" program for people whose incomes are limited and assets don't exceed \$2,000 for an individual or \$3,000 for a married couple. Not all of a person's income and assets are counted. For example, a home, car, and most personal belongings are excluded. Children with HIV disease are also eligible for SSI payments.

Under both programs, the definition of the term "disabled" is the same. Adults are considered disabled if they are unable to do any kind of substantial work for which they are suited — with expectations that the inability to work will last at least a year or that the disabling condition will be terminal. For children, Social Security looks at how the condition affects the ability to function — to do the things and behave in the ways that other children of the same age normally would.

Both benefit programs include some health care coverage. Medicare, the federal hospital and medical insurance program, is available to Social Security Disability Insurance beneficiaries after they have been entitled for 24 consecutive months. Medicaid, the state-run medical assistance program, is also available, primarily to people receiving SSI.

Persons with HIV-related

disabilities who are continuing to work should contact Social Security at 1-800-772-1213 to request an Earnings and Benefit Estimate Statement. The statement summarizes FICA taxes paid and provides estimates of disability, retirement and survivor benefits. Also available are two important publications: "A Guide to Social Security and SSI Disability Benefits for People with HIV Infection" and "Social Security and SSI Benefits for Children with Disabilities."

For more information and confidential assistance in applying for benefits, call Social Security any time between 7 a.m. and 7 p.m. at the toll-free

number shown above.

Deadlines Announced For Overseas Holiday Mail

International and military mailing deadlines to ensure delivery of airmail packages and greetings by Christmas have been announced by the local post office. The chart below shows mailing deadlines by destination and service option.

Parcels destined for military personnel and families can be sent by air most economically by Parcel Airlift Mail (PAL) and Space Available Mail (SAM).

Packages weighing up to 30 pounds and measuring 60 inches to combined length and girth may be sent to military addresses by PAL. These packages are airlifted domestically to a U.S. gateway facility, then sent by air on a space available basis to an APO

(Army or Air Force Post Office) or an FPO (Fleet Post Office) for delivery to the addressee. The mailer pays only the regular domestic parcel post rate to the gateway postal center, plus airmail postage of 30 cents for parcels weighing up to 2 pounds, 60 cents for 2- to 3-pound parcels, 90 cents for 3 to 4 pounds, and \$1.20 for those weighing 4 to 30 pounds.

SAM may be used for mailing parcels of up to 15 pounds and 60 inches in combined length and girth to military addresses overseas at regular parcel post rates. SAM mail is transported domestically to gateway facilities by surface vehicle, then flown to its destination abroad on a space available basis.

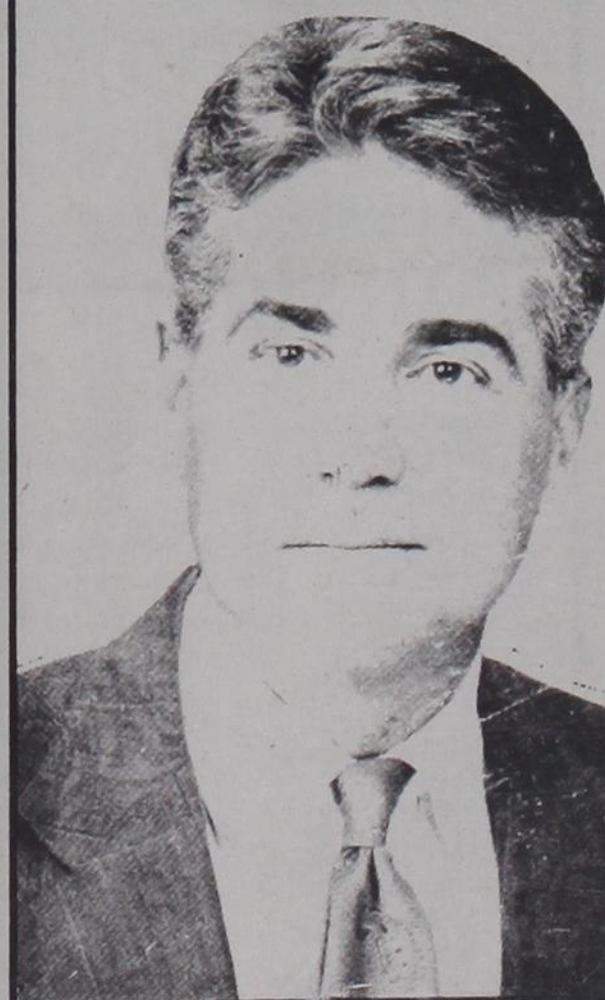
