

A new addition to our family is amazingly similar to a newborn baby. Kozy K., a miniature half Doberman Pincher and Daschund, is a sweet little puppy with her days and nights mixed

The agreement between my teenage children was that they would take complete care of the pup. So they take turns at night when she wakes up. On Kye's first turn, I explained that he would have to listen for her and care enough about Kozy to hear her. The next morning he said, "Mom, I said a little prayer before going to sleep and asked God to let me hear her. I almost wished He hadn't answered that one after waking me at least nine times." It has been a great experience, however, as the kids realize the responsibility and fatigue a little one demands. None of this affects Leah's enthusiasm, while Kye stated that Kozy was cute, but a pain. She is a sweetie all right, with the markings and black and brown coloring of a Pincher and the ears, body, tail and personality of a Daschund. Her body is about six or seven inches long with a four inch tail, standing on two inch legs. Kozy is so tiny that she can run like the wind and loves chasing the kids around the house in hot pursuit. Her long ears flapping and an antennae type tail, she appears mechanical in her forward, reverse, and sidewinding gears. She has a baby Pound Puppy for a toy which we call Spot. If you tell her to fetch Spot, she will grab him by an ear or the back of the neck while growling and shaking him fiercely.

Locally Known Young **Man Recuperating From Austin Shooting**

David Fritz II is currently recuperating at Abilene with his mother and her husband, Jim and Thalia Robertson, following four gunshot wounds.

He was critically injured on June 25, 1992 when he and his uncle, Kermit Fritz, went to visit his father, David Fritz in Austin. David II had just returned from an European tour and the two had called ahead. Upon arrival David Fritz shot his brother, Kermit, seven times with a 9 milimeter semiautomatic, killing him and fired six shots at his son, David.

David was hit in his right leg twice, breaking the bone in two places and shattering his knee cap; another bullet entered his chest and lung, missing his heart by one-half inch; a fourth bullet grazed his shoulder; while two bullets which would have been fatal were blocked by camera and equipment in his back pack. David remained still while his father assumed he was dead and returned to

Following two and one-half weeks in the Intensive Care Unit at Breckenridge Hospital in critical condition, David's condition upgraded and last Friday he returned home with his mother. No surgery was ever performed, as all the bullets passed through his body and he was too critical for surgery at the time. The bullet through his lung caused it to collapse three times and he must have daily X-rays at Humana Hospital.



City Council Minutes

Submitted by the Cross Plains City Council

July 7, 1992

This was a regular meeting of the Cross Plains City Council. Members present were Mayor Gene Dillard, Ted McKeehan, Gary Childers, James Nichols, and Tom Clark. Joe Holland was absent.

Gary Childers moved to accept the minutes of the previous meeting as read. Tom Clark seconded and motion carried.

Mr. James (Red) Weddell with the Texas Water Commission met with the council to discuss the requirement for the city to maintain a pressure of 35 lbs. during normal operation and 20 lbs. during peek operation. He discussed the different options the city has to create this pressure requirement as follows: An in-line booster pump, a standpipe with elevation valve, or an elevated tank. He also discussed the pros and cons to some of the suggestions. Billy Jacob, City Engineer, met with the council to discuss the possibilities. Approximate cost on an elevated tank is \$220,000.00 and a standpipe approximately \$160,000.00. These figures do not include removal of the existing elevated tank. The council will discuss this matter further as information is available.






## WTU New Business Development Department

Rodco Texas title.


